Board Administrative Complex Thursday night. Sponsored by the Blue-Grey Army, the production is free to the public. It starts at 7 p.m., but Blue-Grey Army Major Cody Gray suggests people arrive early to get good seats.

"This play has everything we were looking for, such as comedy, serious moments, lighthearted moments," Gray said, "but it also kept true to the Civil War era and historical viewpoint."

## Water levels on the rise with wet weather

#### Groundwater levels higher, says SRWMD.

The last three months were wetter than normal, with an average of 12.1 inches of rainfall, about 3 inches higher than normal, across the Suwannee River Water Management District, district officials said.

January rainfall was 1.8 inches above average. The wettest November-January on record was in 1947-1948 with over 17 inches, and the driest was in 1956-1957 with just 1.4 inches.

The wet weather caused groundwater levels in the upper Floridan aquifer to rise in January after falling steadily since the almost record-setting wet summer. Forty percent of the district's monitor wells had levels in the top 25 percent of readings, double the number seen in December, officials said.

Conditions on the Santa Fe River are typical for this time of year. Levels on the Suwannee River are higher than usual for early February, but still well below flood levels. Recent rainfall patterns have favored northern Florida over southern Georgia which has helped keep river levels stable without the rapid fluctuations that occurred in 2013.

River residents should remain vigilant over conditions in southern Georgia, since a single large storm can cause problems downstream quickly, district officials said, noting February, March, and April are the peak flood season in North Florida.

#### Man charged in reporter's killing

PENSACOLA — The father of a man on trial in the bludgeoning death of a former Pensacola News Journal reporter told jurors on Wednesday of a "horrible" smell that came from the back of a U-Haul his son drove to his home in Georgia from Pensacola in 2012. "It smelled like a dead

dog," the father testified.

Investigators later unearthed the body of former Pensacola News Journal reporter Sean Dugas from the backyard of the father's Winder, Ga., home. Dugas' body was stuffed into a plastic container surrounded by air fresheners and potpourri and covered in concrete.

Prosecutors allege William Cormier III bludgeoned Dugas to death in August 2012 and transported his body from Pensacola to Georgia, leaving the body in the plastic

container for more than a week before burying it. During his occasional-

ly combative testimony,

Cormier Jr. told jurors that he later received a call from a Pensacola detective asking about Dugas' disappearance. The father said he woke his twin sons up and told them about the call. "I said, What the hell is

going on? There is a detective from Pensacola calling and somebody is missing',"

he testified. "They said they were going to remove whatever was in the backyard."

William Joseph Cormier III is charged with first-degree murder in Dugas' death. Prosecutors allege Cormier III killed Dugas and stole his \$100,000 collection of valuable cards.

sale price for homes sold in Columbia County was \$113,250 and declined to \$110,000 in 2013.

New pending sales, an indicator of potential closed sales, increased to 524 during 2013. The uptick marks a 33.7 increase from 2012, when the number of new pending sales sat at 392. Inventory also jumped from 351 in 2012 to 421 in 2013, a 19.9 percent increase.

Both numbers mean people are more confident in the market, Gherna said. Sellers must be testing the market to see if they can get the price they want, he added.

For the last three years, sellers have seen an increase in the percentage they receive of their original list price. Over the last year, the percentage increased 1.5 percent and now rests at 88.4 percent.

According to Florida Realtors, the number will continue to rise in a recovering market as buyers realize they need to match the selling price or even better it.

"All of the statistics are showing the market is improved or improving," said Board of Realtors president Susan Eagle. "All the reports we're seeing show the economy is getting better and home sales are looking to improve.'

According to her, buyers should jump now before the market transitions to a seller's market. Since 2008, a homes median number of days on the market has been trending downward. For last year, a home sat for a median of 89 days on the market before it sold.

"Houses are moving now," she said. "The inventory — there's just not as much for them to look at, not as much for them to chose from now."

## One dead in early morning collision

LIVE OAK — A Suwannee County woman died in a collision with a log truck here early Wednesday, FHP reports.

Tracy H. Deas, 42, was traveling east on US 90 when a 1998 Kenworth tractor-trailer loaded with logs made a right turn in front of her from County Road 137, FHP said. Her 2004 GMC Yukon struck the left side of the trailer.

Deas was transported to UF Health Shands, where she was pronounced dead at 8:42 a.m. Wednesday, according to an FHP news release.

The driver of the log truck, Eliecer Caceres Labrada, 42, of Ocala, was unhurt.

US 90 was closed for several hours, according to FHP.

counties in North Florida Columbia, Suwannee, Hamilton — is the people in them and their willingness to work together,' Neelands said. "I'll miss all of them."

As chief probation officer, Neelands sees a vast number of children struggling in the juvenile justice system. Lately, her department has made changes throughout the state to help those children become responsible adults.

Now, the department issues citations for children who aren't repeat offenders. The process allows some first-offenders to keep that history from bogging them down for the rest of their lives.

To help the children and their families, Neelands ensures each community offers a wide variety of services. She accomplishes the task by building community partnerships in each of the seven counties in her jurisdiction.

"I think our biggest accomplishment was having a good staff who worked together," she said.

"It wasn't anything I did on my own."

According to Neelands, she started working for the state when the Department of Public Welfare existed. She transitioned to the Florida Department of Health and Reĥabilitative Services, where she stayed until 1996. That year, HRS was reformed into two separate entities: The Department of Health and the Florida Department of Children and Families. Neelands worked for DCF until 2007 when she moved to her current job at the Department of Juvenile

Her job at DCF, she felt, prepared her to take over as chief probation officer.

"Because we were a new agency, you might have come for one job, but you had to learn several jobs," Neelands said. "You did a little bit this and a little bit of that.'

About 30 community members and DJJ employees gathered Wednesday morning at Florida Gateway College to celebrate Neelands' retirement. The words on her cake read: "Best Wishes on Your Next Adventure."

Neelands plans to spend Thursday, her last day on the job, packing away what's left of her stuff. The experience of boxing memorabilia collected over the last 42 years brought back a

flood of memories, she said. "Her dedication and commitment to families has spanned over 40 years and will be missed," said Jill Clemens, the north region director of juvenile probation. "She provides expertise based on continually researching evidence-based practices on a national and state level.

... Her training and support of staff in the circuit has left the community in good hands as they move forward."

The department has not selected a new chief probation officer as of now, but Clemens said she intends to make a recommendation

"What I've found is Sharon is sort of like the oak tree holding fast and steady," said John Hancock, Third Circuit coordinator for DJJ. "She doesn't get swayed.... With juveniles, there's so much to do, some much to accomplish that if you're going to do anything you have to remain steadfast. Sharon has been a solid part of the community while she's been here."

dressed as John Wilkes Booth, jumped into the Presidential Box and tried to kill Lincoln. The bullet missed, and Lincoln survived to enjoy a weekend of celebrations at the annual Battle of Olustee Festival.

Gray doesn't expect any surprises during Thursday night's "Our Leading Lady."

The play premiered at the Manhattan Theater Club in March 2007, depicting the presidential assassination not only as a national tragedy but as a vexing interruption in a woman's quest to fame and glory, Gray said.

"Our Leading Lady" fol-

lows Keene's attempt to bring Lincoln to her closing night peformance despite a series of backstage quarrels that threaten to hinder the play's performance. Before the guest of honor arrives, she labors to bring the theater's stock company together so they can awe the audience. But after the tragedy, she contemplates her uncertain future. Will she be suspected of helping Booth assassinate the president?

Live theater was extremely popular during the Civil War era, a factor in the Blue-Grey Army's decision to start this year's events with a well-known play.

"We always look for something that is unique a draw for people at the festival that isn't something they could find on an everyday basis," Gray said. "Having a local group made this that much better. It showcases the talent in our community."

The Alligator Community Theater has been preparing for the opening night since November. Many people will remember several of the actors performing in "Our Leading Lady" from their work in "Our American Cousin."

"I certainly want to encourage people to come out," Gray said. "It's a family friendly environment, a night of singing and live theater. These are people that have a lot of talent and have practiced months in preparation for this event to make sure it is a grand theatrical production.

## A little girl to remember

hirley Temple is hard to imagine today in Hollywood, or in Topeka or Cleveland, for that matter. She was the sweetheart of an innocent age and a hopeful place that deserved her more than ours, and it's difficult to recall the grip she had on the nation's heart in a time of misery and desperation.

Shirley Temple Black, who died this week at age 85, demonstrated that a child shall lead them to stardom done right. The little girl who danced down the stairs with Bill Robinson — "Mr. Bojangles" — and captured the nation's heart gave America a wink and a little girl's smile to soften the throes of the Great Depression.

Franklin D. Roosevelt observed

Franklin D. Roosevelt observed that "as long as our country has Shirley Temple, we will be all right." And it was so. From the age of 6, she won over the theater crowds to the delight even of the silver screen's harshest critics. Her grace was just what the country needed.

"I class myself with Rin Tin Tin," Mrs. Black once described herself with the self-deprecating modesty that warmed her charm. "At the end of the Depression, people were perhaps looking for something to cheer

themselves up. They fell in love with a dog and a little girl. It won't happen again." Indeed.

Her turn at the top of Hollywood's A-list came to an end, as all such things must. She gave up show business at the age of 22, when most stars are just hitting their stride, and turned to what she found to be far more important, family and public service.

She was a mother, a grandmother and eventually a great-grandmother, and succeeded at all three. She was a delegate to the United Nations and an ambassador to Ghana. She was President Gerald R. Ford's chief of protocol, the first woman to hold the post. She was President George H.W. Bush's ambassador to Czechoslovakia, where she had a front-row seat to watch the fall of communism.

In a town where celebrity marriages are often measured in months, sometimes weeks and occasionally days, Mrs. Black was devoted to her husband, the late Charles Alden Black, for 55 years.

devoted to her husband, the late Charles Alden Black, for 55 years. Today's child actors frequently become ambassadors of immorality. To name just one, Miley Cyrus, who at age 11 was the Disney Channel's

"Hannah Montana," a wholesome

character playing a teenage pop

singer. She grew older, but not wiser.
She listened to her managers
who told her to deliver increasingly
tawdry performances, just for the
shock value. Miss Cyrus continues
to turn in one vulgar and tasteless
performance after another, pursuing

fame and wealth.

Shirley Temple, the brightest and most bankable star in Hollywood in its golden years, shunned the cheap and the frowzy.

She held firmly to her values, once resigning from the executive committee of the San Francisco International Film Festival to protest a screening of the Swedish film "Night Games," which she called "pornography for profit."

America could embrace another Shirley Temple, unlikely as that prospect may be.

With the news of disappointing jobs reports, people losing their health care, higher debt and taxes, a cruise on the "Good Ship Lollipop" to the "sunny beach of Peppermint Bay," a magic place with "lemonade stands everywhere," is just what we need. Shirley would make everything right. She always did.



### Test your history knowleďge

Dr. Smitherman, was born to southern family in Birmingham, Ala., where his father served as a reverend. Young Smitherman saw his father's church



burn down twice during their push for voting registration.

He would later become a pioneering

executive and professional chemist at Proctor & Gamble who led the way for other African-Americans at the prestigious company in the 1960s. He was the first black person with a doctorate hired at Proctor & Gamble.

With a Ph.D in physical organic chemistry, Dr. Smitherman, developed a number of incredibly popular patents, including Crest toothpaste, Safeguard soap, Bounce fabric softeners. Biz, Folgers Coffee and Crush soda, to name a few.

Not only are they still on the shelves, but many of them are on display at the Cincinnati Museum Center in the featured exhibit, "America I AM: The African-American Imprint."

Smitherman was nicknamed the "Jackie Robinson of Proctor & Gamble." After 29 years there, he turned in his lab coat to work as a professor at Wilberforce University.

After serving at the historically black college, Smitherman turned his attention to starting a high school called the Western Hills Design Technology School to help black students perform better in math and science.

## Working together to build the Village

ast week a group of citizens traveled to Ft. Mose, located in the historical St. Augustine, Florida, Ft. Mose is the first all black settlement of free black people. These people lived in Spanish Florida in a time when Florida was not part of the United States.

The group of travelers consisted of 34 passengers, 17 of which were schoolaged children. The bus trip to Ft. Mose is an opportunity to discuss black history, and all things that concern the making of it.

This year we discussed the cultural contributions to black history and the part such culture plays on progress. The passengers were asked to identify cultural characteristics that

were unique to the black community. The things identified and discussed ranged from soul food, and family reunions to being fashionably late (out of season) and self-identity.

Students shared ways that changing the cultural norms could positively impact the progress being made. The statement of one child set off a nerve for most adult passengers

to such degree that further discussion and focus is warranted. A little girl on the bus felt that if 'adults would mind their own business, the community would be better off."

Imagine for a moment,

sitting in your car at a stop light and watching a young child wander aimlessly into traffic. Do you sit until they cross? When you notice the direction of the child is unknown, do you park and get out and offer assistance? Or do you call for help? Whichever you choose, something would be wrong if you drove uninterrupted by the child's presence. To observe practices fatal to the progress and development of our children, is to watch them walk aimlessly

in traffic.

The more significant the decisions are to the ability of the child to be safe and develop represents the busier the traffic is that you are metaphorically observing.

Research shows that parental involvement improves a child's chances of being successful academically, without regard

"When a mountebank came to town, he would put on an entertainment interspersed with sales pitches for whatever treatment or medicine he was selling. These men depended on their ability to read an audience and manipulate their hearers to their wills."

Entertainments might include dramatic sketches, magic acts, strongman exhibitions (which allowed the mountebank to extol the virtues of his product for producing strength and vigor), music and acrobatics.

tradition The European mountebanks

was already centuries old when it reached American shores during the colonial period, and it remained essentially unchanged for decades. But in the 1850s it began evolving into a more Americanized form, drawing on local entertainment traditions such as minstrel shows. At the time of the Civil War, most medicine men were independent, hawking their own elixirs and pills, but by the 1870s a traveling medicine show was increasingly likely to be working for a manufacturer of patent medicines or medical devices.

Most of the cures were worthless and some were downright dangerous, leading to states' attempts to regulate these shows as

early as the 1770s. But the shows remained popular up until the death of the patent medicine industry in the 1930s, not only because of medical ignorance but because they provided rarely-seen entertainment in small towns and rural areas. While the purpose of the show was to sell medication or medical devices, only about 10 percent of the show actually revolved around the direct sales pitch; the rest of the time was taken up by entertainment and "spieling," a form of storytelling which introduced the cure-all and laid out enticements to buy it while weaving a tale that appealed to the audience.

While no two traveling medicine shows were ever exactly alike, Joiner's thespians will be presenting what might be considered a "typical" show for the Civil War era. The presentation will open with a "day in the life" scene of a town hall meeting. This will set the stage for the medicine man's arrival with his bottles of "Chief KeCouey's Imitation Fresh Water Elixir" and the opening of his show.

Within the show, the audience will be treated to a tale of the North's evil attempts to kill the noble South during the war, interspersed with scenes from Shakespearean dramas the medicine man will use to illustrate the main themes of his story. The last such scene, the famous balcony scene from Romeo

a flirtation show, in which couples will demonstrate the 19th-century art of passing courtship messages via handkerchiefs, ribbons, parasols and flowers. Finally, the medicine man will give his sales pitch for the marvelous elixir, "straight from the Itchetucknee Springs."

Fortunately, those who decide to spend a dollar on the "medicine" will not be getting anything more dangerous than a drink of water (not, of course, from the Itchetucknee River or its springs). But whether the audience buys or not, they will be getting a taste of a bygone era and the history of American popular entertainment.




