I. Length of Authorization

- Coverage for myopic choroidal neovascularization (mCNV) will be provided for 3 months and may be renewed.
- Coverage for all other indications will be provided annually and may be renewed.

II. Dosing Limits

- A. Quantity Limit (max daily dose) [NDC unit]:
 - 0.3 mg vial/prefilled syringe for injection: 1 vial/syringe per eye every 28 days
 - 0.5 mg vial/prefilled syringe for injection: 1 vial/syringe per eye every 28 days
- B. Max Units (per dose and over time) [HCPCS Unit]:

Neovascular Age-related Macular Degeneration (AMD)/ Macular Edema following Retinal Vein Occlusion (RVO)/Myopic Choroidal Neovascularization (mCNV)

• 10 units every 28 days

Diabetic Macular Edema (DME)/Diabetic Retinopathy (DR) – (Lucentis and Cimerli Only)

• 6 units every 28 days

(Max units are based on administration to both eyes)

III. Initial Approval Criteria ¹⁻²¹

Coverage is provided in the following conditions:

Patients must have an inadequate response to an adequate trial of, or contraindication or intolerance to bevacizumab prior to initiating therapy with ranibizumab; **AND**.

• Patient is at least 18 years of age; AND

Universal Criteria

- Patient is free of ocular and/or peri-ocular infections; **AND**
- Therapy will not be used with other ophthalmic VEGF inhibitors (i.e., aflibercept, pegaptanib, brolucizumab, bevacizumab, ranibizumab via ocular implant*, etc.); **AND**
- Patient's best corrected visual acuity (BCVA) is measured at baseline and periodically during treatment; **AND**
- Patient has a definitive diagnosis of one of the following:

Neovascular (Wet) Age-Related Macular Degeneration (AMD) †

Diabetic Macular Edema (DME) (Lucentis and Cimerli Only) †

Diabetic Retinopathy (DR) (Lucentis and Cimerli Only) †

Macular Edema following Retinal Vein Occlusion (RVO) †

Myopic Choroidal Neovascularization (mCNV) †

*Note: Excludes use as 'supplemental-treatment' in conjunction with Susvimo for Neovascular (Wet) Age-Related Macular Degeneration (AMD), if clinically necessary

IV. Renewal Criteria ¹⁻²¹

Coverage can be renewed based upon the following criteria:

- Patient continues to meet the universal and indication-specific relevant criteria as identified in section III; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include the following: endophthalmitis and retinal detachments, increase in intraocular pressure, arterial thromboembolic events, etc.; **AND**
 - Patient has had a beneficial response to therapy (e.g., improvement in the baseline best corrected visual acuity (BCVA), etc.) and continued administration is necessary for the maintenance treatment of the condition; **OR**
 - <u>Myopic choroidal neovascularization ONLY</u>: Continued administration is necessary due to disease activity (i.e., drop in vision, visual symptoms (e.g., metamorphopsia), or the presence of intra-/sub- retinal fluid or active leakage)

| Diabetic macular edema and Diabetic retinopathy | Lucentis and Cimerli Only 0.3 mg intravitreally per affected eye once a month (approximately 28 days) |
|-------------------------------------------------|--------------------------------------------------------------------------------------------------------------------------------------------|
| AMD* and macular edema following RVO | 0.5 mg intravitreally per affected eye once a month (approximately 28 days) |
| Myopic Choroidal Neovascularization | 0.5 mg intravitreally per affected eye once a month (approximately 28 days) for up to 3 months. Patients may be retreated if needed. |

*Patients with AMD may be treated with 3 monthly doses followed by less frequent dosing (4-5 doses on average in the following 9 months) or one dose every 3 months after 4 monthly doses. Patients should be assessed regularly.


