Project Overview:

The Centers for Medicare & Medicaid Services (CMS) has contracted with Acumen, LLC to develop care episode and patient condition groups for use in cost measures to meet the requirements of the *Medicare Access and CHIP Reauthorization Act of 2015* (MACRA). The contract name is "MACRA Episode Groups and Cost Measures." The contract number is HHSM-500-2013-13002I, Task Order HHSM-500-T00002. As part of its measure development process, CMS asks contractors to convene groups of stakeholders and experts who contribute direction and thoughtful input to the measure developer during cost measure development and maintenance.

Previously, Acumen convened a Clinical Committee comprised of more than 70 clinical experts from over 50 professional societies that convened from August – September 2016. The Clinical Subcommittees convened currently represent the first of multiple waves of Subcommittees that will be convened for this project and focus on a set of procedural and acute inpatient medical episode groups relevant to a particular clinical area. The first wave of Clinical Subcommittees includes members for the following seven Clinical Subcommittees: Peripheral Vascular Disease Management, Musculoskeletal Disease Management – Non-Spine, Pulmonary Disease Management, Cardiovascular Disease Management, Neuropsychiatric Disease Management, Gastrointestinal Disease Management – Medical and Surgical, and Ophthalmologic Disease Management. Next waves of Clinical Subcommittees under this project will be convened in separate nomination periods.

Clinical Subcommittee members will build off of the work of the August – September 2016 Clinical Committee provide recommendations on (i) the episode triggers from the draft list of episode groups posted by CMS in December 2016 and (ii) what services should be included in episode costs.

Please note that the Clinical Subcommittees provide clinical expertise for the MACRA Episode-Based Cost Measure Project. Information regarding members' expertise in other subject areas outside of clinical content was not collected, but Clinical Subcommittee members may have experience in other areas.
