All data refer to global trade of fresh or dried major tropical fruits, as covered by HS codes 080430 (pineapple); 080440 (avocado); 080450 (mango, mangosteen and guava); and 080720 (papaya) under the harmonized tariff nomenclature system of the World Customs Organization. The raw trade data collected are subsequently processed and validated following a rules-based approach designed to exploit all information inherent in the underlying data to produce consistent, plausible and consolidated trade flows at the global level. A variety of imputation rules is applied in conjunction with expert judgement to eliminate apparent mistakes in reporting and processing of the raw data. Where inconsistencies remain present, these result from differences among officially reported data. Data on the import volumes by origin of the European Union and the United States of America are compiled from data provided by the European Commission and the US Department of Agriculture (USDA), respectively. Data are reported as collected and totals may differ from the processed and validated data reported in the 'World import by country' tables. Price data on the United States of America wholesale prices are calculated from data collected from the USDA Agricultural Marketing Service (AMS) terminal market reports. Data on the import volumes of the European Union exclude the United Kingdom since February 2020.

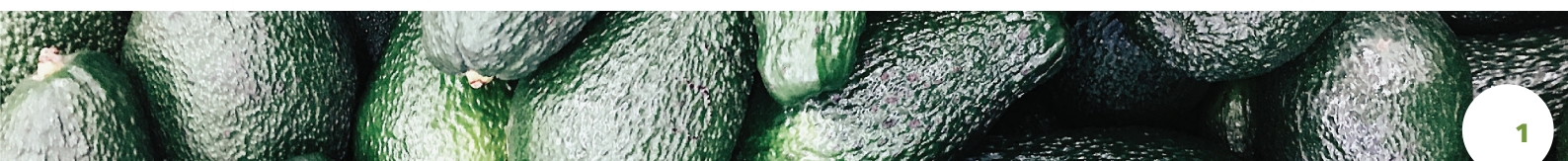

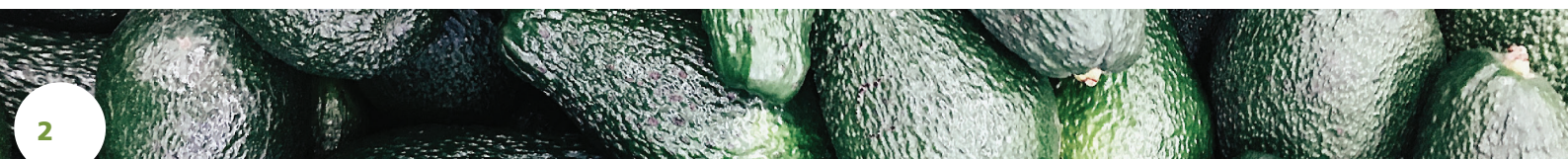

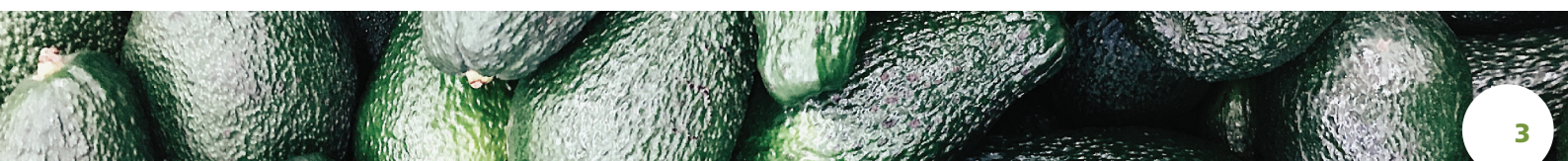

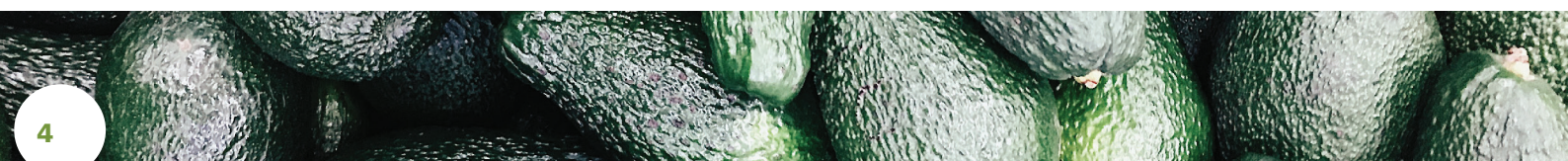

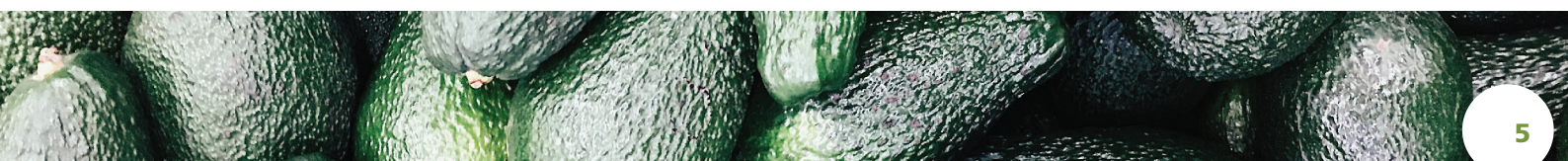

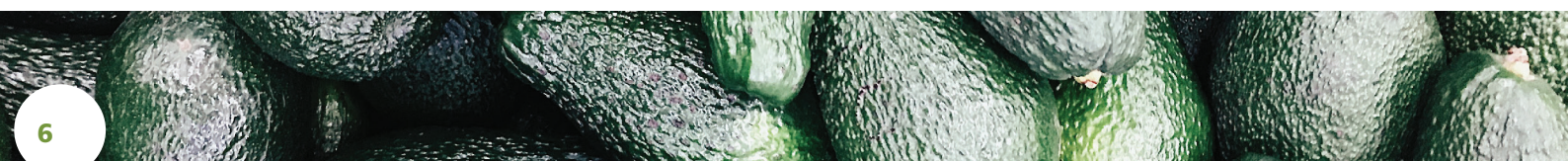

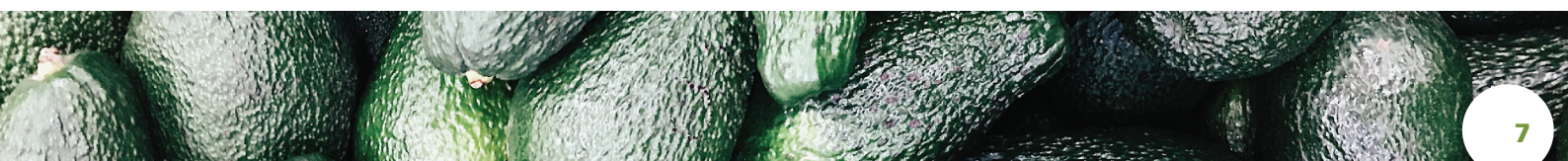
