2016 Citizen of the Year - Dr. Brenda Sanders Dede



She is the daughter of Reneva and Larry Sanders and was born and raised in Houston, Texas, the oldest of six children: three brothers (Rudolph, Ronnie and Ronald) and two sisters (Alma and Dyetta). She has one daughter, Angelique and one grandson, Mycal. She received her three degrees from Texas Southern University (Bachelor of Arts in sociology/social work; Master of Education in business education; and Doctor of Education in higher education administration), then went on to work at TSU for more than two decades, serving the last seven years there as associate director of the Office of Sponsored Programs before bringing her education and experience here to Clarion in 1995.

This recipient currently serves as associate vice president for Academic Affairs at Clarion University and serves as the university student advocate/ombudsman. She previously served as interim associate provost, associate Vice President for Academic and Student Affairs, assistant vice president for Academic Affairs, coordinator of Graduate Studies and director of Faculty Research Development at Clarion.

This honoree is a proposal reviewer for the US Department of Education and was a member of the National Faculty Policy Review Project sponsored by the American Association of State Colleges and Universities. She is a certified grants specialist and a certified grants reviewer.

She is a charter member of the American Association of Blacks in Higher Education and is a previous recipient of the Doctoral Student Award given by the American Association of Higher Education, the Black Caucus. She has served as a member of the American Association of Blacks in Higher Education Planning Committee, where she was chair of the Graduate Student Recognition Committee.

She is a member of the Pennsylvania Black Conference on Higher Education, where she has served as secretary and president. She received the Pennsylvania Black Conference on Higher Education 2002 Mary Davis Baltimore Award for Distinguished Service. Other memberships include the National Council of University Research Administrators, where she has been a member of the professional development committee; served as chair for the Pennsylvania Association of Graduate Deans, and is a member of the Northeast Association of Graduate Deans. She was also inducted into Texas Southern University's Hall of Fame in 2011.

She is actively involved in numerous committees and activities on the Clarion University campus. She is the founder and chairperson of the Martin Luther King Community Breakfast, the Juneteenth Program, and the Martin Luther King Celebration on campus.

This year's recipient is very active in the Clarion community, serving on the Borough Planning Commission, the Kiwanis Club, United Way, Big Brothers/Big Sisters, SAFE, Clarion County Community Choir, and the First Baptist Church, and also is a former member of the Clarion Area Chamber of Business & Industry Board of Directors. Currently, she is an elected member of the Clarion Borough Council, where she is in her second four-year term and is the vice president of the council.

For her amazing work and incredible achievements, as well as her continuing and endless contribution to the Clarion Area community, the Clarion Area Chamber of Business & Industry have chosen Dr. Brenda Sanders Dede as the 2016 Citizen of the Year.

2016 Lifetime Achievement Recipients - Bill & Judy Miller



Bill and Judy Miller came to Clarion in 1979, when Bill took the job as Head Swimming Coach at Clarion University. From 1979-2000, he coached the Golden Eagles' Men's swimming team for 22 seasons and the Women's swimming team for 13 seasons. During that time, the teams won 80% of their meets with 28 Pennsylvania State Athletic Conference Championships. Despite being named PSAC "Coach of the Year" 13 times and inducted into Clarion University Athletic Hall of Fame, there is more to this couple's story than Bill's coaching career.

In addition to raising their three sons in Clarion, Bill and Judy have been the mentor and the guiding force in countless lives. The Summer and Fall is a time when their house hosts a steady stream of visitors who have been impacted through their association with the Millers. Former students, athletes, community members, and people they've met through their business come back to say hello and check-in on this dynamic couple. Among them is a young man from a broken home who did not have the resources or the confidence to attend college. Bill and Judy paid for him to take one class per semester until he felt confident enough to apply for

full-time admission. He was even awarded a scholarship because of his academic performance while being a part-time student. This is one of many examples of quiet compassionate service to individuals and the community that characterize these two award winners.

Twenty-five years ago, while still working their "day jobs, they decided to open a Bed and Breakfast. They bought and refurbished the historic Ross House on Seventh Avenue, saving this architectural treasure from being cut-up into apartments. As innkeepers, they have welcomed people from all over the world to our town, many of whom return again and again for another dose of Clarion hospitality. The Clarion House is a favorite venue for small community events, club socials, and nonprofit fundraisers. Few if any of these groups ever pay for use of the house or gardens. While pursuing a successful career as a teacher with the Riverview Intermediate Unit in the Redbank Valley and DuBois schools, Judy took on the day-to-day operations of the Clarion House Bed and Breakfast, including landscaping the beautiful gardens, planning and cooking the breakfasts, and maintaining the comfort and décor of the house. Bill often says that he gets all the credit for the bed and breakfast, because he greets the guests and gives tours of the house, but that it is Judy who makes everything at their business a success.

In addition to their successful careers in teaching and coaching and their thriving business, our two award winners have given back to their community through hundreds of hours of service. Judy has served for many years as a member and officer of the Wildflower Garden Club, and as a member and officer of the local Nydill Chapter of the Embroiderers' Guild of America. Bill served for six years on the Clarion Borough Council, served on the Clarion Area Authority (Water and Sewer), and was the Chairman of the Clarion County Democratic Party for thirteen years. Both of these recipients were founders, board members, and officers of Choice Enterprises, a non-profit company that finds homes and employment for people with mental handicaps. This has since been merged with Passavant Homes of Pittsburgh. They were both members of Clarion County's Mental Health and Mental Retardation Board for twenty years, assuring services for our community's most vulnerable. In addition, Bill has served on the board of the Clarion University Credit Union and the Western Pennsylvania Bed and Breakfast Association.

Bill and Judy Miller have lived lives of service and dedication to our community and our neighbors. They have shown through their involvement in their profession, business and volunteerism that a purposeful life, one that is not dedicated to the accumulation of material rewards, but rather the joy of doing good is a rich life indeed.

It is with great honor that the Clarion Area Chamber of Business & Industry bestow the 2016 Lifetime Achievement award to Mr. and Mrs. Bill and Judy Miller.

2016 Volunteer of the Year - John McCall



Each year, the Clarion Area Chamber of Business & Industry awards a special token of appreciation to a special person in the community. Besides working as a full time salesman for Deets Mechanical in Seneca, he also operates his own business as the Duct Cleaning Specialist. He and his wife Jennifer also recently started a new endeavor when they opened McCall's Rustique on Route 66, south of Interstate 80 in the area where he grew up.

This recipient volunteers every year with many aspects of the Autumn Leaf Festival and is always willing to lend a hand when needed. He has been involved in the car show since 1979 and has been the chair of that committee for over ten years. He also helps with the Tractor Show as

well as the Clarion Industries Farmers and Crafters Day. For several years he has volunteered to haul the borrowed golf carts from Clarion Oaks Golf Club to the Chamber for use during the Autumn Leaf Festival. He even served as Co-Chair of the festival in 2014 and ALF™ Chair in 2015.

Our award winner's volunteerism doesn't end with the Chamber or the festival, however. He has been incredibly active with the Limestone Fire Department, where he has also served as a past President. He is also the trustee at New Rehoboth Greenville Presbyterian Church.

He married his wife Jennifer in June of 2011. He has a daughter, Katelyn, two stepdaughters, Megan and Alicia, and three grandchildren, Finnley, Zaiden and Mackston.

Our choice for this year's award came with no hesitation. He has volunteered so tirelessly and for so long that there was no other candidate that could possibly fit it better. That's why the 2016 Douglas L. Sharrar Volunteer of the Year is Mr. John McCall.

2016 Business of the Year in Economic Development - WRC’S Highland Oaks at Water Run

WRC Senior Services opened their very first Highland Oaks facility on June 6, 1988 in Shipperville as a 38 bed personal care home, purchasing the two story building from Riverview Intermediate Unit 6. At the time, it was one of the largest personal care homes in Clarion and Venango counties.

In 1996, WRC built an addition onto the original building to add accommodations for 24 more residents and an activity room. Air conditioning and an elevator were also added at that time.

In 2008, the organization began discussing Highland Oaks’ future. The building was aging, and some of the suites were very small. In order to try to meet the changing needs of consumers, the accommodations had been renovated and arranged to then accommodate 39 residents.



In 2010, WRC began exploring the feasibility of renovating Highland Oaks versus building an entirely new facility. Then in 2011, they purchased 20 acres of land just off Route 68 in Clarion, and in 2012 officially announced plans to build a new campus in Clarion on Water Run Road.

In May 2015, WRC broke ground for the new campus, dubbed Water Run Landing. This began a 15 month construction project that employed many local contractors such as your fellow Chamber Member, Luton’s Plumbing, Heating and Air Conditioning.

In June 2016, they held an official ribbon-cutting ceremony for the newly opened Highland Oaks at Water Run and in July 2016 broke ground for the Villas at Water Run, and independent living neighborhood on the campus. On August 5, 2016, residents officially moved from the old Highland Oaks to the new. In subsequent weeks, several people from the community who had been on the waiting list also moved in. The capacity of Highland Oaks rose from 39 accommodations to 60 with the opening of the new building. As a result, Highland Oaks’ workforce has doubled, offering more job opportunities in healthcare administration, resident care, dining services, housekeeping and laundry, activities and maintenance and custodial care.

In December, residents began moving into the Villas at Water Run. Six homes have been built with the capacity of 30 at the site. Additional homes will be constructed in phases as they are purchased. As more homes are built, additional job opportunities will be created. WRC will soon be opening The Bistro at Water Run to the public. The Bistro will be a small café which will also offer catering. It is a licensed trademark operator of Genuine Broaster Chicken. As the Bistro operations grow, additional staff will need to be hired.

An organization that continues to grow and expand, over almost 3 decades, offering an increasing job market and an ever improving quality of life for the citizens of the Clarion Area community cannot be overlooked. This is why Clarion Area Chamber of Business & Industry has chosen Highland Oaks at Water Run as this year’s Business of the Year – Economic Development Award recipient.
