


COMMERCIAL & INDUSTRIAL

Market Commentary

All but one of our publicly traded indices were up this month. Most prominently, Industrial Equipment saw the largest one-month growth (up 11.7%), followed by Flow Control (up 8.8%), Commercial Durables (up 7.9%), and Industrial Distribution (up 7.0%). Indices with more industrial manufacturing and non-construction distribution exposure (Flow Control, Industrial Distribution, Industrial Equipment) have shown an expansion in enterprise value/EBITDA multiples since last month. While the ISM – Purchasing Managers' Index ("PMI") fell to its lowest level in the past year, ISM-New Orders bounced back with a 2.8 percentage point increase from September. Both indicators have readings above 50, which is evidence of continuing market expansion. The PMI showed expansion in the manufacturing sector for the 34th consecutive month, while the ISM-New Orders indicated growth for the 35th consecutive month. M&A activity remains strong, and the Commercial & Industrial Group recently closed the sale of Colony Hardware Corporation, a portfolio company of AEA Investors, to Tailwind Capital.



EBITDA Valuation Multiples¹




Historical Enterprise Value/EBITDA Multiples

















ISM – PURCHASING MANAGERS' INDEX (PMI)¹






INDUSTRIAL PRODUCTION⁵













ARCHITECTURAL BILLINGS INDEX⁶
