## Domain: RATIOS \& PROPORTIONAL RELATIONSHIPS

Cluster 1: Analyze proportional relationships and use them to solve real-world and mathematical problems. (Major Cluster)

For example, if total cost $t$ is proportional to the number $n$ of items purchased at a constant price $p$, the relationship between the total cost and the number of items can be expressed as $t=p n$. <br> d. Interpret products of rational numbers by describing real-world contexts. <br> b. Understand that integers can be divided, provided that the divisor is not zero, and every quotient of integers (with non-zero divisor) is a rational number. If $p$ and $q$ are integers, then $-(p / q)=(-p) / q=p /(-q)$. Interpret quotients of rational numbers by describing real-world contexts. <br> c. Apply properties of operations as strategies to multiply and divide rational numbers. <br> d. Convert a rational number to a decimal using long division; know that the decimal form of a rational number terminates in Os or eventually repeats. |
