 Screening tool for initial symptoms. Age range: 11-18 years.

 Distinguishes between anxiety symptoms and dimensions that broader measures do not cover. Age range: 8-19 years.

 Assesses defined anxiety and depression. Age range: 8-18 years.

 Assesses symptoms, cognitions and behaviors to measure social anxiety. Age range: 14+ years.

 Assesses symptoms of a manic episode. Age range: 5-17 years.

 Discriminates between behaviors in the average range and those that are risk signs for anorexia, bulimia and obesity. Age range 8-18 years.

 Assesses inward and outward expressions of anger. Age range: 10-17 years.
