

With the NFL (National Football League) celebrating its 100th anniversary during the recently completed 2019 season, and with the playoffs starting Saturday, January 4, 2020, I thought it would be an appropriate time to share my impressions of my visit to the Pro Football Hall of Fame (HOF) in Canton, OH this past October.

I was in Buckeye country with my wife, Clarene (who was born in Ohio) to help sell copies of her self-published book, "Shine Online with LinkedIn" at an African American book fair in nearby Akron.

I'm sure you've heard of it (my wife's book)! If you'd like a copy, visit Clarene's LinkedIn page to find out more about it and where you can order a copy. I guarantee, you will find the book an engaging and informative read you will refer to over and over when

Okay, back to my HOF visit! As a way to say "thank you" for coming with her to Akron (we drove) and helping her at the book fair, she encouraged me to visit the "Cradle of Professional Football" in the city where the NFL was born.

All I can say about the Pro Football Hall of Fame is "WOW!" The place lives up to the hype it so richly deserves! I would definitely go back multiple times! It's that good! The HOF is first and foremost a museum with quality exhibits that totally immerse you in the game. The HOF motto is: "Honor the Heroes of the Game, Preserve its History, Promote its Values, Celebrate Excellence Everywhere."

This is especially true of the Hall's primary exhibit, "The NFL's First Century." A two-story, circular exhibition hall contains the history of the pro game from its birth and infancy, to its maturity today, its impact on American culture; with references



(continued from page 2) to significant moments in American and world history that impacted and influenced the League, not to mention the NFL's impact on the culture.

The exhibit does a great job of focusing on the Black experience in pro football, 1920 Akron Pros championship team, the NFL's first!

During the League's first 14 seasons, there were only 13 African American players who trodded the pro "gridiron" (as football fields were called back in the day because they were marked with regularly spaced parallel lines).

Pollard was also the FIRST African American to play quarterback in the NFL. He played for --and sometimes coached--four different teams during his NFL career.

Pollard's career (and the careers of other Black football pioneers of that era such as Joe Lillard of the Chicago Cardinals, and Ray Kemp of the Pittsburgh Pirates--now Steelers) was cut short. All three were the last Black players to play in the NFL before the enactment of pro football's 12year "color barrier."

That odious barrier was "championed" by William Preston Marshall, a son of the South (West Virginia), and the owner of the Washington Redskins.

Among his many "contributions" to pro football--the rules of the pro game, two division format and a championship game to name a few--Marshall persuaded the fledgling league to ban Black players from playing pro football.

Marshall "was identified as the leading racist in the NFL," according to professor Charles Ross in his 1999 book, "Outside the Lines: African Americans and the Integration of the National Football League."

Aside from his own racist views, Marshall reportedly refused to sign African American players because of his desire to appeal to the Southern markets. Until the Dallas Cowboys entered the league in 1960, the Redskins were the southernmost team in the NFL. Marshall's wife at the time, silent film actress Corinne Griffith Marshall (no relation to D.W. Griffith. the director of "Birth of a Nation"--according to Wikipedia) wrote the lyrics to the team fight song, "Hail to the Redskins." At one time, the song contained the lyrics "fight for old Dixie." Fortunately, someone in--most likely outside--the organization

"suggested" they change that line (among a few others) to: "fight for old D.C." That wise move spared Marshall and the football franchise embarrassment. The team's very name has long been considered politically incorrect and an insult to America's indigenous people.

Oh, did I forget to mention the Redskins didn't draft or trade for Black players until the early 1960s? No?...Well, I just did! In 1962, Marshall was told by the U.S. Department of Interior and the then U.S. Attorney General Robert F. Kennedy to sign a Black player or have his 30-year lease to play in D.C. Stadium (now Robert F. Kennedy Memorial Stadium), which was paid for with government money and owned by Washington city government, revoked.

Marshall relented (finally) and was planning to draft running back Ernie Davis of Syracuse, who was--ironically--the first African American to win the Heisman Trophy (in 1961). But Davis balked at being drafted by the Redskins and demanded a trade, saying: "I won't play for that S.O.B."

Davis got his wish and was traded to the Cleveland Browns for All-Pro Bobby Mitchell, who became the first Black Redskins player. A star running back and later wide receiver, Mitchell (no relation to this story's author--I think) was inducted into the HOF in 1983.

Here's some historic irony for you: Quarterback Doug Williams was the first Black quarterback to start and win a Super Bowl (he was also the game's Most Valuable Player)! He accomplished this historic feat as a member of (drum roll please)...The Washington **Redskins! Now THAT's** karma folks! The "color barrier" started to come down, brick by brick, in 1946 when the NFL's Los Angeles Rams and the AAFC's Cleveland Browns each signed two Black players: former UCLA stars Kenny Washington and Woody Strode (Rams), and Marion Motley and middle guard Bill Willis (Browns).

starting with the legendary Fritz Pollard (also an HOF enshrinee), who was not only one of the first early Black players in the NFL's infant years (he and Bobby Marshall, who played for the Rock Island Independents were the initial pioneers), but Fritz was also the FIRST African American coach in the league when he became a player-coach with the Akron Pros in 1921.

(Note: Former player and head coach Art Shell of the Oakland Raiders is considered the FIRST Black head coach in the Modern Era, a period from 1946 to today.) Pollard was also part of the

In the 1960s, the emergence of the American Football League (AFL), with its wide-open style of offensive football, contributed greatly to the advancement of Black players.

Hungry for new players, the AFL began to recruit from historical Black colleges and universities and signed many Black players that were either overlooked in the draft or uninvited to tryout for teams in the established NFL.

By the 1970s, Black players comprised over 30 percent of the NFL's labor force. Progress continued through the 1980's and 90's and by 2002, 70 percent of the NFL's players were African American.

There were a number of factors for their meteoric rise: the growth of the League, successes in the civil rights movement, and external pressure from government, community and grass roots organizations.

The 100th anniversary exhibit was not only a treasure trove of football history, it was also a valuable trove of Black history, period! There are a number of non-NFL historical facts on display in the exhibit that parallel the rise of Blackness in the League.

And, believe it or not, the HOF has a section devoted entirely to Black college football and the NFL stars who played for HBCU's such as former Green Bay Packers great (and HOF enshrinee) Willie Davis, who played for another Black football legend at Grambling State University, Coach Eddie Robinson.

If you're Black, a football fan, and love the NFL and Black history, I recommend visiting "The Hall" (espe-
