PET/218/16 Tree Warden Scheme

The Committee RESOLVED to appoint Mr M Smith as a Tree Warden for North Horsham Parish Council. The role will be to report back to the Council on trees in the Parish within the time that Mr Smith has available and to work with the Parish Council to better understand what trees there are within the Parish. A Tree Warden may be called upon to look at trees for specific planning applications. It was understood that anything other than a visual inspection of the tree would need authorisation by the Council. The Parish Council's insurance company would be notified of the voluntary role for public liability insurance purposes.

PET/219/16 List of culturally significant, historical and heritage areas in North Horsham Parish.

The Parish Council had received information from the curator at Horsham Museum and Horsham District Archaeology Group offering considerations, support and assistance in drawing up a list of culturally significant, historical and heritage areas in North Horsham Parish. HDC and Horsham Society are currently updating The Horsham Town Local List which catalogues locally important historic buildings and which contains source material for this project. The Committee expressed appreciation for the assistance from the wider community.

It was RESOLVED to produce a reference document in the form of a list of culturally significant, historical and heritage areas in North Horsham Parish using the sources identified and including any suggestions from Parish Councillors.

PET/220/16 Consultation

HDC Community Infrastructure Levy (CIL) - Draft Charging Schedule for Independent Examination and Statement of Modifications Consultation.

The CIL Draft Charging Schedule and supporting information was submitted to the Secretary of State for Communities and Local Government for Examination on 18th November 2016. There were minor changes except for the inclusion of the strategic development at Kilnwood Vale in the Zone 2 designation where there is a zero CIL rate charge. This change would not affect the charge rate or the amount of CIL collected.

It was RESOLVED that the Committee would not comment on the 'CIL - Draft Charging Schedule' consultation originated by HDC.
