April 10th placed **1st in Advance B Rally**

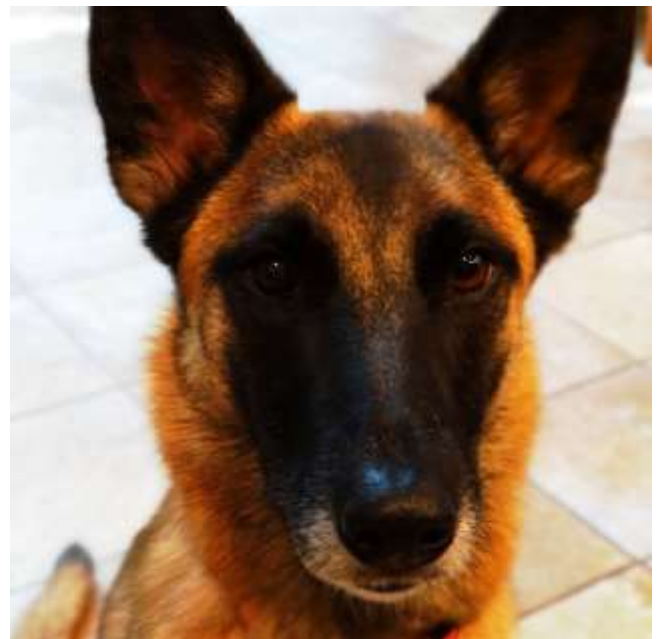
Tried her in Open A Obedience for the first time & she did well except went down on the long sit. This show was held outside & it was the 1st time we ran outside since last year!

The Orthopedic Foundation for Animals, along with the American Belgian Tervuren Club, is pleased to present the 2014 Champion of Health award to "Quila", Ch. LaBarge's Strate T'Quila Nite CDX, RE, MX, AXJ, NAP, NJP, HSA, owned by JoAnna Rizzo and Shirley LaBarge.

The OFA Champion of Health is an annual award given through the breed's parent club to a dog that has achieved significant accomplishments in the ring, in the field, as a producer, or as a working dog, AND that has the appropriate complement of health certifications.

Quila has achieved success in multiple venues including the conformation ring, obedience, rally, agility, and herding. She has also been an outstanding producer. Offspring from her single litter have achieved conformation championships, MACHs, over 75 combined obedience, agility, and herding titles, and one has gone on to become a Dual Champion. On the health front, Quila has hip, elbow, eye, and thyroid clearances, and 2 of her titled offspring are CHIC dogs.

Quila is a wonderful choice for this honor, and we are pleased to honor her with this engraved silver medallion. In addition, the OFA will make a \$100 donation to the ABTC's Donor Advised Fund at the AKC Canine Health Foundation in her name.

Revised Awards Policy

Background: A request for relief from the "3 meeting attendance" requirement to earn an award paid for by the club was made.

Proposed Policy: Either **one of the following 2 requirements must be met.**

- A. Members must **attend 1 meeting** per year & **make a significant contribution to the club.**

B. Members must attend 3 meetings

Member must work at 3 club events (e.g. help with classes, seminar, set or give a program, help plan or work at a fun match, trial, mall demo, etc)

Additionally, each applicant must notify the awards chairman of accomplishments in writing by the date set by the Board & published by the Club in its newsletter. Proof of titles, dates & locations of club events at which qualifying scores were received, & of club events where the applicant worked, shall be provided to the awards chairman. A record of attendance at meetings shall be provided by the club secretary.
