We rely on our volunteer mediators, their knowledge, occupational expertise, and commitment to utilizing their mediation skills to foster self-determination, respect and empowerment. Our volunteers donate their time which allows individuals, our communities, and businesses to access professional services they couldn't otherwise afford at commercial mediation and consulting rates.

This year our volunteer pool expanded to 54 volunteers, with the great majority being licensed attorneys. They collectively donated 800+ hours of service during Fiscal Year 2018.



20 Years Of Service

Midlands Mediation Center celebrates 20 years of service. Thanks to the Community Mediation Center's originating steering committee that adopted a mission statement and established the organization's goals, that have endured.

Mission: to create a safe environment for all community members to learn to resolve conflicts, improve relationships, and strengthen communities through mediation services and educational programs.

Goals:

- 1. Offer the citizens of Richland County quality community mediation services by trained volunteers that focus on preserving and/or strengthening interpersonal relationships.
- 2. Provide educational presentations and training workshops in the area of conflict resolution and peacemaking to citizens and organizations in Richland County.
- 3. Develop a diverse cadre of skilled citizens who can serve as role models and mentors for constructive approaches to conflict.

We have expanded our service area and diversified our caseload, as reflected in our name change from Community Mediation Center to Midlands Mediation Center, that occurred in February 2013. While our current primary service area is Richland and Lexington counties, in 2018 we also provided mediation services to people whose family court cases originated in 13 other South Carolina counties.

We, unlike most community mediation centers today provide a hybrid of services including mediating community-based cases and those that are referred by the courts. Our referral network continues to expand and includes government, businesses, consumer organizations, neighborhood and civic groups, human service organizations and churches.



20 Years Of Service

Over the years, we are grateful to have earned the financial support of a variety of funders; and to have partnered and collaborated with a wide variety of organizations.


Through the years, our contributions have included:

- Mediating through local school districts to uncover and address the root causes of students' chronic truancy.
- Training, presentations and facilitations for community organizations, work conferences, youth programs, state government agencies and private employers.
- During the last 11 years our mediators have been helping reduce the need for jury trials in Magistrate Courts in Richland and Lexington Counties by working through issues between landlords and tenants, consumers and small businesses, and auto accident claims, etc.
- Serving families with modest means who are ordered to mediation in Family Court matters such as separation and divorce, and increasingly involving grandparents and other family members caring for young children.
