AUTHORIZING THE USE AND ISSUANCE OF PROCUREMENT CARDS (P-CARDS) IN ACCORDANCE WITH N.J.A.C.5:30-9A and N.J.S.A. 40A:5:5-16

WHEREAS, the Township of Delran will issue Procurement Cards to the Business Administrator Jeffrey Hatcher; Public Works Superintendent Bryan Mullen; Interim Police Chief James Mitchell; Municipal Clerk Jamey Eggers; and CFO Kareemah Press; and

WHEREAS, the Procurement Card will be used by the Township of Delran and the Finance Office, upon receiving a signed requisition from the Department Head will encumber the estimated total cost of the requisition, not to exceed \$5,000. Upon receiving the designated employee's signature the procurement card will be issued for use by the Finance Officer or Designee; and

WHEREAS, the receipts of goods will be returned to the Finance Officer or Designee to be compared to the requisition, the encumbrance will be adjusted and the procurement card will be signed back to the Finance Office, and

WHEREAS, any purchase over \$5,000 but under the quote threshold will need to be approved by the Department Head and the individual authorized by the Governing Body to do purchases; and

NOW THEREFORE BE IT RESOLVED that the Governing Body of the Township of Delran, County of Burlington, State of New Jersey has approved the use of theses procurement cards for the Year 2015 with the above stipulations and in accordance with N.J.A.C.5:30-9A and N.J.S.A. 40A:5:5-16
