Act 1 (p. 169 – 189)

1)	In the opening stage directions of the play, Arthur Miller writes that Tituba "is very frightened because her slave sense has warned her that, as always, trouble in this house eventually lands on her back." The term "slave sense" most likely refers to what? (p. 169)
2)	When Abigail enters, she is described as "a strikingly beautiful girlwith an endless capacity for dissembling." What does the phrase an "endless capacity for dissembling" suggest? (p. 169)
3)	When Susanna tells Abigail and Parris that the doctor who examined Betty couldn't find a natural cause for her illness in his books, why do both Abigail and Parris warn Susanna to "go directly home and speak nothing of unnatural causes?" (p.170)
4)	Why did the girls dance in the woods instead of in Salem?
5)	Parris says to Abigail: "It must come out – my enemies will bring it out. Let me know what you done there. Abigail, do you understand that I have many enemies." What does this tell us about Parris? (p. 170)
6)	What does Parris mean when he asks Abigail if her name is "not entirely white"? (p. 171)
7)	When Parris asks Abigail if there is another reason why she was dismissed as the Proctor servant, how did Abigail respond? (p. 171)

8)	Abigail claims that the Proctors "want slaves, not such as I. Let them send to Barbados for that. I will not black my face for any of them." What does this tell us about Abigail? (p. 171)
9)	We find out that the Putnams and Parris have something in common; what is it? (p. 172)
10)	What could be some of the motivations for Putnam wanting Parris to announce that there is witchcraft in the town? (p. 172 – 173).
11)	Why did Mrs. Putnam send her daughter Ruth to contact Tituba? (p. 173)
12)	In anger, Parris shouts to Abigail: "What proper payment for my charity!" Why do you think Parris feels that Abigail is indebted to him? (p. 173)
13)	The girls have a conversation about other events that took place the night before. A) What did Abigail do in the forest that she wants to hide from her uncle and others? (p. 175)
	B) What threat does Abigail make to the other girls if they tell what Abigail did? (p. 175)

18) What is the rumor going around about Betty that the Putnams mentioned earlier and now Giles

Corey mentions? (p. 178)

19) Rebecca Nurse quiets Betty, and Parris asks Rebecca what she makes of the situation (p. 178 – 179)
A) What does Rebecca Nurse seem to think is going on with these "sick" girls?
B) Why does Rebecca Nurse believe this?
C) What does Rebecca advise?
D) Considering your answers to the above questions, what do you believe to be the function of Rebecca Nurse in the play?
20) Why does Rebecca Nurse tell Parris: "I think you'd best send Reverend Hale back as soon as he come"? (p. 180)
21) What seems to be the source of tension between the Putnams and Rebecca Nurse? (p. 180)
22) Why does John Proctor dislike Reverend Parris? (p. 180)

23) Parris lists various frustrations that he has. What are they? (p. 180 – 181).
24) Why do you think that Parris so concerned with obtaining the deed to his home? (p. 181)
25) What animosities between Proctor and Putnam are revealed in this scene? (p. 181 – 182)
26) There are several arguments and resentments between the citizens of Salem that are seen at this point. Why would the author break away from the discussion of witchcraft to show the resentments between the different citizens?
27) Reverend Hale's past experience with the supernatural (when a woman in his community was accused of being bewitched but then recovered after a few days rest) "never raised a doubt in his mind as to the reality of the underworld or the existence of Lucifer" (182). What impact do you think this will have on how he proceeds during the play?
28) What does Hale warn the others of? (Hint: He says he will leave Salem if this happens). (p. 185)
