


NAIA Conduct in Competition Suspension Rubric

In the NAIA, any ejection in any sport carries a mandatory suspension of at least one game (see NAIA Bylaws Article VI, Section B, Item 7). In addition, the specific sport itself may also carry a suspension, as determined by rules of competition for that sport. If both an NAIA and sports rule suspension apply, the two suspensions run concurrently. For every type of ejection found in the rulebook for each championship sport, this rubric details which suspension – NAIA or sports rule – applies, and what options for recourse exist. Please contact the NAIA Officiating or Legislative Services departments with any questions.



- = NAIA rule applies. The NAIA suspension appeal process is available, **except as noted.**
- = NAIA and sports rule are equivalent. Appeals only available through sport specific processes.
- = Sports rule applies. Appeals only available through sport specific processes.

Protests refer to sport-specific competition rules and the applicable protest procedure (if allowed by the particular sport). To protest an incident, the basis of the protest must align with the requirements as dictated by the sports rule, and the follow the prescribed sports procedure for lodging the protest. When sports rule dictates the basis of the protest must be "misapplication of the rule," a judgment call by the official is not a protestable misapplication.

<u>Soccer sports rule</u>: 12.8.2 A player or other bench personnel serving a game suspension(s) may be in the team area, provided he/she is not in uniform.

- 12.8.2.1 A player serving a game suspension(s) may not participate in any pregame activities.
- 12.8.3 A coach serving a game suspension(s) shall not be in the venue from one hour before the scheduled start of the game until 30 minutes after the completion of the contest. During the suspension, the coach must be out of sight and sound and is prohibited from any communication or contact, direct or indirect, with the team, coaches and/or bench personnel until the completion of the contest, including all overtime periods.
- 12.8.3.1 A coach serving a game suspension(s) may participate in any pregame activities up until one hour before the scheduled start time.

Vollevball sports rule:

- <u>6.1.2.3.1</u>: Disqualified team members must leave the playing and spectator areas for the remainder of the current match and are restricted from participation in the subsequent match.
- <u>6.1.2.3.2:</u> Disqualified team members are permitted up to one minute to pick up belongings from the bench area provided they refrain from further misconduct. If the team member has not departed the team and spectator areas within one minute, the playing captain is warned that further delay will result in a default of the set. If the team member has not departed within 15 seconds after this warning, the set is defaulted.
- <u>6.1.2.3.3:</u> In the subsequent match, disqualified players are restricted from any participation, including the timed warm-up activities. <u>6.1.2.3.4:</u> In the subsequent match, disqualified coaches are restricted from any participation after the referees arrive at the court and begin administration of the match.

Football sports rule — 2.27.12: a. A disqualified player is one who is declared ineligible for further participation in the game. b. A disqualified player must leave the playing enclosure under the escort of team personnel before the next play after his disqualification. He must remain out of view of the field of play under team supervision for the duration of the game. c. A player serving a first-half suspension due to his disqualification in the team's previous game may participate in pre-game warm-up activities. During the first half, he must remain out of view of the field of play under team supervision. Football Exception 8/18/17 - Player(s) suspended under (Rules 9-1-3 and 4)- targeting-.may be restricted to the sidelines if the suspension is to be served while the team is on the road and no other suitable supervisory options are available. In this case, while the suspended player(s) may still take part in warm-ups pre-game, the suspended player(s) helmet must remain under the control of the athletic trainer during the first half while serving a suspension.

<u>NAIA NAC Policy Article IV – Conduct in Competition:</u> A player or coach serving a game suspension shall be restricted to the designated spectator areas and prohibited from any communication or contact, direct or indirect, with the team, coaches, bench personnel and/or game officials from the start of game to its completion, including any overtime periods. While the suspended coach or player is allowed on the field and in the bench area during pregame activities, the suspended player may not be dressed in their game uniform, and they may not take part in any warm-up activities.

<u>Basketball sports rule</u>: In addition to being disqualified, an individual who is ejected shall leave the playing court and floor area and report to her team's locker room until the game is over.

<u>NAIA NAC Policy Article IV – Conduct in Competition:</u> A player or coach serving a game suspension shall be restricted to the designated spectator areas and prohibited from any communication or contact, direct or indirect, with the team, coaches, bench personnel and/or game officials from the start of game to its completion, including any overtime periods. While the suspended coach or player is allowed on the field and in the bench area during pregame activities, the suspended player may not be dressed in their game uniform, and they may not take part in any warm-up activities.

* 1 game suspension is required by sports rule (not appealable through NAIA process); additional 1 game suspension is only required by NAIA bylaw and therefore is appealable through NAIA process.

<u>Baseball sports rule</u>: A suspended person must follow the same penalties as those in an ejection (e.g., removed from sight and sound of the contest). Additionally, a suspended person cannot: a. Be dressed in game uniform; b. Communicate with any team personnel or umpires; c. Take part in any pregame activities at the site of competition; and d. Be in the stadium or on the field once pregame activities have started. Procedures for enforcing penalties are as follows: (1) After an ejection and suspension, the offending individual must leave the field and dugout area immediately and is not allowed to communicate with team members or the umpires. (2) Suspended personnel shall not be in uniform, allowed in any team area or perform any team duty while serving their suspensions. (3) It is the responsibility of the institution's head coach and director of athletics to administer and enforce the suspension penalty. If a suspended player or coach is found to have participated in a game during the prescribed suspension, the game will be forfeited by the offending team.

<u>Softball sports rule</u>: An ejected player may remain in the dugout but shall not remain on the playing field or communicate with opponents or umpires. Ejected nonplaying personnel must leave the playing field, dugout and other team areas and be out of sight and sound. Out of sight and sound means unable to view the remainder of the contest and the umpires cannot hear any additional comments. In either case, they shall not communicate (visually, electronically or verbally) further with the teams or umpires.

Note: Suspended student-athletes shall not be in uniform, shall not be allowed in any team area from the time umpires enter the field until after they leave the field, and shall not perform any team duty while serving a suspension. Suspended coaches and other non-playing personnel shall not communicate with any umpire or be in the playing facility once pregame activities have started until the umpires leave the field of play at the conclusion of the game(s). **Exception:** Players suspended under Rule 13 may be restricted to the dugout if the suspension is to be served while the team is on the road and no other suitable supervisory options are available. **EFFECT**—If an ejected or suspended student-athlete, coach or other nonplaying personnel violates the conditions of the ejection/suspension and it is discovered during the contest, the game will be forfeited (see Rule 6.20.1.9). If an ejected or suspended student-athlete or other nonplaying personnel violates the conditions of the ejection/suspension and itis discovered once the contest has ended, the suspension (1) for the student-athlete/nonplaying personnel is two games and (2) for the head coach is four games.
