The papers of Lillian D. Wald, 1867-1940, concern both the administration of the Henry Street Settlement and her involvement in numerous philanthropic and liberal causes. Her office files trace the foundation and growth of the Henry Street Settlement from 1895 until 1933. Miss Wald retired from active directorship in 1932. Her other activities include Child welfare, civil liberties, immigration, public health, unemployment, and the peace movement during World War I.

The correspondence files contain letters from public figures and writers, among them Jane Addams, Roger N. Baldwin, Van Wyck Brooks, Levinia L. Dock, John Galsworthy, Samuel Compers, William D. Howells, Charles Evans Hughes, Mabel Hyde Kittredge, Frances Perkins, Dorothy Thompson, Norman Thomas, Ida Tarbell, Margaret Sanger, and Jacob Riis.
