1. INTRODUCTION

- i) The FMGE-Screening Test has been introduced by the Screening Test Regulations 2002. As per the regulations, "An Indian citizen possessing a primary medical qualification awarded by any medical institution outside India who is desirous of getting provisional or permanent registration with the Medical Council of India or any State Medical Council on or after 15.03.2002 shall have to qualify a screening test conducted by the prescribed authority for that purpose as per the provisions of section 13 of the Act."
- ii) The Examination is held twice a year at New Delhi.
- iii) The test is conducted in English language.
- iv) The exam consists of one paper.
- v) There will be 300 multiple-choice questions (MCQ) of single response type in the paper.
- vi) There is NO negative marking.
- vii) An applicant shall be declared as having passed only if he/she obtains a minimum of 50% of marks in the examination.
- viii) Results (Pass/Fail) for eligible candidates will be displayed at the website and office of NBE. Marks obtained shall be declared for all the candidates and also displayed as the website <u>www.natboard.edu.in.</u>
- ix) The applicants who qualify the Screening Test may apply to the Medical Council of India, New Delhi or to any State Medical Council for provisional registration / permanent registration.
- There are no restrictions on number of attempts that can be availed by an applicant.

1. परिचय

- एफएमजीई प्रारंभिक परीक्षा नियमावली 2002 द्वारा आरंभ की गई है। दिशानिर्देशों के अनुसार "भारत के बाहर किसी भी चिकित्सा संस्थान द्वारा प्रदत्त प्राथमिक चिकित्सा की योग्यता रखने वाला भारतीय नागरिक जो भारतीय चिकित्सा परिषद् अथवा किसी भी राज्य की चिकित्सा परिषद में 15.3.2002 या उसके बाद अपना अस्थाई अथवा स्थायी पंजीकरण कराने की इच्छा रखता है तब उसे अधिनियम की धारा 13 के अधीन इस उद्देश्य हेतु निर्धारित प्राधिकारी द्वारा आयोजित एक प्रारंभिक परीक्षा उत्तीर्ण करनी होगी।
- यह परीक्षा दिल्ली में साल में दो बार आयोजित की जाती है।
- 3. यह परीक्षा अंग्रेजी में ली जाती है।
- इस परीक्षा में केवल एक पेपर होता है।
- 5. इस परीक्षा में एक उत्तर वाले 300 बहु–वैकल्पिक प्रश्न (एमसीक्यू) होते हैं।
- इस परीक्षा में नकारात्मक मूल्यांकन नहीं किया जाता है।
- किसी आवेदक को उसी दशा में उत्तीर्ण घोषित किया जाता है जब वह परीक्षा में कम से कम 50 प्रतिशत अंक प्राप्त करता है।
- 8. <u>उत्तीर्ण / अनुत्तीर्ण</u> पात्र आवदेकों का परीक्षाफल एनबीई की वेबसाइट और उसके कार्यालय में प्रकाशित किया जाता है। सभी उम्मीदवारों द्वारा प्राप्त अंको को घोषित किया जाएगा और वेबसाइट <u>www.natboard.edu.in</u> में प्रदर्शित किया जाएगा।
- 9. जो आवेदक प्रारंभिंक परीक्षा में उत्तीर्ण होते हैं वे भारतीय चिकित्सा परिषद, नई दिल्ली अथवा किसी भी राज्य की चिकित्सा परिषद में अस्थाई / स्थायी पंजीकरण के लिए आवेदन कर सकते हैं।
- कोई भी आवेदक इस परीक्षा में जितनी बार चाहे बैठ सकता है और उस पर इसके लिए कोई प्रतिबंध नहीं है।

2. INSTRUCTIONS FOR APPLICANTS

- a) Instructions in the booklet are liable to changes based on decisions taken by the Government / Medical Council / Competent Authority / Court decisions from time to time. Applicants are required to refer to the latest bulletin or corrigendum that may be issued to incorporate these changes Refer <u>www.natboard.edu.in</u> for latest updates or corrigendum.
- b) Application forms can be downloaded from website www.natboard.edu.in; downloaded forms have to be submitted alongwith form fee of Rs.750/-.
- c) No Queries of the Guardians/Parents will be entertained on telephone with regard to the eligibility and disclosures of results.
- d) Applicants, for eligibility criteria, should go through the bulletin carefully before writing to the Board's office.
- e) Submission of incomplete applications or applications not in accordance with instructions will not be considered and the candidates will be declared ineligible. In such cases, the entire fees will be forfeited.
- f) Applicants are required to submit all the requisite annexures with the application form; lack of relevant annexure shall lead to cancellation of application form and the entire fees will be forfeited.
- g) Applicants should have passed the Primary Medical Qualification i.e. MBBS or Equivalent degree and must submit proof of passing the same with the application form. In absence of Proof of Passing certificate before the last date of application submission, the application shall be treated as incomplete and fees will be forfeited.
- h) The foreign medical degrees should be attested either by the Embassy of India or should be Apostilled by the appropriate authority of the foreign country. Copy of the same duly attested/Apostilled by the Gazetted Officer in India, (showing full details...... Name, Designation, office, Government etc.) should be submitted. Kindly note that the apostile/attestation is to be as per the screening test regulations (amendment) dated September 2009.

For details regarding Apostilled documents, candidates may refer to the website of Ministry of External Affairs (www.meaindia.nic.in)

i) Applicants are advised to fill their postal address correctly as this address shall be used for sending the Roll Numbers and Results.

- j) Fees once paid will neither be carried forward to a future date nor be refunded under any circumstances. Fee should be paid by Challan & deposited to selected branches of Indian Bank.
- k) Applications of applicants producing false or fabricated records will not be considered and such applicants will be further debarred from appearing in the

2. आवेदकों के लिए अनुदेश

- a) पुस्तिका में दिए गए अनुदेश समय–समय पर सरकार / चिकित्सा परिषद् / सक्षम प्राधिकारी / न्यायालय के निर्णयानुसार बदले जा सकते हैं। इसलिए आवदकों को नवीनतम बुलेटिन अथवा संशोधित अंक को ही देखना चाहिए जिसमें समस्त संशोधनों का समावेश किया गया है।
- b) आवेदन फार्म वेबसाइट www.natboard.edu.in से डाउनलोड किया जा सकता है जिसे 750 रु. की फीस के साथ जमा कराना होता है।
- c) पात्रता और परीक्षाफल से संबंधित किसी भी प्रश्न का जवाब संरक्षकों/अभिभावकों को टेलीफोन पर नहीं दिया जाएगा।
- d) पात्रता मापदंडों के लिए आवेदकों को मंडल कार्यालय को लिखने से पहले बुलेटिन ध्यानपूवर्क पढ़ लेना चाहिए।
- e) ऐसे आवेदन फार्म जो आधे—अधूरे हैं अथवा उन्हें भरते समय अनुदेशों का पालन नहीं किया गया है और उन्हें जमा करा दिया जाता है तब उन पर विचार नहीं किया जाएगा और उन्हें अपात्र घोषित कर दिया जाएगा।
- f) आवेदक सभी जरूरी परिशिष्ट के साथ आवेदन फार्म जमा कराएं, अपेक्षित परिशिष्ट के बिना आवेदन फार्म जमा कराने पर आवेदन फार्म रद्द हो सकता है। ऐसी स्थिति में समस्त शुल्क जब्त किया जाएगा।
- g) आवेदक द्वारा प्रारंभिक चिकित्सा योग्यता अर्थात एमबीबीएस अथवा समकक्ष उपाधि उत्तीर्ण कर लेनी चाहिए और उसे आवेदन फार्म के साथ इसके उत्तीर्ण होने का प्रमाण अवश्य संलग्न करना चाहिए। आवेदन जमा कराने की अंतिम तिथि से पूर्व परीक्षा उत्तीर्ण होने के प्रमाण–पत्र के अभाव में आवेदन को अधूरा समझा जाएगा और शुल्क जब्त कर लिया जाएगा।
- h) चिकित्सा की विदेशी उपाधियों को भारतीय दूतावास अथवा विदेश के किसी उपयुक्त प्राधिकारी द्वारा साक्ष्यांकित / हस्ताक्षरित किया जाना चाहिए। किसी भारतीय राजपत्रित अधि ाकारी द्वारा इसकी साक्ष्यांकित / हस्ताक्षरित प्रति जिसमें संपूर्ण ब्यौरे जैसे नाम, पदनाम, कार्यालय, सरकार आदि का उल्लेख हो भी अवश्य जमा करानी चाहिए। उपयुक्त दस्तावेजों की जानकारी के लिए उम्मीदवार विदेश मंत्रालय की वेबसाइट (www.meaindia.nic.in) पर संपर्क कर सकते हैं।
- i) आवेदकों को परामर्श दिया जाता है कि वे अपना सही डाकपता लिखें क्योंकि इस पता का उपयोग अनुक्रमांक और परीक्षाफल भेजने के लिए किया जाएगा।
- j) एक बार शुल्क जमा हो जाने पर उसे किसी भी स्थिति में भविष्य में किसी अन्य तिथि के लिए वैध नहीं माना जाएगा और न ही उसे लौटाया जाएगा। शुल्क चालान या इंडियन बैंक की चुनिंदा शाखाओं पर भुगतान किया जा सकता है।

- I) Application Status / Roll numbers / results can be seen at the website www.natboard.edu.in
- m) Roll number can be downloaded from the website and quoted when not received by post in time.
- n) Appearance or success in the screening test does not confer any right upon a candidate for seeking registration with MCI/State Medical Council.

Registration of FMG by the MCI /State Medical Council is subject to fulfillment of MCI /State Medical Council criteria/rules/regulations framed for this purpose.

- o) Undertaking by applicant as per Annexure 'E' has to be submitted with application form.
- p) Notifications, regulations etc. issued by Government of India, Medical Council of India may be referred for eligibility criteria, pattern, schedule of exam. There is no provision for retotalling/re-evaluation.
- q) The Admit Card is not transferable to any other person. Impersonation is a punishable offence under law. CANDIDATES ARE REQUIRED TO BRING THEIR PASSPORT ALONGWITH THE ADMIT CARD FOR ENTRY TO THE EXAMINATION CENTRE. National Board of Examinations reserves its absolute right to verify the identity of the applicant/examinees/candidates.
- r) Candidates are required to strictly adhere to the reporting time as indicated in Admit Card/Information Bulletin. Exam centre gates shall be closed at 9.00 AM sharp. Late entry or early exit of candidates is not permissible under any circumstances.
- s) **Unfair means** NBE reserves its absolute rights to take penal action as applicable under civil/criminal procedure/guideline or any other action deemed appropriate against candidates found using unfair means.

Unfair means includes canvassing for support of a candidate with examiners of DNB Exam/NBE office/any other functionary/use of electronic gadgets as Mobile Phones during exam/Impersonation/use of study aids as books/notes etc. during exam./Influencing any functionary of exam system/any other act intended to breach the sanctity of examination process.

 Candidates are advised to enter a correct/valid 10 digit mobile number in their application form for receiving SMS alerts.
 Jurisdiction for all disputes shall be at Delhi/New Delhi in the Delhi High Court.

- m) अनुक्रमांक वेबसाइट <u>www.natboard.edu.in</u> से डाउनलोड किया जा सकता है और यदि डाक द्वारा समय पर नहीं मिलता है तब उसका उल्लेख किया जा सकता है।
- n) प्रारंभिक परीक्षा में उपस्थिति अथवा सफलता किसी उम्मीदवार को एमसीआई / राज्य की चिकित्सा परिषद में पंजीकरण कराने का अधिकार नहीं देता है।

एमसीआई / राज्य की चिकित्सा परिषद द्वारा एफएमजी का पंजीकरण इस उद्देश्य हेतु एमसीआई / राज्य की चिकित्सा परिषद के मापदंड / नियम / नियमावली के अधीन शर्तों को पूरा करने पर ही वैध होता है।

- o) आवेदन फार्म के साथ परिशिष्ट 'ई' के अनुसार आवेदक को एक घोषणा पत्र जमा कराना होगा।
- p) पात्रता मापदंड, पैटर्न, परीक्षा की अनुसूची के लिए भारत सरकार, भारतीय चिकित्सा परिषद द्वारा जारी की गई अधिसूचनाओं, नियमों आदि को देखा जा सकता है। अंकों के पुनःयोग/पुनःमूल्यांकन का कोई उपबंध नहीं रखा गया है।
- q) प्रवेश पत्र किसी अन्य व्यक्ति को हस्तांतरणीय नहीं है। इसका गलत उपयोग कानून की दृष्टि में दंडनीय है। परीक्षा केंद्र में प्रवेश हेतु उम्मीदवारों को अपने साथ पासपोर्ट लाना होगा। राष्ट्रीय परीक्षा बोर्ड के पास आवेदक / परीक्षक / उम्मीदवारों की पहचान के सत्यापन का अधि ाकार सुरक्षित है।

- s) किसी भी उम्मीदवार द्वारा अनुचित साधनों का उपयोग करते हुए पाए जाने पर उसके विरूद्ध लागू होने वाले सिविल/आपराधिक प्रक्रिया/दिशानिर्देश के अनुसार एनबीई के पास दंडनीय कार्रवाई अथवा जो भी उचित हो वैसी कार्रवाई करने का समुचित अधिकार सुरक्षित है। अनुचित साधनों में परीक्षा के दौरान डीएनबी परीक्षा/एनबीई कार्यालय/किसी अन्य कार्यालय के परीक्षक के साथ उम्मीदवार को सहायता देने की गलत विधि अथवा इलेक्ट्रॉनिक उपकरणों जैसे मोबाइल फोन, पुस्तक/नोट आदि का उपयोग, परीक्षा प्रणाली के कार्यकर्ताओं पर अनुचित दबाव/ऐसा कोई भी कार्य जो परीक्षा प्रक्रिया की पारदर्शिता को भंग करे आदि शामिल किए गए हैं।
- t) आवेदकों को सलाह दी जाती है कि वे एसएमएस प्राप्त करने के लिए अपने आवेदन पत्र में सही/वैद्य 10 अंकों का मोबाईल नं. दें। सभी विवादों को निपटाने का अधिकार क्षेत्र दिल्ली/नई दिल्ली में स्थित दिल्ली उच्च न्यायालय का होगा।

3. ELIGIBILITY CRITERIA

The Applicant must meet/fulfill the following criteria :

- a) He / She is a citizen of India.
- b) Possesses primary medical qualifications that are recognized by the Government of the country issuing that qualification and the holder of that qualification is entitled for practice in that country. The said medical school must be listed in WHO directory of medical schools.
- c) He / She had obtained "Eligibility Certificate' from the Medical Council of India (applicable only in respect to students who took admission abroad on or after 15.03.2002). This requirement shall not be necessary in respect of Indian citizens or overseas citizens of India who have obtained admission in foreign medical institute before 15th March 2002.
- d) All students who have taken admission abroad prior to 15.03.2002 and are required to qualify the Screening Test for their registration, shall be allowed to appear in the Screening Test even if they do not meet the minimum admission norms of MCI for joining undergraduate medical course, subjected to the compliance of the Judgment(s) of the Hon'ble Supreme Court/Competent Courts in this regard including but not limited to judgment dated 8th March 2002 in Civil Appeal No. 2779 of 2000 & other judgments.
- e) From 15.03.2002 and onwards all students are required to obtain an Eligibility Certificate from MCI before proceeding abroad for studies in Medicine.
- f) Applicants/Candidates may also refer to Screening Test Regulations and Regulations on Graduate Medical Education, Eligibility Certificate Regulations issued by Medical Council of India. The same may be referred to at www.mciindia.org or obtained from Secretary, Medical Council of India, Sector 8 Pocket 14, Dwarka, New Delhi. Telephone: 25367033, 25367035 Fax: 25367024.
- g) Cut off date for primary medical qualification shall be the last date of submission of application form for screening test. It is mandatory to provide proof/documentary evidence in support of the candidate having passed final examination for such a primary medical qualification/posses the primary medical qualification on before the cut-off date. In the event of the date of issue of result/proof, primary medical qualification being after the prescribed cut off date, the application forms shall be rejected and candidates declared as ineligible

4. EXAMINATION CENTRE

- a) The exam shall be held on 26th September, 2010 at New Delhi
- b) Timing of the exam are:
 - i) Forenoon/ Ist Session 9:00 AM to 11:30 AM
 - ii) Afternoon/ IInd Session 1:00 PM to 03:30 AM
- c) Reporting Time for candidates for the first and second sitting is 08:30 AM and 12:30 PM respectively.
- d) The Exact venue at New Delhi Shall be notified in the Admit Card.
- e) Applicants are to make own arrangements for Travel /lodging etc.
- f) All candidates are required to bring their Passport as proof of Identity at the exam center. Candidates may not be to allowed to appear in exam if they are unable to produce original passport.
- g) Candidates are advised that (due to security reasons) they may not be allowed to leave the exam center between 09:00 AM, to 03:30 PM.

3 पात्रता मापदड

आवेदक को निम्नलिखित मापदंड अवश्य पूरे करने चाहिए:-

- a) वह भारत का नागरिक हो।
- b) उसके पास प्रारंभिक चिकित्सा की योग्यता होनी चाहिए जो उस योग्यता को जारी करने वाले देश की सरकार द्वारा मान्य होनी चाहिए और उस योग्यता के धारक के पास उस देश में प्रेक्टिस करने का अधिकार हो। उस विद्यालय का नाम डबल्यूएचओ डायरेक्टरी के चिकित्सा विद्यालयों की सूची में अवश्य होना चाहिए।
- c) उसने भारतीय चिकित्सा परिषद से ''पात्रता प्रमाण–पत्र'' प्राप्त कर लिया हो (केवल ऐसे छात्रों पर लागू होता है जिन्होंने 15.03.2002 को या उसके बाद विदेश में प्रवेश लिया हो) | यह अर्हता ऐसे भारतीय नागरिकों या भारत के विदेशी नागरिकों के लिए अनिवार्य नहीं है जिन्होंने 15 मार्च 2002 से पहले किसी विदेशी चिकित्सा संस्थान में प्रवेश ले लिया हो |
- d) ऐसे सभी छात्र जिन्होंने 15.03.2002 से पहले प्रवेश लिया है और उनके पंजीकरण के लिए उन्हें प्रारंभिक परीक्षा उत्तीर्ण करने की जरूरत है, उन्हें माननीय सर्वोच्च न्यायालय / सक्षम न्यायालय के आदेशानुसार अंडरग्रेजुएट कोर्स में शामिल होने के लिए एमसीआई के न्यनूतम प्रवेश मापदंडों को पूरा न करते हुए भी बैठने की अनुमति दी जाएगी। इस संबंध में 8 मार्च 2002 के सिविल मुदकमा सं0 2000 का 2779 पर दिए गए निर्णय एवं अनुदेशों का उल्लेख किया जा सकता है।
- e) 15.03.2002 और उसके बाद से सभी छात्रों को औषधि में अध्ययन हेतु विदेश जाने से पहले एमसीआई से पात्रता प्रमाण पत्र प्राप्त करना होगा।
- f) आवेदक / उम्मीदवार ग्रेजुएट चिकित्सा शिक्षा के संबंध में भारतीय चिकित्सा परिषद द्वारा जारी किए गए प्रारंभिक परीक्षा के नियम व नियमावली, पात्रता प्रमाण पत्र के नियमों को पढ़ सकते हैं। इन्हें वेबसाइट पर भी देखा जा सकता है या सचिव, भारतीय चिकित्सा परिषद, सैक्टर 8, पॉकेट 14, द्वारका, नई दिल्ली, दूरभाष 25367033, 25367035 तथा फेक्स 25367024 से भी प्राप्त किया जा सकता है।



(Published in Part III, Section 4 of the Gazette of India Extra-ordinary issue dated the 18th February,2002)

In exercise of the powers conferred by section 33 of the Indian Medical Council Act, 1956 (102 of 1956), the Medical Council of India, with the previous sanction of the Central Government, hereby makes the following regulations, namely: -

- 1. Short title and commencement -
 - (1) These regulations may be called the Screening Test Regulations, 2002.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Definitions:- In these Regulations, unless the context otherwise requires,-
- a. "Act" means the Indian Medical Council Act, 1956 (102 of 1956);
- b. "Council" means the Medical Council of India constituted under section 3 of the Act;
- c. "Permanent Registration" means registration for the purpose of enrolment on any State Medical Register or Indian Medical Register after obtaining the Primary Medical qualification followed by completion of such practical training as prescribed either in India or abroad as per the provisions of the Act;
- d. "Prescribed" means prescribed by regulations made under this Act;
- e. "Prescribed Authority" means a medical institution or any other examining body authorized by the Central Government/Medical Council of India to conduct Screening Test.
- f. "Primary Medical qualification" means a medical qualification awarded by any medical institution outside India which is a recognized qualification for enrolment as medical practitioner in the country in which the institution awarding the said qualification is situated and which is equivalent to MBBS in India;
- g. "Provisional Registration" means provisional registration in a State Medical Register or Indian Medical Register for the purpose of undergoing practical training in India as



prescribed and for no other purpose by an Indian citizen possessing any primary medical qualification but has not undergone such practical training after obtaining that qualification as may be required by the rules or regulations in force in the country granting the qualification;

- "qualifying examination" means the examination to be qualified to become eligible for admission to MBBS course in India as prescribed in the Graduate Medical Education Regulations, 1997.
- i. "registration" means either Provisional Registration or Permanent Registration.
- 3. An Indian citizen possessing a primary medical qualification awarded by any medical institution outside India who is desirous of getting provisional or permanent registration with the Medical Council of India or any State Medical Council on or after 15.03.2002 shall have to qualify a screening test conducted by the prescribed authority for that purpose as per the provisions of section 13 of the Act:Provided that a person seeking permanent registration shall not have to qualify the screening test if he/she had already qualified the same before getting his/her provisional registration.
- 4. Eligibility Criteria: No person shall be allowed to appear in the screening test unless:
- he/she is a citizen of India and possesses any primary medical qualification, either whose name and the institution awarding it are included in the World Directory of Medical Schools, published by the World Health Organisation; or which is confirmed by the Indian Embassy concerned to be a recognised qualification for enrolment as medical practitioner in the country in which the institution awarding the said qualification is situated;
- 2. he/she had obtained 'Eligibility Certificate' from the Medical Council of India as per the 'Eligibility Requirement for taking admission in an undergraduate medical course in a Foreign Medical Institution Regulations, 2002'. This requirement shall not be necessary in respect of Indian citizens who have acquired the medical qualifications from foreign medical institutions or have obtained admission in foreign medical institution before 15th March, 2002.
- 5. The purpose of conducting the screening test shall be only to determine the eligibility or otherwise of a candidate for his or her registration with the Medical Council of India or any State Medical Council and qualifying the same shall not confer any other right, whatsoever, on a candidate.
- 6. The details regarding the Scheme for conducting the screening test and the syllabus of the test shall be announced by the Medical Council of India from time to time for the information of the candidates.

- 7. The screening test shall be conducted twice every year as per the Schedule of examination announced by the Prescribed Authority. The procedure of conducting the test shall be in accordance with the Scheme announced by the Medical Council of India in this regard.
- There shall be three papers of multiple choice questions in Pre-Clinical, Para-Clinical and Clinical Medicine and its allied subjects including Obstetrics and Gynaecology. The language of the test shall be English. The test for each paper will be of three hours duration.
- A candidate shall be declared as having passed only if he/she obtains a minimum of 50% (fifty percent) marks in each paper separately. The minimum qualifying marks shall apply to all categories of candidates without exception.
- 10. A candidate may avail of maximum three chances to appear and pass the test. Actual appearance at the test will constitute an attempt. If he/she does not qualify even in his/her 3rd appearance in the test, the candidate will not be eligible for registration by the Council or by any State Medical Council in India.
- 11. The Prescribed Authority shall intimate the result of the Screening Test to the candidates as well as to the Secretary, Medical Council of India and the State Medical Councils. The unsuccessful candidates shall also be appropriately informed. The candidates who qualify the Screening Test may apply to the Secretary, Medical Council of India, New Delhi or to any State Medical Council for provisional registration/ permanent registration along with the requisite registration fee in favour of Secretary, Medical Council of India or the State Medical Council. The Medical Council of India or the State Medical Council. The Medical Council of India or the State Medical Council of shall issue provisional registration to such successful candidates, who are yet to undergo one year internship in an approved institution and issue permanent registration to such eligible candidates who have already undergone one year internship, as the case may be.

The application form for issue of the Eligibility Certificate may be obtained from the Council office. The application form alongwith the details required therein may be submitted to the Council alongwith the demand draft in favour of Secretary, Medical Council of India, New Delhi, for the prescribed sum. It may be understood that Eligibility Certificate will be issued by the Council only to such candidates who fulfill the criteria of age of admission to the medical course and passing of qualifying examination (10+2 or equivalent or higher qualification) with the required percentage of marks as prescribed in the Graduate Medical Education Regulations, 1997, copies of which are available in the Council office on payment of Rs.100/-. This is to bring to your kind notice that the Indian Medical Council Act,1956 has been amended by the Indian Medical Council (Amendment) Act,2001 under which Regulations have been approved by the Central Govt. and notified in the Gazette of India which provide broadly for the following

- No new primary medical qualification (equivalent to MBBS in India) granted by any medical institution outside India shall be included in the Schedules to the Indian Medical Council Act after coming into force of the Indian Medical Council (Amendment) Act,2001 i.e. 3rd September, 2001.
- 2. A citizen of India possessing a primary medical qualification as defined in the enclosed Screening Test Regulations,2002 {para 2(f)}granted by any medical institution in any country outside India and who is desirous of getting provisional or permanent registration with the Medical Council of India or any State Medical Council on or after the 15th March,2002 shall have to qualify a screening test conducted by the prescribed authority.
- 3. An Indian citizen seeking admission in a foreign medical institution for obtaining a primary medical qualification as defined in the enclosed Screening Test Regulations, 2002 {para 2(f)} on or after the 15th March, 2002 shall be eligible to appear in the Screening Test only if he possesses the eligibility qualification as per the regulations framed by the



MCI (for admission to MBBS course in India) – Extracts of Graduate Medical Education Regulations are enclosed for reference.

4. Any person who is desirous of joining an undergraduate medical course in any foreign medical institution on or after 15th March,2002 should approach the Medical Council of India, New Delhi for issue of Eligibility Certificate for that purpose as per the Eligibility Requirement for Taking Admission in an Undergraduate Medical Course in a Foreign Medical Institution Regulations,2002. All such candidates will be allowed to appear in the screening test only if they produce the eligibility certificate, after completion of the medical course abroad and if they are eligible to sit for the screening test as prescribed in the Screening Test Regulations, 2002.

MEDICAL COUNCIL OF INDIA AMENDMENT NOTIFICATION New Delhi, the 25th September, 2009

No. MCI, 203(9)/2009-Regn./39606 - In exercise of the powers conferred by Section 33 of the Indian Medical Council Act, 1956(102 of 1956), the Medical Council of India with the previous sanction of the Central Government hereby makes the following regulations to further amend the "Screening Test Regulations, 2002" namely:-

- 1. These regulations may be called the "Screening Test Regulations (Amendments), 2009-Part-I".
- 2. They shall come into force on the date of their publication in the Official Gazette.
- 3. In the "Screening Test Regulation, 200" the following additions/modifications/deletions/ substitutions, shall be, as indicated therein :-
- 4. (i). In Regulation 3, first line after the words "An Indian citizen" the following shall be added:-

"or a person who has been granted Overseas Citizenship of India".

(ii). In Regulation 4 under the heading "Eligibility Criteria", para (1) shall be substituted with the following :-

"No person shall be allowed to appear in the screening test unless : he/she is a citizen of India or has been granted Overseas citizenship of India and possess any primary medical qualification, which is confirmed by the Indian Embassy concerned, to be a recognized qualification for enrolment as medical practitioner in the country in which the institution awarding the said qualification is situated".

(iii). In Regulation 4 under the heading "Eligibility Criteria", in para (2) after the sentence "This requirement shall not be necessary in respect of Indian citizens", the following shall be added:-

"or Overseas citizens of India"
