Hui # 12, 13, 14 – of 9th, 12th & 15th August 2019

- Discussed combining the 3 MACA claim's together.
- On the 27th August VT, TA and BD went and saw IENZ to discuss the possibility of taking on the role of NRNWKA registrations.
- TA gave out minutes for Kawa marae first information hui.
- Auckland Council capacity building was signed off and circulated.
- Confirmed information hui 21st Sept 2019 with AE at Matapouri marae.
- Combined Validation Committee hui that had been pencilled for 19 October may likely have to change because IENZ cannot engage until November.
- Discussed reimbursements. TA has Bruce's receipts for travel to Aotea for Kawa Information Hui on 3 August: for flights, food and parking.
- VT Did we give a koha to the marae? BD states this has not been discussed. TA should koha to each marae and venue we hui/visit.
- Money to be paid: reimbursements to: Nicola M, Hillarey & Rhanae McG, IRD, Charities and Storage King. TA Wants to complete this today.
- Discussed the Auckland Harbour dredged sludge dumping off Aotea consent.
- Participation in the Auckland City unitary plan process.

TA moves that the minutes are correct VT seconded. Unanimous TA BD VT AE. Kua mana

Hui #15 Draft Minutes – 27 Aug 2019

- NRNWTB Capacity contract entered with Auckland City and an invoice generated to the city for the remaining \$25,000 for the remainder of the 2018/19 financial year. The city have received it and it looks favourable we hope to be paid so we can do the trust's mahi: engage IENZ, hui, validation committee hui, AGM elections. TA thanks to KK for her mahi and contributions by preparing the Board template invoice & details in it.
- Financial. Tikanga, is important to look at giving koha for the hui venues St James Hall, Kawa marae, Tauranga and Matapouri and any marae we hui at.
- Maori Cultural Heritage Project invoiced city. Kelly and Michael attended \$400 fee paid for the mahi done is gifted to the trust petrol reimbursement of 230 from Auckland Council to KK for her driving herself and Michael from Auckland to Whangarei return for that hui.
- MACA High Court claim for Aotea VT talked about consolidating the MACA claims- there are 3 Aotea claims in the High Court-to do in due course.
- IENZ TA happy to hui and to find out what the professionals can assist us with and when they become available. BD states he was intrigued that there were only 2 companies in the country. TA want to find out when and how they can assist us. Expect letter to come from manager.
- Roles and Responsibilities for KK, which was laid out in the minutes.

- Need to add JW to Facebook as admin. Add JW to the bank account. JW didn't want to go on as a signatory to bank account because there are already four trustees on it but TA advised that the more of us the better to be available to share the mahi and make approved payments and added that in April the Court directed us trustees to take over from the previous board members.
- Asked Catherine Munro to cancel the old Facebook page but still hasn't done this yet.
- For website we need photos of trustees and a short introduction, and contact details. Each trustee to do this and send to KK to post.
- Need to write letter to Siteground and IRD to get access into Board accounts. Charities Register has been filed and will make payment to finalise.
- TA asked about the computer from the old trust BD suggested we should get the computer back. But it was being used by the whanaunga who was working on the kokako restoration project on Aotea.

Moved minutes a true and correct record: VT moved, seconded AE. Unanimous TA BD VT AE. **Kua mana**

8. Finances

Reimbursements for costs paid for TB Nicola \$435 – Storage King March 2019 Hillary Rhanae \$466.90 – Siteground and 2 degrees – April 2019

KK – km's that Auckland Council pay to the trust. With the sludge dumping the trust was given \$5,000 from Aotea Local Board. Reimbursement, \$3,500 for Sue Grey the lawyer, to her bank account and the Aotea whanau have raised the balance of \$3,500 to pay her fees and costs. BD asks is KK VT getting any of the money. No. TA proposes to keep the balance of putea in the bank account in case it is needed for later, during a likely appeal process. Also, the grant from the Aotea Local Board also requires that the Trust Board report to the Local Board on the use of the \$5,000 for the appeal.

Resolution: That KK is reimbursed for her airfares to court hearing, Sue Grey \$3,500 to be paid and the rest of the money to remain in trust account to support the appeal process.

Moved BB second JW. Unanimous. Kua mana

TA this is worth a fight – stop the dredging dumping in your moana

BD costs he incurred for travelling to Board hui, 1 night accommodation 19 July and First Board Information Hui at Kawa on 3 August: – flights \$316, freight \$8, countdown \$177.55, hotel \$197.93, Petrol 443.84

Approve all the payments: TA second VT. Unanimous. **Kua mana** VT, can we afford this?

While on finances - going through the trust's bank accounts, AE questions the trust board payments to the Māori Women's Welfare League ('MWWL') from the board's GST account: \$1500 Sep 2018; \$2300 Aug 2018? BD states don't dwell on that - it will come up during the AGM. TA these accounts will have to be tabled at the AGM and people will have the right to ask about the finances. Described understanding of accountant preparing financial statements with the receipts and accounts, then the accounts are sent to auditor, who checks the accounts and provides a report. Those auditor's reports for the past 3 years are to be provided to the hapū for their questions and scrutiny. We will look at printing off all the bank account statements. AE – asks, have we received any copies of authorisations of board payments made or board meeting minutes in regards to payments from the previous board? TA received one set of minutes from the board in 2017. Not any others from earlier, 2015, 2016. AE the last payment to MWWL was in September 2018 after the appointment of Maori Trustee as interim board chair. He asks who authorised this? BD would also like this answered.

TA our responsibilities as trustees are to be transparent and accountable with payments and reimbursements – need to hand in all receipts etc. TA would expect that this information is open and affirms that the people of Ngati Rehua are able to inspect and look at it.

TA speaks to AE about the Board's Storage King locker and when he gained access to it in March 2019, he made an inventory of what was there. Those records only came up to March 2014. Since then he has seen some monthly board hui minutes up to 2014, and then has also received a set of monthly board hui minutes from Jan – Dec 2017. But he doesn't have any monthly board hui minutes from 2015-16. TA did receive from Nicola MacDonald a copy of the board's Agenda for the AGM of 16 Jan 2016, which contained the AGM of 17 Jan 2015 minutes and SGM Minutes of 7 March 2015.

AE – asks again are there any minutes to confirm authorising the payments to the MWWL in 2018? TA Don't have any board minutes for that time, we only have audited financial accounts for the years ending 31 March 2016, 2017 and 2018 only. BD we haven't had an AGM since 2016 hence why we have 3 years worth of end of year financials (audited accounts), these need to go through and be approved at our next AGM. TA stated that he has asked the previous trustees for the financial records, but has not received those as yet. In terms of our responsibility as trustees we need follow proper procedures where money is concerned. VT we had to pay a \$1500 phone bill that belonged to a former trustee. TA it went to a debt collector. We paid TA – to send KK the 2-degree account

TA await reply from city to our invoice for balance of 2018/19 financial year grant so we can do mahi. We provided initial report and invoice to them. We seek to continue engagement with them to progress this to the next stage.

12. Auckland City Cultural Sites project

KK does not receive money for attending hui for cultural sites project. The hui fees go to the trust for use on our mahi.

13. Website, Faceache, communications, information to post on website etc.

TA – has sent through the first 11 board hui confirmed minutes and asked for confirmation to post on webpage BD agrees. TA also wants to post the court judgements, all court minutes, TA reports, to put them up to keep everyone informed. TA need to keep everything transparent - our discussions, what information we consider and why we make the decisions we make. This keeps everyone safe: the people, the trust, we as trustees, and the court will see that as well. Resolution: the board have a policy of transparency, accountability, minutes, court documents be put up on the facebook and the webpage Moved: TA second AE. Unanimous. **Kua mana**

14. Equipment: Trust Board Laptop & Software?

Approved subject to getting funds, buy Apple computer, and software Moved: TA Second VT

BD – would it not be best to buy an external harddrive? TA found it difficult getting information from the previous trust board presumably because it was not all stored in one central database or computer. BD is going to do some research about computers etc? and look to see what our options are. Carry over to next hui.

15. Prep and Panui for our Third Information Hui at Maunganui, address, panui, koha, logistics.

TA The next Information hui is at 6 Salisbury Ave Maunganui, Tauranga. What are the logistics we need to consider and prepare for? KK panui is on the whanau page. TA asks are everyone coming? AE are you coming? AE answered Ae.

16. Review of Interim Administration Assistant role.

TA – thanks KK for work done so far. 44 emails on mahi received from KK in a short time– he has less of a headache he can now concentrate on other things – hui, discussions, AGM, etc

AE – tautoko the work KK has done. The efficiency and things are flowing TA this is a volunteer position – KK is not getting paid
TA the floor is open for your comments and feedback.
BD and JW have nothing to say
VT is grateful for the charities services return getting lodged and paid
Resolution: We thank KK and continue with administrative assistant
BD has this been approved?
Moved by AE and second VT
BD opposes because it is in the hands of the High Court judge.
TA Justice Palmer said in his 6 Sept Directions that this is to be dealt by the trustees.

TA reads through paragraph 6 of the judge's decision:

[6] "I understand the circumstances in which the current appointment of an administrator, on a temporary basis, came to be made. I note there is some feeling that the administrator of the trust should be relatively independent of the two groups. I am sure that the trustees will consider that in their pending review of the appointment."

TA - He has left this to us to decide.

JW – would prefer that I was more neutral. In the hui minutes KK prepared of the Second Information Hui (of 7 Sept 19 at Māngere) he had concerns about the terminology she used. I did not agree to the resolution passed by Lynette Hoey, however, KK said that it was accepted by the hui. TA explained what that resolution meant, namely that the hui support the interim board trustees getting funding to carry out the duties - and it is not binding on us or the trustees on other, later hui of hapū. TA also states that the court has ordered that the whole database has to be reviewed. JW feels that the table has tipped to one side. BD believes it needs to go to a vote. TA doesn't want to put it to the table and he has to be the casting vote.

TA – proposes that he takes the minutes and KK do the rest of the mahi.

TA also notes that if we want an alternative to take over the mahi that KK is doing – First do we have someone else who is keen to take over immediately? And secondly KK is doing this for no payment. She is volunteering and getting the mahi done. The cost of recruiting another admin person to do this is not yet known, although we would like to know this. But we do not have an ongoing source of money to support paying an alternative yet. There is mahi to do.

TA it is getting late and can we have a hui in Tauranga, after the Information Hui to discuss this further?

BD – can we defer this till the next week?

AE – move motion that we support continuing KK's services and acknowledge her work and the standards of her work. [*AE falls out of internet connection*] TA KK to remain on 24th Sept, when we can hui after our next information hui. Carried over to next hui.

17. Other matters

TA thanks everyone for their mahi and encourages us to continue. Tavake to go online to pay the approved bills after others leave.

Date of Minute: 6 September 2019 MINUTE NO 4 OF PALMER J Context

[1] There have been a number of developments in this proceeding in the past few weeks. I have awaited responses from all parties before making my decisions. Today is the last day of a three-week trial over which I have been presiding. Yesterday, the second to fourth defendants (the defendants) applied, without notice, for an interim injunction directing that information hui scheduled for 7, 14 and 21 September not proceed, and directing the interim trustees and interim independent chair not to: (a) take any steps other than payment of invoices and receipt of correspondence necessary for the day-to-day administration of the Trust: and

(b) pass any resolution that is binding on the Trust.

[2] The defendants' stated concern is to prevent the series of information hui proceeding and to stop decision-making when the Trust Board is not properly constituted. I convened an urgent teleconference during the lunch adjournment of my trial today and heard from counsel.

Decisions

[3] I decline the application for the urgent interim injunction. It is not necessary to preserve the defendants' position. I do not consider the hui will prejudice the defendants. I do not consider any resolutions at the information hui will be determinative of decisions I or the trustees have to make. But the discussion that has occurred, and that is proposed to occur, at the information hui appears likely to be useful for implementing the directions in my judgment of 18 December 2018.1 More discussion of these issues is required amongst the beneficiaries, rather than less. I expect the korero at these hui will inform any decisions the trustees and I will eventually have to make. I do not expect the information put to the hui, or the views expressed at them, will be one-sided. My advice to the defendants is that they should engage with the discussions and put their perspective, constructively of course. [4] I am conscious there is a need to appoint a trustee to replace Ms MacGregor. I appoint Mr Jason Wii as proposed by the defendants. I make that appointment effective from today. I note the plaintiffs' concerns. But I am satisfied, on the basis Ngawaka v Ngiiti Rehua Ngatiwai ki Aotea 1h1st Board [2018] NZHC 3398. of the information filed in support of Mr Wii, that his appointment is appropriate. As I said in the judgment of 18 December 2018 (at [25]) there is a need for the composition of interim trustees to reflect an even-handed or balanced approach

between the two groups until trustees can be elected.

[5] As I also observed in the judgment (at [27]), none of the trustees are "representative" of one group or the other. Each of them owes, to all beneficiaries, the exercise of their independent judgement unclouded by animus concerning the wider dispute. I have full confidence in the interim independent chair. I endorse his comments, in his memorandum of 30 August 2019 (at [5.1]), that it will be important for all trustees to leave aside the animus of the various confrontations which led to the litigation and get on with the work to be done for all beneficiaries. I am sure all trustees will do that. If, contrary to my expectation, the chair considers any individual trustee displays a consistent and persistent pattern of destructive behaviour in trustee meetings, I expect he would advise me of that. In that event, I would consider whether the trustee should remain or not.

[6] I understand the circumstances in which the current appointment of an administrat01~ on a temporary basis, came to be made. I note there is some feeling that the administrator of the trust should be relatively independent of the two groups. I am sure the trustees will consider that in their pending review of the appointment.
[7] I have not yet formed a view on the other directions sought by the defendants or about the proposals being discussed at the information hui about registration, reregistration etc. I expect the views expressed at the information hui will be useful for me to take into account in considering the directions sought. The parties may also

wish to have a brief hearing about those issues. We will proceed step by step. *Palmer J* Attachment 2.

Ngāti Rehua-Ngātiwai ki Aotea Trust: - Representatives and Te Papa Atawhai 1. Thank you for your email dated 22 August seeking clarification on mandate and representation matters between Ngāti Rehua-Ngātiwai ki Aotea Trust and Te Papa Atawhai. I have delegated this mahi to tangata whenua co-trustee because the High Court's remit to myself as independent interim chair and counsel assisting the court requires my focus to be primarily on regularisation of the hapū beneficiary database, convening processes in respect of that and heading to a well overdue AGM and trustee elections.

2. You may recall we advised earlier this year that Dr Valmaine Toki is to be the key contact with Kelly Klink as a support person. I can confirm that this remains the case and this delegated mandate from the interim board was re-confirmed in discussions about this topic during our most recent Trust Board hui on 27 August.

3. In response to your questions: a. How the trust would like to receive consultation requests for statutory processes?

b. Who are the mandated representatives for consultation?

c. Who would be the mandated representative to converse with for operational matters?

4. Valmaine Toki, with Kelly Klink in support, are the key contacts for the receipt of consultation requests for statutory processes. They are the mandated representatives from the Ngāti Rehua-Ngātiwai ki Aotea Trust Board for consultation, operational, governance, permits, concessions and all associated matters with Te Papa Atawhai.

5. I understand that Valmaine Toki has scheduled a meeting with Andrew Baucke, Te Papa Atawhai Operations Director for the Auckland region and John Galilee, Statutory Manager also for the Auckland region regarding procedural matters around the nomination process and advice provided to the Minister for members of the Aotea Conservation Park and the Hauraki Gulf Island Forum. From our perspective as Ngāti Rehua-Ngātiwai ki Aotea Trust Board it is important that we are consulted, participate and are involved in decision making in appointments affecting mana whenua.

6. I can confirm that Hillary MacGregor has resigned from the Ngāti Rehua-Ngātiwai ki Aotea, effective 3 July 2019.

I take it this message finds you well. I need to bring to your attention some advice that has been inadvertently passed to DOC in regards to the Ngati Rehua Ngatiwai ki Aotea Trust. There are two points that need clarification.

- Firstly, our permissions team received advice that Kelly Klink is the environment representative for Ngati Rehua Ngatiwai ki Aotea and that she would like to be consulted on any and all matters relating to environment in her rohe and would like to receive wildlife permit applications. Kelly (and Valmaine Toki) has also sought consultation on a multi-regional filing permit that is currently in process. We have advised Kelly to seek a mandate letter from her Iwi Authority (preferably Chair, CEO or General Manager) to affirm mandate representation. Are you able to provide clarification on this matter?
- Secondly, we have also received advice that Hillarey McGregor has stood down from the interim trust. Can you also clarify this matter?

On another note, we've been asked by Valmaine to reconsider the selection of two members of the new Aotea Conservation Park Committee. We have discussed this with Valmaine over the phone but I understand she is seeking a meeting with Andrew Baucke, Operations Director for the Auckland region and John Galilee, Statutory Manager also for the Auckland region.

Tavake, this brings to mind the intent of our last interaction in March where I stated that it would be great to get some form of operational relationship ASAP and build from there. Essentially this is probably anticipating the intent of the next trust board but I'm aware that this may still be some time away. In the meantime we're faced with a need to clarify how we work together. I guess what I'm saying is it would be great to clarify

- How the trust would like to receive consultation requests for statutory processes?
- Who are the mandated representatives for consultation?
- Who would be the mandated representative to converse with for operational matters?

If you could please consider these questions and get back to me with any feedback? Alternatively, I'm available on the phone.

Ngāti Rehua-Ngātiwai ki Aotea Trust Board Information Hui 10am – 2pm, Saturday 3 August, 2019 KAWA MARAE, AOTEA INTERIM INDEPENDENT CHAIR'S HUI MINUTES [*please note these are summary notes] 10am Whakatau Karakia: Maia Mihimihi: Opo, Tavake Whakanoa - Kapu Ti Whakatuwhera/Introduction: Interim Independent Trust Board Chair, Tavake Barron Afeaki

Background, Vision for Future: Tavake's perspective as independent chair on the need for Ngāti Rehua-Ngātiwai uri having the opportunity to gain some understanding of the nature of the issues and work towards facing the challenges collectively and using their knowledge and vision to resolve the problems as a people, for the tamariki mokopuna to have a better chance. The uri of Aotea deserve much better and this series of hui and processes is the chance right now for Ngāti Rehua-Ngātiwai uri to resolve the issues themselves in a manner which navigates personal disputes, black-letter law and be guided by your own tikanga.

High Court Orders: In response to a question about how long it will take? – The matter has taken some years to get to this stage of intense conflict, and eventually went to the High Court two years ago. Tavake mindful that rather than impose a solution, Justice Palmer has made orders about what he directs to happen to regularise the beneficiary database (read these out to the hui and discussed) and given the interim trust board until June 2020 to complete a combined validation committee process and then have an AGM with election of new trustees, who can take over. Recognised that time is passing and there is always work to

be done, but we have to do this properly. Importantly there needs to be good will and dedication to work for all of us to surmount the challenges together. Disputes about leadership of hapū, of whānau are not new nor unusual. Tavake's deep wish that Ngāti Rehua-Ngātiwai uri are able to unravel the animosity which has preceded and work to resolve this without having to go to a long, expensive and risky court campaign, where the rules are very tough and we cannot have these discussions on your marae with your people and everyone have their say about what they feel and what they think is tika. Going to court will not empower your people to make the decisions you need to make. You are better placed to do it on your marae with your people present. Hence this series of information hui. So back to the question how long is it going to take? – It took years to get to this level of difficulty and conflict and we have less than a year left to properly address the problems we face. We must work together and inform the people, gain understandings of what is at stake and together make real efforts to properly work out and resolve the problems as a hapū. This is distinct from handing it over to the court to decide for you, uri o te hapū.

Trust Board Beneficiary Roll: There was a robust discussion about the beneficiary roll. Tavake explained some of the issues, the current unavailability of ElectioNZ (ENZ) due to their bookings for 2019, the current status of the roll. Because ENZ were booked out with local government, school and other elections, they were not available to assist until 2020 earliest. The Court has ordered that we need their (ENZ) professional services to conduct the combined validation committee hui and AGM, and rightly so, because this is serious mahi and requires expert service and skills. We are looking for engagement with the other professional election services provider to ascertain whether or not we can contract them. Clarified in response to a question from Kuia, Ms Wi, that it was not Tavake who came up with the term lack of 'integrity' of the database. - In fact it was the election service professionals and also the Maori Trustee who had said that they had concerns about the 'integrity' of the current database. That description was taken up by the judge because he was relying on their being independent of the different parties. This was the reason for needing to put in place a proper process for validating the information in the beneficiary database. Meantime, the trust board had asked ENZ for the beneficiary database which they sent us – as two lists, one is a spreadsheet with 1622 names and addresses on it, many of whom are contested by either side of the court dispute. ENZ also sent another of 46 names of member enrolments agreed to in the earlier separate validation committee hui of 2017. Interim Trustees Bruce Davies and Valmaine Toki explained how we had asked ENZ to send us the originating documents they held so we could look at what we had to work with. They sent these to us last month, July 2019. We received and opened the two boxes of your hapū documents received from ENZ at our trust board hui on 19 July and inspected them. There were many piles of documents, signed membership registration forms, including some piles of proxy voting forms. Bruce commented on one pile of proxies which were all received at the last failed AGM from his brother, who had signed about 200 of them. This gave rise to discussion in the hui about needing clear processes for proxies because the validity of voting processes is so important.

One kaumatua asked why were proxy forms used and what were the rules about proxies? Tavake advised the hui that if proxies are to be accepted for voting, there needed to be one properly designed proxy form used, with a proper, clear manner explained to everyone in which proxies are reliable and lodged two weeks well in advance of the AGM, so they could be properly verified prior to the AGM and measured against the properly organised and validated hapū membership database.

This led to further korero about the underlying issue of the form, content and processes of the beneficiary registration forms.

Advised the hui that different beneficiary registration forms had been used by different people applying which meant that there was different information being given by people wanting to register. The problem was that it created inconsistent information being provided by beneficiaries.

One kuia, Ms Stephens, said that despite being from Aotea, having been a registered beneficiary for many years and who had earlier served the trust board administration as secretary, she had been removed from the beneficiary database as a member. Another kuia, Ms Hope raised that she did not want to be re-registered as she is a kaumatua and is already registered. Hui discussion that perhaps kaumatua should not be required to re-register and that the combined validation committee could review the database and confirm who should remain on it or not. Tavake recalled in February 2019 meeting one Aotea kuia who was 88 years of age and resides at Okiwi and how someone had mentioned it would be offensive for this kuia to have to re-register. However, the combined validation committee would have enough people who hold the knowledge and ability to know who is in fact a kaumatua.

Another view expressed and discussed was that we should not whaka-iti or 'put down' anyone uri by only requiring some to apply to re-register and not others, because the same fair procedure and criteria should be done by everyone applying.

Was agreed by everyone at the hui that we should invite people to register. Tavake added that the judge had directed us to do this. We will provide one registration form to be used. Looking forwards, the trust gave some more background to the work we believed necessary and then the hui had some more ideas, discussions about what needed to happen next to validate and regularise the beneficiary database

Request for Feedback, Registrations:

Combined Validation Committee: Tavake advised the Hui that the judge had ordered that a combined validation committee come together and process the database information, call for further registration applications of uri and regularise the database. This is because at the earlier validation committee hui, two committees met separately and considered the forms separately. They came to quite different conclusions.

Tavake advised the hui that present at our trustees hui of 19 July 2019 in Auckland, two members of the two earlier validation committees attended; Bruce Davies and Aperahama Edwards. They had already seen those sets of documents first-hand and had been through the experience. They knew how that earlier separate validation committee hui went and the disputes which happened in them. After long discussion the trustees had decided to start registrations afresh and seek views from the hapū beneficiaries and of course direction from the Court as to whether this is acceptable.

Trust considered that we need a better process for us to succeed and this was the reason why we are holding the information hui and the series of them in the different places where uri reside, so we could together inform the whānau and hapū, seek feedback and help the whanau to ready the to participate for best results.

Resolution Moved by kuia Marylin Stephens (wrote up on whiteboard), and was debated by Hui: - resolved:

- That the current beneficiary register be reviewed in part by the combined validation committee.

- That the NRNWTBoard call for registrations and re-registrations
- That the NRNWTBoard secure professional election services

Those in favour. Kua mana.

The hui then discussed and supported the Board's following series of proposed information hui, combined validation committee hui and AGM with tentative dates and confirmation as soon as able, if not - to be advised and alternative arrangements to be made: -

10 August – Tauranga

17 or 24 August - Matapouri

7 or 14 September - Auckland

19 October - Combined Validation Hui #1 – Auckland

Second Combined Validation Hui – Kawa/Motaihere?

23 November - AGM – Auckland?

[*these hui are subject to availability, confirmation of marae, organisation, professional services for the CVC hui & AGM and funding]

AGM – reports, accounts & elections of Trustees

Timetable next steps

Other Matters: Kuia, Ms Hope raised the matter of the resignation of the interim trustee, Hillarey McGregor and a replacement trustee for this role for the defendants. Tavake advised the hui that he had already reported on that matter to the Court which has used its powers to appoint the 5 interim trustees. Advised that the Justice Palmer has seen Tavake's 31 July 2019 report to the court, is taking legal submissions from both parties and had directed that once he has heard from both sides, he will make a decision on the appointment issue. We told him that we are not going to discuss it at this hui today as it is out of our hands. Communication – of hui, information, proper forms to register with and updates on the process and hui timetable through website, facebook page – Must happen ASAP. Volunteers to help sought.

Taumata – Kaumatua, Opo told the hui that the Aotea Taumata Kaumātua had resumed having monthly hui and that they wanted the board to keep them informed. Noted that they are the ahi kaa roa and that they do not want to be marginalised by others who do not come to the island - making decisions about the motu without them ahi kaa - being given prominence as kaitiaki. For example we should have hui here on the motu like this to stay involved.

Whakataukī whakataki [Introductory proverb] 'Ko te tao rakau, e taea te karo. Ko te tao kupu e kore e taea te karo' [The wooden spear can be parried. The spoken spear cannot.]

1. Update of Independent Interim Chair: Information Series Hui 1.1. Further to my report to the court filed on 31 July 2019 and directions sought therein, I am writing to update the honourable court on the first Trust Board Information Hui held at Kawa Marae, Aotea on Saturday 3 August 2019.

1.2. Please find **attached** as an exhibit my summary minutes from the first Trust Board Information Hui derived from the Panui and Agenda circulated for that purpose.

1.3. I attended that first Trust Board Information Hui as Independent Interim Chair and Counsel Assisting the Court, together with two of the other court-appointed trustees of the Trust Board, William (Bruce) Davies and Valmaine Toki. I am very grateful again to the Hau Kainga of Kawa and Aotea for their warm hospitality on their marae tīpuna. *No reira, he mihi nui anō ki a koutou e ngā rangatira kaitiaki o Kawa, o Aotea*.

1.4. As *Amicus*, I consider that this first information hui was a worthy exercise because we were able to *hui a kanohi* with Ahi Kā on Kawa Marae, inform them face to face of background and processes including what we have to do, seek their views and give them an opportunity to help us understand their concerns and proposals for advancing their situation. I ask that the Court consider my minutes for their terms.

1.5. The tentative timetable for the series of Information Hui has again shifted since my last report to the Court due to various contingent factors. Accordingly, I **attach** as an exhibit for the Court's information a further Trust Board Information Hui Panui and Agenda for the purpose of promoting the second Information Hui to be held at St James Church Hall, Māngere Bridge, Auckland on Saturday 7 September, 2019. Further Information Hui are to be held at Maunganui, Tauranga on Saturday 14 September and at Matapouri on Saturday 21 September.

1.6. The Court will please note that at the base of the Panui and Agenda, to inform the hapū and whānau, I have inserted the following note:

1.7. We have two confirmed bookings for the second and third hui and are seeking confirmation of the fourth hui marae venue. We are well aware that we must be flexible because contingencies arise and we will deal with such matters as they arise. As a Board, we are committed to this process. As we listen to people, consult more and as a result learn more about processes and availability of professional services, we become more aware of the need to engage with the uri of Ngāti Rehua to empower them to make informed decisions. In saying this we are necessarily flexible as to timing due to contingencies, funding and the like because ultimately we are attempting to provide best processes for best quality outcomes.

1.8. I am puzzled that some have expressed the view that in my reports on the proposed series of information hui, we are attempting to resolve wider grievances within the hapū, revisit the negotiated Treaty Settlement, or otherwise 'unwind' due process. This is not correct. We are holding information hui and the intention is to engage Ngāti Rehua uri in the safety and convenience of places near to where they reside, inform them and ask for their views. These hui are about empowering and informing them in what has been a protracted and confrontational process and honing in on the database, combined validation committee and this process. Of necessity also, we have not yet been able to engage any independent professional election services which we believe are crucial to the success of our efforts, especially with regard to any processes with the database, combined validation committee hui and AGM. I report further on this below.

1.9. Meanwhile we wish to hui a kanohi with the people, pay our respects to them, inform them and ask for their help. There is often mention of tikanga and in my personal view as Amicus, this surely includes 'whakamana tāngata i roto ngā hui a kanohi' (acknowledging/respecting mana of people in face to face meetings). Kei a rātou, ngā uri, te mana whakawhiri. (They, the descendants have the mana to decide).

"**Please note that this is the second in the series of Information Hui which are being held by the Interim Trust Board. The current timetable is as follows: 1. Kawa Marae, Aotea, Sat 3 Aug DONE; 2. St James Church Hall, 31 Church Road, Māngere Bridge, Auckland, 1-4pm, Sat 7 September; 3. Te Maire, Te Runanga o Ngāi Te Rangi Iwi Trust, 6 Salisbury Ave, Maunganui, 10am – 1pm, Sat 14 September; 4. Matapouri Marae, Matapouri, Sat 21 September (time TBA); 5. Combined Validation Hui, Auckland Venue to be advised, tentative date Sat 19 October (time TBA); 6. AGM, Auckland Venue to be advised, tentative date Sat 23 November 2019 (time TBA). The Board advise that these hui are subject to change. Variable contingencies include availability of combined validation committee members, marae, venues, funding, and professional election services providers in the combined validation committee processes and AGM." 2. Hui on 27 August 2019 with Independent Election Services Ltd 2.1. In the absence of ElectioNZ being available until some time in 2020, I wrote as chair to the Director or Independent Election Services Ltd introducing in very basic terms of our circumstances and seeking a hui with their company team to discuss our needs and whether or not they would be able to provide us with services and if so, when they might be available and terms and conditions thereto.

2.2. I conducted research into Independent Election Services Ltd. This included the personnel, background, expertise, other work they had conducted, bona fides and overall professional reputation. Importantly they are located in Auckland, they are the

independent election service provider for Auckland City and other local government elections in the Northern regions of Aotearoa. In my initial view, prior to meeting them in person, they appeared to be a quality provider and will be able to provide the required level of professional service to the trust.

2.3. Three of us trustees, Bruce Davies, Valmaine Toki and myself attended a meeting with the company's Director and Manager on Tuesday 27 August 2019 at their offices in Auckland.

2.4. The meeting was positive and helpful as we were able to provide them with some background to what we needed their help to achieve, discuss the Court's orders and our efforts. They were able to analyse and put some 'shape' to how we might work together, including an overall strategy, clarifying forms to use, possible online processes, compliance with the trust deed and lawful processes, promoting and informing the Ngāti Rehua people, sequencing, timetabling and heading to combined validation committee hui and in due course, when we had regularised and created a robust beneficiary database, holding the AGM.

2.5. Importantly from our discussions with them we believe that with their professional services we can, as intended, keep the existing database as the foundational information set and work with that information on seeking new registrations and re-registrations. Certainly we do not aim to destroy the existing database. It is very important that it is preserved. The names and details of all those on the database will be preserved and not removed. Rather the database will provide a foundation for the engagement with and updating of everyone on it, including for those who have passed and those who have become of majority age since it was compiled.

2.6. We aim to contact all the people on the database to advise them of what we are doing and ask for their engagement, registration and assistance to create the most reliable database possible so that Ngāti Rehua uri can have their best opportunity for proper elections and decide for themselves who they wish to provide hapū leadership for their long-term interests.

2.7. For those who do not wish to re-register for various reasons, the combined validation committee will also be able to assess their status and make necessary decisions. For example, it will likely be the case that the kaumātua and kuia who are long-established hapū members and do not wish to be subject to the re-registration, can be validated by the combined validation committee. Likewise with whānau members who might not otherwise be known to one party or another. It is the combined committee who will have the collective knowledge, the mana to make those decisions.

2.8. I do not at all propose to usurp the role of the combined validation committee, but instead provide them with as much good information as we can get and have them hui consider, discuss and if necessary, debate and vote on any additions or deletions to the database.

2.9. The proposed process will take some time to do properly. Engaging Independent Election Services Ltd advice and expert services in that process will be key to the trust's success.

2.10. The next steps are ensuring that we keep focussed on good quality processes, maintain momentum so we can engage and inform the people, securing funding to engage Independent Election Services Ltd to assist us after they become available

following the Auckland City and other local government elections in late October, November 2019. We have asked them for costings, including contingencies, disbursements and the like, so that we can negotiate, clarify details, timing and expectations and enter a contract. Given their work timetable and upcoming availability and our developing understanding of our workplan and tasks, we believe we will be able to undertake informing and *whakamana tāngata o Ngāti Rehua* process, convening combined validation committee hui and convening an AGM.

2.11. I am mindful that in its 18 December 2018 judgment, the Court had ordered the trust to engage ElectioNZ as the original service provider to provide professional election services for the regularisation of the beneficiary database, validation committee and AGM. As a matter of courtesy, I defer to the authority of the Court and seek endorsement of our seeking to contract the services of the only other professional independent election services company, Independent Election Services Ltd.

2.12. As Amicus, I acknowledge the Court's directions concerning the database and regularising the same so that we can confidently call and hold AGM elections. I am highly interested in investigating processes which provide the best quality database but am not completely 'wedded' to the proposals herein if the parties can come to some principled agreement on a way forward.

2.13. In so saying I welcome the Court's wisdom and orders hereto. Of course if after having considered these updates and the further views of the parties, it remains the Court's view that we proceed with the orders granted by consent at the earlier stage, then we will act accordingly.

2.14. We will proceed as able and continue to update the Court, parties and the beneficiaries. I welcome the Court's directions hereto.

3. Trustee Mr Davies did support the board's 19 July 2019 resolution to the proposed registration process 3.1. In my 31 July 2019 report to the Court, I described at paragraph 3 the process by which we as a board of trustees had sought, received, and on 19 July 2019, had opened the boxes of originating documents from ElectioNZ, considered and discussed the database in respect of and relating to the originating documents from the most recent attempted validation committees and failed AGMs.

3.2. I can confirm that our 19 July trustees' discussions about this subject were intensive and fairly lengthy. It was the main purpose of our board hui. Arriving at the resolution took a number of discussions and refinements and as Chair drafting the proposed process, I took the notes and re-read them out three times, during which we debated and re-worded and refined the resolution and steps we discussed taking. At the end of that discussion, I added that the Court must have this information and proposed process and be invited to endorse the process.

3.3. We voted on the resolution. We had designed the content and wording of it and had worked to agree on its terms and component parts, including seeking the Court's endorsement of it or directions thereto. Trustee Aperahama Edwards moved the resolution. I seconded it. All trustees: Aperahama Edwards; Bruce Davies; Valmaine Toki and myself voted in favour and I recorded this as 'unanimous'; '*Kua mana*'.

3.4. Those Hui Minutes were circulated and later debated in a subsequent Board Hui #14 on 15 August 2019 and we then discussed again the content of the resolution and the issue of his later recanting to others his support of the resolution. On 15 August, Bruce Davies abstained from voting on confirming the resolution and the Board Hui Minutes thereto. The other trustees confirmed their recollection of the resolution and the Board Hui #11 Minutes at our hui on 15 August 2019. Below is reproduced my recorded Hui Minute from Hui #11 of 19 July 2019: -

"NGĀTI REHUA-NGĀTIWAI KI AOTEA TRUST BOARD

TRUSTEES' HUI #11, 10 am Friday 19 July, 2019 HUI A KANOHI, Auckland City Offices, 135 Albert Street CBD

AGENDA

1. KARAKIA/MIHI – Tavake/Aperahama

2. Trustees In Attendance: TA, BD, VT, AE.

3. Election NZ Originating Documents & Beneficiary Database

4. Opened and inspected two archive boxes from ElectioNZ containing Registration Forms from 2017 & 2018 Hui and also proxy voting forms

5. AE: Resolution – Due to the state of the beneficiary roll and because neither the trust nor ENZ have any original documents (beneficiary registration documents) from prior to 2017, the interim trustees resolve that we need to begin the registration process afresh. **5.1**. This process is to include a new, agreed registration form, which will be the only form that is accepted;

5.2. The trust will engage available professional election contractors to compile, maintain and receive registrations;

5.3. The trust will embark on a series of information hui with the uri of Ngati Rehua to advise, engage, update, consult and seek their input in the running of the process;

5.4. The election contractors will process the registrations, monitor and compile updated database for ongoing combined validation committee hui;

5.5. The series of hui will be timetabled, culminating in a final combined validation hui, prior to notifying the date of the AGM;

5.6. Then the trustees will formally notify the date for the AGM and elections to be held;

5.7. The funding of the database registration, series of hui, validation processes, AGM and election process is to be resourced by the trust engaging in capacity-building arrangements with Auckland City and any other possible funding sources. It was also noted that the proposal would have to be put to the court for endorsement.

3.5. In light of this update and noting some comments and further affidavits filed in respect of the process for facing the challenges posed by the beneficiary database, and with the recent benefit of some initial independent professional insights and the prospect of expert service to assist us, I am interested that the Court receive information about the recent events. I am keen to receive directions from the Court so we may proceed with the work.

AE Moved. TA Seconded. Unanimous. Kua Mana."

4. Other Matters: Further Evidence Filed 4.1. I note that there have been a number of affidavits filed in respect of recent matters such as the appointment of a replacement trustee for Hillarey McGregor.

4.2. As Amicus, I note that the provisions of the Trustee Act 1956 must be read in conjunction with the Court exercising its inherent supervisory jurisdiction in the circumstances of this case. Of necessity this will obviously include the due consideration of procedural fairness and natural justice.

4.3. Importantly also for me in my role as Independent Chair, this will include whether or not in the event of an appointment of a particular replacement trustee, all the trustees together as a working board will be able to leave aside the *'animus'* of the various confrontations and differences which led to the litigation and get on with the very important work to be done for all beneficiaries' interests. In my submission, the overriding consideration must be what is in the best interests of the trust, when all aspects have been taken into account.

4.4. I note that there are some who dispute the interim appointment of Ms Kelly Klink for a month trial from 15 August 2019 to provide important secretarial administration services and support the regularisation of the beneficiary database.

4.5. I note that at our Trust Board hui #12, #13 and #14 on 9, 12 and 15 August, we followed through on many discussions over many months concerning the need for administrative support services. I had asked for

support and people for months. We had some support by Ms McGregor's initial efforts but this reduced as her commitments to whanau increased.

4.6. For clarity's sake, as a board we considered different nominees to provide that support. On 12 August we hosted one person in a zoom hui who provided her offer to provide services. She was Jackie Davies, the wife of trustee, Bruce Davies. I welcomed the offer of support. Another person, Kelly Klink of Ngāti Rehua had earlier offered her services after the first Information Hui on 3 August, where we had asked the hui for support. Having already provided Mrs Davies an opportunity to meet us online and offer her services, as a matter of procedural fairness we thanked her for her offer and when she had left the hui, discussed further. We decided to provide the same opportunity to invite Ms Klink on our next hui which we set for 15 August.

4.7. Meantime on the morning of 15 August Mrs Davies emailed our board and withdrew her offer to provide administration services.

4.8. On the afternoon of 15 August we met again and Ms Klink attended to present herself and offer her services. We noted the withdrawal of Mrs Davies services and as a board resolved to make an interim appointment of Kelly Klink to provide much-needed support services for a month trial from 15 August 2019. We will consider and review her activities and position in two weeks. I have thanked Ms Klink for her support and advised her of her obligations to the trust, the beneficiaries and the Court, including that the information we are party to as a board is confidential and that we must be sensitive to the privacy, confidentiality and sensitive nature of our duties. She is not in a decisionmaking role.

4.9. In the absence of any other avenues or offers, we have accepted Ms Klink in a trial and will review next month.

4.10. In two weeks, Ms Klink has already provided us with administrative support, which has taken some of the pressure off myself as chair. I do not have administrative skills to carry out website and facebook campaigns to advise board communications with the Ngāti Rehua uri, account entries, and Xero reconciliations, tax returns and Charities Services, minute taking, hui organising, correspondence and following up contacts with other entities. It is much preferable to have a person with that skill set to carry out those duties, so that the trustees may focus on the substantive work.

4.11. I am concerned to be advised during the recent handover process that it appears that not all the governmental compliance returns have yet been completed by those charged with those tasks earlier this year. I will report on that once I have contacted the government agencies directly as interim chair and sought their direct advice.

4.12. I am of course willing to take directions on appointment of the admin support person and we as a board are considering our options and will review the situation in two weeks.

5. Conclusion, Court Directions Sought 5.1. I seek directions on the matter of the replacement of Ms McGregor as a trustee. I note the provisions of the Trustee Act 1956 must be read in conjunction with the Court exercising its inherent supervisory jurisdiction in the circumstances of this case. Of necessity this will include the due consideration of procedural fairness and natural justice. Importantly this will include whether or not in the event of an appointment of a replacement trustee, all the trustees together as a working board will be able to leave aside the '*animus*' of the various confrontations which led to the litigation and get on with the work to be done for all beneficiaries' interests. In my submission, the overriding consideration must be what is in the best interests of the trust, all aspects taken into account.

5.2. We seek the Court's endorsement of our engagement of the services of Independent Election Services Ltd in order that we may plan for the next steps towards validation processes and set down a firmer timetable for implementing the court ordered processes.

5.3. I welcome any further directions in respect of the proposed processes described herein in respect of the beneficiary database, the call for new registrations and reregistrations and for any further information or orders the Court deems necessary.

5.4. I am privileged to serve the Ngāti Rehua-Ngatiwai ki Aotea hapū and thank the people who we have met thus far for their engagement and proposed constructive solutions.

5.5. I thank the Court for its appointment of me as counsel assisting and look forward to making further progress with the duties ordered.

- 1. E tatou ma, it has been a busy couple of weeks and I trust this finds you and your whanau well.
- 2. I wanted to touch base with you all and keep our trust 'dashboard', our mahi, our activities, plans and timetable in focus. Ko ia ra nei te take e panuitia atu nei e ahau.

Maori Sites of Cultural Significance: engagement & hui with Auckland City

- 3. Thank you for your mahi for the Trust with the kaupapa of the hui concerning the Maori Sites of Cultural Significance Kelly and as such we also pass on our thanks to yourself and Mr Michael Beazley for you mahi at the 4 June hui.
- 4. Thanks also for invoicing Auckland City for that mahi. I understand that the **attached** NRNWTB invoice to Auckland City for \$679.28 has been paid to the NRNWTB Kiwibank operational account. I will check and revert.
- 5. I note that you are seeking reimbursement for your kilometrage from that invoice for your own vehicle travel from Whangarei to Auckland return on 4 June. 316km @ .73c per km = \$230.68
- 6. I support this reimbursement for Kelly taking her and Michael to represent the trust in the hui and ask you my co-trustees to approve payment by return.

Protect Aotea – Sludge Dumping Consent Appeal – update and reimbursement of travel disbursements

- 7. We are grateful also for your, Valmaine and Kiri Toki's mahi in support of the appeal and for you having travelled to Wellington to attend the July High Court Appeal (Protect Aotea) in respect of the Sludge Dumping Consent granted to a commercial operator to dump sludge off Aotea's East Coast. As a Trust, we have received a grant of \$5,000 to our Operational account which is earmarked for NRNWTB work and support in advancing the appeal. We have to report as a Board each six months, to the Auckland City and Aotea Community Board who granted us those funds.
- 8. I refer to your **attached** Jet Star airlines receipt for \$624 which you paid from your personal funds to travel to Wellington's High Court hearing in July.
- 9. I support reimbursement of this \$624 airfare to Kelly for her travel to the hearing to support the kaupapa for nga uri o Aotea.
- 10. I seek the trustees' consideration of these reimbursements to Kelly and ask that you trustees indicate your support or comments in this email loop for her reimbursement.

Other Reimbursements of costs: Hillarey, Nicola, Bruce, Aperahama, Tavake

- 11. This also raises the issue of the Trust reimbursement of other costs incurred by all of us.
- 12. I hope that one of you other trustees has logged in online to Kiwibank to coauthorise payment of the reimbursements to Hillarey and Nicola which I made earlier this week.
- 13. I have received some requests from Bruce for reimbursements of his kilometrage and hotel accommodation for the night of our 19 July 2019 hui #11 at Auckland. Those are listed in the 'finances' section at para 14 of the **attached** NRNWTB Hui #11 Minutes of 19 July 2019, confirmed by us as a Board on 12 August. We had approved payment of those costs to him.
- 14. I would like to instruct **Kelly** to please reconcile those amounts and provide a figure for payment. I will locate Bruce's 19 July 2019 hotel receipt for \$198, which Bruce gave me to process. Then when we went to Aotea for the Saturday 3 August Information Hui, Bruce purchased our airfares and bought a nice amount of food as koha to Kawa Marae and gave me some receipts. These will have to be collated, reconciled and considered by us as a Board and approved for payment by us, so that we leave a clear accounting trail.
- 15. However, I must say that my receiving receipts, listing and writing up amounts and dates of travel and other costs is **not** ideal nor efficient use of my time and I would like to make a point that we need to utilise Kelly's skills offered to make this a better, effective and efficient process for all of us. Again this is why I have asked for admin support for many months, so I and all of us can get on with our high-level goals with an efficiently running dayto-day trust behind and around us.
- 16. To put some shape to this process, I ask **Kelly** that she please design a basic NRNWTB Reimbursement Claim Form for us to use, including all the key information so that it can be entered into Xero accounting and can also be reconciled with GST returns etc when we gain access to those platforms.
- **17.** When we have that in place, I ask for further claims for reimbursement from yourselves, with receipts be provided to Kelly cc to us in the claim form she will design. For transparency's sake, of course these will have to be collated, reconciled and considered by us as a Board and approved for payment by us, so that we leave a clear accounting trail. And when I ask for trustees to please log in to Kiwibank and co-approve payments, please can you make it a priority, because when I log in, create and authorise a payment if another co-signatory trustee does **not** log in and co-authorise payment, it lapses after a few days and when that has happened, I have had to log in again and re-create the payment. This is again inefficient use of my and all of our time.

Legal Compliance & Communications: Transfer of usernames, codes, passwords, Trust website, Trust facebook page, IRD, Xero, Charities Services

- 18. I have passed on the emails received from Hillarey McGregor in respect of the handover of codes and passwords to us, so that we can use our accounting package, comply with government regulations and communicate with the uri o Aotea. I have some concerns that the IRD letters I have seen from April mention arrears and penalty fines and I had been led to understand by Hillarey and through her from Ngaire Pera that those tax matters had been dealt with.
- 19. We are having some challenges in gaining access to information and systems and I thank Kelly for following through to get access for us so we can operate lawfully, transparently, accountably and in respect of online presence, that we can update and upgrade our website/faceache page and panui the upcoming hui etc, provide updated agreed registration forms which people can use – and generally to inform and empower the Ngati Rehua uri o Aotea.

INTRODUCTION - Ngāti Rehua-Ngātiwai ki Aotea Trust: Engagement, Capacity Grant and ongoing relationship

Rehua, of Mataahu of Te Kawerau and his wife Te Kura, was born at Whangaparaoa in the Mahurangi. Rehua married Hinurere of Ngati Manaia and their son was Te Rangituangahuru.²

In seventeenth century, the '*take*' that took Rehua to Aotea was related to avenging the death of Te Whaiti's daughter, Te Koro, killed by Ngati Te Hauwhenua, who were the resident Ngati Tai hapu in the northern part of Aotea. Te Whaiti sought the assistance of whanaunga Rehua and Hinuere. The battle was successful and many landmarks now carry the name of this battle e.g. Te rangi I whakaea te matenga o Te Koro, "the day that the death of Te Koro was avenged". As a result, Rehua extinguished the rights of Ngati Hauwhenua forever. 2

Following this battle, to arrange lasting peace, marriages were arranged. Mataa, Ngati Taimanawaiti, *tomoed* his sister Waipahihi as a wife for Rehua. Taipikingarangi the leading rangatira of Ngati Te Wharau *tomoed* his daughter Rangiarua as a wife for Rehua's son Te Rangituangahuru. Thus, the two remaining hapu of Ngati Tai were united in peace with the Ngati Rehua and Ngati Manaia invaders. It is from this union that the Ngati Rehua – Ngatiwai ki Aotea people descend.

Trust

The Ngati Rehua Ngatiwai ki Aotea Trust ("Trust") is a Charitable Trust and operates in accordance with a Trust Deed dated 11 September 1985. Its objects include working for the betterment of the Ngati Rehua – Ngatiwai ki Aotea people (see [2(c), (j) and (k)]). The Trust is also the body recognised by Auckland City and Te Papa Aatwhai as the entity holding mana whenua and mana moana for Aotea and its surrounding islands and environs and the entity to be engaged with on all matters within this rohe. It undertakes work in this regard.

Recent Background

Certain beneficiaries of the Trust issued High Court proceedings against the Trust itself and former trustees Nicola MacDonald, Yvonne Wiki, Catherine Munro and Rodney Ngawaka. Further claims were brought during those High Court proceedings in concerning allegations of a lack of transparency and accountability afforded to the people of Aotea₃ and terms upon which the recently proposed Deed of Settlement with the Crown was negotiated.

Following a raft of High Court hearings, the former trustees Nicola MacDonald, Yvonne Wiki, Catherine Munro, Kris MacDonald and Rodney Ngawaka were removed as trustees, but without the Court having made any findings on the substantive allegations. Instead the Court called for nominations of interim trustees from both parties to the case. On 18 December, 2018, the court ordered that the Trust is comprised of five interim trustees, Aperahama Edwards, Valmaine Toki, Hillarey McGregor and William (Bruce) Davies, appointed by Justice Palmer. In addition, he appointed as an interim trustee an Independent Interim Chair, and Counsel assisting the court, barrister, Tu'inukutavake Afeaki.4 The current trustees are interim trustees and are tasked with the day to day operations of the Trust and also have until June 2020 to hold an Annual General Meeting and facilitate trustee elections. The Court has also directed that both parties to the litigation form a combined validation committee of kaumatua (comprised of people from both parties to the case) to consider the registrations of beneficiaries for the Trust's beneficiary database roll. Hillarey McGregor has since resigned as a trustee due to whanau committeents. The High Court is considering submissions from the parties on nominations for appointment of a replacement interim trustee for Ms McGregor. 3

The Court has in effect adjourned the substantive allegations of the case while it has directed the work for the interim trustees to represent the Trust, facilitate and carry out the day to day operations of the Trust and importantly also, to carry out the reviews and regularisation of the database with an end goal of the combined validation committee process and an AGM with elections, so that when this has been done, duly elected trustees may take over and carry out the work of the Trust for the beneficiaries. We have held 14 Trust Board Hui so far this year, with three of them on marae on Aotea. We have a series of further hui planned and tentativly timetabled over the coming quarter and beyond if necessary and we look forward to continuing to progress with our capacity-building and developing wider engagement within Ngāti Rehua-Ngātiwai ki Aotea uri and with Te Waka Anga Mua, so that we may properly advance the beneficiaries' long term interests.

Introduction to the deliverables report

The Trust had previously entered into a signed contractual agreement with the Auckland City Council Te Waka Anga Mua to develop, support, strengthen and build capacity of the Trust. Rather than vary the existing contract a letter of agreement for the term ending June 30, 2019, was signed between the Trust and Auckland City Council. The Trust would like to acknowledge the assistance from Te Waka Anga Mua to reach this stage that will enable our Trust to re-engage with Auckland City Council, develop relationships with council and stakeholders, also establish administrative support and build internal capacity.

Overview of activities

We acknowledge that the existing deliverables from the current capacity building contract will be placed on hold and consistent with the letter of agreement the following objectives have been identified to take place prior to 30 June, 2019.

1. To undertake a governance reset

2. The reset is to include re-engaging with Auckland City (at both governance and operational level)

3. Understand the Council landscape

4. Administrative support
