Report of the NMSSAR Historian (Received by e-mail from Teddy Adams, 2012 Historian) "The state historian is an on-going job. I have not received any information from any of the chapter historians."

Combined Americanism and Education Committee Report and Color Guard Committee Report (Received by various e-mails from George Garcia, Commander of the Color Guard and Head of the Americanism and Education Committee)

On January 6th, we presented the Colors at the Rotunda in Santa Fe with Governor Susana Martinez. On February during our state Convention, we presented the Colors in Las Cruces. On April 11th, I presented a speech to the students at Freedom High School here in Albuquerque. That same night, my spouse and I were invited to make a presentation in Santa Fe by the Military Orders of the World Wars .Both of my presentations were on Captain General Don Bernado de Galvez and his great Spanish Contribution to the American Revolution. The teachers and students plus all the members present in Santa Fe were not aware of what took place back in 1777 through 1783. During May, quite a few of our SAR compatriots took part presenting Awards and Certificates to UNM and NM High Schools around NM. On June 9th, Albuquerque & Santa Fe SAR Color Guard Chapters presented Colors, which we do every year for the Massing of Flags, sponsored by the Military Orders of the World Wars. On June 23rd, compatriot Adams and I, presented the Colors for the NM Purple Heart Veterans of NM. Then our fellow compatriots were in Phoenix, AZ, for our National Convention.

On September 22, 2012, our Albuquerque Chapter, was invited to make a presentation of our NSSAR organization at the Mormon Church located at Mc Mann and 7 Bar Loop. Compatriot Robinson talked about who we are and what we represent;, Compatriot Rael talked about Genealogy and Compatriot Garcia talked about the Spanish Contribution to the American Revolution with aids of SAR Photos, Presidio Soldiers Poster and SAR pamphlets.

Invited to a Kirtland AFB National Hispanic Breakfast where I presented information on the Spanish Contribution to the American Revolution In attendance was NMAIR National Guard Brigadier General Judy M. Griego, the first Spanish female General in the National Air Guard .SAR Color Guard photos of past events were presented and seen by many of the 150 people were present on September 25.2012. On October 10,2012, I was invited to speak to an assembly of Acoma Elementary Students wearing my uniform explaining the Spanish Contribution to the American Revolution and our ancestors contribution with money and Captain General Don Bernado De Galvez Y Madrid whose soldiers and sailors died and sacrificed defeating the English forces during the American Revolution in many battles along the Gulf Coast. On October 15,2012, I was invited in uniform to inform and make a presentation to all grades at St. Charles Borromero. Approx 300 students attended I talked about the NSSAR what we do and about the Spanish Contribution to the American Revolution. SAR Color Guard photos were posted for viewing Compatriot Robinson and I presented Ford Dealership a certificate awarded for flying the American Flag every day and night. On November 12, a day after Veterans Day, Don Chambers Ford invited us, the ALB Chapter to a BBQ on Veterans Day, in which we spoke about the NSSAR and the NM involvement during the American Revolution. Compatriots Adams, Robinson, Real, and Garcia were in attendance - Adams and Garcia in our Presidio uniforms. Immediately afterwards, Belinda and I were invited to speak at the Bernalillo Vietnam Memorial. Approximately 250 people were present. I spoke about replica of the Presidio Spanish uniform that I was wearing and about the NMSSAR here in our state. I was asked to return on Memorial Day 2013.

The NMSSAR Color Guard, under the leadership of Compatriot George Garcia, was well-represented. NMSSAR spouses and friends staffed the Ladies' program. Compatriot Gene Tomlinson headed the Registration and Credentials Committee. Many NM attendees received the Samuel Adams Congress Appreciation Medal for their hard work. Well done to all the participants; particularly Congress Credentials Chairman Gene Tomlinson, Teddy Adams who served as a Day Captain, Perkins and Patricia Patton who raffled a wall hanging Patricia created, Jim Thornton who was sworn in as Rocky Mountain District Vice President General, and George Garcia's NMSSAR Color Guard and participating members!

Well done to David Lee Harris, Gene Tomlinson, Sam Baty, George Garcia, as well as to William Baker, NMSSAR webmaster, and all individuals who have submitted materials to the Newsletter and the website!

Find volunteer(s) for the positions of State Treasurer and State Secretary: We thank Ray Alexander for his years of service as State Secretary. In November, 2011, Ray received the state's highest award for his exceptional performance of NMSSAR State Secretary duties: the State Medal of Distinguished Service. For the year 2012, Ray agreed to stay on as Secretary for one additional year to provide his skills and experience for the upcoming Congress. Ray Alexander deserves our sincere thanks for his tireless efforts. John Farris, State Treasurer, has served for most of this decade in the job as State Treasurer – designing and managing the statements and budget for the Society. We thank John Farris for his service and are pleased to award him shortly with the State's Meritorious Service Medal for his hard work. The 2012 NMSSAR Nomination Committee nominated Compatriot Phil Blumenthal as their replacement.

Update the NMSSAR history: NMSSAR is older than the State of New Mexico. The New Mexico Society was founded in 1908. An effort was made in 2008 to publish the Centennial History of NMSSAR. NMS-SAR will continue to give publishing our centennial edition priority attention.

Revisit the NMSSAR Handbook, Constitution, and By-Laws. Under the leadership of First Vice President Mike Barger, Mike and colleagues have revisited, reviewed, and tweaked these documents where necessary. The revised document is ready for approval by NMSSAR. Well done, Mike, and assisting colleagues.
