ONE clergy or lay person to be elected to a 1-year term

Jerome Laurent – St. Luke's, Whitewater

Jerry Laurent, St. Luke's, Whitewater, has been a Lay Deputy to the Diocesan Convention since 1968, with the exception of 2014. In addition, he was a member of the Trustees of Funds and Property (now Trustees of Funds and Endowments, Inc.), 1983-1992, and President, 1991-1992. He was re-elected and served from 2004-2010; and 2012 - present; he served as President 1991-1992.

In addition to his service on the Trustees of Funds and Endowment, Jerry has been a delegate in years past on the Diocesan Commission on Ministry in Higher Education, the Central Diocesan Convocation and the former Southwest Deanery.
