MEMBER UPDATE

American Saxophone Quartet to premiere major work by Bob Mintzer

The American Saxophone Quartet will give the first performance of *Rhythm of the Americas: Music for Saxophone Quartet and Orchestra*, a new four-movement work composed by Bob Mintzer, in a week-long engagement with the National Symphony Orchestra conducted by Leonard Slatkin at the Kennedy Center in Washington DC. The premiere performance will take place on January 24, with subsequent performances on the January 25 and 26.

The American Saxophone Quartet is based in New York City. Its members are Albert Regni, soprano saxophone; David Demsey, alto saxophone, David Carroll, tenor saxophone; and Lino Gomez, baritone saxophone. Mintzer is best known as a multi-instrumentalist, leader of his own large jazz ensemble, member of the group Yellowjackets, and is one of the most in-demand big-band composers. He has composed several large-scale works for European jazz orchestras, and Slatkin was attracted to the project by this crossover connection.

The Quartet has just released a new CD, *The Clarinet Commission Project*, containing works for saxophone quartet and clarinet featuring soloists Larry Combs of the Chicago Symphony, Paquito D'Rivera and Ron Odrich with first performances of new works by D'Rivera,

Bernard Hoffer, Michael Holober and Gabriel Senanes. They recently presented a program at Weill Recital at Carnegie Hall in New York City on October 14, featuring music from that CD, the Glazounov Saxophone Quartet and the New York premiere of *Blow!* by Perry Goldstein.

Pardus wins commission for sax/MIDI piece

The New Hampshire Music Teachers' Association (NHMTA) has announced the recipient of the 2001 New Hampshire Commissioned Composers award is William D. Pardus, Professor Emeritus of Music of Keene State College. Pardus is commissioned to compose a work for saxophone and MIDI (electronic sounds) which will be premiered on October 20 in the recital hall of the Redfern Arts Center on Brickyard Pond. The premiere of the composition, *Dreams and Realities*, will be performed by Dr. Craig Sylvern, Assistant Professor of Music at KSC with accompaniment engineering done by Prof. Pardus. After the premiere, the work will be sent to the Music Teachers' National Association's competition in Cincinnati and it will also be published.

The piece is written for tenor saxophone and CD accompaniment, but the published version will include an alto sax part, with the necessary tessitura adjustments.

- 2. All contestants must be current members of the North American Saxophone Alliance (NASA).
- 3. Contestants who are not current members of NASA must include the appropriate membership fee with the competition application form to be eligible for this competition.

- 2. Preliminary and final rounds of the Classical Saxophone Performance Competition will be held March 6-9, 2002, in conjunction with the Biennial Conference of the North American Saxophone Alliance at the University of North Texas, Denton, Texas.
- 3. Contestants may perform on soprano, alto, tenor, baritone, or any combination of these saxophones during the competition.
- 4. Contestants must submit an entry fee of \$35. All payments must be in the form of a certified check, money order, or bank draft payable to North American Saxophone Alliance. NO PERSONAL CHECKS WILL BE ACCEPTED.
- 5. Contestants may also enter the Jazz Improvisation Performance Competition, but they must submit an entry fee of \$35 for each category entered. A separate application and entry fee must be submitted for the jazz competition.

- 6. The contestant's birth date must be verified by including a photocopy of the contestant's driver's license, birth certificate, or passport with the application form.
- 7. All fees and dues are non-refundable.
- 8. All expenses, including lodging and transportation to and from the competition, are the sole responsibility of the contestants.
- 9. A minimum of 15 entries is required to hold this competition. Entry fees will be refunded if the competition is cancelled.

Special Guidelines

The Preliminary Round

- 1. Contestants are expected to perform ten minutes of music of their own choice that demonstrates contrasting styles. One work may be unaccompanied; however, the remainder of the round must be with piano accompaniment. Selections demonstrating both technical and lyrical playing are recommended.
- 2. An accompanist will be available upon request for an additional fee.

The Final Round

- 1. Five finalists will be selected to perform in the final round of the Classical Saxophone Performance Competition.
- 2. Finalists are expected to perform 25 minutes of music of contrasting styles of their own choice. One work may be unaccompanied; the others must be with piano accompaniment. Music from the first round may not be repeated in this round.
- 3. An accompanist will be available upon request for an additional fee

Judging

- 1. Preliminaries: Three professional musicians will serve as judges. Judges reserve the right not to name a finalist in this competition.
- 2. Finals: Three professional musicians will serve as judges. Judging will be based solely on the live performance of that round. Judges reserve the right not to name a winner in this competition.

- 2. The final round of the Jazz Saxophone Performance Competition will be held March 6-9, 2002 in conjunction with the 2002 Biennial Conference of the North American Saxophone Alliance at the University of North Texas, Denton, Texas.
- 3. Contestants may perform on soprano, alto, tenor, baritone, or any combination of these saxophones during the competition.
- 4. Contestants may enter one or both competition categories, but they must submit an entry fee of \$35.00 (US) for each category entered. All payments must be in the form of a certified check, bank draft, or postal money order. NO PERSONAL CHECKS WILL BE ACCEPTED.
- 5. The contestant's birth date must be verified by including a photocopy of the contestant's driver's license or birth certificate with the application form.
- 6. All fees and dues are non-returnable.
- 7. All expenses, including transportation to and from the competition, and lodging, are the sole responsibility of the contestants.

Special Guidelines

The Audition Tape, Preliminary Round

1. The audition tapes or CDs must contain a performance of the

Horace Silver composition *Nica's Dream* and soloing on two (2) other tunes of contrasting styles such as blues, ballad, Latin, jazzrock, samba, or waltz, etc.

- 2. Solos should be recorded with rhythm section, a big band, or one of the "Music Minus One" jazz aids.
- 3. The audition tapes or CDs must be 15-20 minutes in length.
- 4. CDs may not have any edits or professional mastering. Tapes must be professional-quality cassette format, recorded at normal cassette speed (1-7/8 ips). The tapes must be marked appropriately with an indication of "normal," "chrome," or "metal" tape bias and indicate with or without Dolby noise reduction (dbx encoding is unacceptable). No tape editing (splicing) is permitted. If the solo is part of a larger work (i.e. for big band, live performance of a small group, etc.), tape may be faded in for the contestant's solo and faded out at the conclusion of the solo as long as a proper leadin and out is provided. No spoken words or verbal comments may occur on the tape, unless the musical composition itself requires vocal sounds.
- 5. Contestants will submit three (3) identical cassette tapes or CDs. The name and address of the contestant as well as the titles of the compositions on the tape must be written on the cassette or CD as well as the cassette or CD container.

The Final Round

- 1. Up to Five (5) finalists will be selected to perform in the final round of the Jazz Improvisation Performance Competition. Judges reserve the right not to name any finalist.
- 2. Contestants are expected to perform 20 minutes of music with contrasting styles of jazz improvisation. The final round will include a performance of *Nica's Dream* and other selections demonstrating contrasting styles such as blues, ballad, Latin, jazz-rock, samba, waltz, or eclectic.
- 3. Finalists must perform with a live rhythm section during the final round. Contestants may bring a rhythm section to the competition, or a professional rhythm section will be available upon request for an additional fee.

Judges

- 1. Preliminaries: Three (3) professional jazz musicians will serve as judges. Judges reserve the right not to name a finalist in this competition.
- 2. Finals: Three (3) professional jazz musicians will serve as judges. Judging will be based solely on the live performance of that round. Judges reserve the right not to name a winner in this competition. A minimum of 15 entries is required to hold this competition. Entry fees will be refunded if competition is cancelled.
