To become a Notary Public in the State of Washington you will need to personally create your notary profile online with the Notary Section at the Department of Licensing's Notary website www.dol.wa.gov/business/notary as well as purchase a notary surety bond.

#### Obtaining your bond from us and your license directly with the state:

- 1. Complete the enclosed Bond Application/ Declaration of Applicant page.
- 2. Complete the enclosed order form. This is where you order your required new notary bond as well as supplies and optional insurance.
- 3. Send these two pages to our office with the payment method of your choice.
  - Once we receive your request we will write your bond and send it to you via email.
- 4. Go to the Department of Licensing's Notary Section website https://www.dol.wa.gov/business/notary where, if you have not done so already, you will create your notary profile through the SecureAccess Washington (SAW) account. (Please allow half an hour for this step.)
  - Once you have established your profile, file your signed notary bond and notarized application.
  - Remember to print your notary license. We need a copy of it to manufacture and legally release your stamp.
- 5. If you have pre-ordered your supplies simply send us a copy of your notary license via email at license@ansofwa.net or fax 425-271-6396.
  - If you didn't pre-order your supplies you can order them at this time.

Should you not want to electronically file the new bond yourself we can accommodate you by paper processing your commission with the State of Washington's Notary Section for an additional \$10. Please keep in mind that paper processing can take up to six weeks and requires different paperwork. Call our office and we will email you that information.


