The service is required for a period of twenty-four (24) months. Only qualifying suppliers will be pre-selected and invited for a closed tender. The required service for this tender will include the following:

- Diesel 50ppm
- 23 000 L Diesel Tank
- ❖ Fuel Management System ("FMS") that guards against theft

To express interest, each potential supplier will be required to submit the following documentation (mandatory):

- Letter of Good Standing with the Nature of Business relating to Supply of Fuel
- Section 37 (2) Contractors Agreement
- ❖ Valid Tax Clearance Certificate
- Original VAT Certificate (if applicable)

2. Technical/Operational Requirements

- The FMS must at minimum offer the following functions (FMS profile document must be provided):
 - Tag allocation per operator and vehicle
 - Report on hours and kilometers on machine at each point of refueling
 - Report Fuel usage from each vehicle
 - Stock control Fuel Level Notification to both Fraser and Supplier

3. Safety

The Suppliers is required to comply to the following:

- National Road Traffic Act, 1996 (Act No. 93 of 1996)
- Transportation of Hazardous Materials



- SANS 10087-2: The handling, storage, distribution and maintenance of liquefied petroleum gas in domestic, commercial, and industrial installations Part 2: Installation of LPG systems in mobile units, including but not limited to caravans, motor homes, park homes and mobile kitchens
- SANS 10087-4: The handling, storage, distribution and maintenance of liquefied petroleum gas in domestic, commercial and
 industrial installations Part 4: The transportation of LP gas including the design, construction, inspection, fittings, filling,
 maintenance and repair of LP gas bulk vehicles and rail tank cars
- SANS 1398: Road tank vehicles for petroleum-based flammable liquids.

4. Value-Add

Suppliers are also encouraged to provide value added benefits above what has been requested.

Fraser Alexander will only consider Suppliers that adhere to the following:

- Minimum BBEE Level: 4
- Compliance to the above-mentioned requirements
- Submission of all required documentation

Where the Supplier fails to meet the above, the bid will be considered unacceptable and may be automatically disqualified from the formal closed tender.
