#### IN MEMORIAM -

#### Marian Sue Glattauer Dudley, OTR, FAOTA.

Occupational therapy in the state of Florida recently lost a champion for excellence. Suze Dudley passed away from an extended illness on April 5<sup>th</sup>, 2010, surrounded by her family. Suze's contribution to the education of OT Practitioners was legendary. She served as tenured faculty at FIU for many years, before leaving to develop the educational program at Nova Southeastern University. She was known to tackle new projects and to push the boundaries of education. Along with Diane Ward, Suze developed the software

'Fieldwork Clerk' which continues to be used by educational programs to schedule fieldwork. A team player, Suze is fondly remembered by her past students as one who would go the extra mile for them.

Her lifetime of service within FOTA and AOTA contributed greatly to the OT profession in Florida.

In 1987, Suze was awarded a Fellow of the American Occupational Therapy Assn in recognition of her service. The idea to coordinate and the implementation of the Great Southern Occupational Ther-

apy Conference (GSOTC) with others is one of her legacies. This originally was planned as the Southern OT Conference that would be located in a southern city and no-one involved with the initial planning knew the success that this event her life and easy death. Now... she belongs to became. Suze was the person that worked behind the landscape; whether it was the educational program, organizing speakers, formatting a schedule. Her hours behind the scenes were

many and contributed to the success of this event.

Within FOTA, Suze held many offices and was well respected as President. She mentored new Presidents and other leaders as they worked for FOTA. Her support of FOTA saw her spending many hours and years of involvement and leadership to her State Assn. Suze was awarded an Honorary FOTA membership for her contribution to FOTA some years ago. Even in 2009, shortly after becoming ill, Suze was still working on behalf of FOTA. As President, I needed some advice on information

needed for a Committee task. Reaching out to Suze was easy and within days, I had the information I needed for FOTA - she always had the time to assist or comment whether she knew you or not... the fact is if you were working on behalf of FOTA, then that was all she needed to hear!.

So, as we all remember Suze Dudley, let us remember her husband Bob, her children and grandchildren. But let us also remember her legacy. As Bob wrote on April 5<sup>th</sup>, 2010:

"Suze went to heaven today at 9:20am. She died peacefully in her sleep. Her last thoughts were about you and the good

times you shared with her. Suze's life enriched us all. Think about her often, when you see a sunrise, a sunset, a rainbow, a clown and brightly colored balloons. God blessed us with the Ages"

### OT Meets with Florida Governor

Fellow FOTA members,

I recently had the unique opportunity to speak with our Governor Crist at a reception on February 28th 2010. Even though this was an informal small gathering, I thought it was an opportune time to bend his ear about issues related to OT. In the short time we spoke, we discussed the Medicare therapy cap exceptions process and how this impacts our practice. Another important issue I brought to him was that PT was opening up their practice act to expand their role to include some of the areas that are traditionally within OT's expertise. This gave me a wonderful opportunity to educate him as to what OT does and the unique abilities that we possess. This conversation was about 5 minutes long (a lifetime

for a one-to-one conversation with a politician). He stated that he would keep this in mind and I referred him to the Florida OT advisory board (that he appoints) or myself if he had further questions. I followed up this discussion with a phone call to Gov. Crist's office the following Tuesday morning (March 2<sup>nd</sup>). As coincidence would have it. his office informed me about some very good news. The good news was that **President Obama signed** the Temporary Extension Act of 2010 (HR 4691) into law. The main function of this act is to suspend the 21.2% reduction in payments to providers under the Medicare physician fee schedule. Another provision included in this act is that it reinstates the therapy cap exceptions process until March 31, 2010. It is still under inter-

pretation if the exceptions process is retroactive to the first of the year however. In the next coming months I plan to keep calling Gov. Crist's office about our causes with the hopes of his office listening in this primary election year for Florida's Republican Senate nomination. This hotly contested race may give us a unique opportunity to get our voices heard on many issues including maintaining the Medicare cap exception or to abolish the cap all together. Physical Therapy has filed a bill in the Senate to update their practice act. However this bill is not moving this session. The senate is not spending any time on it because there is not a companion bill in the house.

Also during the FOTA Day at

the Capitol FOTA representatives of FOTA and FAMU students were recognized in the Gallery of the Senate by Senator Peaden. So Tallahassee definitely knows more about OT than they did before. So again I ask, where were you?

It was an awesome opportunity to impact the legislative process in support of the profession of Occupational Therapy.

### News from the Capitol:

This is a brief update on key Medicaid issues moving in the Legislature this session:

Medicaid Reform. The House Health and Family Services Policy Council approved the filing of a committee bill which was referred to the House Health Care Appropriations Committee. This committee is scheduled to meet one week from tomorrow (Tuesday, April 6) and this bill could be heard at that time. This is the bill that would change the current policy of assigning most Medicaid patients who don't voluntarily choose a health care plan to Medicaid HMOs. Under this bill (see attached) AHCA would instead assign 65% of Medicaid patients who refuse to choose a health care option to "medical homes". The bill would not only establish medical homes as the model for Medicaid, but also would direct the State Department of Management Services to establish a medical home model for the State Group Health Plan. On the Senate side, the companion bill has been referred to the Health Regulation Committee and is co-sponsored by Senator Gaetz, who chairs the committee. That committee meets next Wednesday afternoon, however, the agenda will not be available until this Friday.

Medicaid Behavioral Health Services. SB 476 requires the funds returned to the Agency for Health Care Administration (Agency) from behavioral health plans that do not spend at least 80 percent of their capitation rate on behavioral health care services, as required by law, must be deposited in the Medical Care Trust Fund and reallocated to the community behavioral health providers in the network of the plan making repayments. Providers must use the funds for any Medicaid-allowable type of community behavioral health and case management service. This bill has cleared two committees in the Senate and its companion bill (HB 583 is in the House Health Care Appropriations Committee that will be meeting next Tuesday.

<u>Health Care Fraud.</u> SB 752 by Senator Gaetz is a clean-up bill to soften some unintended consequences of SB 1986 that passed in 2009 and put licensees who committed felonies many years ago in jeopardy of losing their license even though they subsequently paid their penalty and have now become productive, law-abiding citizens. The bill has cleared on committee and is now in the Senate Criminal Justice Committee. HB 7069, a similar bill dealing with background screening of health care providers has already passed the House and is Messages in

<u>Medicaid Home and Community-based Services.</u> SB 1468 reduces the annual maximum expenditure to each client assigned to the Agency for Persons With Disabilities and establishes a budget program for delivery of home and community-based services. The bill expects to save \$25 million/ year. HB 5303, the companion bill, and SB 1468 are both moving quickly through their assigned committees.

**FOCUS Trivia QUESTION:** What's the difference between a capital and a capitol? The word capitol is used to refer to the building where a legislature (such as the U.S. Senate and House of Representatives) meets while the word capital refers to the city which serves as the seat of government.
