Approve the new regular status CTE capstone course outline for Lakewood High School's DMAC pathway, entitled *Advanced Media Production*. The new course outline reflects the Linked Learning guiding principles and the LBUSD Strategic Plan's goals and objectives. Students will research, develop, and produce project plans to promote original media productions and online presence that will be marketed and distributed to the school, community, and festivals. The Assistant Superintendent for OCIPD and the Assistant Superintendent of High Schools have reviewed the course outline and support implementation of this curriculum.

Approve the new regular status CTE concentration course outline for Poly's MEDS pathway, entitled *Business Technology for Medical Occupations*. The new course outline reflects the Linked Learning guiding principles and the LBUSD Strategic Plan's goals and objectives. This course is designed to bring students to a basic level of proficiency in applying business technology in the medical office setting. The Assistant Superintendent for OCIPD and the Assistant Superintendent of High Schools have reviewed the course outline and support implementation of this curriculum.

4. APPROVE NEW HIGH SCHOOL CAREER TECHNICAL EDUCATION (CTE) COURSE OUTLINE – FINANCIAL SERVICE AND ACCOUNTING (NAF)

Approve the new regular status CTE concentration course outline for Millikan High School's MBA/NAF pathway, entitled *Financial Services and Accounting (NAF)*. The new course outline reflects the Linked Learning guiding principles and the LBUSD Strategic Plan's goals and objectives. This course provides students with an overview of banks and other financial services companies, and an understanding of the critical accounting process and how it facilitates decision making by providing data and information to internal and external stakeholders. The Assistant Superintendent for OCIPD and the Assistant Superintendent of High Schools have reviewed the course outline and support implementation of this curriculum.

TRANSLATION; INTRODUCTION TO ENGLISH/SPANISH MEDICAL
INTERPRETATION AND TRANSLATION

Approve the new regular status World Language course outlines for Wilson High School, entitled Introduction to English/Spanish Legal Interpretation and Translation and Introduction to

English/Spanish Medical Interpretation and Translation. The new course outlines reflect the Linked Learning guiding principles and the LBUSD Strategic Plan's goals and objectives. These are introductory level courses that will provide (English/Spanish) bilingual, biliterate students the vocabulary knowledge and bilingual interpretation and translation skills needed to be able to work as an interpreter/translator in various legal and medical settings. #### Delegating Employee Travel Authorization to the Superintendent

The Board of Education of the Long Beach Unified School District hereby delegates to the Superintendent of Schools, or his/her designees, the authority to authorize travel for employees (excluding members of the Personnel Commission) in accordance with the Education Code and District guidelines and administrative regulations.

It is the policy of the Board to pay all actual and necessary expenses, including mileage and travel expenses, incurred by any employee of the District in the course of performing authorized services for the District at the direct request of the Board of Education or the Superintendent of Schools, or his/her designees.

The governing board of any school district may provide for the reimbursement of employees of the district for the use of automobiles owned by the employees and used in the performance of regularly assigned duties, by establishing allowance for such use on a mileage or monthly basis.

The Superintendent, or his/her designees, shall approve employee-initiated requests, or requests made on behalf of employees by their superiors, for travel, meetings and conferences within the financial limitations set forth by the annually adopted budget and by the Board-approved regulations and guidelines for employee travel. Any reimbursement for expenses incurred in attendance at meetings, conferences, and workshops shall be determined on an individual basis by the funding budget administrator and the divisional administrator in accordance with Board-approved administrative regulations. All claims for travel expenses will be subject to review and adjustment by the funding budget administrator, the Superintendent of Schools and the Board of Education if they are not in conformance with the Board-approved regulations and guidelines for travel.

All travel requests by Personnel Commission employees (excluding Commission members) shall have prior approval of the Commission in accordance with Commission-adopted rules for Commission employee travel.

**WHEREAS**, Proposition 55 would extend Proposition 30's temporary income tax rates for an additional 12 years, to continue funding the Education Protection Account and boost spending on health care for low income families; and

**WHEREAS**, unless Californians extend Proposition 30's temporary tax increases, the state's schools would likely receive relatively fewer dollars in the years ahead, raising the prospect that California's school spending will fall even further behind the nation; and

**WHEREAS**, The Long Beach Unified School District has invested resources in supporting our students and closing the achievement gap with college and career readiness programs, classroom interventions, increased access to technology, parental involvement programs, and professional development for all staff;

**BE IT RESOLVED** that the Long Beach Unified School District Governing Board joins school districts and community college districts around the state in supporting Proposition 55 and in urging the Legislature to work with the public education community to identify stable, long-term, adequate funding solutions for public schools and community colleges; and

**BE IT FURTHER RESOLVED** that this body, the Long Beach Unified School District, supports the passage of Proposition 55 because it provides needed revenue to public schools and will specifically benefit this district for the reasons described herein.
