1. Q. General Provision, 22, Use and Possession Prior to Final System Acceptance, appears to leave the risk of loss for the work with the Contractor even after the Board takes possession of the work. Builders' Risk and Installation Floater coverage ends once the work is put to its intended use and when the owner takes possession of the work. It is not equitable to give the risk of loss to a party which is unable to insure said risk. We request the last sentence be replaced with the following, "Contractor's risk of loss shall end upon Board's possession, use, or acceptance of any portion of Work."
  - A. Board's possession of the work shall occur at final system testing, acceptance and commissioning, not at Bidder delivery. Bidder shall be fully responsible for all loss prior to Final Acceptance and Commissioning by the Board.
  
2. Q. General Provision, 46, Insurance, B (1), states Contractor's deductibles must be satisfactory to the Board. Contractor deductibles are Contractor's sole financial responsibility and should be left to Contractor's discretion. Please remove the word "deductible" from line three.
  - A. Disregard references to Phase 1 or Phase 2. Correction Period begins on date of Final System Acceptance.
  
3. Q. Please clarify the breakdown of work in Phase and Phase 2 as noted in the General Provisions Page 6 & 7 paragraph A, and on page 27 Number 43 "Additional Bond security" paragraph B.
  - A. Disregard references to Phase 1 or Phase 2. Performance & Payment Bond shall be in the amount of 100% of the amount of the Bid.
  
4. Q. General Provision, 46, Insurance, B (3) requires all policies include the named entities as Additional Insureds. Additional insured status is not commercially available on workers compensation and professional liability insurance policies. Please insert, "except for workers compensation and professional liability insurance" after "All policies" and before "shall designate".
  - A. This clause contains Board Approved boiler plate language. The Board's Risk Management Department exempts Professional Liability Insurance and Workers Compensation Insurance from the additional insured requirement.
  
5. Q. General Provision, 46, Insurance, B (5) Contractor deductibles are Contractor's sole financial responsibility and should be left to Contractor's discretion. Please delete the last sentence of this paragraph.

As such, Contractor will be unable to secure Professional Liability insurance. Will the Board accept Contractor's Protective Professional Indemnity (CPPI) coverage to fulfill this requirement?
