

## A Ballot Question Results Tell A Story

The fact that on Tuesday Massachusetts became the third state in the nation to guarantee paid sick days for workers, it finds itself juxtaposed against the result of Question 1 with voters rejecting the automatic indexing of the gas tax.

Essentially, the anti-Casino and pro-Bottle Bill initiatives became a battle of the well funded, media blitzing vested interests versus the under-funded, grass roots activists, where money won out. In contrast, the gas tax and sick leave initiatives were battles waged based on key public policy concerns. On the one

## Good Veteran's Day News to Report/ Harry Reid Lost His Gavel

This being South Boston Today's pre Veterans Day edition, we take great pleasure in the good news reported last weekend regarding the release of one of America's decorated war heroes: Andrew Tahmooressi – United State Marine Corps. As our readers are well aware, he wasn't being held by the Taliban in Afghanistan where he served with honor, 2 tours of duty in combat. ## Window Into The State House

Window Into The State House provides our readers a synopsis of important issues of interest, past and current, that are being proposed, debated or acted upon by the Massachusetts Legislature. Many issues that are not related to local city government services are acted upon and have a direct impact on daily life. They are tax policy, transportation infrastructure, judicial appointments, social services and health, as well as higher education. We will excerpt reports from the gavel-to-gavel coverage of House and Senate sessions by news sources focused on this important aspect of our lives. These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

### MA Republicans Grab Moore, Murray Senate Seats

Two Massachusetts House members have picked off the Senate seats currently held by Senate President Therese Murray and Senate President Pro Tempore Richard Moore. Moore (D-Uxbridge) lost to Rep. Ryan Fattman (R-Webster), while former Rep. Matt Patrick (D-Falmouth) was bested by Rep. Vinny deMacedo (R-Plymouth) in a race for the seat held by Murray, who opted against seeking reelection. Sen. Stanley Rosenberg (D-Amherst) is expected to take over the Senate presidency in 2015. "At this point, it looks like Dick Moore and Matt Patrick

are the two Senate losses we're looking at right now," said Sen. Thomas McGee, a Lynn Democrat and chair of the state party. McGee said Sen. Jason Lewis (D-Winchester) won reelection over Melrose Republican Monica Medeiros, while former Rep. Barbara L'Italien (D-Andover) kept outgoing Sen. Barry Finegold's seat in blue hands by beating out Selectman Alex Vispoli (R-Andover). Sens. Kathleen O'Connor Ives (D-Newburyport) and Jennifer Flanagan (D-Leominster) also won reelection, McGee said. Democrat Eric Lesser, a former Obama White House aide, declared victory over Republican Debra Boronski

and independent Michael Franco in the race for Sen. Gale Candaras's seat. - Gin Dumcius SHNS

### MA. Economy Grows, But More Slowly

Economic growth in Massachusetts slowed in the third quarter to a 3.2 percent annualized rate, down from 4.8 percent in the second quarter, according to data released Thursday. The U.S. economy grew at an annual rate of 3.5 percent from July through September, marking two consecutive quarters of growth, according to data released by MassBenchmarks, an economic journal published by the UMass Donahue Institute with the Federal Reserve Bank of Boston. Both the state and national economies contracted during the first quarter of 2014. The jobless rate in Massachusetts rose from 5.5 percent in June to 6 percent in September, but the economic journal's authors said the increase "does not signal a weakening labor market" and reflects workers entering or re-entering the labor force because they are "gaining confidence in the economy." The size of the workforce grew by 16,900 people in the third quarter, compared to the second quarter. - M. Norton |

### Gov. Patrick Signs \$86M Spending Bill

Gov. Deval Patrick on Friday signed an \$86 million spending bill, closing the books on fiscal year 2014, giving the Massachusetts Department of Transportation ownership of its headquarters next to the Boston Public Garden, and creating a \$2 million fund to support municipal public works and public health projects. House Republicans had objected to an earlier version of the budget bill that included about \$1.4 million in earmarks for senior centers and infrastructure

projects in Templeton, Hatfield, Hubbardston, Easthampton and Boylston. The new law also funds low-income home heating assistance and more than 70 collective bargaining contracts and provides funds to sheriffs, while reversing a change to the MBTA's funding mechanism made in the fiscal 2015 budget bill passed in July. - A. Metzger/SHNS

### Courts Help MA. Litigants Represent Themselves

Massachusetts court officials say there are a growing number of self-represented litigants in Massachusetts and on Thursday touted a new Boston Court Service Center to address the problem. The center, at the Edward Brooke Courthouse, is led by a manager-attorney who assists people representing themselves by helping them understand legal terms and filing requirements and by offering them access to public computers, interpreter services and connections to city and state services. The center opened in June and has helped 2,200 people so far. Supreme Judicial Court Chief Justice Ralph Gants, Trial Court Chief Justice Paula Carey, and Trial Court Administrator Harry Spence held an event Thursday to promote the center and its work. "As budgets for legal aid have been drastically cut in recent years, more people are representing themselves in court -- from fighting foreclosures and tenant evictions to probate matters involving divorce and child custody issues," Gants said in a statement. A second court service center is up and running in Greenfield. There are plans to add four more centers in the coming year and to have a center in each of the state's 15 largest courthouses in the next three years. - M. Norton/SHNS

The options came down to everyone waiting for the election results and working late to get out the newspaper, or stay with our regular schedule. Considering that by Thursday’s edition the results would already be old news the choice was easy. By now the results have been digested, analyzed and fed back to us with someone else’s spin. It’s probably safe to say the future direction of America was determined. While that is always true to some extent, in my lifetime the country has never seemed so bitterly divided.

Many will point back to Viet-Nam and the unrest caused in America. ## LEGAL NOTICE REQUEST FOR QUALIFICATIONS

The MASSACHUSETTS PORT AUTHORITY (Authority) is soliciting consulting services for **MPA CONTRACT NOS. AP1314-S3 and S4, FY15-16 LOGAN INTERNATIONAL AIRPORT/ SOUTH BOSTON BRIDGE AND TUNNEL INSPECTIONS**. The Authority is seeking qualified consulting firms or teams with proven experience to provide professional services related to the inspection of bridges and tunnels on an on-call, as needed basis. These services are expected to be provided at Massport-owned property in East Boston and South Boston, MA. The Consultant must be able to work closely with the Authority and other interested parties in order to provide such services in a timely and effective manner.

The consultant shall demonstrate experience in bridge and tunnel inspections and have the ability to provide traffic control, prepare bridge inspection reports, and prepare recommendations for maintenance and repair of the structures. The consultant shall also have the ability to prepare cost estimates for any recommended repairs. The work will also include an inventory and inspection of existing roadway sign structures.

The scope of work shall include, but not be limited to the following:

- (1) Review of existing bridge inspection reports and available plans for the structures to be inspected.
- (2) Prepare Traffic Management Plans and submit Lane Closure Requests in advance of the inspections.
- (3) Coordinate with State Police and Massport Operations regarding the necessary access and impacts on travelers during the inspection period.
- (4) Conduct the inspections and complete the Bridge or Tunnel inspection forms with appropriate sketches and photographs to accurately depict the observed field conditions. The work shall also include inspection of all overhead sign structures as assigned by the project manager.
- (5) Prepare and submit the SI&A forms and submit to MassDOT for incorporation into their bridge management system, as appropriate.
- (6) Submit two hard copies and one electronic copy (PDF) of the completed inspection reports with a letter summarizing the recommended maintenance and repairs for the structures.
- (7) Conduct inventory and inspection of roadway sign structures.
- (8) Present periodic summaries of the bridge, tunnel, and sign inspection findings to the Director of Capital Programs.
- (9) Prepare cost estimates and repair sketches for critical areas needing repair, as requested.

The Authority expects to select two consultants. However, the Authority reserves the right to select a different number if it is deemed in its best interest to do so. Each consultant shall be issued a contract in an amount not to exceed Three Hundred Thousand Dollars (\$300,000.). The implementation of these services will be dependent on available funding, but if fully funded, the project is likely to take place over a two year period. The services shall be authorized on a work order basis.

Each submission shall include a Statement of Qualifications that provides detailed information in response to the evaluation criteria set forth below and include Architect/Engineer & Related Services questionnaires SF 330 ([www.gsa.gov/portal/forms/download/116486](http://www.gsa.gov/portal/forms/download/116486)) with the appropriate number of Part IIs. M/WBE Certification of the prime and subconsultants shall be current at the time of submittal and the Consultant shall provide a copy of the M/WBE certification letter from the Supplier Diversity Office, formerly known as State Office of Minority and Women Business Assistance (SOMWBA) within its submittal. The Consultant shall indicate the proposed percentage of M/WBE participation in its qualification package. The Consultant shall also provide an original and nine copies of litigation and legal proceedings information, **signed under the pains and penalties of perjury**, in a separate sealed envelope entitled "Litigation and Legal Proceedings". The submission shall be evaluated on basis of:

hand, spending, tax burden and government accountability considerations brought out the conservative side of the voters, but at the same time, fairness and mutual self interest brought out the liberal side.

This should present an important lesson to elected leaders, especially those from the Democratic Party. As blue as Massachusetts has been painting itself for years, the electorate appears to be informing its elected officials that purple is the right color for the time being. Governor-elect Charlie Baker is more purple than red. This is actually good news for the democrats. His election will cause the re-evaluation of the Deval Patrick led agenda and impose a new political dynamic to the all democratic state leadership of the past eight years. Furthermore, it gives the Democratic Party some time to caucus about its strategy and tactics over the next two to four years at least.

Given the shift in power in Washington DC after the mid-term elections, if the MA Democratic Party is smart, it will more pointedly speak to the moderate, middle class, and classic liberal constituencies that seem to have gotten lost in the din of the progressive left policies that drove this election cycle.

While most citizens want to protect the environment, want to treat immigrants fairly, want civil rights protected, want global peace, want social and economic justice and energy independence, they ask the question – at what price, both to our pocketbooks and our national security? On the other hand, the progressive agenda only considers the price after the fact. That approach has come home to roost, both here and around the country. Consequently, the agenda that suffers is the one that needs to focus on quality education, job creation, health care delivery, drug prevention and treatment, treating mental illness and affordable housing.

Finally, the economy is still growing but at a much slower pace and the U.S. trade deficit rose in September, a sign that we are starting to feel the impact of weakening global growth. The famous Clinton adviser, James Carville, quip “It’s the economy, stupid” is timeless. Any agenda needs a balanced political agenda and a healthy economy. The price of public policy must also be a fundamental factor in the ultimate decision.

No one’s agenda - populist, elitist, progressive left, neo-conservative or otherwise - is void of costs. The public insightfully and thoughtfully made its choices on these Ballot Questions and party leaders should take measure.

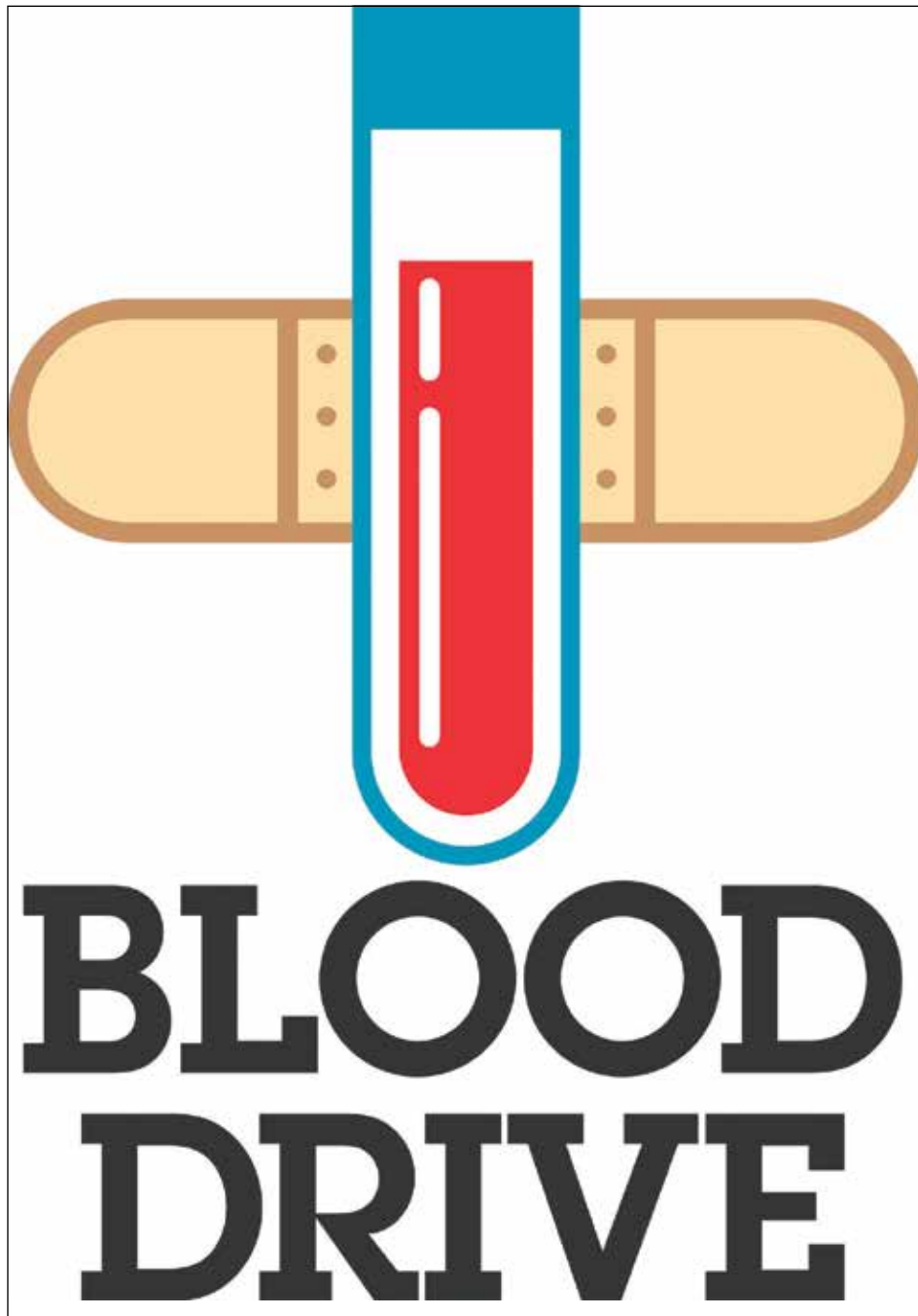
Bianka Kellici, the director of

Every week, we run part of a segment from Danny Picard's daily iTunes podcast, "I'm Just Sayin." He can also be heard weekends on WEEI 93.7 FM and seen on Comcast SportsNet New England.

This week, Danny talked Celtics with Comcast SportsNet's Kyle Draper:



**DANNY PICARD:** What are you telling Celtics fans after the home-opener win? Because while that looked exciting, and I'm not going to lie, there were a couple times that I was jumping out of my seat. I'm very excited to see what Evan Turner is bringing to the table here. And it looks like -- after the first game -- that Rondo is back to playing the way we're used to seeing him play. What are you telling Celtics fans, as good as that first game looked?

**KYLE DRAPER:** The reality is, the Celtics played great against the Brooklyn Nets, but the Nets, defensively, played like garbage. And so, I'm not going to get

too high or too low this early in the season. It's still a work in progress for the Celtics.

**DP:** I think this Celtics team is going to provide a good amount of exciting moments this year. But at the same time, I'm not going to sit here and guarantee playoffs because of those exciting moments. I'm just not going to do that. So that leads me to the conversation that Danny Ainge has to be having behind the scenes, which is, what do you do this year? Do you let this thing play out and then try to bring somebody in to convince Rajon Rondo to stick around and re-sign, or do you get to

the point where you say there's nobody out there that they can bring in that's going to convince Rondo to stick around, so you

trade Rondo? What do you think the conversation should be right now, behind the scenes, if you're the Celtics front office?

**KD:** I think the conversation is, let Rondo build up his trade value, and if somebody overwhelms you with an offer, and I'm talking about another All-Star in return, then of course you entertain that. But you don't just want to give Rajon Rondo away for pennies on the dollar. And I know people talk about how you'll lose him anyway in free agency. Well, there's always a sign-and-trade after the season is done. That way, you still get something in return. Whether it's some sort of combination of picks and players. So, I'm not giving away Rondo just to give away Rondo. I think if you're Danny Ainge, you're encouraged by what you saw in the opener, and you've got to be thinking in the back of your mind of Rondo's trade value. This offseason, Rondo's trade value wasn't that high. If he keeps playing like he did against the Nets, then his trade value goes up. If you're Danny Ainge, it's only due diligence that you think that way.

**DP:** My personal preference would be to keep Rondo. I've had you on my show many times, and I've expressed this to you. I'm one of the biggest Rondo fans out there. I'd like to see this team build around Rondo and put some big-time pieces on the floor in a Celtics uniform to try and win a championship with him. But that guy was Kevin Love. And when that didn't happen,

you begin to take a step back and say, "Okay, how can you now put a championship team on the floor with Rondo? Is there anybody out there that you could bring in, whether it's before this year's trade deadline or this offseason as a free agent, that would convince Rondo to stick around?" Because ultimately, this will come down to what Rondo wants to do.

**KD:** And I think ultimately, if you're Danny Ainge, I don't think he'll be able to lure a big-name free agent here. If you look at the free-agent class this upcoming offseason, you're talking about a guy like Marc Gasol, maybe the big man out in Portland LaMarcus Aldridge.

**DP:** LaMarcus Aldridge is the guy on my radar.

**KD:** But why would he leave Portland? They've got a good situation going. They've got a younger point guard in Damian Lillard. They've got a better team right now. Then you've got DeAndre Jordan out there in LA. He's not leaving that, is he? Greg Monroe maybe? That's the issue the Celtics are going to have. The guys on the free-agent market, do they realistically have a shot at bringing them in? That's why I think they'd have to make a trade. And if you want to keep Rondo here, you're going to have to trade some of these other pieces that you have, maybe some of these other young

pieces that you have. Maybe a Marcus Smart or somebody like that, or a Kelly Olynyk or a Jared Sullinger, to get that kind of player that you want. So, I don't know what's going to be done. But if I'm Danny Ainge, and Rajon Rondo is playing like he did in the opener against the Nets, you definitely want to build around him, you definitely want to keep him here.

**DP:** If there's one guy on this Celtics team this season that I think will at least get Rajon Rondo thinking about staying here and saying, "Hey, I really like playing with this guy," I think he's going to have a blast playing with Evan Turner. I think Rondo is going to have a blast playing with Turner.
