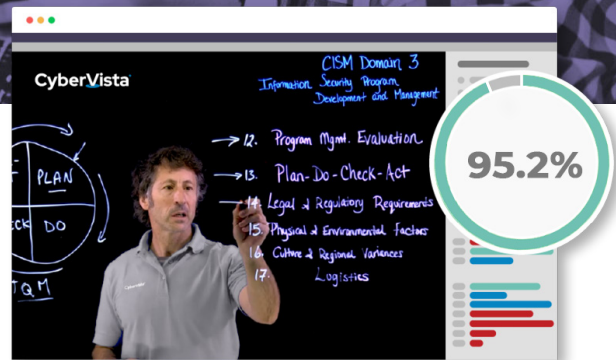

EC-Council Exams are provided in multiple forms (i.e. different question banks). Each form is carefully analyzed through beta testing with an appropriate sample group under the purview of a committee of subject matter experts that ensure that each of our exams not only has academic rigor but also has real world applicability. EC-Council also has a process to determine the difficulty rating of each question. The individual rating then contributes to an overall cut score for each exam form. To ensure each form has equal assessment standards, cut scores are set on a "per exam form" basis. Depending on which exam form is challenged, cut scores can range from 60% to 85%.

Steps to Certification

You must purchase the CEH exam voucher before submitting an application to take the exam. Most approved training providers will include the exam voucher with the cost of training at a discounted rate. Once the application is approved (usually 5-10 business days), it is valid for three (3) months from its date of approval. Therefore you must purchase a voucher within three (3) months. After you receive the voucher, you have 12 months to redeem it on your exam. Once you schedule and pass your exam, you'll officially be credentialed as a Certified Ethical Hacker.

EXPERIENCE REQUIREMENT

Two (2) years of related information security experience. Proof of experience is required.



EXPERIENCE SUBSTITUTION

You can be exempt from formal training if you provide proof of at least 2 years experience of the information security domain. Experience must be verified and endorsed by your employer.



RETAKE POLICY

If you do not successfully pass the CEH exam on your first attempt, you may purchase an exam voucher at a discounted rate and sit for your second attempt immediately.

Benefits of Achieving Your CEH™

When you are a Certified Ethical Hacker, the knowledge you've gained equates to more than just a title like security analyst, penetration tester, or vulnerability analyst. There are additional benefits that you should consider when pursuing this in-demand certification.

1. Validation of your skills and capabilities

At a minimum, earning the CEH validates your commitment to a career in cybersecurity. Achievement of a certification showcases a level of commitment, diligence, and aptitude giving you credibility as a cybersecurity practitioner.

2. Screening mechanism for HR

According to Burning Glass, more than 33% of cybersecurity job postings require a recognized certification and a much larger number mark certification as a preferred credential. HR professionals activate key word screens to include those magic certification letters. Without a certification, you might not even make it through the first pass.

3. DODD job requirement 8140/8570

DoDD 8140 was signed in 2015 and serves to establish policies and assign responsibilities for managing the

U.S. Department of Defense's cybersecurity workforce. 8140 is an update to the original directive, DoDD 8570, which outlines the baseline qualification requirements for information security jobs. In short, if you want to work for the government or military, then certifications like and including the CEH are required for many ranks and roles.

4. More money

Bonuses. Salary increases. Often certification achievement comes with a significant bump in pay just for earning the certification.

5. Career advancement

Not only do certifications potentially set you up for career advancement in your current cybersecurity position, but also obtaining a new one could help qualify you for adjacent and more advanced cybersecurity roles within your company or organization. Career advancement is far more available with the right combination of letters next to your name. It's also important to remember the education that comes with preparing for certifications. The act of preparing for and passing certification exams speaks volumes to current and future employers.

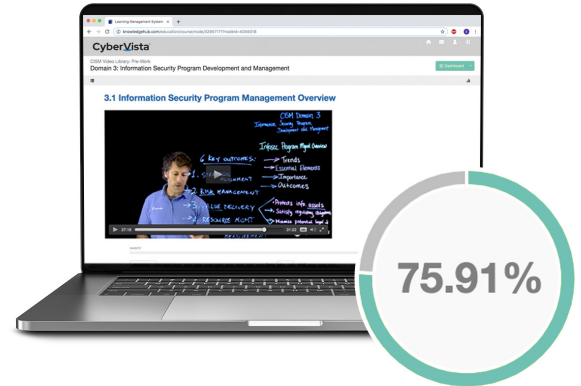

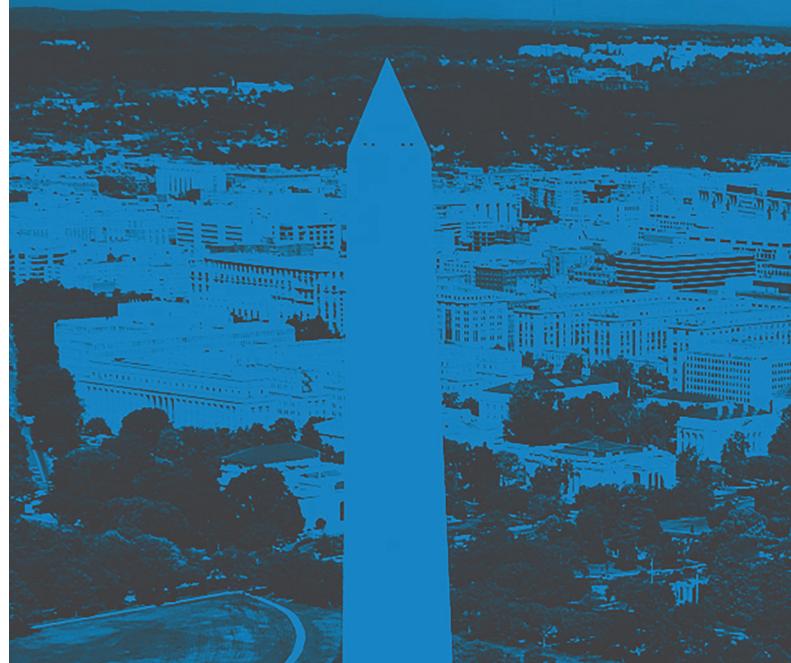
