Shared Decision-Making article	Article	This journal article by Deegan and Drake discusses the importance of using shared decision making in medication management. Shared decision making provides a framework for moving from initial preferences to informed preferences by taking the team (including the client and family members) through specific steps that allow the exploration of options, utilizing available information and client preferences to explore the pros and cons of each option and then arriving at an agreed upon decision.

Early Detection article	Article	This journal article by Melle et al., highlights the importance of having an early detection program for of the first episode of schizophrenia and suicidal behavior, given the high risk of suicide early in the course of schizophrenia. When comparing clients who have nonaffective psychosis across treatment units that have either an early detection program or without, study findings showed that the rate of severe suicidality (plans or attempts) was significantly higher in patients from treatment units without the early detection program relative to those with an early detection program.
Safety Planning Intervention article <i>Topic: Trauma-Informed Care</i>	Article	Journal article that describes the suicide planning intervention (SPI) which consists of a written, prioritized list of coping strategies and sources of support that individuals can use to alleviate a suicidal crisis. The basic components of the SPI include (a) recognizing warning signs of an impending suicidal crisis; (b) employing internal coping strategies; (c) utilizing social contacts and social settings as a means of distraction from suicidal thoughts; (d) utilizing family members or friends to help resolve the crisis; (e) contacting mental health professionals or agencies; and (f) restricting access to lethal means.

Trauma and Psychosis article	Article	This journal article presents findings on the relationship between interpersonal trauma and the likelihood of a classification of psychosis using data from the National Comorbidity Survey. Childhood physical abuse was found to be the most significant predictor of psychosis.

FIT Module 12: Stage-Wise Treatment ©2009 RFMH	Online Class	This training module provides an introduction to the Stages of Change and the Stages of Treatment models including what they are, how they interact and the importance of providing interventions that work best for each stage. Participants will learn the four stages of treatment, the goal of each stage, the interventions that match the stage and how best to recognize clients' stages of treatment.
FIT Module 13: Early Stages of Change ©2010 RFMH	Online Class	This is the second of four modules that discuss the stages of change, stages of treatment and stage-specific treatment interventions. This module concentrates on early change and stages of treatment. It begins with an overview of the Stages of Change and Stages of Treatment and how they are related. You will learn how to assess a client's stage of change accurately and how to use Motivational Interviewing as a primary tool in the early stages of treatment. The module then explores treatment interventions for each of the three early stages of change: precontemplation, contemplation and preparation. Real-life case studies illustrate interventions that are helpful during early stages of change.
FIT Module 14: Later Stages of Change ©2010 RFMH	Online Class	This is the third of four modules that discuss the stages of change, stages of treatment and stage-specific treatment interventions. This module concentrates on later stages of change. It begins with a short review of the Stages of Change, lists the criteria for accurately assessing clients in these later stages and examines treatment interventions for each of two later stages (action and maintenance). Real-life case studies illustrate interventions that are helpful during later stages of change. You will also learn about treatment approaches for clients in multiple stages for different disorders; for example, contemplation of substance use and action for mental health issues.
FIT Module 22: Individual Interventions ©2010 RFMH	Online Class	This training module describes the use of individual interventions in the treatment of people with co-occurring disorders. Participants will learn about the advantages of individual treatment and the situations and clients where individual work would be the most appropriate; and strategies for developing the therapeutic relationship, especially the use of motivational interviewing skills. Participants will also learn how to use a stage-based approach in designing treatment plans for individual interventions, including criteria for assessing a client's stage of change and matching interventions appropriate for each stage.

Participants will also learn strategies for putting each principle into practice and for recognizing, eliciting and reinforcing client's change talk.

You will learn the basics of CBT for co-occurring disorders, the learning theories behind CBT, principles for implementing CBT and strategies for using CBT in addiction counseling. The two fundamental components of CBT are conducting a functional analysis and teaching coping skills. SDM Chapter 1: What is Shared Decision Making?	Video	In this chapter, shared decision making is broadly defined as we explore its origins in general medicine. The evidence to support the practice of shared decision making is discussed and the ethical imperative that underscores its use is presented.
SDM Chapter 2: Shared Decision Making in Behavioral Health	Video	In this chapter, we narrow the scope from shared decision making in general medicine, to shared decision making in behavioral health. We discuss the question of the relevance of shared decision making for people diagnosed with serious mental illness, especially in relation to decision capacity. We also explore various crossroads and continuing care decision points encountered in routine work. We place special emphasis on the fact that shared decision making is not just for decisions about medications. Shared decision making can also be used at other decision points such as deciding to return to work or school, deciding to move away from home, deciding when or if to disclose psychiatric history in a new relationship and the like.
SDM Chapter 3: Why SDM with Young People?	Video	In Chapter 3, we raise the question of why shared decision making is important for teams working with young people and their families. In particular, we explore the importance of a developmental approach and how to involve families in shared decision making, especially when working with teens.
SDM Chapter 4: Decision Aids	Video	Decision aids are specially crafted tools that support shared decision making. They can be used during appointments or prior to consultations with the team. Links to various decision aids for your use are included in this Viewer's Guide
SDM Chapter 5: Doing shared Decision Making	Video	In Chapter 5, we look at the specifics of how to do shared decision making. We learn how to set up a lending library and other techniques for building a programmatic infrastructure to support shared decision making. We also present a three-part method to support shared decision making that includes Choice Talk, Option Talk and Decision Talk. Shared decision making can be done in the office, but it can also be done when working with folks out in the community.
SDM Chapter 6: You Are Part of the Team	Video	Chapter 6 is a bit different than the others. Chapter 6 was created specifically for individuals and their supporters or family members. It explains why shared decision making is important and what to expect from the team. Clearly, being asked to collaborate in decision making will be a different kind of experience for many people. This video will help folks better understand the importance of being a member of the decision-making team. Although this video was made for individuals and families, it is recommended that the team study it as well.

Substance Use Evaluation	Video	Duration: 15 min. Video illustrates how the ORC conducts an eligibility evaluation for a client with psychosis in the context of substance use by ruling out substance-induced psychosis and looking at temporal relationship between psychosis and substance use by creating a timeline. A completed timeline is shown at the end of video.
Team Meeting	Video	This video demonstrates an OnTrack team discussing one of their clients during a weekly team meeting. Each team member discusses his or her work with the client and any challenges the client is facing, and the team develops a plan for next steps with the client and family.
Skills Building in Session	Video	In this video, an OnTrack clinician engages a client in a skill-building exercise in support of the client's recovery goal of making new friends. After helping the client identify a scenario – starting a conversation with the barista at a local coffee shop – the clinician uses role play to work with the client on enhancing her social skills.

Pat Deegan: Introduction video	Video	This video introduces Pat Deegan, PhD, a psychologist and independent consultant who specializes in research on the topics of recovery and empowerment of people diagnosed with mental illness. She is an activist in the disability rights movement, a lecturer at Dartmouth and at Boston College, and a frequent collaborator with OnTrackNY. In this series of videos, she shares her own recovery journey after being diagnosed with schizophrenia in her teens.
Pat Deegan: The Experience of First Episode Psychosis	Video	Pat talks about experiencing the onset of symptoms of schizophrenia as a high school student and her efforts to make sense of and cope with her experience. She offers a number of suggestions for clinicians working with people experiencing psychosis, including attending to the person's basic needs for food, water, and safety; using simple, clear language; and remaining curious and respectful.
Pat Deegan: Help That Hurts	Video	In this video, Pat addresses the concept of "toxic help" messages that can be damaging to clients, leading to hopelessness and despair. She recalls her experience of being told that she will need to take medication for the rest of her life, for a condition from which people do not recover. She encourages clinicians to avoid focusing on clients' medication "compliance" and to approach their clients with a willingness to walk alongside them in a spirit of humility and collaboration.
Pat Deegan: Early Recovery	Video	Here, Pat recalls the turning point in her recovery: her decision that she was "not going to do this anymore not going to be a schizophrenic" and that she would instead "become Dr. Deegan and change the mental health system so that no one gets hurt in it again." Several months later, she took the first step toward this goal, which was to accompany her grandmother on a trip to the grocery store. As she continued on her journey, she began to realize the power of "personal medicine" – one's own strategies for managing symptoms and staying well – and the importance of finding the right balance between personal medicine and psychiatric medicine.
Pat Deegan: Recovery	Video	In the final video of this series, Pat talks about her recovery journey: the role of mental health treatment, including therapy and medication; the importance of her marriage, her relationship with her daughter, and her connection to a higher power; recovery as transformation rather than restoration to a former self; and the value of peer support.

Learning to see the young person with psychosis as are salient individual with which the team can collaborate is a central focus of this video.
Spirit of OnTrack: Chapter 2 – Coming to Terms with a Diagnosis of Psychosis	Video	This chapter focuses on the effort of young people and families to make sense of the experience of psychosis. OnTrack teams do not insist that all individuals adopt a medical understanding of their condition. Instead, teams seek to support individuals and families as they grapple with the existential meaning of this unanticipated turn of events. Clinicians are not expected to abandon their perspective and understanding of psychotic disorders. Rather, the task is to help young people and families find an understanding of the condition that empowers them to gain control and make good choices for recovery.
Spirit of OnTrack: Chapter 3 – Navigating the Duty to Care and Dignity of Risk	Video	In Chapter 3, we begin by asking how to do recovery oriented work with people who appear to be making a self- defeating choice. Do we just "let people" make a self-defeating choice? Is it better to persuade, or somehow stop the person from making a bad choice? In many respects, this chapter gets to the heart of the work and offers teams a method for navigating risk management.
Spirit of OnTrack: Chapter 4 – Creating a Culture of Respect	Video	Research has shown young people can be especially attuned to issues of respect and confidentiality. OnTrack teams are encouraged to take very specific steps to build a culture of respect, including modifying the physical space of the program and being very aware of respectful communication. In our experience, creating a culture of respect is a sensitive topic many teams would rather avoid. However, we encourage you to accept the challenge, develop a detailed plan for transforming your team culture, and stick with it over time. The result will be a more positive and healing experience for individuals and families. It will also result in better team morale and mutual respect.
Spirit of OnTrack: Chapter 5 – Professional Boundaries as a Means of Building Relationships	Video	In Chapter 5, we deconstruct some assumptions about professional boundaries. We emphasize the need to balance clinicians' personal and professional boundaries with the needs of young people to know clinicians and feel connected with the team. We then offer a 5-part algorithm to guide clinicians in establishing boundaries that are consistent but flexible and responsive to individual needs. This, in turn, will help the team build stronger relationships with families and young people.
Spirit of OnTrack: Chapter 6 – From Compliance to Partnership	Video	In this chapter, we argue that the framework of compliance actually disempowers clinicians and can lead to less effective practice. Learning to use treatment optimally is a journey that takes time. It is a dynamic process throughout which individuals and families need the ongoing support and guidance of the team. Partnering with people on this journey is an important role of OnTrack teams.

A Systematic Review of Psychosocial Research article	Article	This article reviews 45 studies of psychosocial interventions for people with co-occurring substance use disorder and severe mental illness. Three types of interventions (group counseling, contingency management, and residential dual diagnosis treatment) show consistent positive effects on substance use disorder, whereas other psychosocial interventions have significant impacts on other areas of adjustment. Findings demonstrate a need for multiple types of interventions when working with clients who have a dual diagnosis.

Involving Families in the Care of Persons with Schizophrenia article	Article	This journal article provides an overview of the impact of mental illness on the family and the role of the family in recovery, a summary of available services, and recommendations for ways to work with people and families to overcome barriers to family involvement and increase the likelihood of family participation in care. By taking a more individualized, tailored approach to working with families, providers can help increase the likelihood of family involvement, which can lead to better outcomes for clients.

The 2009 Schizophrenia PORT article	Article	The 2009 Schizophrenia Patient Outcome Research Team (PORT) psychosocial treatment recommendations provide a comprehensive list of current evidence-based psychosocial treatment interventions for persons with schizophrenia. A total of 16 treatment recommendations were provided: the revision of 11 previous treatment recommendations and 5 new treatment recommendations. There were 13 interventions and/or outcomes for which there was insufficient evidence for a treatment recommendation, and a statement was written to summarize the current level of evidence and identify important gaps in our knowledge that need to be addressed

Skills Training article	Article	This is a journal article that presents a comprehensive overview of three general psychosocial interventions for schizophrenia: social skills training (SST), cognitive behavior therapy (CBT) and cognitive rehabilitation (CR).
