## Orange County Childhood Language Center



### Brethren,

It is important for the Orange County Scottish Rite Valley to understand how our Orange County Childhood Language Center OC CLC is operating to benefit the children we serve. As you know the State of California has 14 Childhood Language Centers all operated by different Scottish Rite Valleys. We are fortunate that our Language Center is leading the state in many categories and here is why.

### Impact:

The purpose of operating a charity is to benefit a group of people who need help. We have many families in the Santa Ana area whose children need help to overcome their communication challenges but they cannot afford the cost of therapy. Our Language Center provides excellent therapy at no cost to these families in affiliation with Chapman University. Chapman University receives a grant from the OC CLC Board to provide the structure needed to provide this therapy. Fully trained and accredited Speech Language Pathologists are onsite as Supervisors to ensure the highest standards in care are maintained. The Graduate Student Clinicians work very closely with a supervisor to provide high quality and individual therapy to the children who are enrolled for therapy. Judy Montgomery PhD. oversees the entire operation as the Executive Director and personally evaluates each child before they are enrolled in our Language Center. Last year she evaluated 72 children to determine if they would benefit from the therapy we provide. Our average enrollment was 57 children and we graduated 25 children from our award-winning program last year.

### Financial Responsibility:

The Board of Directors oversees the operations of our Language Center and is led by myself serving as President. The Board of Directors is comprised of some Masons and business or community leaders who have the right type of expertise to help guide the direction and operation of the Language Center. The Board of Directors creates a yearly budget to ensure that all donations are used according to a specific plan. They meet on a regular basis to monitor OC CLC operations. Every penny is squeezed until we receive the maximum benefit from the donations. Many charities fail to receive donations from all Board Members. The OC CLC requires that 100% of its Board Members donate a minimum of \$500 per year. We started this outstanding tradition so our Board Members would have "skin in the game". The Board of Directors is constantly raising money for our Language Center. Building sustainability for the future is another Board responsibility. We currently have over 50 months, and growing, of operating reserves in the bank to safeguard the operations of our Language Center during difficult financial times.

I hope you are very proud of how our Language Center benefits the children in Orange County who need a special place to help them become great communicators. As Scottish Rite Masons we are providing the Gift of Voice to those who need it most.

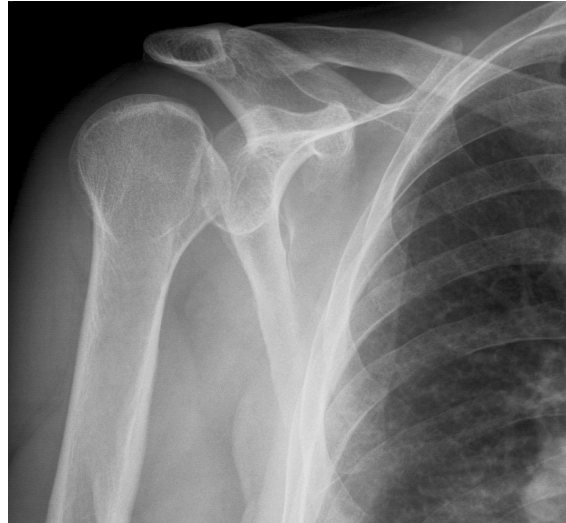

Greetings Brethren,

Welcome to the month of November. The year is coming to a close quickly, I can't believe how fast it has gone by. Some interesting facts about the month of November: In any given year, November starts on the same day of the week as March and ends on the same day of the week as August. There is no mention of the month of November in any of Shakespeare's plays or sonnets. November 2 is the only day of the year that was the birthday of two US presidents: Warren Harding (born 1865) and James Polk (1795). November is the only month when more rain usually falls on London than Paris. "If there's ice in November to bear a duck, there'll be nothing after but sludge and muck" (old weather lore). The Anglo-Saxons called November 'Blotmonath' after the blood of slaughtered cattle.

Here are your Masonic Tidbits for the month of November: on November 4<sup>th</sup> 1752 Worshipful Brother George Washington was made an Entered Apprentice in Fredericksburg Lodge, Virginia. On November 28<sup>th</sup> 1911 Brother Franklin D. Roosevelt was raised to the sublime degree of Master Mason.

Don't forget to change your clocks on the 5<sup>th</sup> at 2:00am, remember spring forward, and **fall** back. In 1966, President Lyndon Johnson signed the Uniform Time Act into law. The U.S. Dept. of Transportation is the keeper of daylight saving time. Brother Lyndon Johnson received his first degree on October 30, 1937. After receiving the degree he found that his congressional duties (elected in 1937) took so much time he was unable to pursue further Masonic degrees.

## Wise Master



Why do we need Ancient Landmark in Masonry?

Are the Ancient Landmarks in Freemasonry the opinion or the tradition? What constitutes an Ancient Landmark and why do we have them. Some have many opinions of what these landmarks are based on their own experience derived by many years of study, but still, an opinion remains bias. The Ancient Landmarks of Freemasonry are immutable, there exists to remove opinion and interpretational bias. They exist as the building blocks of a foundation of which if one piece is remove or changed, the whole begins to collapse and differ from ancient usages and customs which are developed over time and unique to each jurisdiction or Lodge.

Are these Landmarks something physical, something that marks a boundary, or a formation? Most authorities of Masonry have enumerated to say, all three. Some, like George Oliver, in his *Dictionary of Symbolic Masonry*, says, "Some restrict the Landmarks to the obligations, signs, tokens and words: others include ceremonies of initiation along with the forms dimensions, supports, coverings and ornaments". Some say the Landmarks are the fixed tenets by which the limits of Freemasonry may be known and preserved and some they are only customs and there are no Landmarks. Albert Pike made a lengthy discourse on the Ancient Landmarks stating: "They are the fundamental principles of Ancient Operative Masons and were few and simple, and the word 'Landmark' didn't appear in any written text until 1723. No one really knows what the Ancient Landmarks are, or can agree that there are any Landmarks that haven't been changed. Whatever the case, notwithstanding, we as Masons are charged to live by and act upon the Ancient Landmarks of this venerable institution.

Some suggested Landmarks of Freemasonry; a man, freeborn, of lawful age, under the tongue of good report, of no felonious convictions, believes in a Supreme Being and a man lives the moral standards of a Mason.

As the idea started to build in her mind she knew a special team would be needed to succeed. Who better to enlist than mom and dad?

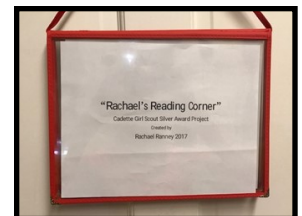


We all know moms have great ideas and dads like to use power tools. This was going to be the best library because it was made with the love of a family!

Others suggest the Ancient Landmarks are; Modes of recognition, the symbolic three degrees, the legend of the Third Degree, that the Master is the rule of the Lodge, that a Lodge is governed by 3 principal officers and only a Grand Master can make a Master Mason on the spot.

Although all of these are true they are not Landmarks and certainly not Ancient. What we do know is;

Every constituted lodge is required to have present, displays or worn, are, a Charter, a Book of Holy Writ, a Square & Compass, aprons, rites, prayers and rituals, and the most important members. These are the Ancient Landmark of every Masonic Lodge of every State, Country or Nation from time immemorial.

I'm sure if you think about it, you could find a few more..

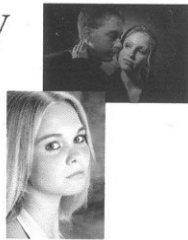
