From 1982 to 1989 he was a Magistrate in the Judiciary of Hong Kong with acting appointments as Principal Magistrate and as Coroner. After leaving the Judiciary he obtained his LL.M in European Legal Studies from Exeter University. From 1990 until retirement in 2009 he was an Associate Professor in the School of Law of City University where he taught Criminal Law, Criminal Procedure, Evidence and Criminal Justice System. Since retirement he has been a part-time tutor at the University of Hong Kong. He was Co-Convenor of the Head II Civil and Criminal Panel for the Overseas Lawyers Qualification Examination from 1995 to 2007 and has also served as a member of the Head IV Accounts and Professional Conduct Panel. He is currently a member of the Law Society of Hong Kong's Criminal Law and Procedure Committee. He has contributed to Archbold (Hong Kong) and to Halsbury's Laws of Hong Kong. With Christopher Knight he authored Criminal Litigation in Hong Kong which is now in its third edition.


