

Opposition BJP and Congress demanded lifting of paddy from farmers

Bhubaneswar, March 13: In an unprecedented scene, both the ruling BJD and the Opposition BJP and Congress MLAs created ruckus in the House, obstructing the proceedings throughout the day, Saturday. The BJD members were responsible for the chaos in the House even during introduction of eight Bills.

As soon as the House assembled for the day at 10.30 am, BJP members rushed to the well and raised slogans demanding procurement of paddy lying with the farmers across the state. Congress members too joined them, disrupting the entire Question Hour.

Even as the bedlam continued, government chief whip Pramilla Mallick demanded an apology from BJP legislator Subash Panigrahi, who attempted suicide Friday by consuming hand sanitiser inside the House. This prompted the Treasury bench members to rush into the well of the House and create chaos. Unable to continue with the proceedings of the House, Speaker SN Patro adjourned the House first till 11.30 am and again till post lunch session (4 pm). The situation remained same during the second half. After in-

### India reports year's biggest COVID spike

New Delhi, March 13: The single-day rise of new COVID-19 cases in India Saturday is the country's highest tally so far this year. It recorded 24,882 cases, showing eight per cent increase since Friday. There were 140 deaths in the last 24 hours, according to the data shared by the Union Health Ministry. With it the cumulative tally rose to 1,13,33,728 while the toll reached 1,58,446. The infection level in the country is back to what it was in December as it soared to 1.78 per cent from 1.55 within a week.

In the last four days, the number of fatalities has spiked, which earlier was

hovering under 100. The country on Friday

reported 22,885 new COVID-19 cases, 117 fatalities. On Thursday, India had reported 22,854 COVID-19 cases and 126 deaths; while Wednesday, 17,921 COVID-19 cases and 133 deaths were recorded.

As per the Ministry's data, the active cases present in the country have breached 2-lakh. It was reported 2,02,022 Saturday.

With the discharge of 19,957 patients in a day, a total of 1,09,73, 260 persons have been discharged so far.

The rise in the number of COVID-19 cases is now beginning to show up in several other states. States/UTs such as Delhi, Haryana, Gujarat, Rajasthan, Madhya Pradesh have had very similar growth trajectories in recent weeks.

# Woman's skeleton found in seized vehicle at Janla

Bhubaneswar, March 13: The in-charge of Janla outpost under Khandagiri police station was suspended Saturday following the recovery of a human skeleton from a vehicle seized in February and kept at the outpost premises.

Interacting with the media, Umashankar Dash said that Sub-Inspector Satvabrata Grahacharva, who was in charge of Janla outpost, has been suspended for the dereliction of duty.

Grahacharya had no inkling of how or since when the body remained locked inside the car. According to police sources, it was Grahacharya's duty to regularly check the status of all seized vehicles on the premises.

Sources claimed that Rambha police in Ganjam detected cannabis in a vehicle at a place under Janla police limits in November 2019. The cops followed the vehicle all the way from Ganjam to Bhubaneswar and seized the contraband here. Later, the vehicle was taken to the Janla outpost when it developed some technical glitches.

In January, the owner of the vehicle obtained the release order for his vehicle from a court and had come to Janla police

station along with cops from Ganjam police station and relevant documents to take charge of the vehicle. To everyone's shock, they found a woman's mummified body was lying inside. The body was sent to AIIMS, Bhubaneswar, for post-mortem and the report revealed that the deceased was a 45-year-old woman who had natural death.

While the deceased is yet to be identified. it is being claimed that she was possibly a mentally ill person or a very poor destitute. Even the medical officers of AIIMS also found that the deceased was suffering from tuberculosis and malnourishment.

The DCP said police have initiated a probe as to how the deceased got into the vehicle.

# Pichai, Nadella in war of words

Google and Microsoft are at odds over whether publishers should have more control over a digital ad industry dominated by the search giant and Facebook

San Francisco, March 13: Sundar Pichai-run Google has launched a scathing attack on Microsoft, accusing the Satva Nadella-run enterprise of willing to break the way the open Web works in an effort to undercut a rival.

The attack came as Microsoft president Brad Smith, who Friday issued a testimony for the House Committee on the judiciary looking into antitrust and commercial aspects of competition for a free and diverse press, and slammed Google for hampering the growth of news organisations.

"News organisations have ad inventory to sell, but they can no longer sell directly to



Smith said in a statement.

"Instead, for all practical purposes they must use Google's tools, operate on Google's ad exchanges, contribute data to Google's operations, and pay Google money. All this impacts the ability of news organisations to benefit economically even from advertising on their own sites.

Smith noted. Kent Walker,

time practices. "It's no coincidence that Microsoft's newfound interest in attacking us comes on the heels of the Solar Winds attack and at a moment when they've allowed tens of thousands of their customers to be actively hacked via major

"They are now making selfserving claims and are even willing to break the way the open web works in an effort to undercut a rival. And their claims about our business and how we work with news publishers are just plain wrong,' he added.

report from the National Remote Sensing Centre (NRSC), Hyderabad claimed that forest fire situation in Similipal region is improving. "The FSI Dehradun has indi-

cated 341 forest fire alerts in the state Saturday with only four fire alerts in Similipal as against 701 fire alerts of Friday," said a statement from the PCCF office. The department claimed that

all the officials concerned, including the Collector and the police personnel are working in tandem to resolve the issue. The officials are on 24x7 alert to deal with the situation. "Patrolling has been Beefed up

and the situation is being monitored round-the-clock through the Odisha Forest Management System (OFMS)," the department said.

The department is also sharing the fire alert points received from FSI, Dehradun to the ground level personnel and other concerned departments through Whatsapp and SMS alert to keep them updated.

"Forest Staffs have promptly attended to these points and about 95 per cent of all these fire points have been dealt with. As per the FSI Alerts, there is no continuous fire at any places in state, said the department.

# 8 Bills tabled amid pandemonium

Bhubaneswar, March 13: Amid uproar, eight Bills, including Odisha Fiscal Responsibility and Budget Management (Amendment) Bill were introduced in the state Assembly Saturday.

Amendment to the Odisha Fiscal Responsibility and Budget Management (FRBM) Act, 2005 will allow the state government to raise the level of fiscal deficit by another 2 per cent of the Gross State Domestic Product (GSDP).

As per the proposed amendment, additional 2 per cent fiscal deficit includes unconditional borrowing of 0.5 per cent of GSDP and another 0.5 per cent bonus for completion of at least three of state-specific reforms.

The balance 1 per cent depends on the implementation of four sectoral reforms, each carrying weightage of 0.25 per cent. The decision would give an additional leeway to the state government to go for higher borrowing for meeting its rising capital need, sources said.

Through the Odisha Repealing Bill, the government has proposed to repeal 206 old and obsolete Acts that were passed between 1976 and 2016.

The other Bills are—Xavier University Odisha (Amendment) Bill, Odia University (Amendment) Bill, Odisha Appropriation Acts (Repeal) Bill, Odisha Advocates' Welfare Fund (Amendment) Bill, Societies Registration (Odisha Amendment) Bill and Biju Patnaik University of Technology (Amendment) Bill.

# 46,731 unemployed techies in state

**BHUBANESWAR:** General students apart, there are over 46,000 engineering students who remained unemployed in the state after completing professional engineering courses.

According to a written reply from Skill Development and Technical Education Minister Premananda Navak, 46,731 engineering students have registered themselves in employment exchanges of the state. Out of which, 9,487 students have completed B Tech course, 3,497 are M Tech pass-outs and 33,747 are diploma pass-outs, he said.

For employment of students, the government has opened placement cells in its technical university, colleges and polytechnic schools. The technical students also get jobs from their own attempt, he said.

Besides, the government is providing soft skill training, software training and employability skill training to pass-out students to make them employable. The state has signed an MoU with various companies to set up a centre of excellence at different col-

leges, the minister further said. Nayak said the government doesn't have any plan to provide monthly allowance to the unemployed engineering students or waive off their loans.

# State has 2,924 transgenders, 8,338 beggars



Bhubaneswar, March 13: There are altogether 2,924 registered transgenders and 8,338 beggars in the state, said Social Security & Empowerment of Persons with Disabilities (SSEPD) Minister Ashok Chandra Panda in the Assembly, Saturday.

In a written reply to an un-starred question by BJD MLA Ramesh Chandra Sai, Panda said that Mayurbhani district had the highest number of 485

transgenders, followed by Balasore— 302, Khurda—283, Rayagada—209, Angul—195, Cuttack—183, Bolangir— 153, Dhenkanal—136 and Koraput— 127. Similarly, there are 31 transgenders in Bargarh district, 32 in Bhadrak, 12 in Boudh, 26 in Deogarh, 34 in Gajapati, 90 in Ganjam, 17 in Jagatsinghpur, 40 each in Jajpur & Jharsuguda, 96 in Kalahandi, 65 in Kandhamal, 49 in Keonjhar, 42 in Malkangiri, 23 in Nabarangpur, 36 in Nayagarh, six in Nuapada, 41 in Puri, 65 in Sambalpur and 30 in Sonepur district.

Kendrapara has only four registered transgenders, the lowest among the 30 districts. The minister further said housing and urban development and panchayati raj & drinking water departments have been requested to provide houses to transgenders. Replying to another question, Panda said 8,338 beggars have been identified in Odisha and his department doesn't have any information about the baggers from outside the state.

# NOW, ROBOT TO HELP CLEAN MANHOLES IN HOLY CITY



Puri, March 13: In what could be the first-of-its-kind development in the country, robots would now supplement the manual cleaning of manholes in the Puri munici-

The robot named 'Bandicoot' nas been engaged for cleaning manholes, which is considered to be the most dangerous work in the scavenging field.

Puri Collector Samarth Verma Saturday flagged off the commissioning of the robot operations in the Puri municipality and the cleaning of the first manhole began in front of Sonali plaza here. An official release Saturday said that this is the country's first robot to supplant manual cleaning

Every year, a large number of people lose their lives while cleaning manholes.

This robot has been developed by an Indian company 'Genrobotics' under the 'Make in India' initiative.

This would keep away persons normally engaged for manual cleaning of manholes risking their lives. Robots too dispose of sewage waste through an automatically-operated system. The sanitation workers would be trained by professionals how to operate the robot.

The robot operator and the sanitation workers would be equipped with sanitised PPE kits. This apart, their health check up would be conducted at regular intervals.

Induction of robots for cleaning manholes not only would make lives easy for sanitation workers but improve their dignity of life style and socio-eco-

# **Revenue dept seeks ₹50cr for census, NPR**

Bhubaneswar, March 13: A standing committee report of the revenue and disaster management department claimed that it is ready to carry out the census and update the National Population Register (NPR).

The decadal exercise suffered a setback owing to the pandemic that hit all parts of the country and was put on hold by the Union government. The report claimed that the department has prepared the required infrastructure for the same.

In their proposal for funds from the State Budget 2021-22, the department has sought assistance to the tune of Rs 50 crore for the census exercise under the central scheme projects. The department claimed that the Information Technology (IT) systems have been bolstered for the same.

"Census-2021 will be carried out as per Census Act, 1948. The population register shall be updated as per provisions of the Citizenship Act, 1955 and the Citizenship Rules, 2003," the report said

The report said that the whole exercise was put on hold as per a decision of the Union government.

"As per the direction received from the registrar general and census commissioner of India, ministry of home affairs, the first phase

# HC asks DMs to make surprise visit to jails

Cuttack, March 13: The Orissa High Court (HC) has directed all district magistrates (DMs) to make surprise visits to jails in their respective jurisdictions and submit reports about the condition of the

Adjudicating over a 15-year-old writ petition after receiving a recent report submitted by the Amicus Curiae in this matter, the high court has expressed shock and concerns over the precarious conditions prevailing in various jails of the state.


A bench headed by Chief Justice S Muralidhar on March 9 directed all district magistrates to make surprise visits to the jails in their respective jurisdictions and submit reports detailing jail conditions, overcrowding, food, accommodation and recreation of inmates.

"Preferably, these visits (of the DMs) should be unannounced", said an order passed by the high court fixing April 27 for the next hearing. The state government, in the meantime, has been asked to arrange at least one medical visit to each jail and submit a report on it.

The high court has also sought cooperation from Odisha State

the High Court Legal Aid Services Authority for the execution of jail reforms in Odisha as suggested by the Supreme Court in its judgements passed in 2016 and 2017.

Khurda, March 13: At a time when the state government is spending crores of rupees to ensure superior healthcare at the government-run facilities, the district headquarters hospital (DHH) here is plagued by a host of issues for which 'private practice by a few of its doctors' as well as 'diversion of patients to private facilities' are being blamed.

Sumitra Nayak of Tangiapada area here has written to the chief district medical officer (CDMO) highlighting the crippling healthcare at the DHH, especially its maternity care centre.

"Pregnant women, experiencing labour, approaching the DHH late at night and being referred to Capital Hospital, citing health complications even though there is hardly any is a common scenario at the facil-

Khurda CDMO said that they would investigate into the allegations and action will be taken against erring doctors if any

ity. On the other hand, the same women deliver babies at private hospitals without any complications," Nayak said, alleging that the referrals to any state-run facility like Capital Hospital is an indirect way to divert patients to nearby private healthcare facilities.

Moreover, the DHH staffers are not at all patient-friendly as fracas between patient/attendant and hospital staffers could be seen almost every other day, the Tangiapada resident added.

Gadadhar Behera and Saroj

Nayak, recent victims of the creaking healthcare at the DHH, said that the government is spending crores of rupees for infra upgradation of the state-run hospitals so as to ensure healthcare to all. However, a precious little is being done on the ground level as it is evident in case of the Khurda DHH.

"After being turned down by the DHH, if the same women can deliver at the private hospitals without any health complications, then why do we have government-run facilities like the DHH? A few officials of the DHH have been working hand-in-glove with some private healthcare facilities to divert the patients there," they alleged.

Sources said although the consulting time at the DHH begins at 8am and ends at 12 noon, hardly any doctor remain present there as most of them visit nearby private healthcare facilities from 8am to 9.30am. "As a result critically-ill patients were left with only a few options—wait for hours at the DHH or visit nearby private healthcare facilities and cough up huge sum of money. Anyways, be it private practice or patient diversion, at the end, it's the patient who bears the brunt," said a source.

While confirming of in receipt of the complaint, the CDMO said. 'We'll investigate into the veracity of the complaint. Action will be taken against the doctor(s) if any one of them is found practising in private during the official hours.

# People feed on stream water in Swabhiman Anchal

Malkangiri, March 13: A lot of development has taken place in various pockets of Swabhiman Anchal in Malkangiri after Gurupriya Setu was commissioned. However, there are many remote villages in hilly terrains which are deprived of safe drinking water. People in some villages

still depend on stream water, a report said. According to the report, Malkangiri district is a hilly and forested region. The area has Kalimela, Satiguda dams, rivers like Poteru, Saberi, Pangam and several streams. In monsoon, areas close to these rivers are flooded. But in summer, they

Many villages under nine panchayats have been awaiting basic facilities like roads and drinking water. In the absence of tube wells, people have no way but to fed on stream water

are hit hard by water crisis. Before Gurupirya setu was made functional in 2018, there was no tube well

and piped drinking water projects in

scores of villages under nine panchayats of Swabiman Anchal.

Thereafter, various developmental works like roads and tube wells were made in many villages while many villages have been awaiting basic facilities like roads and drinking water. In the absence of tube wells, people have fed on

stream water. Meanwhile, tube wells have gone defunct in the area, forcing people to drink stream water. According to the RWSS, there are 12,223 tube wells in seven blocks. 34 of the tube wells have gone defunct.

Besides, 48 drinking water projects out of total 362 have been out of order. Moreover, 100 solar-powered drinking water projects are not working now. Locals alleged that water of some tube

wells is not fit for drinking as the water has a more ferrous content. According to official sources, a population of over 6 lakh is in 1058 villages

under seven blocks of the district.

Ensuring drinking water in the hilly and forested pockets has been a challenge for the administration particularly in summer.

On the other hand, the administration has been pushing road connectivity in remote areas on a priority basis so that other development activities are carried

# Inconsistent ideology

The BJP won 18 of the 42 Lok Sabha seats in West Bengal. It is hard to see why it will not win the Assembly elections because it has so much more resource than the rest (more than 90 per cent of electoral bond money, which is the anonymous but legal funding by corporates to parties, according to RTI reports) and also the power of the national administration. The prime minister says he will bring real change to Bengal. Perhaps he will. The interesting thing to me is that his party has never defined what

Formed in 1951, the Jana Sangh/BJP manifestos move effortlessly back and forth from grand and formless expression like 'national rejuvenation yagna' directly to things like running more trains with third-class compartments as opposed to air-conditioned ones, pushing the benefits of cow manure and asking linguists to introduce technical and scientific terms based on Sanskrit

The party's ideologue, Deendayal Upadhyaya did not want states to exist. In his Integral Humanism lectures, he has said: "According to the first para of the Constitution, 'India that is Bharat will be a federation of States', i.e. Bihar Mata, Banga Mata, Punjab Mata, Kannada Mata, Tamil Mata, all put together make Bharat Mata. This is ridiculous." He did not tell us if we removed the states what mechanism of administration would come between the Union government and the village.

In the first manifesto the party identified black-marketing, profiteering and nepotism as key problems. Over time, the Jana Sangh drops reference to these problems without saying whether they had been solved or had become less relevant to the party.

The first point on agriculture of its first manifesto calls for 'a country-wide campaign to educate and enthuse the cultivator about the necessity of harder work for more production'. Later it is for 'encouragement of the use of mechanical appliances in agriculture'. However, still later it says that 'tractors will be used only to break virgin soil. Their use for normal ploughing purposes will be discouraged' (1954). This was of course because it was trying to protect the bull and the ox from slaughter. In 1951, prohibition of cow slaughter was explained as something needed 'to make the cow an economic unit of agricultural life'. In 1954, the text was more religious and called cow protection a 'pious duty'

In 1954, and again in 1971, the Jana Sangh resolved to limit the maximum income of all Indian citizens to ₹2,000 per month and the minimum to ₹100, maintaining a 20:1 ratio. It would continue working on reducing this gap till it reached 10:1 which was the ideal gap and all Indians could only have in-

comes inside this range based on their position. Additional income earned by individuals over this limit would be taken by the government for development. The party would also limit the size of residential houses in cities and not allow plots of more than 1000 square yards.

In 1954 the party said it would repeal the first amendment to the Constitution that curbed freedom of speech by imposing 'reasonable restrictions'. This amendment essentially took away freedom of expression because the list of what is seen as a reasonable restriction was far too wide and broad. The Jana Sangh sensed that it was not something that could be allowed to go unchallenged. However, after 1954, this demand that the first amendment be repealed and freedom of speech, association and assembly be restored to Indians disappeared from the Jana Sangh manifestos.

Interestingly, the Jana Sangh said it would also repeal preventive detention laws which it said were absolutely in contradiction to individual liberty. This promise was made repeatedly in the 1950s. In time, the Sangh and BJP became the most enthusiastic champions of preventive detention and laws like UAPA.

Even though the idols were smuggled into the mosque on the night of 22-23 December 1949, a few months before the Jana Sangh was formed, there was no reference to Ayodhya or a Ram temple there in any of the Jana Sangh manifestos from

Its idea of defence policy came through such demands as compulsory military training for all boys and girls, removal of licences for possessing muzzle-loading guns (an eighteenth century weapon) and expansion of the National Cadet Corps.

Interestingly, like Atmanirhhar Bharat. Jana Sangh's swadeshi meant giving subsidies to local industries and also tariff protection. Import of consumer goods and luxury goods would be discouraged. Labour rights including strikes and lock-outs would be discour-

In 1957, the party announced it would introduce 'revolutionary changes' to the economic order, which 'will be in keeping with Bharativa values of life'. However, these were not elaborated on nor was this theme of revolutionary change picked up again in any future manifesto. Culturally, the party stood firmly against alcohol and sought nationwide prohibition. And it wanted English to be abolished and replaced in all spheres by local languages and especially, Hindi.

There is no comment whether positive or negative on the Constitution, which was adopted months before the first Jana Sangh manifesto, or even about the ideals it represents. Ambedkar had proposed modest changes to Hindu personal law, especially on the question of inheritance for women. He identified the two dominant forms of traditional inheritance law and modified one of them to make inheritance fairer for women. In its 1951 manifesto the Jana Sangh opposed this reform.

While it signals anti-Muslim intent, the Jana Sangh did not have the transparency of the Bharatiya Janata Party and its open dislike of Muslims. The Jana Sangh was unable to express its majoritarianism as clearly and in as full-throated a fashion as the BJP was later able to. This was because it lacked a specific programme on the back of which to mobilise anti-Muslim sentiment, such as the campaign against the Babri Masjid. It was not important as an issue all this time. The lack of a mass-mobilisation issue nationally meant that the Jana Sangh remained a minor political player, getting only a few seats in each election. In the last election it contested under its own name, in 1971, the Jana Sangh won 22 seats and 7 per cent of the vote, making it only the fourth largest party. It was only under Advani and then especially under Modi, that the BJP became the mass-based electoral force it has become, from the cadre-based party that was the Jana Sangh. It is remarkable that this should have been achieved in the absence of a coherent, consistent ideology and even a definition of what parivartan it stood for and would bring.

# **KEEP FUEL OUT OF GST**

FOCUS ECONOMY

Governor Shaktikanta Das has said that bringing petroleum products under GST will lead to initial sacrifices but will beget benefits in the long run. A report of the State Bank of India has calculated that the initial loss of revenue will be to the tune of ₹1 lakh crore. At present the Union government collects excise duty and the states collect VAT or Sales Tax on the price of oil after adding excise duty. This leads to a cascading effect because an increase in excise duty leads to automatic increase in VAT as well. Bringing petroleum products under GST will merge the two taxes and then there shall not occur any cascading effect. The question, however, remains wherefrom will the loss of ₹1 lakh crore revenue be made up? The ₹1 lakh crore presently being collected from oil will have to be collected from increasing GST collection from cloth, paper, bikes and other items. In other words, bringing petroleum products under GST will not lead to a reduction of taxation. It will only lead to shifting of tax from pe-

from oil or from cloth and paper. It needs to be noted that we import 85 per cent of the oil consumed by us. Thus, reduction of tax on oil will lead to lower price, increased imports and will challenge our economic sovereignty. Instead of increasing, we need to reduce our consumption of oil so that we are less dependent on imports. Thus reduction of tax on oil as proposed by bringing it under GST will push us in the opposite direction and make us more dependent on imports.

In this backdrop we need to understand the statement made by Petroleum Minister Dharmendra Pradhan that bringing oil under GST will lead to the development of the oil sector. Indeed the reduction of price of oil will lead to higher consumption. Instead of

installing solar panels, an industrialist may find it profitable to install a diesel generator. The question, however, is whether we should seek such development of the oil sector or we should, instead, seek the development of the solar energy sector? As said above, increased consumption of oil will be counterproductive. We should instead aim for improving the quality of oil consumption. Petroleum may be used only in such locations and uses that cannot be energized by alternative sources of energy such as solar or wind power. For example, I had purchased a small 500 watt petrol generator for my house in the eighties. At that time the solar panels were very expensive and not a viable option. Today, I have installed a 240 watt solar panel instead because solar panels have become relatively cheap while the price of petrol has gone up. The use of petroleum is justified only for such uses that cannot be served by other domestic and renewable sources of energy such as transporting goods to remote areas

This much is true that bringing oil under GST will lead to the same price of oil in the entire country. An industrialist will not have to consider the price of oil while making a decision to establish a factory. This will lead to greater efficiency in allocation of resources. At the same time, this will remove the autonomy of the states in deciding the VAT collected on oil by them. At present some states collect taxes at a higher rate and use the revenues for securing public good such as forest conservation, water harvesting, vaccination or providing better law and order. Other states collect low VAT on oil. Their logic is that low VAT and low price of oil will encourage industrialists to establish factories in their state. The people will have higher disposable income and attain higher standard of living as well. Both considerations are justified. Welfare is obtained by high taxes and higher expenditures on public facilities; as well as by lower taxes and more encouragement to businesses. However, the people of a state that spends money efficiently will be benefitted by collecting high VAT; while the people of a state that spends money inefficiently will be at a loss by higher VAT. Thus, autonomy of VAT acts as an incentive for states

to spend efficiently. The state gov-

ernment can explain to its tax-

payers that they are getting ben-

efits from the higher expenditures.

Thus, autonomy acts as an incentive for states to spend money efficiently.

The states today have freedom to choose which of these policies they will adopt. Bringing oil under GST will end this autonomy of states and remove the incentive of

Further there is a crisis in the making. The Union government had estimated that the revenue from GST will increase by 14 per cent every year. Accordingly, it had promised the states that it would compensate them if their share of GST will increase by less than 14 per cent. This compensation is to be paid for the first five years of GST ending on June 30, 2022. The states will have to stand on their own feet after that time. The actual increase in GST revenues has been about five per cent per year. There exists today a shortfall of nine per cent from the estimated 14 per cent increase. Thus, on June 30, 2022 the states will see a huge drop in their revenues. The receipt will decline on that date because the actual GST collections have risen only by about 5 per cent. In this situation the states will scramble to raise additional revenues. One obvious source would be higher VAT on petroleum products. Bringing oil under GST will prevent the states from raising revenues from this source and cause much pain.

The two main points are that bringing oil under GST will lead to lower prices and higher consumption of oil and the government will have to collect the same revenue by imposing higher taxes on other commodities. The resulting higher consumption of oil will make us more dependent on imports and affect our economic sovereignty. Secondly, the reduced autonomy of the states will act as a disincentive for them to attain efficiency in expenditures.

# Is nuclear peace with North Korea possible?

Forth Korea's recent public for. The reason is simple: as with all displays of new intercontinental and submarineraised fresh concerns about the poses to the US mainland. As President Joe Biden's administration reviews US policy toward the DPRK over the past four years and draws what lessons it can from Donald Trump's nuclear summitry with North Korean leader Kim Jong-un, it should consider a new arms-control approach.

The failure of Trump's efforts should surprise no one. After all, prior US administrations' initiatives to stop North Korea's nuclear-arms programme - including Bill Clinton's 'Agreed Framework,' the six-party talks during George W. Bush's administration, and Barack Obama's 'Leap Day' agreement came to naught. Quite the contrary: North Korea withdrew from the Nuclear Non-Proliferation Treaty in 2003, and has failed to abide by a 1992 accord with South Korea pledging to keep the Korean Peninsula free of nuclear weapons.

All this diplomatic activity leading nowhere raises a fundamental question: Does nuclear-arms control have a future on the peninsula?

It does, but not as currently practiced. It should be clear by now that Kim will not abolish his nuclear arsenal, or permit a verifiable nuclear freeze, as some have called

nuclear-armed countries today, nuclear weapons remain the regime's launched ballistic missiles have ultimate security blanket. The bomb also provides Kim with leverage risks the regime in Pyongyang over South Korea. The challenge, then, is to ensure that North Korea never uses its nuclear arsenal.

> Realising this aim will require a combination of classic deterrence and new diplomatic thinking specifically, a normalisation of US-North Korea ties. America currently provides deterrence on the Korean Peninsula through its offshore air- and sea-based nuclear umbrella over South Korea, while nearly 30,000 US ground and air troops in the country supplement more than three million active and reserve South Korean troops.

> But relying on deterrence alone against North Korea cannot assuredly prevent or manage missteps, because the country's isolation from the rest of the world breeds unique perils. As menacing as North Korea is today, Cold Warera China under Mao Zedong's leadership posed a far greater threat to American interests. Mao intervened in the Korean War against the US, fomented the Taiwan Strait crises later in the 1950s, and encouraged wars of national liberation against Western powers. When President John F. Kennedy's administration entered office in 1961, it regarded China as a rising nuclear bête noire and considered military action against it.

But America did not bomb away, and Richard Nixon's subsequent opening to China and the normalisation of relations during Jimmy Carter's presidency neutralised US concerns. Despite the absence of a bilateral nuclear-arms limitation treaty, China's arsenal remains largely a low-level issue amid current Sino-American tensions.

Likewise, US diplomatic influence over Pakistan, and its ties with India, helped slow the momentum toward nuclear war during the 1999 Kargil conflict and in the aftermath of the 2001 Jaish-e-Mohammed terrorist attack on the Indian Parliament. To be sure, the centrality of North

Korea's nuclear enterprise to the survival of Kim's regime would complicate any effort to normalise diplomatic relations. Then there are questions about how to build a diplomatic relationship. Can or should the process begin with the opening of embassies, in the hope that this will engender confidence and enable the two countries to address substantive issues? Or can negotiators get down to details immediately? Either way, two priorities stand out. North Korea needs relief from international economic sanctions, and the US needs to eliminate North Korea's capability to strike it with intercontinental ballistic missiles (ICBMs).

Sanctions, domestic mismanagement, natural disasters, and

economy - by Kim's own admission – in desperate need of repair. For America, which currently lacks effective ballistic-missile defenses, the prospect of being in North Korea's nuclear crosshairs is unacceptable. Could this point to a possible trade-off, namely the lifting of sanctions in exchange for the elimination of rockets? Such a deal would leave North Korea's theater nuclear force untouched and help mend the country's economy while reducing the risk of a preemptive American strike. It would also immunise the US against a possible North Korean ICBM attack, leaving it better placed to meet South Korean and Japanese security needs.

COVID-19 have left North Korea's

To determine whether Kim's regime would be open to serious negotiation, the Biden administration could initially endorse socalled Track II diplomacy - former US government and non-government interlocutors meeting informally with North Korean officials in third-party countries. If the outreach sparked interest in Pyongyang, the door to formal talks would open. The challenge will be to convince leaders on both sides that diplomatic normalisation leading to an ICBM-sanctions tradeoff is the best path forward.

# **DMK poll promises:** 75% jobs for locals, steps to ban NEET

Chennai, March 13: The opposition DMK in Tamil Nadu Saturday released its party's manifesto for the April 6 Assembly elections in the state, making a slew of promises in cluding free computer tablets with data card for students and a law to provide 75 percent of jobs in the state to locals.

Financial assistance of Rs 25,000 to one lakh persons going on pilgrimage to major Hindu temples increase in maternity leave period steps to ban NEET were the various promises made by the Dravidian party. Releasing the manifesto, DMK President Stalin said if his party was voted to power, first generation graduates will be given preference in government jobs, reservation in private sector will also be insisted and promised subsidies for small farmers

"Tablets with free data will be provided to government school and college students," Stalin told a press conference at party headquarters Anna Arivalayam.

If voted, the party will reduce the rates of petrol and diesel by Rs 5 and Rs 4 per litre, he said in an apparent reference to tax cuts. Also, a subsidy of Rs 100 towards LPG cylinder will be provided.

Steps will be taken to expedite the submission of a committee (Arumughasamy Committe) report formed to probe the circumstances leading to the death of Chief Minister J Jayalalithaa in 2016, he said.

Further, a law to set aside 75 percent of jobs in industrial houses for locals will be passed if the DMK was voted to power, he added

Promising an allocation of Rs 1000 crore towards renovation and consecration of Hindu temples. Stalin assured to provide Rs 200 crore for churches and mosques.

# Guj's alcohol permit applicants double in 3 yrs

THE STATE GOVERNMENT GIVES LIQUOR PERMIT TO A PATIENT ONLY AFTER THE RECOMMENDATION OF THE LOCAL MEDICAL BOARD

Gandhinagar, March 13: A new data presented in the Gujarat state Assembly points out towards the helplessness against the growing number of alcoholism patients, and the failure of the healthcare system. The number of new alcoholism patients in Gujarat has more than doubled in just three years' period, from October 2017 to September 2020.

From October 2017 to September 2018, a total of 1,717 patients applied for liquor to be obtained under the health permit, which is issued to an alcoholic patient. Also, from October 2019 to September 2020, there were a total of 3,587 patients who were issued such a permit, which is more than double.

The state government gives liquor permit to a patient only after the recommendation of the local medical board. These figures were released in the Gujarat Assembly during the ongoing budget session.

Shailesh Parmar, the Congress legislator from Danilimda, had sought the information regarding the health permits issued from October 2017 to September 2020 in It's not only a worrying picture

for the new alcoholism patients in Gujarat, but also a matter of concern that there has been no improvement in the patients who are already having the permits and are being treated.

The number of such patients is also constantly on the rise as the



33 per cent from a total of 6,259 in 2017-18 to 8,309 permits in 2018-19, which further climbed by 23 per

cent as 10,189 permits were re-

According to the renewed and fresh permits issued in 2019-20, the state has a total of around 13,776 alcoholism patients who needs alcohol for their treatment.

The maximum patients are from the financial capital Ahmedabad 5,101. Surat has the second highest patients, 1,600, followed by Vadodara with 1,345, Rajkot 717, Kutch-Bhuj 691, Anand 566, Porbandar 564, Jamnagar 444, Bharuch 433 and Bhavnagar with

While the patients of alcoholism increasing, the state government is also earning through the health permits issued to them. During the said period of three years, the government earned around Rs 20 crore. The new patient is charged Rs 1,000 for obtaining the health permit, whereas the charges for its renewal is Rs 3.000.

### Haasan targets Muslim, Dalit vote banks



Chennai, March 13: Makkal Needhi Maiam (MNM) chief Kamal Haasan is expecting to make inroads into the Muslim and Dalit vote banks in Tamil Nadu, which is quite vital for electoral gains in the April 6 Assembly polls.

Haasan, who is a Brahmin himself, has been vocal in extending his support to both the Muslim and Dalit communities

During the election campaign in the 2019 general elections, the actor-turned-politician, while speaking at a public rally at Aruvarakurichy which has a large Muslim presence, had said that the first 'terrorist' of the country was a Hindu in an oblique reference to Nathuram Godse.

Although the statement had not endeared Haasan to the Muslim community, but his actions and support on several issues have made the community feel that he will support them.

Abdul Basith Khan, a Muslim trader and an activist of the Jamat Islami Hind, while speaking to IANS said: "Of course we love and respect Kamal Haasan as he had publicly stated that the seeds of extremism in India were sown by Godse by murdering Mahatma Gandhi." There are around 5.85 per cent Muslims in Tamil Nadu, going by the 2011 census.

While there are several Muslim political parties including the Indian Union Muslim League, Manithaneya Makkal Katchi, All India Majlis-e-Ittehadul Muslieemen (AIMIM) and Social Democratic Party of India (SDPI) in the fray in Tamil Nadu, the MNM chief has a special support base among the Muslims and the star is also banking on it.

While there is no dominance of any Muslim vote bank in any of the constituencies of Tamil Nadu, the 2,000 to 20,000 votes in some constituencies from the Muslim community can be a game changer in more than 100 constituencies of the 234 Assembly seats of the state.

Kamal Haasan is clearly targeting the Muslim vote bank and his public postures in issues like CAA and Ram Janmabhoomi is to attract this base.

The Dalits are a stronger community in Tamil Nadu with around a 20 per cent vote share. While the Viduthalai Chiruthaigal Katchi (VCK) led by Thol Thirumavalavan MP is the prominent Dalit party of Tamil Nadu, Dalit votes are divided among the DMK, Congress and AIADMK with a small share to the BJP too. Haasan has invoked the memories of several Tamil Dalit heroes and is trying to capitalize on their popularity to get into the Dalit vote base. Vaidayanathan K, MNM office bearer at Arkonam, told IANS: "Haasan is certainly a good votecatcher and issues like this will take him forward and we expect Dalits voting in large numbers for our candidates.

The MNM is contesting 154 seats in the Assembly polls and the party leaders are targeting both the Muslim and Dalit communities to get their support to ensure smooth wins for the party candidates.

Three adolescents get

Gandhinagar, March 13: The Vibrant state of Guiarat is also vibrant as far as rape of adolescent girls is concerned. The state has seen more than three rapes of adolescent girls everyday during the past five years. According to the state government figures released in the ongoing Assembly session there were 6,215 incidents of adolescent girls raped in the period from October 2015 to September 2020.

Congress MLA from Petlad. Niranjan Patel had raised the question before Gujarat Chief Minister Vijay Rupani as to how many rape incidents had occurred from October 2015 till September 2020 in Gujarat, how many persons were still to be nabbed and what action did the government take to curb

In reply the Gujarat government's home department informed that during the said period a total of 6.215 adolescent girls were raped in Guiarat. Practically this amounts to more than three rapes of teenage girls everyday in Gujarat which boasts of having coined the slogan, 'Beti Bachao, Beti Padhao'.

The maximum number of rapes were registered in the largest city, Ahmedabad with 977 cases. The highest number of gang rapes was also registered in Ahmedabad, 9 during the same period. The Diamond City, Surat was second in line with 753 rapes in 5 years. Surat incidents of adolescent girls being raped in the period from October 2015 to September 2020

period. Bhavnagar witnessed 432 rapes of adolescent girls from 2015 to 2020 and 6 incidents of gang rape. The Saurashtra capital, Rajkot witnessed 311 incidents of teenage girls raped and 4 incidents of gang rape. The North Gujarat city of Mehsana registered 272 rapes, Rajkot rural 271, Vadodara city 270, Ahmedabad rural 214, Chhota Udaipur 179, Surat rural 174, Morbi 171, Jamnagar 163 and Patan 153 rapes of adolescent girls.

Out of these 6,215, the Gujarat Police still has to arrest a total of 209 persons connected with the crimes. In response to what steps did the government take to prevent such crimes, the home department replied that 39 women police stations were set up across the state. For the protection of women, 181 'Abhayam' women helpline was made available. The department had also launched an Abhayam 181 mobile application on August 6, 2018.

Moreover, Women Security Committees were set up at the village, tehsil and district levels across the state and every district

### Man booked for selling false **Covid negative** reports in Gujarat

Rajkot, March 13: An FIR has been registered against a laboratory agent for allegedly selling false COVID-19 negative reports to people in Gujarat's Rajkot city, police said Saturday

According to the police, the accused Parag Joshi managed to procure COVID-19 negative certificates for people who needed them for Rs 1,500 each

Based on a complaint lodged by deputy medical officer Dr Parag Chunara, a case has been registered against Joshi and other unidentified accused under relevant provisions of the IPC, Disaster Management Act and Gujarat Medical Practitioners' Act at Gandhigram police station, an official said



Joshi ran a home sample collection centre and sold COVID-19 negative reports to people without collecting their swab samples,

"We have learnt that the sample of a different person was sent to a laboratory with the documents of the person in whose name the report was to be issued," the offi-

The laboratory would then issue a report in the name of the person whose documents it received, he said. The accused also did not have a licence to run the sample collection centre, and was hence also booked under the Gujarat Medical Practitioners' Act, the official said, adding that further probe is underway.

# Ecologists urge parties to take up human-animal conflict as poll issue

Chennai, March 13: Leading environmentalists in Tamil Nadu have urged political parties to take effective measures to resolve the humananimal conflict in the state. The conflict has claimed 81 human lives since 2016, they say. The environmental activists called upon the political parties to take up this issue and include it in their election manifestos.

V. Surendra Kumar of the Coimbatore-based organisation Sraddha, while speaking to IANS, said, "Human-animal conflict is a major concern for state administrators. We don't know whether the political parties who are wielding power have any concern for this issue and if this is not taken up seriously, it is certain that more human lives and crops will be lost."

As many as 81 people lost their lives in wild elephant attacks since 2016 which is an average of 16 peo-



ple a year. Kumar elaborated, "Politicians who frequently visit Krishnagiri, Coimbatore and Nilgiris are aware of what is happening, but without an initiative nothing will happen and it is high time that pre-

ventive measures are taken." The Tamil Nadu Agriculture department also attributed the heavy losses to crops to attacks by wild animals including wild boars, pigs and even elephants which reach the human settlements bordering forest areas in herds. Shanmughasundaram, Deputy Director, Tamil Nadu Agriculture department, while speaking to IANS, said, "Indeed there are heavy crop losses through wild animal attacks. Mostly the issues are settled through crop insurances but there are instances where this hap-

pens late. The government has formulated several policies and we are trying to make the settlement process quick and convenient. However, farmers must also not encroach on forest land for cultivation and in certain cases it is such encroachment in the habitat of elephants that leads to attacks.

With loss of lives and crops becoming a regular phenomenon, agriculturists and environmentalists are jointly of the opinion that a concrete policy must be there to put an end to such losses.

R Veerapandyan, President, Nilgris District Farmers Association, said: "The government must take pro-active measures to bring to an end these conflicts. This has to be taken as a priority or we may have to take to the streets. We have already petitioned all the major political parties to make this a top priority matter in their election



# Implementing ancient TN electoral system will be a major reform

The present system of electing people's representatives is not a foreign import but was practiced in 920 AD as per the inscriptions in a temple in Uthiramerur in Kancheepuram

Chennai, March 13: Implementing the ancient Tamil Nadu system of electing people's representatives will be a major electoral reform that would clean up the existing system, is the general view of the people who visit Uthiramerur and see the stone inscriptions.

The present system of electing people's representatives is not a foreign import but was practiced even way back in 920 AD as per the inscriptions in a temple in Uthiramerur in Kancheepuram district about 90 km from here

"Electoral systems in ancient times can be seen in temple stone inscriptions in Uthiramerur, Madurai and other regions. Archaeologist G. Thirumoorthy told IANS. Not only electing their representatives, people then had the right to recall their elected representatives, state the stone inscriptions.

It is election time in four Indian states and one Union Territory viz Assam, Kerala, Tamil Nadu, West Bengal and Puducherry.

Prime Minister Narendra Modi while laving the foundation stone for the new Parliament building in December 2020 pointing Uthiramerur said, "There are in-

scriptions on stones in Tamil language about the Panchayat system prevalent during the Chola Empire in the 10th century.

"It explains how every village was categorized as Kudumbu, which

we call the ward today. One representative from these kudumbus was sent to the General Assembly, as it happens today. The General Assembly, which used to take place in this village thousands of years ago, is still there," Modi said.

He also said the stone inscrip-

tions also mention the disqualification norms for the candidate who contests in the election.

"And, the rule was that the public representative or his close relatives would not be able to contest the elections if he fails to furnish the details of his property," the Prime Minister said. In those days, the village assembly drafted and finalised election rules and also guidelines on the public servant's personal and social life. There were committees/boards to look after irrigation

tanks, roads and other subjects. As per the rules, the village was divided into 30 wards with one rep-

resentative elected from each ward. The qualification prescribed for contestants was that they should be between 35 years and 70 years of age, paid taxes on farm land and had homes built on a legally owned land. A person, already a member of a committee, was ineligible to contest for three years.

An elected member could be disqualified on the grounds of incest, bribery, illegal grabbing of someone's property and acting against the public interest, read the inscriptions. Murderers, drunkards, swindlers and those having extra marital affairs with married

women were not allowed to contest. In case of an elected member proven guilty, he, his family members and blood relatives could not contest polls for seven generations.

According to the inscriptions, the public servants were elected through the system called Kudavolai. As per the system, voters were expected to write the name of preferred candidate on a palm leaf (pannai olai in Tamil) and put that in a huge mud pot (kudam in Tamil), placed at a central place.



# J&K ex-MLAs call for resumption of political process

ex-legislators council said. It said the council discussed the current political, social and economic situation prevailing in Jammu and Kashmir and was of the opinion that the current impasse on the restoration of a political process has only added to the miseries of the general masses

It sought intervention of the Lt Governor to impress upon the Union government for resumption of political process, the statement

The meeting was attended by former ministers Ram Paul, Jagjivan Lal and Haji Nissar, former MLA Gul Rafiquee and ex-MLCs Kashmira Singh, Brij Mohan Sharma, BL Bhat, Depinder Kour, Iqbal Butt and Firdous Tak.

"The participants observed that a delay by the Union government in restoring the democratic political system in Jammu and Kashmir creates an adverse effect and negates the very purpose of a federal structure," the statement said.


Also, the watchdog has directed airlines to treat a passenger as "unruly" in case the person violates the protocols.

New Delhi, March 13: Amid concerns over dangerous side-effects of the Oxford's COVID-19 vaccine, India is evaluating all serious adverse events post-vaccination to determine the causality aspects of Covishield and Covaxin, an expert associated with the process said Saturday.

His comments came in the backdrop of some European countries suspending the Oxford-AstraZeneca COVID-19 vaccine Covishield over fears that it may be causing dangerous blood clots in some people.

India has reported 234 adverse events following immunisation (AEFIs), including 71 deaths, for both the vaccines till Friday said Dr N K Arora, an advisor to the national AEFI committee.

Manufactured in India by the Serum Institute of India (SII), the Oxford vaccine is one of the two vaccines being used in India currently, the other being Covaxin



made by domestic company Bharat Biotech. "Till Friday, 234 AEFI's (adverse events following immunisation) (for both the vaccines) including 71 deaths have been reported. The district and state level initial investigations have found no causal relationship vaccine and these events,' Arora, an advisor to the national AEFI committee, told PTI.

"The national AEFI is reviewing these cases again for a final causality assessment," he said. "No specific vaccine is being looked at. We are carrying out a detailed evaluation of

all the serious adverse events including deaths and hospitalisations following vaccination to determine the causality aspect for the both vaccines-Covishield and Covaxin. If any cause of concern emerges, it will be conveyed," Dr Arora said.

The WHO had on Friday said there was no reason to stop using the vaccine as several countries suspended the use amid concerns of blood clotting. The WHO's global advisory committee on vaccine safety is presently reviewing the

### Centre's panel for air quality control in NCR shuts down within 5 months -

New Delhi, March 13: The central Quality Management in National Capital Region and its Adjoining Areas has been shut down within five months of its constitution.

The commission, which was established by the Centre October last year, has shut down due to lapsing of the ordinance under which it was set up.

Speaking to PTI, Union Environment Secretary R P Gupta said the since ordinance was not introduced in Parliament within six weeks of its convention, it has lapsed and consequently, the commission also stands shut.

The ordinance never became an Act. Any ordinance has to be introduced within six weeks of convening of Parliament. It did not happen so the ordinance is lapsed, hence the commission is dissolved," Gupta said. The commission was headed by M M Kutty, former secretary to the Ministry of Petroleum and Natural Gas. Official sources from the ministry said they will The commission, which was established by the **Centre October last** year, has shut down due to lapsing of the ordinance under which it was set up

try to introduce the ordinance in the next session of Parliament and in the meantime, the state pollution control board and Central Pollution Control Board (CPCB) will be the supervising authorities.

Faced with rising air pollution in Delhi-NCR, the Centre had introduced the ordinance that put in place the commission and provided for up to five years of jail term and Rs one crore fine for violators with immediate effect.

Under the ordinance released by the Ministry of Law and Justice on October 28, the Environment Pollution (Prevention and Control) Authority (EPCA) was dissolved and replaced by the commission. The 20-member commission was

set up under the ordinance, which was signed by the president on October 28, to ensure strict compower to lay down parameters of air quality, parameters of discharge of environmental pollutants, inspect premises violating the law, ordering closure of non-abiding industriesplants, etc.

The ordinance may be called the Commission for Air Quality Management In National Capital Region and Adjoining Areas Ordinance 2020. It shall apply to national capital region and also adjoining areas in so far as it relates to matters concerning air pollution in the NCR. It shall come into force at once," the ordinance had said. As per the ordinance, the areas where it was in force included Punjab, Haryana, Rajasthan and Uttar Pradesh, adjoining areas of the NCR and Delhi where any source of pollution was located.

The commission had the power to restrict any industry, operations or processes or class of industries that could have implications on air quality in the region.

# 'Transport connectivity can dramatically boost economies of India, B'desh'

Kolkata, March 13: Seamless transport connectivity between India and Bangladesh has the potential to increase national income by as much as 17 per cent in Bangladesh and 8 per cent in India, says a new

World Bank report Titled Connecting to Thrive Challenges and Opportunities of Transport Integration in Eastern South Asia, the report contends that improving transport connectivity between the two countries could increase exports even further, yielding a 297 per cent increase in Bangladesh's exports to India and a 172 per cent increase in India's exports to Bangladesh.

Previous analysis indicates that Bangladesh's exports to India could increase by 182 per cent and India's exports to Bangladesh by 126 per cent if the countries signed a free trade

Geographically, Bangladesh's location makes it a strategic gateway to India, Nepal, Bhutan, and other East Asian countries. Bangladesh can also become an economic powerhouse by improving regional trade, transit and logistics networks, said Mercy Tembon, World Bank Country Director for Bangladesh and

While trade between India and Bangladesh has increased substantially over the last decade, it is estimated to be \$10 billion below its current potential, Tembon said, adding The World Bank is supporting the government of Bangladesh to strengthen regional



and trade transit through various investments in regional road and waterways corridors, priority land ports, and digital and automated systems for trade.

Today, bilateral trade accounts for only about 10 per cent of Bangladesh's trade and a mere 1

per cent of India's trade. In contrast, in East Asian and Sub-Saharan African economies, intraregional trade accounts for 50 per cent and

22 per cent of total trade, respectively. In fact, it is about 15–20 per cent less expensive for a company in India to trade with a company in

Brazil or Germany than with a company in Bangladesh, the report points out. High tariffs, para-tariffs, and non-tariff barriers also serve as major trade barriers. Simple average tariffs in Bangladesh and India are more than twice the world average, the World Bank report said.

The report analyses the Bangladesh-Bhutan-India-Nepal (BBIN) Motor Vehicles Agreement (MVA); compares it with international best practices; and identifies its strengths as well as gaps for seamless regional connectivity.

The report also discusses regional policy actions the countries can take to strengthen the MVA and proposes priorities for infrastructure investments that will help the countries maximize its bene-

fits. Weak transport integration makes the border between Bangladesh and India thick. Crossing the India-Bangladesh border at Petrapole-Benapole, the most important border post between the two countries, takes several days.

In contrast, the time to cross borders handling similar volumes of traffic in other regions of the world, including East Africa, is less than six hours, the report highlights.

The eastern sub-region is poised  $\rightarrow$ to become an economic growth pole for South Asia. An important component of this development potential is for countries to invest in connectivity - rail, inland waterways, and roads, said Junaid Ahmad,-World Bank Country Director

There is a need to end politics over it (vaccine) given that it is a scientific fight not a political one. That is why we should work unitedly, Vardhan said. The efforts of our scientists are praiseworthy as due to their labour we have achieved all this. Year 2020, apart from being a



COVID-19 year, will be remembered as the year of science and scientists, he added

He said that initially there was only one laboratory in India for COVID-19 testing. But we have 2,412 testing facilities now, he added.

We were the first in the world to isolate the coronavirus. We isolated its mutation. And our scientists helped the ICMR in vaccine. People have praised it (vaccine). Some people tried to create confusion, but truth is unbeatable, he said.

Talking about the rising infection cases, the minister said this disturbing trend was due to the carelessness and misunderstanding.

People think that as the vaccine has come and all is well now, he said, while urging them to follow the COVID-19 rules for protection against the virus.

### Amarnath yatra to start June 28

Jammu, March 13: The annual 56-day Amarnath yatra will commence June 28 with all COVID-19 protocols in place, and culminate, as per the tradition, on the day of Raksha Bandhan festival August 22, officials said Saturday.

They said the registration process for the pilgrimage to the 3,880-metre high Himalayan cave shrine in south Kashmir would begin April 1 through 446 designated branches of Punjab National Bank, Jammu and Kashmir Bank and YES bank in 37 states and Union Territories.

A decision to this effect was taken at the 40th board meeting of the Shri Amarnath Shrine Board (SASB) chaired by Lt Governor Manoj Sinha at Raj Bhavan here, the officials said.

Last year, the yatra was restricted to a group of Sadhus due to coronavirus pandemic, while in 2019 it was called off mid-way due to a "terror threat" August 2, three days before the Centre revoked provisions of Article 370 and divided the state in to two union territories

In 2019, over 3.42 lakh pilgrims visited the Hindu cave shrine, housing the naturally formed ice-shivlinga, while the highest number of over 3.52 lakh pilgrims paid their obeisance at the shrine in 2015.

As many as 3.20 lakh offered their prayers at the shrine in 2016, 2.60 lakh in 2017 and 2.85 lakh in 2018, the officials said.

between 10 and 50 to the famed Sabarimala temple, as suggested by the apex court a few years ago. Incidentally it was Vijayan who led from the front and even went to the extent of heralding a renaissance movement, soon after the apex court ruled the entry of all women to the Sabarimala temple in 2018.

What then followed was a never seen strong protests and a 'battle' between the believers and the police.

At one point of time two women in the hitherto banned age group was able to get a darshan at the famed temple, with a strong police force accompanying them.

Even though at the moment the case has been referred to a sevenmember bench of the Supreme Court, Surendran, in an open admission, altered the earlier position and Thursday said looking back on what happened, all of them are deeply sad.

"We have made it very clear that whatever is going to be the apex court verdict, we will go forward only after taking into the views and opinion of all concerned into confidence," said Surendran.

It was the Congress party which fired the first salvo, when last week the party leadership said if elected to power, Kerala will bring legislation on women's entry to Sabarimala temple.

Not to be outdone, CM Vijayan announced all not-so-serious cases registered against the protesting believers, then will be cancelled

and it was done last week. Reacting to the Devasom Minister's regret, state BJP president K Surendran Thursday said even if the state minister takes a thousand holy dips in the Ganga, his wrong position taken then cannot

be cleaned away.

"I am sure all of you will remember the statements made by their top brass including Vijayan and

the State Devasom Minister that for a few votes, they will not change their stand. And see now the hypocrisy of the CPI-M. It was after he took over as Devasom Minister, he was out to destroy the temple culture and systems that were there. See, now what they are saying, they are sad it seems," lashed out Surendran. The CPI-M which was routed in the 2019 Lok Sabha polls, when they managed to win just one of the 20 seats. The general perception was that it happened because of their wrong stand in the Sabarimala issue.

In the days ahead, it's clear that both the BJP and the Congress will go hammer and tongs against Vijayan on this issue, as the firststatement on this came from none other than the Devasom Minister.

# Floyd family agrees to \$27mn settlement amidst ex-cop's trial

Minneapolis, March 13: The city of Minneapolis on Friday agreed to pay \$27 million to settle a civil lawsuit from George Floyd's family over the Black man's death in police custody, as jury selection continued in a former officer's murder trial. Council members met privately to discuss the settlement, then returned to public session for a unanimous vote in support of the massive payout. It easily surpassed the \$20 million the city approved two years ago to the family of a white woman killed by a police officer.

Floyd family attorney Ben Crump called it the largest pre-trial settlement ever for a civil rights claim, and thanked city leaders for "showing you care about George Floyd.'

'It's going to be a long journey to justice. This is just one step on the journey to justice," Crump said. This makes a statement that George Floyd deserved better than what we witnessed May 25, 2020, that George Floyd's life mattered, and that by extension, Black lives matter."

"Even though my brother is not here, he's here with me in my heart," Philonise Floyd said. "If I could get him back, I would give all this back." L Chris Stewart, another attorney who worked with the famFloyd's family attorney Ben Crump called it the largest pre-trial settlement ever for a civil rights claim, and thanked city leaders for showing

# US to reconsider objections to H-1B visas during Trump regime

Washington, March 13: The Biden administration has said it is will ing to reconsider the objections or ers on visas like H-1B, the most sought after among Indian IT professionals, due to the three policy memos by the previous Trump regime which now have been rescinded.

The move is expected to come to the rescue of a large number of Indian IT professionals who were having a tough time during the previous Trump administration due to various policies and memorandums on non-immigrant work visas, in particular the H-1B.

The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in spe-

cialty occupations that require theoretical or technical expertise. The technology companies depend on it to hire tens of thousands of emplovees each vear from countries like India and China.

The US Citizenship and Immigration Services (USCIS) on Friday announced "it may reopen and/or reconsider adverse decisions" on Form I-129, Petition for a Nonimmigrant Worker, made based on three rescinded policy memos.

The USCIS said it will generally use its discretion to accept a motion to reopen filed more than 30 days after the decision, if filed before the end of the validity period requested on the petition or labour condition application, whichever is earlier, and the decision was based on one or more policies in the three rescinded H-1B memoranda.

On June 17, 2020, the USCIS issued Policy Memorandum 602-0114, which officially rescinded two prior policv memoranda. First titled "Determining Employer-Employee Relationship for Adjudication of H-1B Petitions, Including Third-Party Site Placements," that was issued on January 8, 2010; and second "Contracts and Itineraries Requirements for H-1B Petitions Involving Third-Party Worksites," issued on February 22, 2018.

# WHO discourages Covid-19 vaccine export bans: Officials

Geneva, March 13: Following reports of Covid-19 vaccines being restricted for export, World Health Organization (WHO) officials have expressed their disapproval against the practice.

"The WHO is always very concerned about export bans on products that will help to end the acute phase of this pandemic. Mariangela Simao,

Assistant-Director General for Access to Medicines and Health Products, said at a virtual press conference Friday.

"So the WHO very much discourages the use of this type of measure," she continued.

In a newsletter Tuesday, European Council President Charles Michel said: "The UK and the US have imposed an outright ban on the export

# 4 killed as forces continue crackdown on protesters

Mandalay, March 13: Security forces in Myanmar Saturday again met protests against last month's military takeover with lethal force, killing at least four people by shooting live ammunition at demonstrators.

Three deaths were reported in Mandalay, the country's secondbiggest city, and one in Pyay, a town in south-central Myanmar. There were multiple reports on social media of the deaths, along with photos of dead and wounded peo-

ple in both locations. The independent UN human rights expert for Myanmar, Tom Andrews, said Thursday that "credible reports" indicated security forces in the Southeast Asian nation had so far killed at least 70 people, and cited growing evidence of crimes against humanity since the military ousted the elected government of Aung San Suu Kyi.

Reports on social media also said three people were shot dead



Friday night in Yangon, Myanmar's largest city, where residents for the past week have been defying an 8 p.m. Curfew to come out on the streets.

Two deaths by gunfire were reported in Yangon's Thaketa township, where a protest being held outside a police station was dispersed. A crowd had gathered there to demand the release of three young men who were seized from their home earlier Friday night. Photos said to be of the bodies of two dead protesters were posted online. The other reported fatality Friday night was of a 19-year-old man shot in Hlaing township.

Tesla investor sues

New York, March 13: Tesla Inc been sued by a shareholder who accused him of violating his 2018 settlement with the US Securities and Exchange Commission over his Twitter use.

According to a complaint unsealed late Thursday in Delaware Chancery Court, which also names the electric car company's board as defendants, Musk's "erratic" tweets and the failure of Tesla directors to ensure he complied with the SEC settlement have exposed shareholders to billions of dollars of losses.



The complaint highlighted several Musk posts on social media platform Twitter, including his assessment last May 1 that Tesla's stock price was "too high," prompting a more than \$13 billion tumble in Tesla's market value.

Chase Gharrity, the plaintiff, said Musk's actions and the directors' inaction have caused "substantial financial harm," and that they should pay damages to Palo Alto, California-based Tesla for

breaching their fiduciary duties. The lawsuit was filed even though Tesla's share price has soared nearly fivefold since Musk's "too high" tweet, giving Tesla a valuation well above \$600 billion. and the SEC has not publicly ac-

cused Musk of recent violations. "It could pressure the SEC into taking some sort of recourse," said Charles Elson, a University of Delaware professor and corporate governance specialist.

Tesla did not immediately respond on Friday to requests for comment. Gharrity's lawyers, Musk's lawvers in the SEC case,and the SEC did not immediately respond to similar requests.

### China denies \$1billion fine

# Bitcoin hits \$60K for first time ever

Paris, March 13: Bitcoin briefly rose above \$60,000 for the first time Saturday, as increasing backing from corporate heavyweights helps the world's most popular virtual currency continue its record-breaking run. The cryptocurrency hit an all-time high of \$60,012 at 1149 GMT, according to the website CoinMarketCap.

Bitcoin has been on a meteoric rise since March last year, when it stood at \$5,000, spurred by online payments giant PayPal saying it would allow account holders to use cryptocurrency.

Last month Elon Musk's electric carmaker Tesla invested \$1.5 billion in the virtual unit, while Twitter chief Jack Dorsey and rap mogul Jay-Z said they are creating a fund aimed at making Bitcoin "the internet's currency

Others jumping on the bandwagon include Wall Street player BNY Mellon, investment fund giant BlackRock and credit card titan Mastercard. Bitcoin, which was launched back in 2009, hit the headlines in 2017 after soaring from less than \$1,000 in January to almost \$20,000 in December of the same vear.

The virtual bubble then burst in subsequent days, with bitcoin's value then fluctuating wildly before sinking below \$5,000 by October

# 'Fintech sector valuation to touch \$150-160bn by 2025'

The report noted that over the past five years, Indian fintech companies have raised about \$10 billion from investors all over the world, catapulting the sector's total valuation to an estimated \$50-60 billion

New Delhi, March 13: India is strongly poised to realise a fintech sector valuation of USD 150-160 billion by 2025, translating to an incremental value-creation potential of about USD 100 billion, a report by Boston Consulting Group (BCG) and Ficci said.

The report, titled "India FinTech:  $A\,USD\,100$ bn opportunity", noted that over the past five years, Indian fintech companies have raised about USD 10 billion from investors all over the world, catapulting the sector's total valuation to an estimated USD 50-60 billion

"India is strongly poised to re-

alise a fintech sector valuation of USD 150-160 billion by 2025, translating to an incremental value-creation potential of approximately USD 100 billion. "Further, it is estimated that to

meet this ambition, India's fintech sector will need investments of USD 20-25 billion over the next five years, The report said India has seen a

sharp rise in the number of financial technology (fintech) firms. Of the over 2,100 fintech firms existing in India currently, 67 per cent have been set up in the past five years. While Indian fintechs have cu-

mulatively raised more than USD

10 billion since 2016, eight fintech

companies have reached the "billion-dollar-valuation" milestone (unicorns) and an additional 44 are valued at over USD 100 million as of date, it added.

The report said COVID-19 has accelerated the pace of digitisation across categories. While certain fintech segments (for example, lending) may see a blip in the near term, there is a large sustainable behaviour change towards digital offerings in financial services

Between March 2020 and January

2021, UPI payments (by value) have risen to 3x of their pre-pandemic value, while other payment modes have declined. Similar acceleration has also been seen in online broking, where the share of active clients with fintech discount brokers (Zerodha, Upstox, 5paisa) grew from 43 per cent to 57 per cent in the same timeframe. India has seen a significant surge in fintech valuations over the last 12-14 months, with three new unicorns (Pine Labs, Razorpay and Digit Insurance) and five new 'Soonicorns" (about to become unicorns) being created since January 2020, the report said. "We believe that India's fintechs

are at the precipice of a significant

value-creation of USD 100 billion over the next five years.

"To actualise this potential, the industry would require additional investments to the tune of USD 20-25 billion," BCG Managing Director and Partner Prateek Roongta said. Consequently, the number of Indian fintech unicorns, will more than double by 2025, he added.

"The fintechs that will achieve  $\rightarrow$ these milestones will be the ones that "master the core" by building deep, differentiative capabilities on their primary offerings. India will also see the emergence of ecosystem orchestrators and multinational fintechs, making it a global fintech powerhouse," Roongta said.

Ahmedabad, March 13: Left shaken by a bunch of world-class operators, the Indian team's white-ball stars will be aiming to put up an improved batting effort in the second T20 International against England here, Sunday.

It was India's first white-ball game in three months and the rustiness of some of the premier shorter format players like KL Rahul, Hardik Pandya, and Yuzvendra Chahal's showed in the first game in which the hosts were clinically outplayed.

One defeat is never the end of the story and no critic can rule this Indian team out of the series on the basis of a singular performance especially because of its zeal to fight.

However, as skipper Virat Kohli talks about players with X-factors doing the job, he would expect Rishabh Pant and Pandya to do a bit more with their explosive hitting, which should not be confined to one audacious reverse scoop (Pant off Jofra Archer) or a falling ramp shot (Pandya off Ben Stokes).

They are more than capable and will be expected to give a far better account of themselves, trying to play more shots square of the wicket like Shreyas Iyer did during his

innings of 67 off 48 balls.

Both Pandya (19 off 21 balls) and Pant (21 off 23 balls) weren't able to gauge the pace of the track as Archer and Mark Wood bowled fast and straight denying them any width for the cut shot. The extra bounce also didn't allow them to drive on the up.

"The wicket didn't allow you to hit the kind of shots you wanted to. Shreyas' innings was an example of how you could use the depth of the crease, ride the bounce because there was variable bounce at times, and hit the areas square of the wicket which others failed to do.

"It was just a below-par batting performance and England made us pay for it," Kohli had summed it up aptly at the end of the match.

The captain's acknowledgement of Iyer's performance could well mean that the wait for Suryakumar Yadav might get a tad longer with only one middle-order slot available currently.

However, Kohli's propensity to change his playing XI at the drop of a hat is well documented. While giving his team's oldest member, Shikhar Dhawan, a couple of matches is perfectly understandable but how long does he want to persist with the left-hander, who

looked completely out of sorts during his 4 off 12 balls.

Rohit Sharma, as per Kohli, is rested for a couple of matches having played six consecutive Test matches along with 14 days of hard quarantine at the start of his Australian sojourn.

But Rohit's presence is very necessary at the top of the order and even though no one is really talking about it, it's been long since the Indian skipper has had an impactful T20 performance. He is too good a player to miss out.

The bowling department didn't have enough runs on board to put up a fight but whether one of the three spinners can make way for a tearaway quick like Navdeep Saini remains to be seen.

Perhaps Yuzvendra Chahal could make way for Rahul Tewatia, who may not be as crafty a leg break bowler but certainly a decent one with good batting prowess.

Eoin Morgan, one among the more likeable international captains, has been provided a team that has its bases covered with 12 players plying their trade in the IPL.

Unless something really goes wrong, this England team is a contender to win the T20 World Cup trophy in October this year with way too many powerhouse performers.

# Eves aim to level series against SA

Lucknow, March 13: The absence of power-hitters has been Indian women's bane for the longest time and they would expect all-rounder Deepti Sharma and wicketkeeperbatter Sushma Verma to up the ante at the back-end during the fourth ODI against South Africa here Sunday.

Blown away in the series-opener, India had bounced back in style in the second ODI but Mithali Raj's side couldn't go the distance in the third game, going down narrowly by six runs via D/L method.

The hosts were outclassed by an unbeaten 131-ball 132 by opener Lizelle Lee, who anchored South Africa's run-chase with consummate ease after India had posted a competitive 248/5.

Despite going strong at one stage, India couldn't step up the rate with the team managing just 27 runs in the last 30 balls following the dismissal of vice-captain Harmanpreet Kaur and this is an area the team will look to improve, especially with the World Cup less than a year away.

Deepti is one of the pillars of this Indian team but sadly, she hasn't been able to make any significant improvement when it comes to the power aspect of her game that has been lacking for a number of years.

With Neetu David's selection

committee literally creating a 'harakiri' by keeping young Shafali Verma out of WODI set-up, the

only power-hitter in the team is Harmanpreet with likes of Jemimah Rodrigues, Punam Raut and skipper Mithali Raj all possessing same style of accumulating runs and not the greatest of strikerates.

While the lower-order has failed to pack a punch with the bat, opener Rodrigues' lack of form for a long time (even before COVID-19 halted proceedings) will also be a concern for India.

The paucity of talent at the do-

mestic level means that Rodrigues' doesn't face any worthy competition from her peers and even if she is complacent, one isn't left with too many options.

She is a vital cog in the batting unit along with Raut and Smriti Mandhana, who have looked in good touch in the series so far. The first Indian woman cricketer

and second internationally to reach 10,000 runs, Mithali has had a decent run in both outings.

Veteran pacer Jhulan Goswami has regularly provided the break-

and her form will be crucial to India's chances.

The West Indies also earned a winning 2-0 lead in the three-match series.

Lewis and Hope set the strong foundation that allowed the West Indies to overtake Sri Lanka's 273/8 with two balls to spare. A middle order slump which saw the home side slip to 233/4 when captain Kieron Pollard was out in the 46th over put late pressure on the West Indies.

But Pooran made an unbeaten 35 from 38 balls to steer his team home in the final over in the West Indies' highest successful ODI run chase against Sri Lanka.

Sri Lanka batted first after winning the toss and slumped to 50/3 in the ninth over. Danushka Gunathilaka's luck turned and his 96 (96b, 10x4, 3x6) led Sri Lanka's recovery. Gunathilaka seemed to have been wronged when he was given out for obstructing the field in the first ODI which the West Indies won by eight wickets.

He batted superbly on Friday, reestablishing the Sri Lanka innings in a partnership of exactly 100 for the fourth wicket with Dinesh Chandimal (71, 98b, 3x4, 2x6).

A quick-fire innings of 47 from 31 balls (2x4, 4x6) by Winandu Hasaranga lifted Sri Lanka to a competitive total. The final ODI is at the same venue, Sunday.

# BAUTISTA AGUT ENDS RUBLEV RUN

Doha, March 13: Roberto Bautista Agut ended Andrey Rublev's Qatar Open title defense in the semifinals by upsetting the Russian 6-3, 6-3. Rublev was also aiming for back-to-back titles after winning the ABN AMRO World Tennis Tournament in Rotterdam Sunday.

The Russian was in the unusual position of playing a semifinal without having spent a minute on court in the singles tournament following a bye and two walkovers, though he had been playing doubles. Rublev

served eight aces but still had his serve broken four times by Bautista Agut. Bautista Agut is into his second final of 2021 following a loss to David Goffin in Montpellier last month. His win at the Qatar Open in January 2019 remains his most recent title on the tour.

The 13th-ranked Spanish player will face Nikoloz Basilashvili for the title in Saturday's final after the Georgian beat Taylor Fritz 7-6(7-3), 6-1. Basilashvili is in his first final since July 2019 after a Qatar campaign which included a win over Roger Federer's in the quarterfinals.

**Dubai:** Comeback-man Yuki Bhambri proved he is back to his best with a convincing win over India No.1 Prajnesh Gunneswaran in the Qualifiers of the Dubai Duty Free Championships, here Saturday. Yuki, who is competing on a Protected Ranking (PR) knocked out his seventh seed compatriot 6-1, 6-4 in the opening round of the USD 2,048,855 hard court tournament. Yuki has not lost to Prajnesh in three meetings. He had beaten the left-hander twice in 2017 – Bangalore and Karshi. The 28-year-old is now up against another compatriot Ramkumar Ramanathan, who knocked out sixth seed Russian Evgeny Donskoy 6-4, 6-4. In his five matches against Ramkumar, Yuki has emerged winner on four occasions.
