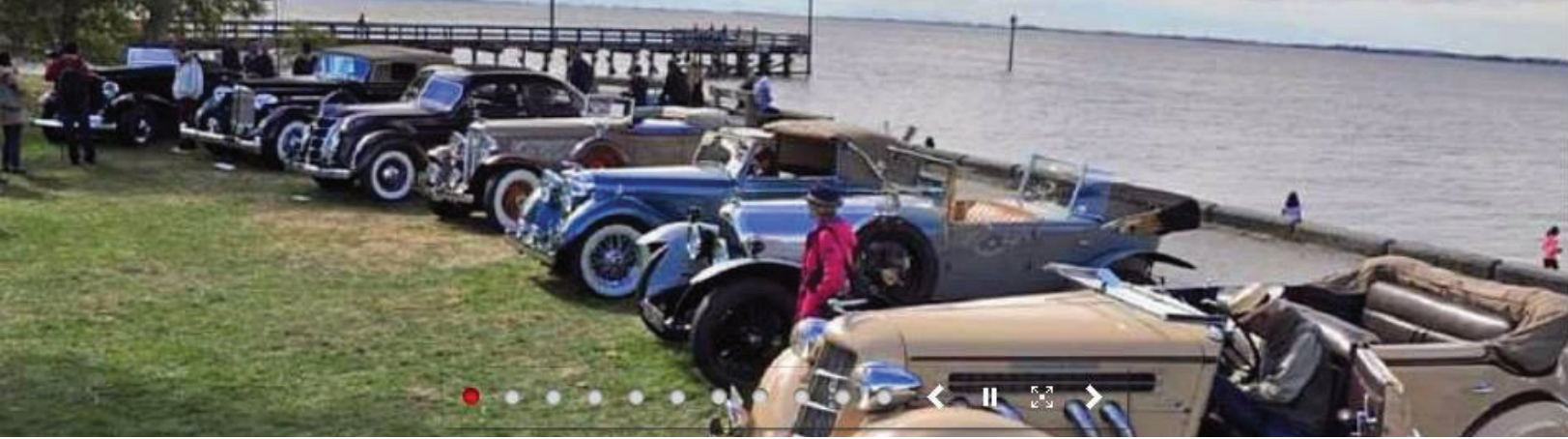

Minutes of the Nov 2018 and Jan 2019: meeting approved with corrections: Darren Wong should be Darrin Wong and the Jarvis's did attend the January meeting. There was no February 2019 meeting.

Membership: Val reported via hand-out Val of 23 lost and 13 gained for a net loss of 10. Hope that some of the lost will come back. The 2019 roster is in the mail.

Treasurer: For Jan., 2019 we had a decrease of \$9,693 due to December holiday party being paid (\$4,402) in January. The event did turn a profit. Total assets \$45,7637.
