Because we value your health, we need to maintain appropriate social distancing practices; therefore, our capacity is set at **35** people.

We ask that you make a reservation to attend worship so we can ensure that we can maintain social distancing.

We will be using Sign Up Genius so you can reserve your seating. Families do not need to observe social distancing, so we can fit 4-6 family members on one of the benches. If you come alone, you will share a bench with one other person.

Please note:

A mask is required during worship.
You might have your temperature taken at the door.
We will wave at one another during the Peace.
We will not sing as a congregation.
Communion will be distributed in one kind (bread).
You might be asked to help sanitize the worship space when the liturgy is concluded.
Refreshments and social time will be suspended for the time being.

We know this isn't optimal, but we are grateful to be able to gather as a community; we look forward to the time when it will be safer for us to gather in larger groups with fewer restrictions. Until that time, we exercise caution out of an abundance of love for one another.

Construction Update - Chairs

As an update on our building construction project, we're beginning to see the light at the end of the tunnel. The sanctuary is taking shape; the feeling for the space is becoming apparent, the walls are closing so that the workers can be inside during the winter. I hope that you will drop by for a quick tour when you are driving up and down Broadway near Covell.

Early in the project, we ordered some very nice stackable chairs made by the Sauder Company. They have stained wood frames, kneelers, and fabric seats to go in the Nave. We put 30% down payment on the chairs. Since then, Covid has taken its toll on our attendance and oil revenue has been cut in half. These events have placed pressure on our budget and we would like to offer you the opportunity to incrementally assist in the purchase of the remaining chairs.

The new chairs cost \$350 each and can be delivered prior to our inaugural service, hopefully on Easter 2021. I am asking each of us to make a special contribution to a "chair" fund to complete the purchase. You can purchase multiple chairs if you are in a position to do so.

Please give this prayerful thought and mark your checks "chair" to make sure that it goes into the right fund.

By the way, I read that we will be able to take an extra income tax deduction of \$300 for qualified contributions even though we use the standard deduction when we file our taxes next spring. What an opportunity to get a tax benefit for a contribution for chairs.

I. MEETING

The virtual meeting of the Vestry was called to order.

II. AMEND OR APPROVE MINUTES

Motion made to approve minutes; motion passed.

III. TREASURER'S REPORT

Motion made to approve the treasurer's report. Motion Passed.

III. RECTOR'S REPORT

The number of reservations for in-person services will be reduced due to increased COVID-19 infections in Oklahoma County, the number is reduced to 35, average attendance has been between 32 and 37. The reduction allows greater social distancing. Only one person has inquired about a second service.

The Christmas service details are not finalized, several ideas are being discussed.

IV. JR. WARDEN'S REPORT

The Diocese approved the sale of the property on Mary Lee Land. A realtor, Joel Hart, a member of the parish, has been engaged to represent St. Mary's. The asking price is \$225,000 for the house, after expenses the expectation is a net of approximately \$210,000 after closing. About \$9000 has been used for repair expenses. It is anticipated the house will sell within a month. The Vestry approved a motion to accept a minimum of \$200,000 with a listing price of \$225,000.

Tim gave an update on the camera and explained the efforts to configure the equipment to be used in the church including the wiring requirements. He discussed the broadcasting station placement in the church, and details about the cost and financing proposals for the system and live streaming.

IV. SR. WARDEN'S REPORT

The Nominating Committee for New Vestry Members has a list of ten candidates and requested that Father Mark review the list to ensure that candidates are communicants in good standing. These individuals will then be contacted to determine their interest in being nominated to serve.

Andy has prepared a letter to be distributed to the parish about contributing to the cost of chairs in the new church at a contribution level of \$350 per chair. About 220 chairs are ordered, the contribution does not represent a profit on the chairs, and Andy's letter will communicate that this is an invitation to purchase rather than a requirement.

Andy proposed a meeting on December 3 for Vestry Members to meet on the budget. Vestry members reached a consensus on this date.

Andy reported that fourteen people attended the men's dinner held at his home, the next dinner will be at the home of Don Hensch.
