In part, this project led to the MFH's multimillion

dollar investment in collective impact efforts to eliminate disparities in birth outcomes in St. Louis and Southwest Missouri.

• 2016 Funded Project by Missouri Foundation of Health (MFH): Analyzed and evaluated birth certificate data in a variety of ways, including a perinatal periods of risk analysis, an analytic approach designed to lead communities to action; detailed analysis of protective and risk factors associated with neonatal and post-neonatal mortality, and geographically based, hot-spot mapping. Results support the conclusion that health is multifaceted, influenced by clinical, behavioral, environmental, and economic conditions.
