

## Twenty-Nine Years Later: A Father's Mournful Cry For His Son (By: Beckie A. Miller)

I awaken in the darkness not knowing why at first. As I lay there attempting to retrieve sleep, I hear what woke me in the first place, the saddest sound I have ever heard. It comes from him, my sleeping husband, a deeply mournful wail that emanates in the silent darkness of our bedroom. I have heard it many times over the years since our son died and it always causes me such sorrow knowing how deeply he hurts. I pat his arm and rub his back as it slowly passes, and he returns to quiet slumber without awakening. I cannot say returns to peaceful slumber, as I do not know if the nightmare has ended, but thankful the mournful sound from the depths of a father's grieving soul have ended.

It happens even now, twenty-nine years later, my husband's middle of the night cries. Another October heralds in. It is the month I wish wiped from the calendar. Our son, Brian, was eighteen-years old, robbed and shot to death by errant gang members, while walking his girlfriend home from work in our neighborhood that should have been safe. It was October 19, 1991, but Brian was also born in October, on the 1st, so I view the entire month as excruciatingly difficult. My emotions run high this month. I shop more. I cry more. I yell more. And then I hear my husband's cries again, and I rub his back and shoulder until they stop as I get angry at the injustice of any father or mother, anyone, feeling such horrifically, awful pain.

I expect the mournful cries from my husband will continue until his dying breaths, when sleep and the dark recesses of the mind bring about the painful images he manages to push down during the daytime hours and life's busy demands. And I will continue to try and comfort him knowing I truly cannot diminish the demons of his own personal grief. It is hard enough living with my own mother's grief. It is not fair what happened to us, to our son. We will never understand it or have full closure with it until we are reunited with him again one day. Faith eases the pain in that respect, but it is little solace with the here and now of missing Brian or the fact he was taken from us so cruelly and all the things in our lives since that he has not shared.

Something on a recent radio show got me thinking. Don told me he had heard this guy who asked people if they could have their loved one back, what then, and the ensuing discussion of if they would even want to come back. Maybe not. If heaven is all we of faith believe it to be and more, why would they want to leave? Another question was would they come back the same age as they died or older as they would be if living. I see Brian as forever 18 and cannot picture him as a 47-year-old man that he would be now.

When push comes to shove, I would probably be selfish and hope that my son would come back to me, to us, if he could. Then I would no longer have to hear the mournful wails from my husband at night and I would no longer feel them in my mother's heart. It hurts, no matter how much time has passed. While the journey without him is easier now, the pain softer in some ways, it is still never easy.

#### TEEN GRIEF

Teen reactions to grief in today's world:

- Isolation (feeling no one understands)
- Mood Swings (grief magnifies normal teen issues)
- •Changes who they were
- •Loss of Childhood (Feel they have to step up/grow up quick)

#### Normal Symptoms of Grief for Teens:

- Anger
- Shame
- Guilt/Regrets
- •A need to retell their story
- Intense Mood Swings
- Change in eating and sleeping patterns
- Desire to connect with person who died
- Lack of concentration
- Poor grades
- Lack of social interests for short period of time
- Worry about dying too, especially when person who died was by homicide/violent death
- Idealizing person who died
- Talking about the funeral
- Inability to express their emotions

#### Causes for Concern:

- •Overly preoccupied with death
- Acting out, bullying or clowning around
- Stopping social life for extended period of time
- Giving their possessions away
- •Using alcohol, drugs or promiscuity
- •Not functioning (remaining in bed all the time)
- Cutting themselves (be suspicious if unseasonally wearing long sleeves)
- Suicidal idealization
- Anxious or abnormally fearful

Parents and or caregivers can help grieving teens by being present, accept and validate their emotions. Show you are a constant but also create boundaries.

When teens express guilt, help them to reframe as motivation to succeed instead of an excuse to fail (ask what would your loved one who died want for you to do. Encourage them to live in honor of and for the person who died).

Normalize things for them: it is okay to feel this and okay to be sad and angry.

Encourage group sessions with other grieving teens. Keep in mind some teens cannot do group sessions and are better off with one on one counseling. Boys often find it harder to participate in group sessions as compared to girls.

In studies 40% of teens reported peers were helpful to them in the grieving process. 76% of teens reported group sessions were helpful.

Things Teens Say Most Helpful:

- Exercise/Playing Sports/Activities
- Talking to others about their feelings
- Reading
- Hobbies
- Talking to a counselor
- •Self reflection
- People being there for them

Don't ask them if they are okay.....they are not okay Ask what you can do for them

Remember there is no time limit on grief/lifelong process especially after homicide Ask if they wish to participate in the criminal justice proceedings/attend trial If fearful help them feel safer in their world (install security doors/alarms)

How to help a grieving teen

- •Build a rapport
- •Be an active listener
- •Remain present (even if just sitting quietly with them)
- Allow them to retell their story
- Provide coping skills (writing, music, poetry, etc.)
- •Be non-judgmental
- Keep a poker face (no matter what they tell you)
- Suggest ways to memorialize their loved one (scrap books, memory boxes, etc.)



#### **COUPLE COMMUNICATION (After a Child Dies)**

When you find a leaky drain, it begs to be fixed. When you hear that screeching metal-on-metal sound while driving your car, you know it is past time to fix the brakes. But when a child dies and you are unable to function due to a broken heart, is it appropriate to seek a fix from your partner? The question, "If it is broken, does it need to be fixed?" is a common dilemma couples face after the death of their child.

We all know people who have a strong need to offer solutions to others' problems. When a death occurs, this 'fix it' type immediately begins searching high and low for the right tools to make it better. If they find that one tool does not work, they frantically search for another. In addition, the one to be 'fixed' might often look to their partner to fix things for them and can be very disappointed when they realize their partner cannot make them all better.

While a "fixer" can be either a man or a woman, it does seem that dads frequently take on this role after the death of a child. Possibly because men are raised to believe they need to be the protectors of their family, they find it difficult to just sit with their partner in a puddle of tears, replaying the injustice and anguish of this tragedy. Often, it seems, men are propelled by a sense of responsibility to take some sort of action – to do something.

Undoubtedly, there are many times in a couple's life where this is a highly valued attribute — when those brakes need fixing, a sound or smell awakens them in the middle of the night, or there is a threat to life or home. However, after a child dies, there is nothing anyone can do to fix it or make it significantly better. Unfortunately, some

individuals do not come to this realization until they are well into the grieving process and have learned the hard way that their good intentions are not useful or even wanted.

The more emotional partner (more often than not, the woman) looks to her support system, particularly her mate, to stand by while she dwells, replays, and remembers their child and the full details of the loss experience. She may simply want to relive the moments, even though they are painful. In her own way, she needs to be "in the experience." And while she may openly share her sadness and frustrations aloud, she is not really looking to be fixed and is not seeking advice about how to move forward. She feels better if she vents, getting it off her chest.

In ordinary times, these two coping styles seem to work for most couples. One is more intuitive and into feelings and might be the one to notice the leak and ask for help. The other might love spending hours at the hardware store looking for exactly the right tool, or at least know what to say when the plumber calls back. This ying and yang probably keeps the relationship in balance.

But everything can go out the window after a child dies. Now, each word and action is measured and noticed. One partner may want the other to cope in "his/her way," in the manner that seems to work for them. When men don't cry or talk enough, women often say, "He just doesn't seem to care. He seems to be 'over it." "I bet he doesn't even think about Robby anymore."

Conversely, men may fear their partners have gone crazy. They worry, "She can't seem to shake it. I don't know if she'll ever be happy again. No matter what I do or say I can't even get her to smile or want to go out and have fun." He's trying to make her feel better and hiding his sad feelings so as not to add to her pain. She sees this as disinterest and moving on. It is like two ships passing in the night.

This doesn't need to happen. With direct communication, honesty, and an understanding of each other's loving motives and goals, relationships can improve.

If you are a problem-solver type person, use that energy to fix things in the house or the car. But when it comes to your partner, I strongly encourage you to hold back. Instead, offer a shoulder to cry on or words of encouragement like, "You are right, this is so unfair," or "I agree, this is a difficult time for me, too." This is called active listening; you are making time to allow your partner to have and express those feelings. Since you can't take them away or magically make them better, don't even try. And, by the way, if you are one who cries or feels deeply sad, offer up that information. It will go a long way toward helping your partner understand where your heart is.

If you are one who grieves by sharing emotions, and you recognize that the process you are going through requires sitting in the puddle of pain while you remember and think of your child, let your partner know you can't be fixed or made better. Try not to ask your partner to be your one-and-only listener on a daily basis, unless that is working for both of you. This can be very hard for someone who is "action" and "moving forward" despite their own pain and sadness. Because their feelings of helplessness pile up as they hear over and over how you feel, find others to hear your stories and your thoughts. Write in a journal or to others on the internet. Attend a support group or seek out a counselor. Rely less on your partner to be that listener and you may find your relationship in a better place.

Of course, keep the doors of communication open. Be gentle and honest with each other. If you have a strong faith, ask for God's help. You have the opportunity to enhance your relationship and build on this test of strength, endurance, and love. Talk and listen to each other. Believe in each other.

#### "Intimate Strangers"

I don't feel I know you anymore, You don't seem to know me like before. Intimate strangers we have become, though outwardly we look the same to some. You lost a son; I lost him, too. The grief from his death has stolen much from you. The ache of his loss took away part of me. We share the same pain yet grieve differently. The changes we feel may all be inside, They've left us no room from each other to hide. I look in your eyes, a mirror of my own pain. You look in mine and see how I've changed. Can we get back what once was us? How do we recapture what we have lost in the midst of the millions of tears we've cried, and continue to weep for our child who died? We've shared the worst, but also the best. Our love has been put severely to test. You are my life despite my grief. Take my hand, come surely to me.
