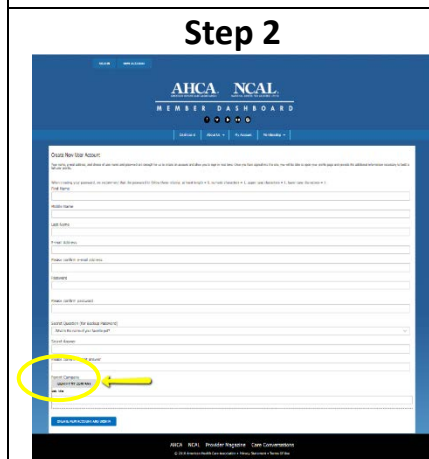

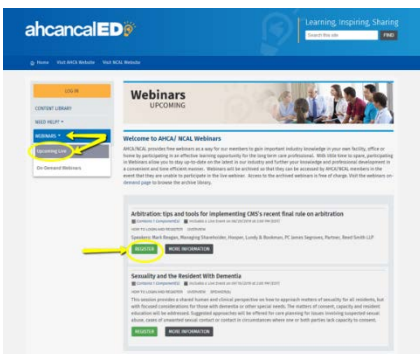

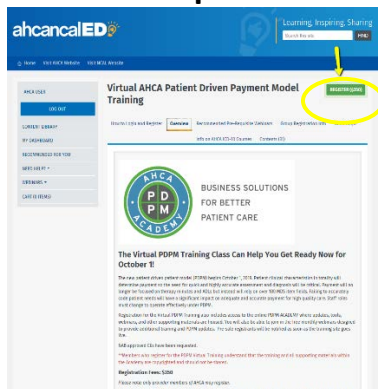


From the home page click on a category (Resources, Training, Webinars or On-Demand Training) For this demonstration, let's try **Webinars- Upcoming Live**.
