The book is the product of an intensive four-year research project sponsored by the Catholic Peacebuilding Network in collaboration with the Kroc Institute for International Peace Studies at the University of Notre Dame and the Bernardin Center for Theology and Ministry at the Catholic Theological Union in Chicago. Sudan: the Church Confronts Risk of New War

In January 2011, southern Sudan will hold a referendum on independence from Sudan. Will this lead to peace or new violence and instability? The Catholic Church in Sudan, with the assistance of Catholic Relief Services and other Caritas agencies, has intensified its long-standing peacebuilding efforts as the referendum approaches. With the U.S. Conference of Catholic Bishops (USCCB) and CRS, the Sudanese Bishops' Conference has launched a campaign: **Change Your Heart, Change the World: Reflections for 101 Days of Prayer towards a Peaceful Referendum in Sudan.** The USCCB and CRS have also launched a **Peace in Sudan initiative** asking Catholics to Pray, Learn, Advocate, and Give to promote a peaceful transition in Sudan. Bishop Paride Taban, Bishop Emeritus of Torit, Bishop Daniel Adwok Marko Kur, Auxiliary Bishop of Khartoum, and John Ashworth, Acting Director of the Denis Hurley Peace Institute in South Africa, will be in the United States with an inter-religious delegation for high-level meetings in Washington and New York.

Cardinal Rosales Urges Philippine Government to Withdraw Troops from Mindanao

Gaudencio B. Cardinal Rosales has urged the Government of the Philippines to withdraw troops from Mindanao, which has suffered from decades of violence. Mindanao Dioceses, CRS and CPN Collaborate on Peace and Reconciliation Workshops

For two weeks in August, the Catholic dioceses in Mindanao, CRS and CPN collaborated on a series of Peace and Reconciliation Workshops designed to enhance the study and practices of Catholic Peacebuilding in the region. Archbishop Antonio J. Ledesma, S.J. (chair, episcopal commission on

interreligious dialogue and convenor, Bishops-Ulama Forum), Fr. Robert Schreiter (Bernardin Center, Catholic Theological Union), and Scott Appleby (Kroc Institute, University of Notre Dame) led three sets of workshops for hundreds of Church leaders at the diocesan and parish levels. These workshops were a follow up to a 2-day workshop on peacebuilding for 70 bishops held in Manila in January 2009 under the sponsorship of the Catholic Bishops' Conference of the Philippines, CRS and the CPN. Religious Leaders Develop Peace Strategy to Address Lord's Resistance Army

According to Fides News Service, "Religious leaders from the four countries affected by the violent raids of the Lord's Resistance Army (LRA) have signed a commitment to apply pressure locally and internationally to find a peaceful solution to a crisis that began in 1986 in northern Uganda and that has extended to parts of southern Sudan, northeastern Democratic Republic of Congo (DRC), and south-eastern Central African Republic (CAR).... Religious leaders, in calling for a peaceful resolution to the LRA crisis, propose to: distribute leaflets and radio messages of peace to the LRA combatants, urging them to desert; prepare a welcome program for former combatants; increase the humanitarian aid to populations in need and for the displaced; detect and block the supports that allow the LRA to continue the war." Annual Week for Peace in Colombia

From September 5–12, the Catholic Church in Colombia celebrated its annual Semana por la Paz (Week for Peace). This year's theme was "integral reparations" for the victims of the conflict. Since 1987, Semana por la Paz has brought together all sectors of the Church, with active involvement by civil society organizations, to highlight the need for peace, justice and human rights in Colombia. Guatemalan Bishops Speak Out Against Violence, Corruption and Mining

The Guatemalan bishops issued a major statement on the violence and corruption that are contributing to political and social instability in Guatemala. They also deplored the "profound and progressive ecological damage taking place in many parts of the country," expressing support for Bishop Alvaro Ramazzini and Cardinal Rodolfo Quezada who have spoken out about open-cast mining and oil drilling by foreign companies in Laguna del Tigre. Archdiocese of Jos, Nigeria: "Religion Alone Should Not Be Blamed" for Violence

The recent violence in Plateau State (central Nigeria) was at the heart of discussions at the 8th General Assembly of the Archdiocese of Jos. The Archdiocese issued a statement that emphasizes, in part, that "...dialogue of life means reaching out lovingly to another person, irrespective of ethnic or religious differences....The lack of clear understanding of the origin and cause of the crises has generated problems even among Christians. While some see nothing in the crises other than the attempt by Muslims to encroach on the sacred space of what is considered a very Christian State, others think that the root causes of the crises are ethnic, social and political, but given a religious coloration. The crises must be put in right perspective. The causes are multiple and so religion alone should not be blamed" (8/23/2010).
