Preface

Malnutrition and overweight and their consequences remain pervasive public health issues for infants and children across the globe. The recent Joint Child Malnutrition Estimates from the United Nations Children's Fund, the World Health Organization, and The World Bank¹ reported that in Africa and Asia in 2011, 36% and 27% of children, respectively, younger than 5 years are stunted. At the same time, overweight affects a third of the children in many resource-rich countries and, in some communities, as many as 60% of school-aged children. An increasing trend for overweight is occurring even in developing countries. Poor nutrition in infants and children has immediate consequences for health and well-being, growth, and development and can lead to long-term and intergenerational effects on health, reproduction, cognition, and chronic disease. This 7th edition of *Pediatric Nutrition* is meant to serve as a current resource for the practicing clinician to provide an understanding of the role of nutrients in human metabolism, the role of nutrition in the prevention and treatment of acute and chronic illnesses and the interaction between nutrients and gene function.
