A key contribution in my first term of service as chair was the thoroughgoing reconsideration of the departmental curriculum and requirements for majors, which resulted in the introduction of our Historian's Workshop course, and in a focus in the major requirements on methodology and skills of historical analysis rather than coverage of content areas.
- Chair, Women's Studies (later "Gender & Women's Studies) Program, 1986-96, 2000-05. I initiated the formation of the Women's Studies Program. This included the development of WS 101, "Women, Culture, and Society," which, like the program itself, served as a model for other interdisciplinary programs that followed. I also successfully led the proposal process for "interdisciplinary concentrations," which allowed students to do a formal concentration in Women's Studies (and then in Black Studies and Religious Studies) before there were enough offerings for a major (and before the College allowed "minors").
