

retiring at the end of the summer and that SPE is relocating from their current offices to one closer to metro New York City but still in Connecticut. They will keep their current phone numbers.

Feina Cao gave the Treasurer's report. Our balance on 12/31/2013 was \$21,340.85. Credits for rebate and interest was \$486.74; expenses for the Teleconference Meeting and bank fees were \$43.94, giving a balance on 4/30/2014 of \$21,783.65. We mentioned that the next PAD Newsletter was being put together by Kevin Menard and Changdeng Liu. They need articles promptly. The Membership report that Dave Riley emailed was read. We have 642 paid members and 105 unpaid, giving us a total of 747. We did not have a Councilor's report.

Barbara spoke about ANTEC 2014 and mentioned that ANTEC 2015 will be colocated with NPE March 23-25 in Orlando. This is one month earlier than ANTEC 2014. We will lose some of our rooms due to a Dow exhibit at NPE. We may go from 21 to 18 rooms available for presentations. Greg and Lexie discussed the PAD presentations at ANTEC 2014. The feeling was that the quality of the talks was very good. There was a range in the number of attendees. Some talks had just a handful; others had close to 60. The room was a little difficult to find, especially earlier in the week.

Vassilios joined us from Abu Dhabi and mentioned that he is coordinating the Best Paper award. He wants the ratings from the committee by next week (week of May 26). He has had 1 committee person rate the papers and needs the rest to do so. It was mentioned that we may need an Author Release Form to put the Best Paper in the PAD newsletter. Vassilios will discuss that with Barbara Spain.

Joel Lischefski, a new member to the Board, and the co-TPC with Ida Chen, asked about the deadline for certain actions for ANTEC 2015. Barbara mentioned that the first call for papers will be around June 4 and that the matrix meeting will be November 15.

We mentioned that Sanjiv will lead us in our participation in a Webinar that he is coordinating with the Upper Midwest Section and Engineering Properties Division. Barbara Spain strongly encouraged PAD to conduct a Webinar like this to give us more visibility and get more people involved with PAD. She also encouraged expansion into international areas.

The meeting was adjourned at 1:50 p.m. EDT.
