Report from PCA – June 11-16 2006

This year's Poodle Club of America annual specialty continued the tradition of being a week of total immersion in all things poodle. It looks like PCA has found a home for the time being in Salisbury MD. The community and the venue are very welcoming to the poodles. For the first time, PCA reached out to the community as well with an information booth in the lobby of the Civic Center. The booth was developed by Mary Ellen Fishler for the AKC Invitational last year. From the booth, the club distributed brochures, showed breed videos, and displayed life-size wooden poodle stand-ups in each size variety. The club also distributed hundreds of "Just Say No to Designer Dogs" buttons as part of its campaign against mixing poodles with other breeds.

Lisa Croft-Elliot kept poodle fanciers around the world up to date with show results on the website in near real time. There is some talk of video streaming for next year, for those who have to stay at home.

Poodle health research also continues to make slow but steady progress. The PCA Foundation announced a new DNA test for Neonatal Encephalopathy (NNE) in standard poodles. This gene is not widespread in the variety, but at \$40 per test, breeders can spare themselves the heartbreak of watching baby puppies slowly dying from this disease. This test was developed at the University of Missouri, which developed such a positive partnership with PCA that they may investigate other genetic diseases such as sebaceous adenitis or juvenile renal disease, both associated with standard poodles.

The National Institute of Health (NIH) which was collecting blood from all varieties of poodles last year for a size study, has broadened their scope of research to include Addison's disease and toe cancer (squamous cell carcinoma of the digit) which affects only black poodles.

The PCA Foundation voted to make contributions to the research ongoing at UC Davis to find DNA markers for Addisons disease and epilepsy. The UC Davis study of epilepsy began with standard poodles, but has been expanded to include miniature poodles. They are actively seeking miniature poodle DNA for the study, both affected and unaffected dogs. Cheek swab kits can be requested online at http://cgap.ucdavis.edu/Epilepsy.htm In addition, the PCA Foundation will donate money to the Rabies Challenge Study discussed in the last issue of the newsletter.

If you feed Purina, you can help support PCA by the Purina Parent Club Partnership Program. You are probably already saving weight circles from the bags as part of the Purina Pro Club. If Purina has identified you as a poodle breeder, they will donate 10% of the value of your points to PCA for education and health research and the same amount to the AKC Canine Health Foundation.

The California poodle clubs have teamed up to offer a Regional in September 2007 in Long Beach California. Three specialties will be held at Queen Mary Park in front of the ship the Queen Mary. The ship now serves as a hotel, so the setting will be both elegant and convenient.

Next year will mark PCA's 75th specialty show. The show will have a Diamond Anniversary theme. The club is planning some special events to commemorate this milestone. A special invitation will be issued to all living Best of Breed and Best of Variety winners to participate in a celebratory parade in the ring. It should be a stirring sight.

A DNA Test for Neonatal Encephalopathy in Standard Poodles

Mission Accomplished! Researchers at the University of Missouri College Of Veterinary Medicine have identified the gene mutation causing Neonatal Encephalopathy and have devised a DNA test that distinguishes clear, carrier, and affected Standard Poodles. This test is available NOW, and breeders are encouraged to test all Standard Poodles before they are bred. The disorder is inherited as an autosomal recessive trait, meaning that both parents must carry a defective gene for any offspring to have the disease. **Therefore, breeders who never breed two carriers to each other will not produce affected puppies in their litters.**

Neonatal Encephalopathy is a fatal disease of the brain in newborns. Affected pups are weak, uncoordinated, and mentally dull from birth. If they survive the first few days, they nurse adequately, but their growth may be stunted. Some cannot stand at all. Others manage to struggle to their feet and walk with jerky movements, falling frequently. Seizures develop in most at 4-5 weeks of age, and the puppies die or are euthanized before they reach weaning age.

The Missouri researchers began investigating this previously undescribed disease in 1997, when they examined two five-week-old Standard Poodle puppies suffering from difficulty walking and seizures. Five littermates were developing normally. Subsequently, veterinary neurologists in various areas of the country identified more than a dozen other litters with pups showing identical signs.

The research team soon suspected an inherited disease. Close to 25 percent of puppies in affected litters had the disorder, males and females equally. These litters were found in different parts of the country and thus very different environments. Despite extensive testing of affected pups, the researchers found nothing else that might cause the problem, such as infection, brain malformation, liver shunt or low blood sugar. None of the parents or older dogs in the households showed any neurological diseases. Toxins, nutritional deficiencies or infections would be expected to affect a much larger percentage of pups in a litter. The 25 percent pattern of disease strongly suggested an autosomal recessive inherited trait.

The researchers studied DNA samples from affected puppies, their parents and other relatives, as well as from dogs of other breeds for comparison. Using gene-mapping technology, they gradually narrowed the field from 30,000 genes on the 39 pairs of canine chromosomes to a small number of genes on a single chromosome. They then began testing "candidate" genes. Once they identified the abnormal gene, they were able to devise a DNA test and offer it to breeders within only a few weeks. This exciting news was reported in a March 28, 2006 press release from the AKC Canine Health Foundation.

The fee for a Neonatal Encephalopathy DNA test is \$40 per dog. Instructions and a form to send with the sample to be tested are in the "sample submission" section of the project's Web site www.canineGeneticDiseases.net/ataxia. Update on Sebaceous Adenitis Research

GENE MAPPING Some 20 years after veterinary literature first described sebaceous adenitis in dogs, SA remains quite a mystery to Standard Poodle breeders. For example, consider Michael, born in 1990 as part of the sebaceous adenitis test litter. Michael developed clinical SA when he began losing hair at about age 2 and had a very sparse coat from age 3-5. With regular oil baths, however, he had no scales, thickened skin or odor. Oil baths stopped at age 6 when he was put on a topical flea preventive, and Michael then surprised his family by re-growing coat that was soft and yet appeared normal for the rest of his 14 years.

Consider also the poodles that develop clinical SA well before reaching their second birthday, contrasted with those that test "affected" in routine SA screening but never show clinical signs of disease. Or consider anecdotes of affected dogs regrowing hair after an upgrade in diet or other environmental change. Then there's the invasive and expensive skin-punch test that can miss lesions and yield a false-negative result. Yet that screening test is the best tool breeders have, augmented by pedigree study and risk-assessment strategies, when making breeding decisions.

Things may change soon. Robert Dunstan, DVM, MS, DACVP, a respected dermatopathologist well known in the poodle world, was among the first researchers using DNA technology to investigate SA. Early pedigree data and the Standard Poodle test-litter breeding suggested a simple autosomal recessive inheritance, in which puppies receiving the defective gene from both parents will be affected with the disorder.

"The biggest problem with this disease, as everybody found out, is that SA almost follows a clear autosomal recessive pattern, but not quite," Dr. Dunstan says. "So some other factor is determining the severity or initial expression that nobody has figured out—either one gene with another factor, or more than one gene associated with the disease. Other factors, even environment, are clearly at work. It's not just that you have it or you don't."

Early SA gene-mapping studies made little headway, Dr. Dunstan notes, but he is optimistic that dramatic advances being made in DNA technology will allow researchers to solve the puzzle of SA genetics. A more complete map of the entire canine genome, reported in the December 8, 2005 issue of the journal *Nature*, was an exciting step. New gene-sleuthing tools based on that map are becoming available and may even allow scientists to close in on the multiple genes involved in polygenic disorders such as hip dysplasia.

At least two research teams are using this evolving technology to study SA. In Germany, a group is looking at SA in Akitas. In the United Kingdom, Cathryn Mellersh, PhD, and colleagues with the Animal Health Trust are studying poodles in a project supported by the Standard Poodle Club. Molly Windebank, the Standard Poodle Club Health & Welfare Officer, reports that this team has completed a genome scan of samples from affected dogs and their close relatives. Working with a quantitative geneticist, they now are beginning an analysis of data to accommodate different potential modes of inheritance.

<u>SCREENING</u> Pending progress in gene mapping, skin-punch evaluation for inflamed sebaceous glands remains the gold standard as a screening and diagnostic test (procedure at www.offa.org/sainfo.html). Early studies looking at levels of certain lipids (fats) in ear sebum to detect signs of SA were discontinued. Dr. Dunstan's current research includes studies of human sebaceous glands using lipid-analysis techniques that—like DNA technology-- have advanced dramatically. He thinks development of an SA test using this approach would now be possible.

TREATMENT A recent study found that long-term cyclosporine therapy in dogs with SA could reduce inflammation (*Journal of the AVMA*, January 1, 2005), but regular oil baths appear to help most poodles with clinical SA and remain the most commonly used treatment after any skin infection is cleared with antibiotics.
