Please remember that the Fines Penalties and Forfeitures Office is located at 610 S. Canal, Chicago, IL 60607.

The Entry Unit is responsible for the processing of entry summaries such as warehouse entries, temporary importation under bond entries (TIB), permanent exhibition entries, etc. Each filer is assigned an entry specialist in the Entry Unit. Questions pertaining to entry processing should be directed to the assigned entry specialist. A current list of entry specialist filer assignments is included in this pipeline. If you have questions on the filer assignment you can contact Stacy Ruscheinsky, Supervisory Entry Specialist over the Entry Unit, at (847) 928-6073.

When contacting a commodity team by phone, the **commodity team number** should be used. An individual import specialist's direct number should only be used when responding to a request from that individual such as a specific rejection, or request for information. General inquiries should be directed to the team number. This pipeline contains updated commodity team HTS assignments information, sorted by HTS number, and sorted by commodity team number.

When contacting AMS by phone, the **AMS group number** should be used, not an individual CBP Officer's phone number.
