**RAE/RACH Entries:** Please check the box on the entry form for RAE/RACH. Dogs entered in this class will be entered in Excellent B/Advanced B or Excellent B/Advanced B/Master. Once the limit has been reached in any class, entries will be returned in their entirety. RAE/RACH entries are eligible for the waiting list, but if \*all\* classes do not become available by closing, the multiple-class RAE/RACH entry will be returned and the next eligible waitlisted person will receive the slot.

**WAIT LIST:** A wait list will be kept to fill entries that are withdrawn prior to the closing date and time. Once the trial is closed and the limits have been reached, all entries on the wait list not accepted into the trial will be returned. There is no post-closing wait list.

**TRANSFERS:** Transfers will be allowed. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial.

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on an official AKC entry form and photocopies of entry forms without agreement and rules on the reverse side of the official AKC entry form are NOT ACCEPTABLE. Entries received without fees, or with post-dated or returned checks will not be accepted. Acknowledgement of entries will be made via email as soon as practicable.

Returned checks do not constitute a valid entry fee. The Show Secretary will add a \$30 collection fee to the amount of each returned check. Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made. Per Rally Regulations (Chapter 1, Section 4) recording fees are \$3.50 per first entry and \$3.00 for each additional entry on the same dog.

# Notice to Exhibitors

- **POLICIES REGARDING WORKING ON THE ARTIFICIAL TURF ARENA**
  - \* The following treats may be used on the turf: String cheese and slices of cheese, meat roll (non-crumbling), freeze dried treats, hot dogs, jerky treats, pupperoni, soft packaged treats (non-crumbling)
  - \* You may not use: Baby food, Braunschwieger, cheese puffs, cooked liver, cooked chicken, ground cooked meats, hard crunchy biscuits, popcorn, raw foods, yogurt.
  - \* You and your dog are required to pick up the treats from the turf.
  - \* **Please potty your dog often.** If there is an accident, there is a charge of \$5 to offset the cleaning of the turf.
  - \* Waterproof covering is required under crates and set-up areas.
- **REFUND POLICY**

Bitches in season are not permitted to compete in rally trials. The club will refund the entry fee for bitches in season that are unable to compete for that reason. Refund requests must be accompanied by a dated, signed letter on official business letterhead from your veterinarian stating the reason that your dog cannot compete. The Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. E-mails, phone calls and non-letterhead notes will not be considered.
- **TRANSFERS:** Transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial.
- Crating space is limited. No ex-pens. No unentered dogs, please. No dogs under 4 months of age on show grounds. All dogs present must be on leash or confined to their crates except when being judged.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**Exhibitors providing email addresses may receive all communication, including confirmation and judging schedule through email.**

# COVID-19 Social Distancing Plan Oriole Dog Training Club (ODTC)

**AKC Rally Trials - April 10 & 11, 2021**

As of the publication of this premium, ODTC is following the State of Maryland's Phase II Plan with respect to the COVID-19 pandemic. Adjustments to this Plan will be made as needed should the State of Maryland and /or the AKC require any changes. Any updates to this Plan will be sent to exhibitors along with the judging program. Everyone who attends these trials is covered by this Plan as outlined below.

**Any person who fails to follow this Plan and maintain at least six feet between individuals at all times during this event or on the show grounds during show hours may result in expulsion from this event.**

---

**Keep in mind that indoor crating may not be feasible and you may need to work out of your vehicles.**

**1. WHEN TO STAY HOME** – You should NOT attend the trial if you cannot answer YES to the following question on the waiver you will be asked to sign on the day of the trial: *“To the best of my knowledge, I am not infected with the virus SARS-CoV-2 or any other virus known to cause the disease currently referred to as COVID-19. I also state that I am free of symptoms of such infection including: FEVER, COUGH, SHORTNESS OF BREATH, AND/OR PERSISTENT PAIN/PRESSURE IN THE CHEST. I have also not to my knowledge been in direct contact with anyone diagnosed with SARS-CoV-2 / COVID-19 / Coronavirus in the last 14 days nor have I been at any large event gathering where proper social distancing and masks were not enforced within the last 14 days”.* Please text the event secretary if you are unable to attend (Debbie Kaminski – 410-917-3775) and at that point, you will be refunded 50% of your entry fee. Anyone who attends a public gathering must recognize they will always be at a risk that they could contract COVID-19 despite all the precautions that will be taken to reduce that risk.

**2. FACE MASKS** – will be required of everyone **AT ALL TIMES** while in the building, including while exhibiting. Your mask must cover your nose, mouth, and chin to protect others. Please bring extra masks with you (ODTC will not be providing masks). While outside in the parking lot, a mask is not required provided you maintain a 6-foot distance from others.

**3. RING SETUP** – we will be conducting a one-ring trial. Exhibitors will be asked to leave the premises at the conclusion of their final class. A practice ring will not be provided due to space constraints.

**4. NO SPECTATORS** will be permitted at these trials or on the show grounds. If an exhibitor requires an assistant, the assistant will be allowed access to the building after signing the COVID-19 waiver at the check-in table.

**5. NO CHILDREN** under 18 will be permitted at these trials or on the show grounds unless showing a dog.

**6. DOG EXERCISE AREA** – Dogs must be on leash at all times, both inside and outside the building, except when being shown in the ring. Maintain at least the required six feet of distance while you are exercising/warming up your dog outside the building and in the potty area. Please pick up after your dog and dispose of dog waste in the receptacles located in the exercise area.

# COVID-19 Social Distancing Plan

**7. CHECK-IN PROCESS** – There will be a check-in table outside the main entrance of the building. You are required to check-in prior to entering the building and may not check-in earlier than 60 minutes before the start of your first class. During check-in you will receive your armband for your class(es), sign the COVID-19 waiver, and receive instructions for navigating the building. **Please check in WITHOUT your dog.** Stay behind the tape line to maintain the six-foot distance from the check-in steward. **Masks must be worn during the check-in process.** If there is a line, maintain at least six feet between you and the next person.

**8. CRATING** – indoor crating space will be limited. Exhibitors may begin crate set up 60 minutes prior to the start of their class. When your class(es) have finished and the awards announced, you will be expected to leave the premises. Each person's crating area will have approximately 10 square feet of space. **PLEASE BRING A CLEAN TARP TO PLACE UNDERNEATH YOUR CRATE. ALL CRATES, CHAIRS AND OTHER PERSONAL BELONGINGS ARE TO BE REMOVED FROM THE BUILDING EACH DAY, EVEN IF YOU ARE COMPETING THE FOLLOWING DAY.**

**9. BUILDING ENTRANCE, EXIT AND HAND HYGIENE** – every time you enter the building, you are required to wash your hands in the designated restroom or use club-provided hand sanitizer. We will make every effort to have several hand sanitizing stations inside the arena area. Please plan to bring your own hand sanitizer, as well in case the club runs low. Please follow signs indicating the entrance and exit paths within the building.

**10. CLASS STAGING** - The Judge or Steward will communicate where the exhibitor will stand and provide instructions on what to do with articles, gloves, dumbbells and leash. Be sure to remain at least six feet from the steward's table, the ring entry, and the dog leaving. **Please avoid congregating near the ring entrance/stewards table.**

**11. PERSONAL CHAIRS** will only be allowed in your crating area. **Chairs may not be set up at ringside.**

**12. CLASS AWARDS** - At the conclusion of each class, the judge will announce the placements/qualifiers. Exhibitors will not return to the ring to receive their awards. Rosettes and qualifying ribbons will be available for pickup in a designated area apart from the ring.

**13. LUNCH** - will be on your own for all exhibitors. No food or beverages (other than water) are allowed in the arena.

**14. PHOTOGRAPHER/VIDEOGRAPHER and VENDORS** – Will not be present at these trials.

**15. PERIODIC CLEANING** - Door handles and common surfaces will be wiped down periodically throughout the trial and at the end of each day.

**16. TRIAL CANCELLATION** - ODTC reserves the right to cancel this trial at any time. Should that happen, any checks for trial entry fees will be shredded.
