- Receive service reminders customized to your personal driving habits.
- Present your Prepaid Maintenance Platinum card when you arrive for your covered maintenance service to save time.
- Receive a detailed Service History Report at the end of your coverage term confirming that your Mazda was maintained with professional Mazda care.
- If you decide to sell your Mazda to a private party in the future, Prepaid Maintenance Platinum is transferable (\$50 transfer fee applies).



## VEHICLE ELIGIBILITY

Available on any Mazda vehicle, new or pre-owned.

### AVAILABLE PLANS

Maintenance plans ranging from 1–5 years are available for purchase, and if financed, can be conveniently included in your monthly payment (subject to credit approval).

## PLAN FEATURES

### PLATINUM COVERAGE

Prepaid Maintenance Platinum covers factory-recommended maintenance services that occur during the time your plan is active. You will find these services outlined in your Maintenance and Care Guide Book.<sup>1</sup>

- Your Mazda will receive Mazda-approved parts and service from technicians who know your vehicle best.
- At each covered visit, Mazda-trained technicians will perform your vehicle's maintenance according to the Scheduled Maintenance Log.
- Major interval maintenance services that occur during your coverage term are included.

### ROADSIDE ASSISTANCE

Prepaid Maintenance Platinum also includes 24-Hour Roadside Assistance<sup>2</sup> for the full term of your Agreement. Coverage includes (parts and fluids excluded):

- Lockout Protection
- Flat Tire Changes
- Jump Starts
- Emergency Fuel Delivery
- Towing for Mechanical Breakdown and Collision Recovery

<sup>2</sup> Lockout Protection does not include the cost of key replacement. Emergency Fuel Delivery includes up to 3 gallons of gasoline up to 2 times per month at no charge. Towing will be provided to the dealership where the vehicle was purchased/leased, or to an alternate dealership if the customer chooses. Maximum towing distance is 400 miles. Customer is responsible for additional towing cost beyond that distance. Certain restrictions may apply.
