LINE-UP TRAINING

Pro-Straint Chair Procedures

Topic # 09

After discussing/reviewing the below training material in line-up (briefing), sworn staff shall sign off as completed in LMS. In the event a staff member is not present when this topic is discussed in line-up, they shall independently read, review, and complete the training.

Completion of this line-up training topic includes reviewing the associated standardized PowerPoint presentation available on the DTU SharePoint site (#09 Standard Presentation).

I. PURPOSE

The purpose of this training is to familiarize sworn staff with policy and procedures for placing an inmate into the department approved Pro-straint chair. This line-up training topic may be utilized in conjunction with the <u>Pro-Straint chair video</u> which is located online in the video training library.

II. POLICY

This training is conducted in adherence to <u>Department P&P Section Addendum F</u>, <u>DSB P&P Section I.89-Use of Force</u>, <u>DSB P&P Section I.93-Use of Restraining Equipment</u>, and Title 15 Section 1058 – Use of Restraint Devices.

Instruments of restraint may be applied to inmates in accordance with outlined procedures and Addendum F. Each facility shall outline, via a green sheet, the types of restraining equipment available as well as the storage location. In situations dealing with an inmate known to be pregnant, or in recovery; after delivery; refer to <u>DSB P&P Section M.38 – Pregnant Inmates</u>.

III. DISCUSSION

- A. Staff shall review and discuss the following topics and procedures related to Pro-Straint chairs as described in DSB P&P Section I.93 and related facility specific green sheets.
 - 1. Authorization for placement and retention in a Pro-Straint chair

- 2. Discuss and demonstrate (if a Pro-Straint chair is available) the steps necessary to prepare the chair for immediate use. Include:
 - a. Preparation includes daily inspections to ensure the Po-Straint chair is not damaged or otherwise in need of repair.
 - b. Presence and function of all straps and locking mechanisms
 - c. Presence of all D-rings
 - d. All tension straps (For wrists and legs) fully extended
 - e. All tri-folds completely open
 - f. Proper functioning of chair mobility latch mechanism
 - g. Spit mask available at back of chair (suggestion only)
- 3. Discuss and review staff/tactical team safety equipment The equipment used by the placement team will depend on what is available, and if time permits donning; at a minimum every deputy should have:
 - a. Helmet with face shield
 - b. Elbow, knee and shin protection
 - c. Chest protection
 - d. Latex gloves or other hand protection gloves (gloves may be removed if they interfere with manipulation of cuffs or straps.
- 4. Discuss and demonstrate (if a pro-straint chair is available) the steps necessary to place an inmate into the pro-straint chair. Include:
 - a. Number of deputies required for placement (include requirement for and the responsibilities of the "Safety Deputy")
 - b. Prior to placing an inmate into the Pro-Straint chair, deputies shall remove any handcuffs and apply leg and waist chains. The Safety Deputy shall monitor this process.
 - c. Waist chains handcuffs must be double-locked to prevent inmates from manipulating them and causing complications such as affecting blood circulation in the wrist.
 - d. Control of all limbs and head during placement.
 - e. Proper order of strap placement and security:



- 5. Medical staff presence, assessment, and evaluations (to include circulation check)
- 6. Discuss indications of excited / agitated delirium (ED). When encountering someone displaying ED like symptoms, those involved should recognize that the incident may represent a medical emergency as well as a law enforcement matter.

Pro-Straint Chair Procedures – Topic #09

Staff shall be trained to recognize behavioral cues which may be indicative of excited delirium and require immediate medical attention. Those signs/symptoms may include:


- a. Bizarre behavior
- b. Confusion and disorientation
- c. Unusual agitation or excitement
- d. Shouting/nonsensical speech
- e. Hallucinations
- f. Paranoia
- g. Violence (Including violence against objects especially glass or mirrors)
- h. Unexplained strength and endurance
- i. Intense struggling against restraint
- j. High body temperature
- k. Profuse sweating
- 1. Shedding clothes/nudity
- m. Insensitivity to pain/increased pain tolerance
- 7. Pro-Straint chair location for observation
- 8. Inmate observation and safety checks
- 9. Evaluation of need for inmate's continued retention in restraints.
- 10. Requirements for placements exceeding two (2) hours
- B. Staff shall review and discuss the following topics and procedures related to reporting and documentation of a Pro-Straint chair placement as described in <u>DSB P&P Section I.93</u>, <u>DSB P&P Section I.89</u>, and <u>Department P&P Section Addendum F.</u>
 - 1. NetRMS (use of force) Incident Reporting requirements
 - 2. Digital video recordings (portable device/handheld)
 - 3. JIMS Incident Reporting
 - 4. J-19A Observation logs

IV. ONGOING TRAINING

Each team should have training in place to practice Pro-Straint chair placement techniques. How frequently training is accomplished will have a direct effect on the success of the placement, the safety of the deputies conducting the placement, and the safety and well being of the inmate.













