## Ethics of Professional **Development**

Professional development is an on-going process. All early childhood professionals need to build their knowledge and skills by attending education and training opportunities; reading the latest research and best practice; and participating in technical assistance or mentoring activities throughout their careers. Practically speaking, what does that mean?

As an early childhood professional, opportunities arise in the community through our employers, state agencies, early childhood initiatives such as Delaware Stars and through higher education institutions. As a participant, we abide by an ethical code of conduct, established by the National Association for the Education of Young Children (NAEYC) in the Code of Ethical Conduct. This Code offers guidelines for responsible behavior and sets a common basis for resolving ethical dilemmas that may happen in early childhood programs.

Recently, it has come to our attention that some participants in Training for Early Care and Education (TECE) 1 & 2 have displayed unprofessional conduct using portfolios from past participants, copying quizzes and sharing quiz answers. The Delaware Department of Education, Early Development and Learning Resources Section and the Delaware Institute for Excellence in Early Childhood (DIEEC) urge all TECE sponsors and others who deliver early childhood professional development, to establish and enforce high standards in their introductory session. If an Instructor thinks guizzes or assignments have been compromised, he/she has an obligation to give a zero (0) for that assignment or guiz.

All early childhood professionals have an opportunity to display ethical/professional behaviors each time they attend a professional development opportunity. These behaviors include:

· Attending the training/education session once you have registered - organizations usually do not give

## **Delaware Health and Social Services Conducts Survey on Child Care Prices**

elaware Division of Social Services will soon be collecting information about the prices providers charge parents. This survey is completed every two years through a contractor hired by the Division. Providers will be contacted and asked what they charge for child care for infants, toddlers, preschoolers and school-age children. The Division is seeking rates that providers charge parents that are PRIVATE PAY RATES. Providers will not be called if they do not serve private pay children.

The contractor, Workplace Solutions, will soon be calling providers to conduct a brief telephone interview to ask providers 1) if they have private paying children in their care; 2) what age children they serve; and 3) what they charge for their child care services. Participation in this survey is voluntary. All information gathered by the research firm is considered to be confidential and only summary information will be reported to the state.

The Division of Social Services and the legislature will use this information about prices to help them as they set rates for state subsidized child care, Purchase of Care. The Division asks that you participate in the phone interview if you are contacted. If called, your participation will help children, parents and providers throughout the state.

refunds to those who do not attend, check upon registering as to their policy;

- Arriving on time and planning to remain in the class until it ends – organizations do not typically give "partial credit" to those who come late or leave early, check as to their policy;
- Becoming engaged in the training/education is expected – this includes turning off cell phone or other electronic devices, bringing a photo ID for the Instructor to check, bringing a pen and paper, reading or completing assignments between classes, understanding how grades are determined and participating in activities; and
- Supporting colleagues in training/education is expected – through respect, trust, confidentiality and collaboration.

Professional development opportunities provide new knowledge and a chance to share ideas, network with peers, visit other early childhood programs and reinforce what you are doing well. Take advantage of planning your professional development in advance. DIEEC has developed an Individual Professional Development Plan form that helps organize your training and education based upon your needs and desires. Some questions to reflect on include:

- What is your Qualification goal? (for example, you may be an Assistant Teacher now and your goal is to become qualified as a Teacher)
- What training/education topics are you interested in? (for example, you may be interested in science)
- What training/education topics would help you in your program? (for example, you may benefit from some behavior or social emotional development topics while looking for some new classroom strategies)
- What training/education would help you achieve higher scores using a tool such as ITERS-R, ECERS-R, SACERS or FCCERS-R? (for example, you may be looking at increasing your score in the block area)
- What training/education is required by regulations? (for example, you may need to renew your CPR certification)

### **Inclusion Credential**

The Delaware Inclusion Credential will be coordinated and monitored by the Delaware Institute for Excellence in Early Childhood (DIEEC). Successful candidates will receive the credential from the Delaware Department of Education. Successful candidates for the Inclusion Credential, are assumed to have the content knowledge and ability to work directly with children and families to affect change in the early childhood environment.

#### **Education Requirement:**

- Successful completion of Exceptional Child or equivalent coursework, minimum of 3 credits; OR
- Successful completion of 42-45 clock hours of the following Delaware Community-Based training: Including Children with Special Needs (6 hours from TECE 2) or Inclusion Best Practice (3 hours); Cara's Kit (3 hours); Success in the Classroom: How to Make Learning Accessible for All Children (18 hours, formerly Inclusive Child Care); and Special Quest (18 hours).

\*Note: Delaware Institute for Excellence in Early Childhood recommends the education be successfully completed no longer then ten (10) years prior to applying for the credential.

#### **Portfolio Requirement:**

 Process: Candidate applies to DIEEC by submitting verification of the required education and a \$25 application fee; portfolio packet is mailed to the candidate; candidate has a maximum of six (6) months to complete and submit her/his portfolio to DIEEC for review along with the \$75 review fee.

\*Note: Limited scholarships are available for the review

- Components: Philosophy Statement; Readings; Assignments; Resource File; Family Interview; and Program Visit.
- Portfolio is scored based on a Rubric, given to the applicant with the assignments; successful completion is a score of 75% or higher. The rubric includes construction, organization and quality of writing as well as content.
- A Candidate Interview is required upon successful completion of the portfolio.

## **Access Denied**

he term accessible is used throughout the Environment Rating Scales (ERS), most often associated with children's access to items in their environment. In order for something to be considered accessible, children should be able to reach the toys, materials, furnishings and/or equipment and also be allowed to use them. The most common way of making toys accessible is to place them on open shelves or in open bins within easy reach of the children. In addition, there can't be any barriers that are preventing the children from reaching the materials. Some common examples of barriers include toys that are in containers with lids that are too difficult for the children to open, a "no touch" rule where items appear accessible, but children are not allowed to use them, and materials that are stored out of sight such as under a chair or in a closed drawer. If children are not able to access the materials on their own, such as non-mobile infants, staff would need to either place the infant where she could reach the materials or place the materials within reach of the infant. In order to receive credit for accessible during an observation, it would have to be evident that the staff regularly provides access to the variety of toys required for that particular item or indicator. Unless stated otherwise, materials must be accessible for at least one hour a day, with less time required for programs operating less than 8 hours per day.

In the ECERS-R, access may be limited to a certain number of children in an area or limited to certain times of the day. However, children must have a reasonable chance to use the materials given these limitations. For materials to be considered accessible they must be within view of younger children (2-3 years old). For older children (4-5 years old), if the materials are stored in closed spaces, they can be considered accessible only if it is observed that children can freely access and use the materials. As the scores increase in the ECERS-R, a "substantial portion of the day" will often be added where accessibility is required. This means that at least one-third of the time the children are in attendance, access is required for that particular item. This can include a reasonable estimate of what is accessible

during the times not observed based on the schedule and on the teacher's report. Substantial portion of the day is an actual calculation of the times accessibility occurs.

In the ITERS-R and FCCERS-R, the term "much of the day" will often be added where accessibility is required. This is based on the observation only and does not require an exact calculation of time. Much of the day means that most of the time that any child may be awake and able to play, the required materials must be accessible. Since very young children are on individual schedules, access must be provided when any child is awake. Some common occurrences that prevent programs from meeting this requirement is that children are prevented from using the materials for long periods of time due to overly long routines where children are waiting with nothing to do, lengthy circle times that they are not engaged in, being confined in bouncy seats and exersaucers where access is not possible, or offering very few toys to non-mobile infants.

If any child who is ready to play is prevented from reaching and using materials for a total of 20 minutes during a 3 hour observation, then credit cannot be given for much of the day. A cranky baby who may need to be held and soothed may not be "ready to play" and therefore is not required to have access to the materials during the cranky time. The 20 minutes can be calculated as a combination of smaller time periods that add up to 20 minutes and does not have to occur all at one time. This is considered separately for each item, but in most cases it affects all of the items where much of the day is required. In addition to the 20 minute rule, if children are kept outdoors for 1/3 of the day or more, thereby limiting access to the materials indoors, then credit cannot be given for much of the day.

Another way children may be prevented from accessing the materials for much of the day is when they are taken for stroller rides. If most of the children are generally engaged, even if some children fall asleep, and no child shows distress during a stroller ride that is less than 20 minutes, this time is not factored into the 20 minutes when children do not have access to materials. However, if most of the children are not engaged during most of the stroller ride, it will be considered when determining much of the day in the Peer Interaction item. In addition, if the stroller ride lasts more than 20 minutes, credit cannot be given for much of the day in the Active Physical Play item since children are not able

to freely move around when confined in a stroller. Furthermore, if the children are waiting for longer than 3 minutes with no access to play materials while being taken in and out of the strollers, this waiting time will count towards the 20 minutes when children cannot access the materials.

In addition to the above information, Delaware Stars will use the following guidelines, based on further explanation supplied by Frank Porter Graham, in determining if much of the day has been met:

- Access to materials will be scored based on the first 3 hours of the observation, not based on the schedule which may allow access to the materials later in the day.
- While very young infants are confined, for example placed in a bouncer seat, the 20 minute rule does not apply if they are engaged. Accessibility to particular items would be based upon the types of items that are made accessible to the infant by the staff. Examples of a young infant being engaged by having items made accessible to him would include staff shaking a rattle in front of the infant, placing a soft doll against his body, or holding a book up close to the infant as they describe the pictures and let the infant touch the book.
- If one group time lasts longer than 20 minutes, much of the day will not be affected as long as the children are obviously engaged and are not overly encouraged to stay in the group. However, after 20 minutes, it must be obvious to the children that they can leave the group with alternatives readily available either visually or announced verbally by the staff or both.
- If children move from activity to activity in groups, even if they are engaged, but are not freely allowed to leave, much of the day is not met since the children do not have access to the materials while in these groups. In order to be considered "freely allowed to leave", it must be obvious to the children that they can leave the group with alternatives readily available either visually or announced verbally by the staff or both.

## Verification of Qualifications Review Process

# Linda's Story: A case study in an effective early childhood mental health intervention

hen Child Development Director Linda Chantler, at the Sussex Family YMCA, first heard about a new service that would help her early childhood education center learn to deal with very young children who have serious behavioral disturbances — such as refusing to follow rules, hitting, biting, throwing objects, and having tantrums — she nearly cried thinking about the one to two children per year that she has had to expel from her program over the years.

"For the safety of the other children, I had to remove these defiant and aggressive children from our program ... never knowing where they would end up or if they were able to get the help they so desperately needed," Linda explained.

While attending the Sussex Child Health Promotion Coalition Conference last October, Linda learned that young children in prekindergarten programs are expelled at more than three times the rates of students in grades k-12, while preschoolers in child care centers are expelled at over 13 times the rate.<sup>1</sup>

She also learned that the stigma of being expelled from these programs tends to follow these children through the years, often manifesting into more serious emotional and mental heath issues as these children age.

Linda knew in her heart that the program she was learning about could help end this senseless cycle and would be an invaluable resource for all involved — the very young child with serious behavior disturbances; the parents and/or caregivers; her staff, both instructors and aides; and the other children enrolled in the program.

As she learned more about this new service called, **Early Childhood Mental Health Consultants (ECMHC)**, which is offered free through the Division of Prevention and Behavioral Health Services (DPBHS), she immediately thought about a foster care child enrolled in her program that could benefit. At the time, she never imagined that within 30 days, Linda and her staff would realize a significant improvement in behavior from this particular child.

Working with Pam Morrison, the Division's Early Childhood Mental Health Consultant assigned to the

Sussex Family YMCA program, Linda and her staff completed the initial assessment. The development of a child action plan followed and, as a team, the 30-day transformation process began.

Pam met with staff weekly to review teacher observations against the child's action plan and to provide staffchild interaction coaching and consultation. Pam also provided the staff with resources that could be applied in the classroom to promote social and emotional development in young children.

"While I work with staff weekly," Pam said, "the staff works with the child daily." Pam attributes the 30-day improvement outcome in this instance to the entire staff meeting daily to ensure the action plan was followed by all.

"As a licensed mental health professional and a former child care provider," Pam noted, "I am privileged to provide this support in our early childhood programs and be able to realize such positive outcomes at a critical time of influence for these very young children."

And in Linda's case, there is an additional happy ending to this story. Seeing the dramatic change in their child's behavior as a result of the ECMHC service, the child's foster parents are now considering adoption.

This story is a reminder and testament to *what happens in early childhood matters for a lifetime*. Through the work of Delaware's B.E.S.T. (Bringing Evidenced-based System of Care and Treatment) for Young Children and Their Families, a DPBHS federally-funded initiative, there are now mental health services and treatment available statewide for young children and their families. ## Update on the Child Care Learning Collaborative:

# Taking Steps to Healthy Success: A Child Care Learning Collaborative to Promote Healthy Eating and Physical Activity

On February 4, 2011, the first session of *Taking Steps to Healthy Success: A Child Care Learning Collaborative to Promote Healthy Eating and Physical Activity* took place at the Duncan Center in Dover. The project, a collaboration between the Delaware Institute for Excellence in Early Childhood at the University of Delaware and Nemours Health and Prevention Services, was developed in order to support programs' efforts to bring about changes in their centers in these critical areas.

Over 30 programs from across the state applied to participate in the Learning Collaborative. Preference was given to child care centers in Kent and Sussex Counties serving children in poverty, as well as participants in Delaware Stars. Twenty-five programs were chosen. Of those twenty five programs, twenty are from Kent and Sussex Counties. We congratulate the twenty-five programs as they embark on this year long process. Important topics discussed over the year will focus on creating healthy eating environments and environments that promote physical activity for children. Here are a few tips for you to promote healthy eating and physical activity in your programs.

#### **Healthy Eating Environments (1)**

#### Infants:

- Meal time is a great time to engage with babies
- Respond to hunger and fullness cues
- Gently encourage new foods, in collaboration with family, around 6 months

#### **Toddler and preschoolers:**

- Meal time is a great time to engage with children, encourage conversation and work in nutrition education
- Encourage growing independence by eating family style

#### What else can you do to promote healthy eating?

- · Offer healthy choices.
- · Offer appropriate portion sizes.

- Respond to hunger and feeding cues so children recognize them.
- Enjoy being together at meal time. You are a powerful role model!

#### **Physical Activity Environments (2)**

#### Infants:

- Place infants on the floor where they can explore.
- Plan simple, safe, engaging activities both indoors and outdoors.
- Limit time in confining devices like exersaucers and swings.

#### **Toddlers and preschoolers:**

- Fun, structured quality physical activity throughout the day
- Supervised, unstructured daily physical activity

# What else can you do to help kids grow up healthy and active?

- Offer planned indoor and outdoor physical activity every day!
- Model enjoyment of physical activity by joining the children in their play.
- Encourage children to make active choices; limit sedentary choices.
- Provide safe space and appropriate equipment.
- Respond to signs of boredom, frustration or fatigue.
