Corresponding Secretary's Report

From September 16th through November 15th, the Club received 6 email and 2 phone requests for breed and breeder information. The Club also received two requests for information on the National Specialty events, two membership inquiries, two change of address requests, and one request for assistance with health issues.

One serious breed inquirer sent the following email in response to the frustration she has experienced, in not receiving responses to her inquires from PCA listed breeders:

"This is not a criticism of Puli breeders in particular because I have experienced the same thing with #### and other breed people, but it seems if we always advise the general public to get their dogs from knowledgeable breeders and not puppy mills, backyard breeders or pet stores, then the breeders need to respond to inquiries and assist prospective purchasers, even if it is to reject them as not suitable for a puppy or dog from the breeder's kennel. I have spoken to owners of pet #### purchased through the newspaper or at pet stores who said they initially tried to contact a breeder who did not respond back to them. My own first #### came from my second choice kennel because the breeder at the first choice kennel never returned my telephone call. On the other hand, when my granddaughter wanted a Golden Retriever, every breeder I contacted spoke with me or returned my emails and, even if they had no puppies available, worked to connect me with a good breeder with an expected litter so that we could begin the process of approval and place a deposit on a puppy."

If you are listed on PCA's breeders list, please make honest attempts to respond to all inquiries, even if it is to inform the inquirer that you have nothing available. The kind of situation this inquirer outlines here, is not only frustrating, but it can appear to reflect badly on the breeds parent club.

Other correspondence:

Hurricane Katrina - The Club continues to receive numerous correspondence from dog clubs and rescue organizations,

concerning animal rescue efforts after devastating Hurricane Katrina struck the Gulf Coast of the U.S. PCA has made an appeal for donations to AKC/CAR, which has responded during previous natural disasters. AKC/Eukanuba National Championship - Carolyn Nusbickel has agreed to act as liaison to AKC for the 2006 AKC/Eukanuba National Championship. If you are interested in helping to man our AKC Meet The Breeds booth at the show, please contact Carolyn, or any member of the Board. Your participation will be much appreciated. The Board received communication from PCA member Mary Ann Haring, who offered to help work the booth. Mary Ann participated last year as well. She reminds us that there is a cluster of shows in Brooksville, FL immediately following Eukanuba, January 16-22, 2006. This would seem to be an opportunity for competition in the Puli ring. As Mary Ann says, "Sure would be nice if all those coming for Eukanuba brought some Pulik for the shows! Just a thought. We might even be able to form some majors! Six shows represent a lot of opportunities!"

CRUFTS - As our June PN report indicated, the Kennel Club, in England, has designated the AKC/Eukanuba National Championship and one parent club National Specialty in each breed as the United States qualifying shows for Crufts. Dogs winning BOB, BOS and Awards of Merit at these events are eligible for entry in Crufts. PCA has now received seven qualifying award cards for winners at our National Specialty. Please keep in mind that entries to Crufts must be submitted with one of these qualifying award cards, from either the AKC/Eukanuba event or from our own National Specialty. If you are a U.S. exhibitor and interested in showing at Crufts, please contact the Corresponding Secretary for more details.

PAWS - The Club continues to receive daily updates on controversial animal legislation, PAWS. AKC is supporting this legislation, while many AKC member clubs are not. AKC/Canine Health Foundation - The Board of Directors of PCA wishes to encourage anyone who uses Purina products to consider participation in the Purina Parent Club Partnership Program(PPCPP). World-renown vaccine research scientist and practicing veterinarian, Dr. W. Jean Dodds of California, and pet vaccine disclosure advocate, Kris L. Christine of Maine, have established **The Rabies Challenge Fund** to raise money to fund a 7 year rabies vaccine challenge study in the United States.

In addition to the challenge study, the fund will finance a study of the adjuvants used in veterinary rabies vaccines and establish a rabies vaccine adverse reaction reporting system.

Rabies vaccination is the one immunization required by law across the country for domestic dogs and cats. Researchers believe this vaccine causes the most and worst adverse reactions in animals. The Rabies Challenge Fund has been founded to improve the safety of rabies vaccines and to determine, by challenge, if they confer immunity for 5, 6, or 7 years.

Delegate's Report

CHAIRMAN'S REPORT ON PAWS

New York, NY – Shortly after the introduction of the Pet Animal Welfare Statute of 2005 (PAWS), the majority of the members of the AKC® Board of Directors made a strategic decision that it was best to be on the inside working to improve the proposed legislation instead of being on the outside with no opportunity to provide positive input. Since then we have been seriously working with the sponsors of PAWS and are pleased with their response to our suggestions.

Our initial judgment to be involved was vindicated when Senator Rick Santorum (R-PA) stated his intention to amend the bill. I want to share some of those planned amendments with you as they affect breeders who register with AKC.

Any one of the following exemptions will exempt all breeders from this federal regulation:

Exempt all who breed six litters or less annually.

Exempt all who sell at retail 25 dogs or less annually.

Exempt all who breed or sell more than those thresholds if they are inspected by a non-profit organization that receives federal approval, such as AKC. It will also explicitly exempt all shelter and rescue organizations and individuals who do not import for resale or operate for profit. In addition, it eliminates any reference in PAWS to hunting and security dogs.

Persons who sell hunting dogs will be treated exactly the same as persons who sell dogs as pets.

AKC has long required "Care and Conditions" nspections on all AKC Breeders who produce seven or more litters per year. The PAWS amendment does not affect those AKC Breeders. They will not be subject to federal inspection if they have received an AKC inspection.

Registering purebred dogs with AKC is purely voluntary. AKC inspects only those who register with us and does not charge any breeder for a kennel inspection. A fee is required only for reinspection when kennels fail the initial inspection. We look forward to the day when all breeders conform to acceptable care and conditions.

As dog lovers, we are concerned about the welfare of all dogs produced by high-volume breeders, whether AKC or not. Additional provisions of PAWS will require care and conditions standards for imported dogs and dogs registered with for-profit registries that have no inspection programs. It will continue the Animal Welfare Act's (AWA) present practice of exercising oversight in the wholesale market.

As a result of the recent Senate subcommittee hearing, chaired by Senator Santorum, the Senator has promised a "discussion draft" of the pending legislation within the next few weeks. When this language becomes available we will share it with you. He assures us that he wishes to "make sure we get a good piece of legislation" and plans to work with the groups represented at the hearing to get it adopted.

The success of any legislation in Congress is uncertain, but we will continue to represent the needs and voice the concerns of our breeders in this legislative process. We are proud to continue to sit at the table as an equal, as we have since the introduction of this legislation, and strive to make a real difference that benefits our responsible breeders and the welfare of all dogs.

There has been much misinformation on PAWS disseminated. I hope the attached "Frequently Asked Questions" sheet will help you separate the fact from the fiction. Please do not hesitate to contact me if you have any questions.

PAWS Senate Subcommittee Hearing Frequently Asked Questions

HEARING UPDATE

Q: What is the status of the proposed Pet Animal Welfare Statute of 2005 (PAWS) bill?

A: The Senate Committee on Agriculture, Nutrition and Forestry's Subcommittee on Research, Nutrition and General Legislation heard testimony on PAWS on November 8, 2005. Senator Rick Santorum chaired the meeting.

Q: How was the AKC involved in the hearing?
A: The hearing included seven witnesses. AKC Chairman of the Board Ron Menaker represented and testified on behalf of the AKC at the hearing. You can view his remarks here: http://www.akc.org/canine_legislation/paws_menaker.cfm

Q: What are the additional provisions to PAWS as announced at the Senate Subcommittee hearing on November 8, 2005?

A: During the hearing Senator Santorum announced his intention to include an additional provision to exempt "retailers" who are in compliance with kennel inspection standards of not-for-profit organizations, such as the AKC, as certified by the Secretary of Agriculture. The kennel standards certified by the Secretary must be at least as effective to those required by the United States Department of Agriculture (USDA) under the Animal Welfare Act (AWA). Dealers will also have the option of a third-party compliance inspection.

Q: When will the proposed changes to PAWS be available?
A: At the subcommittee hearing, bill sponsor Senator Santorum stated his desire to release a discussion draft of the proposed legislation within the next few weeks, incorporating these changes. He further noted his commitment to working with a variety of animal interest groups, including the AKC, to ensure the development and adoption of positive legislation that all parties can support. The AKC will provide updates as soon as draft language is available and encourages purebred dog breeders to monitor our web site closely.

THRESHOLD NUMBERS

Q: Has the exemption based on the number of dogs bred and sold changed?

A: No. The exemption remains the same, although the wording has been clarified to confirm Senator Santorum's original intent as noted in his floor statement to Congress on July 25, 2005. Read his statement at: http://www.akc.org/canine_legislation/paws OA.cfm?page=2#40

Q: Why do we need PAWS?

A: The AKC believes PAWS to be positive legislation that will address many serious problems faced by the breeding community, from the recent surge in importation of puppies for resale, to the large numbers of puppies and dogs being sold over the Internet each year. (One need only read Mr. John Hoffman's article in the August 26 issue of Dog News or refer to several witness testimonies from the recent Senate subcommittee hearing to appreciate the scope of these problems.) As the premier advocate for the health and welfare of dogs, AKC believes the legislation will give the US Department of Agriculture (USDA) the tools it needs to bring into compliance those high-volume breeders who currently evade licensing and inspection. Existing laws and regulations are woefully insufficient at addressing these very troubling problems.

At the heart of AKC's efforts to support PAWS is our strong belief that the legislation is in the best interest of the health and welfare of all dogs. AKC has always been a leader in this respect, and as such strives to develop and support good legislation that protects and advances their humane care and treatment. Simply put, AKC believes this legislation is good for dogs, and that is why we are supporting it.

Q: What will PAWS do to protect fanciers?

A: The legislation actually strengthens protections for responsible hobby breeders by exempting them from federal regulation as a point of law. Currently, hobby breeders are exempt only due to USDA's classification of them as a "retail pet store" (regardless of whether they breed and sell dogs as pets or for hunting and security purposes). USDA has the discretion to change that classification at any time. However, if PAWS is enacted the exemption will be put into statute and will not be open to any agency interpretation. Furthermore, that statute could be changed only by a new Congressional enactment, something that is very difficult to accomplish. Protection for fanciers has also been secured through the recent addition of a third-party inspection exemption.

INSPECTIONS

Q: How will AKC's Care and Conditions policy enable it to become an approved third-party compliance inspector? A: AKC's current "Care and Conditions" policy and inspections program meets the broad standards as called for in the Act. AKC's concerns cover the health, safety, and welfare of the dogs and the environment in which they are kept. Inspectors look to see whether dogs are in good health, have appropriate and clean shelter, and access to food and water. In addition, the inspectors collect DNA samples to verify the parentage of AKC-registrable litters through its DNA Compliance Audit Program. In this regard, AKC's program is at least as effective as, and even exceeds through its DNA program, the broad standards of the Act itself. Not-for-profit organizations certified to do inspections by the USDA will not be required by the new PAWS language to have the same standards as in the existing USDA regulations governing large wholesale breeding establishments, but merely standards that are "at least as effective" in meeting the broad requirements listed in the Act.

Q: Does this mean the AKC will be conducting inspections for the (Continued on page 6)

USDA?

A: No. The AKC will continue to independently enforce its wellestablished inspection program to ensure the integrity of its registry and the proper care and conditions of dogs. Retailers who can show proof of compliance with kennel inspection standards of not-for-profit organizations, such as AKC, as certified by the Secretary of Agriculture, will be exempt from USDA regulation.

Q: Does the third-party exemption mean that a representative from an animal rights organization will be able to forcibly inspect my home?

A: No. If an AKC registrant (regardless of how many litters he or she breeds) is inspected by AKC, that registrant may choose to have the AKC inspection replace a USDA inspection. This will apply to USDA-licensed dealers and will also establish an exemption for retailers so they will not be classified as a dealer. There is nothing that will force breeders to allow inspectors from an animal rights organization onto their premises.

 $Q\colon \mbox{Will}\ \mbox{I}$ have to build a commercial kennel if I am inspected by AKC?

A: No. Qualified breeders who voluntarily elect to be inspected by AKC will be subject to our own Care and Conditions policy. Furthermore, Senator Santorum has stated on multiple occasions that he has no desire to remove whelping boxes from kitchens or in any way target responsible breeders.

Q: What if a new Secretary of Agriculture decides not to permit AKC to be a third-party inspector? Will that make all AKC registrants who exceed the threshold numbers subject to USDA requirements?

A: The statute language does not permit the Secretary of Agriculture to do this. The language in the new version of the statute requires the Secretary of Agriculture to establish guidelines for inspection; it does not give authority to the Secretary to determine who the third-party inspectors are. This type of change would require a new statute.

Q: Is AKC receiving special treatment?

A: No. Any not-for-profit organization that establishes an inspection program, as certified by the Secretary of Agriculture, may also conduct inspections if they desire. It is completely up to the breeder to choose who they want to be inspected by. AKC's Inspection program has been mentioned in recognition of its effectiveness and because no other organization has invested the time, effort and resources to create such a program.

 $\ensuremath{\mathbf{Q}}\xspace$ Will AKC be obligated to share its registration information with the USDA?

A: No.

Q: I raise dogs for fun and a little profit. I do not consider myself a "retail pet store" like the pet stores that sell puppies in the local shopping mall. How will the revised PAWS help distinguish me from the pet shop?

A: It will distinguish you by virtue of the number threshold or by the fact that you have been inspected by AKC. PAWS will give specific hobby breeder exemptions that do not rely on the "retail pet store" definition. Today you are exempt from USDA dealer requirements only because you are considered a "retail pet store" as interpreted by the USDA. Current laws classify everyone who sells one or more dogs as a dealer except "retail pet stores."

Q: What if I have five litters, but sell 30 pupples in a year? Will this subject me to USDA inspection?

A: No. You are still below the six litters or less exemption, regardless of how many dogs you sold.

Q: I co-own several dogs with other people, some of whom may be over the threshold numbers. Will I also be subjected to

inspections?

A: No. A co-owner who sells under the threshold will not be inspected. In fact, PAWS is not as restrictive as AKC's own standards in this matter. Under current AKC inspection criteria, co-owned dogs do count toward your numbers. This will not change. However, under the PAWS language, co-owned dogs do not count.

Q: Can I ask AKC to do my inspection in order to avoid a USDA inspection?

A: Yes. If an individual with AKC-registered dogs requests an inspection from AKC, we will honor that request. AKC will have to examine and possibly establish new policy to determine who we will inspect going forward.

Q: Will AKC charge me a fee for asking to be inspected? What if I fall an AKC inspection?

A: No. If your dogs are registered with the AKC, we do not charge for the initial inspection. We do charge a fee only if you fail the inspection and must be re-inspected.

Q: Where can I find AKC's inspection requirements? A: On the AKC's web site at www.akc.org

Q: Is AKC going to hire more inspectors?

A: AKC will hire as many inspectors as necessary in order to meet our responsibility and keep our current standards of inspecting all AKC kennels that exceed our threshold of more than seven litters produced annually. PAWS will not increase AKC's inspection burden because the PAWS criteria is less stringent than the criteria AKC already uses. Those individuals who will be brought under inspection by PAWS are already inspected by AKC if they are AKC registrants.

Q: What if this program ends up costing AKC a significant amount of money because of the need to hire, train, and cover the expenses of its inspectors? Will AKC drop its involvement? Raise its fees?

A: AKC will not drop its involvement. We will continue the rigorous inspection requirements that it has under our current policies. AKC already inspects all its registrants who will be required to be inspected under PAWS. AKC is not being mandated by the PAWS statute to inspect anyone. We have had our own strict standards for many years because AKC is concerned with the well-being of dogs.

Q: How will the USDA know that I have exceeded the threshold numbers of more than six litters bred and more than 25 dogs sold?

A: Currently, the USDA relies on voluntary compliance with their licensing requirements. One possible way the USDA might know if you exceed the threshold is if your name appeared as a wholesaler on a source record for a retail pet store or if someone filed a complaint against you with the USDA.

Q: How will the USDA know that I have already been inspected by AKC before they come knocking at my door?

A: They would not know if you have been inspected by the AKC. If a USDA inspector knocks on your door, you may show them the proof of inspection certificate from the AKC.

Q: I exceed the threshold numbers one year, but not the next? Will I still be subjected to inspection?

A: For AKC, yes, because you will be in our databases; for the USDA no, because you are only subjected to an inspection in the year that you exceed the threshold.

Q: Is an AKC inspection only good for one year?
A: It is good until re-inspection, whether that be within the period for re-inspection after a failure or within the 18-month cycle currently used for AKC inspections.

Q: Is AKC doing this in order to make a profit?
A: No. We do not charge for initial inspections of those who register their more than seven litters annually. AKC charges for inspections only after a failed inspection with major deficiencies.

Q: I raise a breed of dog that is not recognized by AKC with either full status or its Foundation Stock Service Program. Will AKC be able to help me avoid USDA requirements?
 A: Current AKC inspection policy does not cover AKC's FSS breeds. This is an issue the AKC Board will need to review and address.

RESCUE

Q: Will the new PAWS provisions address rescue groups' concerns with the bill?

A: Senator Santorum also announced at the subcommittee hearing his intention to include an explicit exemption for animal shelters, rescue organizations or individuals as long as they do not import dogs for resale or operate for profit.

Q: What will happen to my rescue organization that does make more money from the placement of dogs than it spends on rescuing and caring for them?

A: Shelter and rescue organizations that are classified as having C3 or C4 tax status are truly not-for-profit businesses and will be exempt under the statute. If the organization is truly a for-profit business, they would have to continue to do what they must do today. Shelters and rescues that do not have to have tax-exempt status still will qualify for the exemption under PAWS as long as they do not make a profit at the end of the day.

IMPORTS

Q: If I import a dog and then later sell it for whatever reason, will that make me subject to a USDA inspection?
A: No, unless you sell 25 or more dogs that year which were bred or raised on your own premises and sell an additional 25 more a year that you did not breed or raise on your premises.

Q: If I sell that imported dog and transfer the ownership, will AKC have to advise USDA that I sold an imported dog? A: No. AKC is not a reporting agency to the USDA.

HUNTING and SECURITY DOGS

Q: How will the new PAWS provisions impact sportsmen?
A: Witness testimonies and comments from Senator Santorum at the hearing provide clear evidence that there is no intent for this legislation to target responsible breeders of hunting dogs.
However, sportsmen will be pleased to know that the third-party inspection exemption noted above will apply to any "retailer," including breeders of hunting dogs, who is in compliance with kennel inspection standards of not-for-profit organizations, such as the AKC, as certified by the Secretary of Agriculture.

Q: I own a hunting breed, which I train and hunt with. Will I be affected?

A: No. The PAWS statute treats people who sell dogs for hunting, breeding and security the same way as it treats people who breed pets. The individual would require inspection for the same reasons that a person who breeds pets would; if they sell at wholesale or if they meet the numbers threshold in the statute.

Q: I raise and train German Shepherds to sell as guard dogs? How am I affected?

A: The same way as the person who breeds pets is effected. You must be inspected if you sell at wholesale or meet the numbers threshold of PAWS.

Reports

Specialty Advisor Patty Anspach was unable to attend, but reports were made from the Show Chairs of the next two National Specialties:

Linda Pitts announced that the 2006 National will be held in Knoxville, Tennessee October 27-28. The host hotel will be the Crowne Plaza, which is downtown, across from a park in a very dog friendly city. Room rates will be \$89. The National will be held in the hotel Ballroom, and most activities will be held in the hotel.

Carolyn Nusbickel announced the 2007 National will be held over Labor Day weekend at the Lancaster Host Resort & Conference Center in Lancaster, Pennsylvania. All activities will take place there; it is self-contained and includes a large show site. Golf, tennis and other activities will also be available.

Linore Cleveland was unable to attend to report on the ongoing Puli Coat Color Study, but Susan McConnell gave the following update: Sheila Schmutz is a professor at the University of Saskachewan. She has done a DNA analysis of coat color in the Puli breed and provided the club with a report. Susan plans to write an article for Puli News highlighting the key findings in this interesting technical report.

Barbe Pessina, Chair of the Constitution and Bylaws Review Committee, said work is still underway, but she plans to present proposed changes to the new Board. Changes must be approved both by AKC and PCA membership.

The Chair read from the Treasurer's report, which will be printed in Puli News. The club's bank accounts, as of September 30, 2005, totaled \$55,535.16, including income but not all expenses for the 2005 Specialty. Joe Merchant, working with the Wild Weavers club in Ohio, reports that PCA-sponsored agility trails

there have contributed over \$6,300 to PCA's accounts. PCA donated \$2,500 to the AKC Companion Animal Rescue fund, and PCA members contributed another \$4,081 to this worthy effort. The 2004 PCA Specialty contributed a net of \$3,432 to PCA's accounts.

Report of the Corresponding Secretary - Michael Rohe

From October, 2004, through October, 2005, the Club received 1 mail, 63 email, and 22 phone requests for breed and breeder information. Inquiries have really fallen off in recent months. The AKC has direct links to the current Breeder's List on their website, which I believe accounts for fewer email inquiries being routed through the Corresponding Secretary. The Corresponding Secretary's general response to inquiries includes an invitation to Puli News subscription and/or PCA membership. I hope that fewer inquiries being processed by the Secretary doesn't result in fewer new members. Our breeders need to encourage membership in PCA to purchasers of their puppies. PCA represents the best way for the owner of a Puli to stay connected with other Puli owners and the greater Puli world.

Numerous contacts have concerned domestic and foreign nonmember breeders, and online listings of puppies for sale. References for non-members cannot be given, nor can help be offered when non-members seek assistance from the Club in placing puppies.

Much, if not most, of the Corresponding Secretary's work involves frequent contact with AKC, on numerous events and issues, including the Eukanuba Championship show, and our own National Specialty. Most of this has been reported in Puli News.

The Kerry Blue Terrier Foundation has brought attention to Pulik in SPCA/rescue facilities on a number of occasions this past year, and we are grateful to this groups volunteers for searching

facilities throughout the US. They search for breeds which might be confused with their own breed, and we are fortunate to be one of the breeds they routinely search for. Special thanks to our own Rescue coordinator, Melinda Peters, for her frequent work on rescue issues, with, and without, the Foundation.

Miscellaneous expenses incurred during the year (excluding phone charges) amounted to \$113. Expenses were for USPS mailing, copying and fax charges at Staples and Kinkos, and miscellaneous supply charges, including the costs for paper, envelopes and copying cartridges. All expenses incurred are donated to PCA.

Report of the Recording Secretary - Jim Moen

It's been a pleasure filling the Recording Secretary's role for the last four years. On the face of it, there's not much to it. Just collect the monthly letters from the other board members, assemble them, add in a report, ballots if necessary, make copies and mail them all out. Send in a report to Puli News and you're done. (Really Marla, there's nothing to it and I'm sure you will find ways to streamline.)

Of course, the problem is with the details. The letters are a kind of "virtual meeting," where a give and take "dialog" among board members can take months instead of the minutes it would during an in-person meeting. We do conduct an informal discussion via email, but all voting and official Board business ends up being done via letters and the US Postal Service. The AKC has allowed some clubs, who have carefully modified their Bylaws approved by the AKC and their membership, to optionally conduct real business online, and I'm hopeful PCA will follow that same path. It would not only simplify Board operations, it would allow the Board to be more responsive to members' wishes and needs.

Report of the Treasurer - Zoltan Kocsondy

My report covers from October 1st, 2004 to 9-30-2005

I completed my second year as Treasurer of your Puli Club and I have to report that the finances for the club are in excellent condition. All our bills are paid and we have a balance of \$ 55,535.16, as of 9-30-05 in our combined PCA , Specialty and Puli News Accounts.

We had Income from several sources. Joe Merchant and the Wild Weavers held PCA Agility trials and sent PCA \$6,303.60
We instituted Dues payment via PAYPAL online. Our thanks to Jim Moen. Our Dues renewal notices included Puli Rescue which brought in \$1,217.41. Plus Donations to Puli Rescue brought in \$800.00 Puli Rescue paid out for rescues \$795.00

Your PCA donated to the Katrina animal victims, through AKC CAR \$2,500.00 And through a fund raising effort from PCA members and Friends, Including generous offers from our overseas members, non-members and from online Puli folks, Our Thanks to all that contributed Puli Rescue raised \$4,081.10 Specialty Trophy donations included on the dues notice brought in, \$1,763.97. Membership renewals brought in \$6,874.17 Reg. Dues: Associate members, \$508.54; a Junior Member \$25.00 totaling our renewals to \$7,407.71 The odd numbers are due to payments through PAYPAL.

We sold 5 Patti G trophies thru DannyQuest and earned a small Profit. **\$417.50**

Your 2004 PCA National Specialty returned a Profit of \$3,432.59, this after repayment of the trophy match (\$2,011.00) PCA has done for the Specialty. We need to thank those hard working folks who helped make this possible.

We had many hands help. I want to thank all those who helped raise money, by shirt sales, state baskets, and contributions to the raffle, the auction and silent auction. Also, the folks got us fed and a place to hold a Specialty. Those who set up and tore down and jumped in to help when asked. And to all of you who bought and paid for all this stuff. You made us stronger and my job easier! And Welcome to all you new members who joined us.

2005 Committee Reports

Agility Chairman Report - Cathy Pronzini

The PCA sponsored a three day All-Breed Agility Trial in Ohio in April and June 2005. These trials were quite successful and earned over \$6,000 for the PCA. The exact accounting was made available by Joe Merchant.

I compiled the Agility Top Ten list for 2004. Based on a report from the AKC, there were 33 Pulik competing in Agility last year.

The Board approved a change in the calculation of the Agility Top Ten points. The change was made to eliminate the extra points for placements and only calculate Agility Top Ten points based on Qualifying Scores. This change was made to eliminate an advantage that Pulik running in the smaller Preferred Agility Classes had in earning placements.

I planned an Agility Fun Match as a fund raiser for the 2005 National Specialty. This match earned \$400. I've also planned the 2005 Puli Club of American Agility Trial that will be a part of the PCA National Specialty. The one day all breed trial is expected to raise approximately \$1,000 for the Club.

I incurred expenses of \$80 during the year for research costs on the AKC website in order to compile the Top Ten in Agility list. I will donate this amount to the PCA.

AKC Gazette Breed Column Report – Tom Motter So far, I've managed to meet the publication deadlines for column inclusion throughout the year. I received positive feedback from several judges on the column I wrote in response to Ann Roger's Clark's column on consistency in breeding programs using our breed to demonstrate the positive results achieved in Pulik over the past 20 years thanks to the dedication, loyalty and hard work of the relatively small core group of long-time breeders we have.

Two judges sent me e-mails thanking me for the article I wrote in response to Dr. Jacklyn Hungerland's column on balance standards (or rather, the lack thereof) in most of the breed standards and the difficulty this causes judges. Of course, my "answer" to her, as expressed in the column, was focused on our breed. Two judges sent me e-mails thanking me for what they characterized as "useful" information.

I received mixed results on the column referencing the last specialty results...all from our own club members. The winners thought it was "Great" and "Well done". The losers all agreed it was "inappropriate".

The most controversial column to date was the one I wrote on color. Apparently I came off sounding like I have a position on color. I do not. I felt that what seems to me to be a touchy and controversial subject needed to see the light of day in a public forum. I received several nasty e-mails from Hungary although I must say my editor at AKC was quite pleased with the column

and starred it for other breed fanciers to read. Oh well!

Folks, if it isn't apparent already, I need all the help I can get. From the outside looking in, writing a 500 word breed column probably looks pretty easy. It's not. I would welcome anyone who's been a breeder and in the breed for over five years to help me out as a guest columnist. You choose the subject and write whatever you feel you would like. I promise I will not interfere in any way. (I can't promise you the AKC editor won't however!) So far, Steve and Alice Lawrence have stepped up to the plate and written what I think you will find is a very well-done and informative column on the Puli Coat, which will appear in the next Herding breed issue.

Futurity/Maturity Coordinator Report – Irma Fertl This year a new class for both dogs and bitches was added: the 18-24 months class which is called "Maturity". Therefore it is now "Futurity/Maturity". It allows more Pulis to compete and gives fellow breeders a chance to observe the growing up process of last year's futurity nominees, or at least see a certain breeding at an older age.

One Pull came back this year to compete in this new "Maturity" class, after having been nominated last year. Word will have to get out that every Pull having been nominated thru the "litter nomination (form #2)" is eligible, even if he/she wasn't individually nominated to compete in "Futurity". As long as the litter had been nominated by the breeder, and as long as s/he fits into the "18 months and under 24 months" class.

This year 5 breeders nominated a total of 8 litters, with 3 breeders at 2 litters each. Breeders are catching on and are show-casing their involvement and breeding programs. Despite this only 4 (3 for futurity and 1 for maturity) individual nominations were received to compete this year in Futurity and Maturity under Futurity/Maturity Judge Mrs. Agnes Benis.

Approximately once a month a reminder to participate was put on the NewNaturalPuli email list, and twice a year the Puli News editor would put an insert into our breed magazine.

Upon request nomination forms were either sent as email attachments or – in rare cases – by snail mail. Updated forms are always available for the asking. Once form #1 – the bitch nomination form – was received every attempt was made from my end to individually contact those breeders to also submit form #2 – litter nomination form – before the deadline for that (litter has to be nominated before pups turn 6 months of age) nomination.

To date six bitches have already been nominated for the 2006 Futurity/Maturity.

<u>Health Committee Report</u> - Barbara Edwards chair Joe Merchant, Leah Belt, Patty Anspach

There isn't a lot to report as the annual CHIC Symposium is the same weekend as our PCA national. Mike Rohe tried to get someone to cover the Chic meeting but no one was available.

There is an interesting study being headed by veterinary immunologist Jean Dodds. Of all the vaccines administered to companion animals, rabies is the only one mandated by law, which varies among states. Dr. Dodds acknowledges the importance of the rabies vaccine but it can produce acute responses such as anaphylactic shock, chronic disease can also result. Dogs cab develop injection-site sarcomas, seizure disorders and neurological problems such as Wobblers syndrome.

The Rabies Challenge Fund is set up to conduct rabies-challenge studies to determine if the immunity last for five or more years,

instead of three, the current maximum.

I would like to suggest that the PCA board approve a donation sent to the Rabies Challenge Fund. This could be taken from the money donated by members upon the death of Connie Peterson and earmarked to be used for heath research that might improve the lives of our Puli.

If you the board are interested in more information I would be happy to help you.

<u>Judges Education Committee</u> – Submitted by Committee Co-Chairs—Susan McConnell, Susi Szeremy, and Barbe Pessina

The Judges Education Committee has worked on several new and ongoing projects this year. These include:

- Breed Mentor Program: Currently we have 25 registered breed mentors. All qualified breeders are encouraged to register for the program.
- 2) <u>Breed Seminars</u>: The JE Committee arranges for Puli breed presentations at a number of judging seminars across the country. Every effort is been made to recruit local presenters and local Pulik for these presentations. Completed presentations include:
- * International Kennel Club in Chicago, Illinois (February, 2005): Patty Anspach presented the Puli and used the PCA-approved format.
- * OKC Summer Classic in Oklahoma (July, 2005): Sandy Schickedanz presented the Puli and used the PCA-approved format.
- * American Dog Show Judges Advanced Institute in Indiana, Pennsylvania (August, 2005): Joe Merchant and Jane McLane presented the Puli and used the PCA-approved format.
- 4) National Specialty Breed Seminar: The JE Committee has arranged for panelists to present the Puli at our breed seminar at the 2005 PCA National Specialty. The Committee has handled inquiries from prospective attendees, organized educational materials for distribution to attendees, and sent information to all registrants about the times, locations, and programs for all of the weekend's events.
- 5) <u>Ringside Tutoring</u>: The JE Committee is recruiting volunteers to serve as Ringside Tutors during judging at the PCA National Specialty. Volunteers will rotate to ensure that prospective judges are exposed to a variety of perspectives.
- 6) <u>Grooming Statement</u>: The JE Committee was asked to draft a statement on grooming the Puli for the show ring, to be distributed via the Judges' Newsletter to AKC judges. This statement was written, approved by the Board, and forwarded to the publisher of the newsletter in February, 2005.

Member Education Committee Report – Nancy Guagenti For the past two years, Member Education has provided an educational opportunity at the national specialty weekend involving health information. The first seminar involved emergency care and last year's seminar dealt with reproductive information. This year we are changing the focus from health issues to ring presentation with a handling seminar provided by Linda Pitts. We hope that Linda's experience will help our membership learn how to present our breed more positively to judges.

Sheila M. Schmutz, Ph.D., Professor at the University of Saskatchewan has been conducting a DNA study on color in Pulis with information and logistical help from Linore Cleveland. For those interested in the topic, the study is posted on the website:

http://skyway.usask.ca/~schmutz/Puli.html. It is very informative and based on the DNA taken from the studied dogs. I would encourage all members to view the site.

Member Education is open to suggestions for future presentations. We have been fortunate that all presentations have been donated to the club. I would like the club to consider whether we should have a budgeted amount in the event that we would like to provide a seminar that costs the club or even for an honorarium for a speaker.

Membership Coordinator Report – Alexandra Davis We have continued to clean our database and this was helped by asking members to confirm their details on their 2005 renewal letter. Eighteen members did not renew. Two of these are in the process of re-joining the Club. As of October 14, 2005, we have 400 members from 292 households. Of these 378 are voting members from 268 households. We currently have 15 Provisional members and 2 Applicants. We have 35 overseas members, and had 44 new members join since October 2004.

During 2005 the status Provisional membership was introduced to expedite our membership process and allowing the applicants to receive Puli News once they were given Provisional membership. The Board assigns Provisional Membership to applicants upon review. Their details are published in the next Puli News and in the absence of feedback, which may cause the application to be rejected, these applicants will automatically become full members after a period of 45 days from the publication of Puli News. Our previous process could take up to 5 months. This new process has meant applications are usually processed well within 3 months. The timing depends on receipt of the application and publication of Puli News.

Obedience Statistician Report – Nancy Kelly
Pulik statistics for obedience are compiled from the AKC Awards
issues from January through December shows. They are
compiled for placements in Novice, Open and Utility classes
(Delaney System) and points are also assigned for all scores of
170 and better in Novice, Open and Utility (Modified First and
Foremost System).

The number of Pulik competing in obedience has gradually decreased over the last few years. In 2004, we did only had 8 dogs who competing and qualified. Those who have competed have done well. Factors contributing include the rise of Agility popularity as well as the introduction of Rally. I have seen the same trends in all breeds and the overall number of dogs in obedience has also slightly decreased. It is also interesting to see the number of all breed dogs who have gone straight into Agility; many are now determining that an obedience background is very helpful to the successful Agility dog.

So – teams get out there and get working with your Pulik. Let's kick some all- breed doggie butt.

Puli News Editor Report - Alexandra Davis

My first issue was August 2005 and October's has been mailed. August's issue was delayed due to many reasons but mainly a steep learning curve. My existing computer was unable to cope with the graphics involved and I had to personally buy a new Media Computer which is able to produce the quality I believe the membership deserves. I have found an excellent printer who is easy to work with and is reasonably priced,

Although I do not have much cost history to date I can state that the August issue cost 2 cents per page to print and an average of \$4.59 to mail overseas with the bulk rate being 46 cents. Costs are driven by quantity and page count. I hope that this time next year I am able to deliver more detailed cost information. We currently have 25 subscriptions in addition to the members.

I plan to split the Top 10 in to two next year having Conformation in April and the rest in June. This will help balance the size of each issue and also publish the results earlier in the year. I also hope to have issues with "themes" such as agility, rescue, obedience and herding.

I have received positive feedback so far on my first issues. To continue I need members to contribute with photos and articles. We all agree that Susi did a great job and I hope to produce the same level of quality that the readers of Puli News have come to expect.

Trophy Coordinator Report - Anita Ritenour

Puli exhibitors continue to show a healthy track record showing their dogs. After compiling the titles reports from the AKC, we showed a total of 123 titles earned from September 2004 through August 2005. Keep in mind, the AKC is doing it's best to encourage dog owners to continue showing. When Agility burst upon the scene, the number of pulis titles earned took a jump. To that we have added obedience Rally at 3 levels. In addition, the AKC now awards an additional title each time a dog fulfills the requirements for particular titles multiple times. As an example, we now have dogs that have been awarded the UDX title x 8. Congratulations to all who have worked hard for these honors.

This does bring up an issue that I feel the membership must think about and that is, do we continue to award title medallions for all of these degrees? The last time we ordered the silver medallions, they cost the club \$11 each (including the jewelers style box). We got 300 at that time. Do the math. To be honest, I have 66 left of those for the 123 actual titles earned. I will likely have enough (along with some additional "recycled" by other members above the 66 figure) to distribute at the annual dinner. I elected not to order more this year in view of our having a new logo in the works. We may want to go to a less costly medallion format &/or define how medallions are awarded. I am suggesting we limit medallions for each dog to 1 per discipline per year. By definition, if a pull in a given year earns a CH, NA, NAJ, CD,RN, PT, they would get 4 medallions. 1 for the CH 1 for the NA & NAJ, 1 for the CD & RN and one for the PT.

I also want the membership to be aware that we continue to have problems with the challenge trophies and need to address that issue as well. We have had yet another challenge trophy go among the missing and had to replace it. We need to decide if we want to have a "no take" policy or create "take and return" guidelines that require those that elect to keep them for the year to return them by a prescribed date or be responsible for replacement costs.

At the annual Awards Dinner, I am trying a new approach for handing out the awards. As the number of earned titles

increases, the attention span of the meeting attendees decreases. Understandable. Listening to the reading of 123 puli names and titles could get a bit boring and make the no-host bar quite popular. This year we have created an awards booklet listing all those that have earned AKC titles, the top 10 in each discipline, the Best In Show and High Score in Trial awards, the Versatile Puli awards and special awards. Only the top and select few awards will be read off.

Good luck to all showing in 2005 - 2006

<u>Versatile Puli Award Program</u> – Cathy Pronzini During the last year, I received requests for the Versatile Puli Award from four owners. All requests were approved and there are now four new Versatile Pulik.

Since the inception of this Award, there have been 1 Versatile Puli Excellent (VPX) Award, 8 Versatile Puli Advanced (VPA) Awards and 33 Versatile Puli (VP) Awards presented. I'm really proud of all the recipients and this awards program that acknowledges them.

The complete list of VPs is posted on the Puli Club website and is updated with the new awardees.

The Board has been asked to approve changes to the Versatile Puli Award calculation. The Rally Obedience category was added, as was a new category for BIS/BISS, Obedience & Herding HIT, and Conformation Group wins. The objective is to give equal weight to all competitive activities available to a Puli.

This coming year, I plan to do more promotion of the Versatile Puli Award program, so we can see even more VP Awards in the club.

I incurred no expenses for the VP Awards program, over than minor postage charges.

Ways and Means Report - Linn Hiett

The Ways and Means account has \$1,800 in it at the present time. We have a few outstanding bills. Working with our webmaster, Jim Moen, I plan to offer some of the products in "inventory" for sale on the web early next year. He will post photos to help describe what we are offering. If any anyone has ideas for new merchandise, please speak up.

Web Page Committee Report - Jim Moen

This year we added new features to the Members Only section of our web site. These include a "Board Issues Under Discussion" page, a list of all motions passed by the Board since 2001, and a simple page allowing any member to send an email to the entire Board. It appears, however, that not many people are accessing these pages, probably because they've misplaced their userids or passwords that were sent with dues renewal or new members welcome letters. I've proposed a simpler way for members to sign on, and hope to get approval to install that early in 2006.

Our web site was used extensively to disseminate information about the 2005 National Specialty, and to allow people to purchase Specialty shirts (over \$3,500), dinner tickets (over \$1,500) and advertising space in the 50th Anniversary Booklet and Specialty catalog (over \$3,300). This is our club's most substantial use of the web to help our members make these kinds of payments. I hope to expand our "PCA Store" with Ways and Means products – Linn Hiett has been asking to do this but this year was a little busy for the web guy.

Marla Williams and I have worked to develop an online BOT – Book of Titleholders. The programming is mostly done, and a nice test BOT database is now on the web, but events this year

prevented me from finishing this project and turning it over to Marla. I expect we'll complete it early in 2006.

I have posted a request in Puli News for volunteers to assist me on the web work, as well as to back me up, should I win the lottery and forget all my passwords.

Book of Titleholders Needs Help

The Online BOT Committee, chaired by Marla Williams and assisted by Jim Moen and Anita Ritenour, is asking for help. We are hoping someone in the club has a pedigree database that they would be willing to share with PCA to help jumpstart our online BOT project. Right now, we have the ability to put the new titleholders online, but if you have ever maintained a pedigree database, you know how much faster things go if the sire and dam are already on file. We have found that many of the popular programs store their data in a way that we can automatically extract the pedigree information and add it to PCA's new pedigree database. 

I would like to thank the members of the Puli Club of America for asking me to judge the National Specialty on the very special occasion of the 50th Anniversary. This will be a day that I will cherish for the rest of my life. As an elder statesman of the breed (if not the oldest) I was always keenly interested in the global cross section of our beloved breed. When I reviewed my placements in the show catalogue I was delighted to discover that this entry represented Pulis from three different continents, and from at least five different countries.

As I mentioned at the Awards Banquet, I was extremely pleased with the overall consistent quality of the Pulis entered at this Specialty. All the classes were very, very competitive. Interestingly, two concerns that I also had at the last PCA National Specialty that I judged, many, many years ago, still lingers on in the breed today longer than ideal muzzles and straighter than ideal shoulders. But, the Puli breed has overcome many of the significant breed issues of the past to blossom into outstanding representatives of the Puli standard. My hat goes off to the breeders for continuously striving to improve the Puli breed and producing the beautiful Pulis that were presented to me - bravo!

Specials Class

This years Specials class hurt my heart when I had to split them one more time. Under somewhat different circumstances many of these Pulis could have gone Specialty BOB and I would have been proud of them. The selections were not easy. One small comment about a very few of the Specials, if I may; it looks to me like some of the Pulis had the opportunity to get into Mom's cookie jar. Keep them fit. They look better, move better and will live longer.

Specialty Best of Breed

Pulis can be, correctly- nicely- perfectly structured- most of them are happy-go-lucky clowns- friendly- energetic- lively- acrobatic-light on their feet, beautiful movers - ...etc. In my judgment, this

years Specialty Best of Breed Ch. Catsun Comanche is all that and I use one more expression, that I very seldom see fit to use for a Puli, HE WAS ELEGANT!

Specialty Best Opposite Sex

Not to underscore, the Specialty Best Opposite Sex, Ch. Loakespark Pretty Smart, was also beautiful, a good mover, plus she was nicely feminine. Since we do not have a size disqualification it is important that one could easily distinguish a bitch from a male, in spite of the abundance of coat.

Award of Merit Pulis

This distinguished group was composed of super quality Pulis, some multi-Group and BIS winners. I am privileged, honored and happy that I had a chance to examine them individually. I have been judging Pulis for over 40 years and I do not think I ever had to make harder decisions then this time.

Best of Winners / Winners Bitch (I call this "the future of the breed" class.)

Best of Winners and Winners Bitch went to Moonshadows Tormentor from the Open Bitch class. From the Puli standard two words jumped into my mind, even before this bitch was put on the examining table; acrobatic and agile! A shoulder blade to die for, tight and well angulated. She is a real clown, which I like in a younger Puli. When she behaved a little bit more distinguished, for a few seconds I had some shocking ideas. One idea was to put her up to BISS, my other idea was to steal her and take her home. Call me chicken, but I did not do either. (Somebody should write a book on the psychology of dog show judging.) This outstanding youngster also finished her championship at this Specialty.

Winners Dog was Amhoeff By Jingo of Fuzzy Farm from the Open Dog class. Good movement was taken for granted in this class. A black Puli with excellent pigment inside and out. The somewhat uneven coat, especially on the rear, takes away a little, from this otherwise beautiful Puli.

Reserve Winners Dog was Immerzu Syncopation from the Bred By Exhibitor class. Structurally excellent. With a little bit more grooming and show training this Puli could go places.

Reserve Winners Bitch went to Kisalfold Mika from the Bred By Exhibitor class. The most energetic, well muscled, but lean, light on her feet bitch. I do not think she could put a foot down wrong even if she wanted to. Definitely not a couch potato. This lovely Puli bitch should be able to do herding all day long.

In this Puli News issue I hope others will also write about the camaraderie and smiles of these few days of the 50th Anniversary Specialty, - the humor, and the trials and problems of long distance driving to a Specialty with a multitude of Pulis. These memories will be part of Puli history for the next fifty or hundred years.

My congratulations again to the breeders of these quality Pulis!







Fay went with us to the Puli Club of America specialty in California last October. A few days into the trip she showed some intermittent lameness on her left foreleg. However, she was sound enough for us to show at the specialty, and seemed otherwise cheerful and healthy.

When we got back home the lameness got worse and she showed signs of loss of appetite. Our vet's diagnosis was deteriorating spinal discs, and he also found a mass in her abdomen, plus a possible mass in her foreleg. Further procedures were discussed, but by now Fay was extremely weak, obviously in pain, and she must have thought that enough was enough and that her fate was her own to decide. She died at home the evening following her second vet visit, two weeks to the day after the specialty.

I can scarcely find the words to describe how devastated this left us, and at the cruel speed of her final illness. Two weeks prior to her death she won Best of Opposite Sex in the 10+ Veteran Sweepstakes at the PCA specialty. A month prior she delighted us by going BOB from the Veteran class at a Puli Canada supported entry in Red Deer, Alberta, and then thrilled us beyond measure by placing 4th in Group, at 12½ years of age. Her picture above is of this win, with handler Tamzin, our daughter, who piloted her to many of her successes. Fay slept on our bed for almost all of her life. She never grew old - right up until her final week she was an opinionated, bright and active Puli, the Boss Bitch of our pack of Pulis. I think we somehow got the idea that she would last forever.

See you later, Fay Wray Puli - multi-group-placer, Winners Bitch at the PCA National in 1998 in Houston, model for the Puli in the Stephen Kline series of Lines of Language canine lithographs, dam of champions and many other titleholders, dog of our bed and oh! most definitely of our hearts.



#### Wrong dog? Wrong breed? Wrong/inadequate training & preparation?

Lately we have seen an inordinate number of Pulik given up to rescue because of the arrival of a new (human) baby. While some cannot, many dogs do learn to live with babies. Research indicates that there is about 100 times more chance of a child killed by an adult than by a dog. However, introducing a dog to a new baby mandates common sense and being a responsible dog owner.

It is believed that most children are killed by dogs NOT because of rank drive or pack issues. Of note, nonetheless, is that predatory behavior is increased as the number of dogs in a family increases.

Has the dog ever been aggressive to strangers? Strange children? Smaller animals? If the answer to any of these questions is 'yes,' you must be extremely careful with this dog around a new baby. If you are a breeder, it behooves you to make appropriate inquiry before agreeing to sell a puppy to a young home.

#### The Leerburg Kennel suggests:

- 1. Make sure the dog is fully obedience-trained, as well as crate-trained.
- 2. Baby's bedroom should always be off-limits, even when you are present.
- 3. The dog should never be allowed access to the baby when not supervised.
- 4. Some people get a doll, wrap it in a blanket, carry it around and place it in the baby's bed.
- 5. Once the baby is born, they wrap a blanket with the baby's scent on the doll.
- 6. When the baby comes home, a quiet introduction first with only mother is in order, and the dog should remain in a 'down-stay' position.
- 7. If the dog is distressed when baby cries, crate it and give it a bone or a Kong to keep him interested and busy.
- 8. Prior to baby's arrival, get the dog a selection of new toys. Keep them available and control access so the dog does not become bored.

These are a few suggestions which should mitigate against new parents giving up their dogs. The proverbial bottom line is that the owners in question never obedience-trained their Pulik, never socialized them around people and kids, and with a new baby they have neither the time nor inclination to do it. So the Pulik are disposable and come to rescue.
