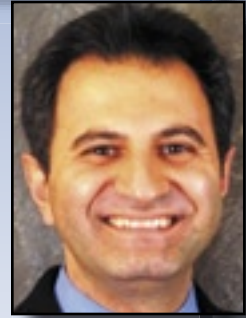

Trying Not to Giggle Through CPR Training

Back in the days when REDS was housed on Cleveland Avenue, we had a regular program of CPR training. REDS had our own Rescusi-Annies, much handled baby dolls for infant CPR, and all the disposables for practicing mouth-to-mouth ventilations on the manikins. Now, Dr. Peyman Hedayati has taken the initiative to revive the program at REDS.

We had volunteer CPR instructors. I volunteered figuring the best way to learn something is to teach it. Also, distinguishing between Red Cross procedures and American Heart Association procedures required some modest attention be paid to new publications.

The hardest part of training as either an instructor or a participant is focusing on the critical skills of performing CPR while the students giggle through the class. With only modest efforts to “get it right”, we would stumble through the evening class regularly checking watches, dodging a coma while watching the CPR amateur movie short, and racing through the written exam that made sure you remembered a few details until you started the car ignition before heading home. Of course the most fun was exploiting the ever-comical sexual innuendo of performing CPR on a mannequin.

I’m not sure if we were just “whistling through the graveyard”

as we would display such a cavalier attitude toward a topic more deadly than anything we do, or we felt that the chances of us really using this technique was too remote to invest too much serious attention. After all, rumor has it that Dr. Heimlich himself never had to invoke the maneuver bearing his name.

Certainly, having to perform any significant manipulation of a mannequin is fertile comic ground, so the temptation is great to crack a joke or make a subtle gesture. She’s the perfect “straight-man”. After all, Annie can’t really be saved, and she can never die.

But our patients can.

In our office, we have CPR annually. I feel having it every 2 years just isn’t frequent enough to truly retain information and have adequate practice. We try to do simulations on a regular basis to see what glitches might occur. We quickly learned, for example, that the defibrillator leads are too short to extend from the operatory counter to a patient in the dental chair so we need to put the AED on a stool near the chair. We need regular reminders where the emergency kit is and how to quickly get items that are needed. Regular medical drills are vital for readiness.

A project I’d like to do to bring medical emergencies into focus is to query the REDS membership about medical emergencies that have really occurred in the dental office.

Whether it was an episode of syncope, angina, seizure, or more threatening event, I’ll bet there was no sniggering going on as the EMT truck pulled up. Did anyone wonder whether you did everything right. Were there any gaps in procedures that put the patient at increased risk of serious injury? How hard was it to figure out what was happening to the patient? Was there fumbling of equipment? Could you find the oxygen and really turn it on? The stories we hear from Stan Malamed or other speakers such as the dentist who didn’t fully recline a patient in syncope and contributed to irrevocable brain damage are poignant, but it is still somewhat distant. It didn’t happen in our counties.

But there are really emergencies that have happened in our offices, and they are inevitable events in offices that provide tissue alteration (including tooth cutting) in a stressful environment. Perhaps we can learn from what our local colleagues have experienced so that in a real emergency we can be real professionals.

I invite you to send in your medical emergency stories including those procedures you’d like to update or change. I’ll bet there was very little kiddin’ around when the patient was in distress. And as we all know, saving a life is no laughing matter.

Important Legal Tidbits for the Dental World

Updates to CDA's Required Poster Set

If you have the poster set distributed in 2009 by REDS and CDA, you will need to replace (or tape over) two posters with the updated versions. The updated posters are (1) the Federal Fair Labor Standards Act (Minimum Wage), updated July 2009; and (2) Equal Employment Opportunity is the Law, revised November 2009. Links to these updated posters can be found on CDA Compass website. Look under the Regulatory Compliance Tab for "Required Postings In A Dental Office." A full Listing of required postings for the dental office can be found on the CDA Compass website. CDA and REDS will be mailing out new posters in 2011.

Records and Retention

According to the California Dental Practice Act Compliance, updated March 2010, records must be kept for seven years if the patient is inactive or if the dentist ceases operations. Records of unemancipated minors shall be kept at least one year after the minor has reached the age of 18 years, and in any case, not less than seven years. (While there is no definition for discontinued treatment, it can be described as being long enough so that the patient can reasonably account for their dental history. Typically it is 24 to 32 months after the last appointment.) Liability insurance carriers typically recommend a much longer period for record retention. Ideally, all dental records, active and inactive, should be maintained indefinitely. For your complete guide to the California Dental Practice Act check the CDA Compass website.

Are you offering commercial credit?

New Laws Effective January 2010

A new law effective in 2010 requires dental practices to provide a notice and follow other requirements when offering commercial credit to a patient. Offices offering third-party credit arrangements through companies such as CareCredit or Chase Health Care Financing must, prior to establishing a commercial credit card, line of credit, or loan for a patient in the dental office 1) Provide a written treatment plan to the patient and 2) The dentist, or his or her staff, must obtain the patient's signature on a specified written disclosure notice. There are forms available on the CDA Compass website that allow dentists to customize the disclosure notice for their practice. There are also translated versions in Spanish, Chinese, Hmong, Russian and Vietnamese.

A 2-Minute Quick Guide to Changes in CE Regulations

- Categories 1 and 2 are no longer required.
- Licensees still can only have 20% practice management, but they are on their own to determine that designation.
- The new regulations will allow for new classes to be counted for CE units, such as foreign language courses, record keeping, office organization and design, and employment law.
- The California Law course will be known as California Dental Practice Act (CDPA)
- Make sure your CE Certificate has an 11-digit number on the upper left.
- You must sign in to all CE Courses.

Into the Nicaraguan Countryside for a Week of Giving

Arranged by Rotary and organized by SRJC's Ezbon Jen, retired REDS member Steve Davis just completed his second dental adventure to Nicaragua.

As a service organization, Rotary has set up dental programs in a number of areas including Haiti and Vietnam, but Dr. Davis joined other dentists and optometrists (to provide reading glasses) to treat underserved peoples in remote areas of Nicaragua. Santa Rosa dentists Kelly Waggoner, her husband Jason Lehman, and retired pediatric dentist Bob Weis have also participated.

In his first trip Steve flew to Managua then transferred to a 12 passenger "fall apart" charter plane, which made a tricky landing on a tilted dirt runway. After kissing the ground, he then boarded a boat that took him up the river to a primitive resort with a thatched roof lodge on stilts with no windows, toilets, or hot water - he wasn't quite clear how it earned the "resort" title.

The Rotary groups now know how to avoid being taken advantage of by officials in the loosely policed and often corrupt management of baggage. Boxes of equipment and supplies were sent ahead of time and when

the volunteers arrived they took care not to appear as a group. Combinations of local Rotarians and Peace Corps workers gave them assistance and helped them maneuver through local communities and procedures.

Pressing on to the villages, the intrepid volunteers rode in vans along 15 miles of rutted, jarring roads through hilly terrain and jungle to the village they would be serving. The rare comfort in the heat (up to 85 degrees) and humidity was the paucity of insects. During their stay, there was no rain.

The local people live in the most simple of houses consisting of shacks and hovels surrounded by lots of hanging laundry. The streets are traveled with just a few vehicles that are mostly tired, rusted, and dented vans. They have a subsistence diet of starches and sugar that inevitably lead to dental caries.

Peace Corps workers had been there between 2-3 years, providing language instruction for the locals and were helpful translators to the Rotary volunteers. It was notable that

despite the primitive conditions the Peace Corp volunteers never griped or complained.

They constructed a make-shift clinic (with "megaphone" type handheld x-ray machine, high speed unit, cold sterilization, and anesthetic) in the town's clapboard-constructed community center. They served people that lined up for care early each morning. Treatment consisted mainly of surgical extractions, root tip removal, and a few restorations. All but the truly frail patients are treated, and fortunately, they found very few patients with

significant medical problems.

Dr. Davis and volunteer colleagues' reward at the end of the trip was a stay at a nice resort (with running water, electricity, working toilets, etc.) near Managua, but Steve relishes the satisfaction of having served so many people in need, and plans to go every two years to wherever the Rotary Club chooses for its next act of kindness.

Crowns for Kids Program Provides Care for Sonoma County Children

Star Refining London and the CDA Foundation have joined forces to launch a scrap crown recycling program to support local philanthropic efforts in the Redwood Empire and provide dental care for Californians in need through the Crowns for Kids program. To participate in Crowns for Kids, the CDA Foundation or REDS, provides a recycling jar for members to collect precious metal.

As a result of the money generated through these collections, the CDA Foundation will be able to give grants to local community oral health access programs. The amount of money that REDS can receive from this grant is based DIRECTLY from the amount

of materials collected. That means the more we can collect the more money will go back directly into our local community.

It is estimated that millions of dollars' worth of services would be provided to underserved children statewide if the vast majority of dentists in California participate in the Crowns for Kids program. This pro-

In Memorium

George Lane Jr., DDS

We mourn the loss of George "Bill" W. Lane, Jr, an active member of the Redwood Empire Dental Society from 1955-2001 who passed away at the age of 84 on March 22. Born and raised in Petaluma, Mr. Lane graduated from St. Vincent de Paul Catholic High School in 1942. Upon graduation, he joined the U.S. Navy Reserves to serve in World War II. He was selected for the Navy V-5 Flight Program, where he flew SBD and SNJ aircraft. He graduated from this program in 1945 in Corpus Christi, Texas, just as World War II ended. Mr. Lane continued to serve in the Navy Reserve Flight Program during



his college education at Stanford University. He graduated from the University of the Pacific School of Dentistry in 1954. Bill Lane served as president of the Dental Society between 1966 and 1967 as well as trustee to the California Dental Association. Dr. Lane graduated from University of the Pacific Dental School in 1954 and practiced dentistry in Petaluma for over 47 years. He was an active member of the community organizations such as Rotary International and the Hanna Boys Center in Sonoma. He is survived by his wife Maureen, who he married in 1958, and 5 children and siblings Dr. Leo Lane and Mary Margaret Dolcini.



John Bihn, DDS

Former REDS President John Bihn passed away in his Petaluma home on June 3. A memorial was held at St. Vincent de Paul Catholic Church in Petaluma.

In 1939, Bihn graduated from St. Vincent Academy and later attended U.C. Berkeley for his undergraduate education. While at Berkeley, Bihn considered studying zoology but was convinced to pursue dentistry. After dental school at U.C. San Francisco, Bihn served in the U.S. Navy medical corps. When he returned from his naval service, he set up his practice with an Army surplus dental chair in a small, rented office in the alley off Kentucky Street. He practiced dentistry for four decades. His last dental office was on B Street.

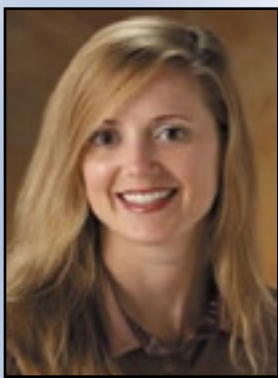
