Introduction

The Miami-Dade Water and Sewer Department (WASD) has an existing Laboratory at the Alexander Orr Water Treatment Plant (AOWTP) for testing and sampling the quality of the Drinking Water in their distribution system. The selected artist(s) will design unique artwork(s) that will contribute to the identity of this facility and engage employees, visitors and passers-by in unexpected and delightful ways.

It is envisioned that artists will address the theme of high-quality drinking water in their public art commission.

Detailed Description

The Miami-Dade Water and Sewer Department (WASD) has an existing Laboratory at the Alexander Orr Water Treatment Plant (AOWTP) for testing and sampling the quality of the Drinking Water in their distribution system. Currently, the Laboratory operations are performed in an outdated and confined space. Because of this situation, WASD issued a Design-Build Project for a new Drinking Water Laboratory within the premises of the AOWTP, which was awarded to Florida Lemark Corp. together with CSA Group.

The new state-of the art facility will be the flagship for WASD on the AOWTP campus at a new site. The building will incorporate administrative offices and amenities, a laboratory and workspaces, and architectural features such as a breezeway, covered terrace, interior garden courtyard, and kitchen. The design criteria features ample natural light through new glazing, established native trees and landscaping, and resilient materials.

DESIGN REFERENCES

Water Treatment Process. The water flows through large rocks, then smaller rocks, then sand, then lime, for example. In our first versions of the building design these elements were used as inspiration for patterns on the walls. Depending on the method of construction selected, we may revisit this for the Architectural Language.

Natural Light. Another important design element is natural light. The laboratory is designed in a way where natural light is accessible to all end users, not only for their well-being, but also as a way to make the building more energy-efficient. We accomplish this by using extensive use of windows, which also allow views into the Interior Garden/Courtyard.

Mango Tree. One of the concerns of the end users was that the beloved mango tree that sits in the middle of the site would be removed for the construction of the lab. We used that as a design directive not only to save the delicious mangoes, but as inspiration to create an Interior Garden/Courtyard which would offer an oasis from work, and be the focus and the main view from which most of the circulation and public spaces would revolve.

Water. Water is life. Water is the reason for the project.

Process

Artist qualifications will be reviewed by Art in Public Places' Professional Advisory Committee (PAC), a panel composed of professionals in the field of art, public art, architecture, art education, art history, or architectural history appointed by the Art in Public Places Trust. It is anticipated that a threemember group drawn from the PAC will identify a shortlist who will be paid an honorarium to develop specific proposals. Shortlisted artists will have the opportunity to access architectural plans etc., engage in an artist orientation and site visit to meet the key stakeholders, and further develop their proposals. A three-member group will be drawn from the PAC to review artists' proposals and make recommendations to the Art in Public Places Trust to create public art commissions.
